On the recommendation of the Executive Committee of the College of Engineering and with the endorsements of the Department of Aerospace Engineering and the Department of Electrical Engineering and Computer Science, I am pleased to recommend that Ella M. Atkins be appointed as associate professor of electrical engineering and computer science, without tenure, in the Department of Electrical Engineering and Computer Science, College of Engineering, effective January 1, 2007.

Professor Atkins graduated from the Massachusetts Institute of Technology in 1988 with a B.S. degree and in 1990 with a M.S. degree, both in aeronautics and astronautics. She received a second M.S. degree in computer science and engineering from the University of Michigan in 1995 and continued on to receive her Ph.D. in computer science and engineering (CSE) in 1999. From 1990 to 1993, Professor Atkins worked as an aerospace project engineer at Structural Dynamics Research Corporation in San Diego, California. While at the University of Michigan, she worked as a graduate fellow/research assistant in the Artificial Intelligence and Real-time Computing Laboratories of the Computer Science and Engineering Department. Upon completion of her Ph.D. in 1999, she joined the faculty of the University of Maryland, Aerospace Engineering Department as an assistant professor. In 2006, Professor Atkins moved to the University of Michigan as associate professor in the Department of Aerospace Engineering. In addition to her academic appointments, she has served as an engineering consultant since 2005 to the Institute for Defense Analyses in Alexandria, Virginia.

Professor Atkins' expertise lies in applying real-time and fault-tolerant computing to a number of important research problems involving autonomous spacecraft software and flight planning. Her research program focuses on the integration of strategic and tactical planning and optimization algorithms to enable robust, autonomous aircraft and spacecraft flight in the presence of system failures and environmental uncertainties. She brings significant experience in applying advanced computational techniques to large-scale applications, and as such, will be an excellent resource for graduate students in CSE, and is very likely to advise and/or co-advise Ph.D. dissertations for CSE students. In addition, Professor Atkins will have the opportunity to collaborate with several CSE faculty members.

With this additional appointment, Professor Atkins is ideally suited to assist the Department of Electrical Engineering and Computer Science by her active involvement with research and students. I am pleased to recommend the appointment of Ella M. Atkins as associate professor of electrical engineering and computer science, without tenure, College of Engineering, effective January 1, 2007.



Following a one-year visiting fellowship at the Cooperative Institute for Research in Environmental Sciences, Dr. Carroll began her career as a research chemist at the Aeronomy Laboratory in the National Oceanic and Atmospheric Administration in 1984. She joined the faculty at the University of Michigan as associate professor, with tenure, in 1992 and was promoted to professor in 2001.


Professor Carroll has close research ties to several faculty in the Department of Geological Sciences and has collaborated with students. She teaches biogeochemistry courses which include several geology students each year. She is also director of the recently renewed Biosphere-Atmosphere IGERT grant that is expected to support one or two geology students in the next five years. Her presence in the Department will benefit research and scientific diversity.



He routinely teaches physics students in his applied mathematics courses and will be working more closely with physics students on individual research projects, including theses and dissertations. He interacts regularly with physics faculty and has scientific interests in common with several on-going research programs.





Dr. Kuppers received a M.A. in film and TV studies from the University of Warwick, UK, a second M.A in Germanistik, film, TV and theatre studies, and social anthropology from the University of Cologne, Germany, a Diploma in health and social welfare studies, from Open University, UK, and a Ph.D. in performance studies and feminist theory from Falmouth College of Arts, UK. 
The Ph.D. program in the Department of Theatre & Drama is being reorganized, and Dr. Kuppers' concentration in performance studies, feminist theory, and disability as an element in contemporary performance will enhance this effort. As is evidenced by Dr. Kuppers' curriculum vitae, her publication record, presentations at national and international conferences, and her artistic contributions will add relevance and dimension to the graduate program. 

Professor Stern began her teaching career as an assistant professor of history at the University of California, Santa Cruz, in 2000. She joined the faculty at the University of Michigan as assistant professor in 2002 and was promoted to associate professor, with tenure, in the Medical School, and without tenure in the College of Literature, Science, and the Arts. Her appointment to a collegiate professorship in the Medical School was approved by the Regents in November 2006.


Professor Stern's research focuses on the history of science and medicine in the Americas with a broad interest in eugenics. She has explored children's health, tropical medicine, and reproduction and sexuality in the United States and Mexico. Her research has been published in historical, sociological, public health, medical, and health policy journals in the United States as well as in Argentina, Mexico, Germany, and the United Kingdom. Her 2005 book, *Eugenic Nation: Faults and Frontiers of Better Breeding in Modern America*, won the 2006 Arthur Viseltear Award from the American Public Health Association for outstanding book in the history of public health.

Professor Stern has many points of connection with the Department of History, including colleagues in the history of science and medicine as well as U.S., Latin American, and modern European history, and the history of colonialism. Formalizing her relationship to the Department will nurture these scholarly and creative connections. A courtesy appointment will facilitate her supervision of students, teaching an undergraduate honors seminar in history, and serving on search committees.





Dr. Worthen was recruited to the University of Michigan as associate professor of English language and literature, with tenure, in the College of Literature, Science, and the Arts in 2006.

Dr. Worthen is a distinguished scholar and teacher, and he possesses an outstanding publication record. He specializes in Modern British and American Drama, Dramatic Criticism and Theory and Practice. 

The Dean and the Executive Committee of the College of Engineering request the establishment of the Joseph B. and Florence V. Cejka Professorship in Engineering effective February 1, 2007.

The Joseph B. Cejka and Florence V. Cejka Foundation, Inc., has provided a gift of \$1,500,000 to establish and support an endowed, full professorship to be known as the Joseph B. and Florence V. Cejka Professor of Engineering. The holder will be a full professor in the College of Engineering who will be appointed to the chair for five-year renewable terms.

A strong advocate of public education, Mr. Cejka earned a bachelor's degree at Wayne State University, followed by a master's in mechanical engineering from the University of Michigan. He taught engineering at Tulane and Rutgers universities before entering the business world. Later, as Chief Executive Officer of Ward Products Corporation, a New York and New Jersey firm, he was well known for helping pay the college costs of his employees' children and for mentoring and supporting staffers who wanted to launch their own businesses.

As a result of a generous gift from Stuart and Barbara Padnos and the Louis and Helen Padnos Foundation, the Louis and Helen Padnos Visiting Professorship in Judaic Studies was established in September 1988. Professor Miron began his teaching career as assistant professor at Tel Aviv University in 1960 and was promoted through the ranks to professor in 1974. He has also held appointments as professor at Hebrew University (1975-1976), visiting professor at Columbia (1977-1978), chair of the Department of Hebrew Literature at Hebrew University (1979-1986), and has been the Leonard Kay Chair at Columbia since 1987.


A prolific scholar, critic, and editor, Professor Miron has established himself as the leading authority on Hebrew literature. His influential books study the most prominent Hebrew and Yiddish authors, fiction writers, and poets since the revival of Hebrew literature in the 19th century. As an editor-scholar, he is also responsible for some of the most important collected writing projects to be published in Hebrew. His latest book, *From the Worm a Butterfly Emerges*, is an examination of the life and work of the poet, Nathan Alterman, as a young man. His first book on Yiddish literature, *A Traveler Disguised: The Rise of Modern Yiddish Fiction in the Nineteenth Century* (1973), can be said to have inaugurated modern academic study of Yiddish.

Professor Miron will teach classes during fall term 2007 that will reflect his literary methodology – one will be a graduate seminar on Sholem Aleichem, the well-known Yiddish writer at the turn of the 20th century; and the other is an undergraduate class on either Hebrew or Israeli literature. These courses will also complement offerings in the Department of Near Eastern Studies and the Program in Comparative Literature.



Previously, he was on the faculty at the University of Wisconsin, Milwaukee, where he was professor (1968-1999) and director of the Center for International Studies (1991-1999).



superb citizen of the Department of Political Science as well as of the College of Literature, Science, and the Arts and the University.



The Dean and Executive Committee of the School of Dentistry are pleased to recommend the appointment of Hom-Lay Wang as the Collegiate Professor of Periodontics effective January 1, 2007 through December 31, 2011, with the possibility of renewal.

This endowed collegiate professorship was established by the Regents in December 2006. The intent of the professorship is that it be used as a rotating title to be awarded to a selected School of Dentistry senior faculty member.

Dr. Wang received his D.D.S. from Case Western Reserve University (CWRU) in 1989 and both a Master of Science and a specialty certificate in Periodontology from CWRU in 1987. Dr. Wang joined the faculty of the University of Michigan as an assistant professor of dentistry in the Department of Periodontics, Prevention, and Geriatrics in 1989. He was promoted to associate professor, with tenure, in 1997 and to professor in 2002. In 1995 he was appointed director of Graduate Periodontics and currently serves in this position.

Dr. Wang has been extensively involved in both clinical and didactic teaching. He has taught and/or directed virtually every offering in the periodontics program. Dr. Wang represents the type of individual needed to translate biological research to the clinical arena. He has been instrumental in bridging the link to understanding the relationship between biological and clinical disciplines. As director of the Graduate Periodontics Program, his students are provided solid training in basic concepts and surgical procedures. His excellent mentoring skills at the didactic, clinical and research levels are proven by the consistently high performance of his students on the Michigan Periodontal and American Academy of Periodontology Board Exams.


Dr. Wang is a researcher in the area of translational research, in the fields of guided tissue regeneration and implantology. He has published widely in this area and is recognized internationally for his achievements. Dr. Wang has expanded his research endeavors to include dental implants, periodontal diagnostics, chemotherapeutics, and new regenerative devices. This gifted clinical investigator continues to excel in these new areas of research.

Dr. Wang has served on several professional advisory boards, national and international review committees; editorial boards, and is a consultant to the Commission on Dental Accreditation of the American Dental Association. The Research, Science and Therapy Committee of the American Academy of Periodontology bestowed upon Dr. Wang the singular honor to write the Academy's informational/position paper on "Periodontal Regeneration." He has also served with distinction as associate editor for The International Journal of Oral & Maxillofacial Implants of Academy of Osseointegration as well as Periodontal Literature Reviews of the American Academy of Periodontology. All of these positions attest to Dr. Wang's outstanding reputation in the disciplines of periodontology and academic dentistry


At the School of Dentistry, Dr. Wang has a strong record of service. He has served on virtually every important departmental committee and on School committees such as Appointments, Promotions and Tenure, Nominations and Elections, Graduate Studies, Health Sciences IRB, and numerous search committees. He has chaired several scientific and clinical meetings. He is an active participant in organized Dentistry at both the generalist and specialty levels and is clearly helping to shape the future of the profession.

I am pleased to recommend Hom-Lay Wang as the Collegiate Professor of Periodontics in the School of Dentistry effective January 1, 2007 through December 31, 2011.

With the endorsement of the Executive Committee of the College of Literature, Science, and the Arts, we are pleased to recommend the reappointment of Henry T. Wright as the Albert Clanton Spaulding Collegiate Professor of Anthropology for a five-year renewable term, effective January 1, 2007 through December 31, 2011.

Albert Clanton Spaulding was curator of archaeology and a faculty member at the University of Michigan from 1947 to 1959. The Albert Clanton Spaulding Collegiate Professorship in Anthropology was established by the Regents in October 2001. A stipend funded from college resources will accompany this professorship.

Henry Wright completed his Bachelor of Arts with honors at the University of Michigan in 1964. He attended the University of Chicago where he earned a Master of Arts in 1965 and his Doctorate in 1967. Professor Wright returned to Michigan where he began his teaching career as assistant professor in 1967 and was promoted through the ranks to professor in 1976. He has been curator of the Museum of Anthropology since 1967 and was its director from 1989 to 1992.

Professor Wright is an anthropological archaeologist whose breadth of knowledge and range of scholarly activity is simply remarkable. A MacArthur Fellow and a member of the National Academy of Sciences, he is internationally recognized for the importance of his work and his stature in the field. Since his appointment to the Spaulding Collegiate Professorship, he has continued to be an active fieldworker, involved in archaeological surveys in Hunan, Madagascar, and eastern Syria. His most recent grants from the National Science Foundation have been in support of his students' research, but Professor Wright remains very closely involved in this work. His recent publications show an unflagging productivity and continue to make important theoretical and methodological contributions.

As for teaching, Professor Wright is a faithful contributor to the graduate core course program, offering a service course every year. He is particularly skilled at linking the course material to the larger anthropological issues that cross subfields and tie into the students' own research plans. He also teaches courses on his own specialty and more general archaeology or prehistory courses.

Professor Wright is an unusual scholar whose national and international reputation rests on brilliant accomplishments and contributes largely to the prestige of the Department of Anthropology. We are pleased to recommend the reappointment of Henry T. Wright as the Albert Clanton Spaulding Collegiate Professor of Anthropology for a five-year renewable term, effective January 1, 2007 through December 31, 2011.
