It is a pleasure to recommend the appointment of Andrew L. Rosenberg, M.D. as interim chief information officer, University of Michigan Hospitals and Health Centers and Medical School, effective April 1, 2016.

In this capacity, Dr. Rosenberg will lead the information technology and services transformation across the academic medical center (AMC) to align the information technology strategy with that of the AMC and the university goals. Dr. Rosenberg will report to the executive vice president for medical affairs and dean of the medical school.

Dr. Rosenberg received his BS from the University of Michigan in 1986. He earned his M.D. in 1991 from the Johns Hopkins Medical School where he also completed a residency in Internal Medicine and an additional year of advanced training in anesthesiology. He continued his training in Critical Care Medicine as a fellow at the George Washington University Medical School from 1995-1997. Subsequently, he returned to the University of Michigan from 1998 to 2000 as a Robert Wood Johnson fellow, where his work focused on clinical informatics and health services research. From 2000-2002, he completed an anesthesiology residency with advanced training in cardiac anesthesiology at the University of Michigan and joined the faculty as an assistant professor. In 2007, Dr. Rosenberg was promoted to associate professor, with tenure, in the Department of Anesthesiology. Dr. Rosenberg is also board certified in clinical informatics.

Dr. Rosenberg has served in a variety of progressively responsible academic and administrative positions including director of the division of Critical Care in the Department of Anesthesiology, director of the Cardiovascular Center Surgical Intensive Care Unit, and director of the critical care medicine fellowship program. In 2007, he became the medical director for the hospital electronic order entry project (Carelink) and became the first health system chief medical information officer in 2010. In January 2016, he became the interim chief information officer for the University of Michigan Hospitals and Health Centers.

Dr. Rosenberg is a frequent presenter at national and international academic societies, meetings and forums on the topics of designing and implementing enterprise analytics programs for academic medical centers and integrating large scale enterprise clinical electronic information systems to health system research information technology capabilities. His expertise includes initiating and maturing a variety of governance organization and implementation strategies to successfully accomplish these socio-technical projects to advance learning health organizations.
