The dean of the School of Nursing is pleased to recommend the reappointment of Debra Barton as the Mary Lou Willard French Professor of Nursing, School of Nursing, effective June 1, 2019 through May 31, 2021.

The School of Nursing was the recipient of a generous gift from Mary Lou Willard French for the Mary Lou Willard French Professorship in Nursing, which was established by the Regents in June 1999. This endowed professorship will continue to be used to further research focused on nursing care for cancer patients and their families. Appointments to this professorship are renewable.

Debra Barton received her bachelor's degree in social work from the University of Illinois, Champaign-Urbana in 1979. She received her associate's degree in nursing from Parkland College in 1985; her masters of science in nursing, adult health from the University of Illinois, Champaign-Urbana in 1991; and her PhD in nursing from Indiana University in 2002.

Professor Barton held the title of assistant professor of oncology at the Mayo Clinic, Rochester, MN from 2003-2007. She was promoted to associate professor, with tenure, at the Mayo Clinic Rochester, MN in 2007. She was a clinical research scientist at the Mayo Clinic Comprehensive Cancer Center in Rochester, MN from 2005-2015, and a nurse administrator in the Division of Nursing Research at the Mayo Clinic in Rochester, MN from 2011-2014. Professor Barton joined the faculty at the University of Michigan in 2014 as a professor of nursing, with tenure, in the School of Nursing, and as a professor of psychiatry, without tenure, in the Medical School. In 2018, she was appointed as the associate dean for research in the School of Nursing.

Professor Barton is a consummate researcher who is highly committed to advancing the sciences of symptom management in patients with cancer. She has furthered the frontier of knowledge by examining the underlying physiology of symptom presentation, and she has tested pharmacologic, behavioral, and complementary treatments for reducing a variety of symptoms, including chemotherapy-induced peripheral neuropathy, hot flashes, and fatigue. In recent years, Professor Barton has conducted over 25 studies funded by the National Cancer Institute (NCI), its National Cancer Clinical Trails Network, the Breast Cancer Research Foundation, and the Department of Defense.

Professor Barton has published numerous papers in a wide array of journals, including some of the most respected journals in oncology: *Journal of Clinical Oncology*, *Journal of National Cancer Institute*, *Clinical Pharmacology and Therapeutics*, *Cancer*, *Supportive Care in Cancer*, and *Oncology Nursing Forum*. She has a reputation for excellence as a researcher, and her peers at the national and international levels recognize her work. She is a fellow in the American Academy of Nursing, an honor that is based on her contributions to the field. Professor Barton's expertise as a scientist is recognized by her appointment to multiple National Institutes of Health (NIH) federal review panels and her role as the editor-in-chief for the *NCI PDQ® Supportive and Palliative Care* information summaries.

Professor Barton is an outstanding citizen of the nursing community and has made impressive contributions to the nursing profession, and to the broader scientific community. Most notably, she has established a track record as a leader in scientific organizations at the national level including being a peer reviewer for the NIH, and leader within the ONS. She served as a leader in the American Society of Clinical Oncology, an interdisciplinary scientific organization with more than 30,000 members, most recently as a track leader on the Scientific Planning Committee for the annual meeting (2012). She has been active in the Alliance for Clinical Trials in Oncology, a national clinical trials network sponsored by the NCI that consists of nearly 10,000 cancer specialists at hospitals, medical centers, and community clinics across the United States and Canada.



I am pleased to recommend the reappointment of James T. Dalton as dean, College of Pharmacy, for a second five-year term, effective September 1, 2019 through August 31, 2024. This recommendation follows an extensive review process.

Under Dean Dalton's leadership, the College of Pharmacy continues to be internationally recognized as a leader in pharmacy education and research. Ranked among the very top in the nation, the college engages in far-reaching initiatives with the university, state, national, and international scientific and business organizations committed to speeding new medication therapies from bench to bedside. Dean Dalton has a clear understanding of university priorities and has worked to align the college with efforts such as Precision Health and Inter-professional Education. He has taken a leadership role in collaborations between the health sciences schools, particularly in the creation of a new Inter-professional Exchange Stimulus grant program. The college's research portfolio continues to grow; research expenditures in the college increased 98 percent from FY14 to FY18.

Dean Dalton has inspired and led continuing fundraising success to surpass the college's recent campaign goal. In each of the past four years, the college has been able to award between two and three million dollars in direct student support thanks to generous support of alumni and friends. His strong commitment to fiscal stewardship ensures the long-term health of the college. He is a dedicated team player who works collaboratively with faculty, staff, students, and central administration in every way to improve the college and to plan for future facility needs. His goal for the College of Pharmacy is to be a place where everyone is committed to helping others achieve their personal and professional goals, to providing leadership in pharmacy education and research, and to providing an environment where any idea or issue can be discussed respectfully and openly.

James Dalton earned a B.S. degree in pharmacy from the University of Cincinnati in 1981; in 1990 he earned a Ph.D. degree in pharmaceuticals and pharmaceutical chemistry from The Ohio State University (OSU). He was a pharmacist intern and staff pharmacist at Kettering Medical Center in Kettering, Ohio from 1982-1988. From 1991-1992, he was a post-doctoral fellow in the Division of Pharmaceuticals and Pharmaceutical Chemistry at OSU. In 1992, he joined the Department of Pharmaceutical Sciences at the University of Tennessee as an assistant professor. He was promoted to associate professor in 1997 and tenured in 1998. In 2000, Professor Dalton joined the Division of Pharmaceuticals and Pharmaceutical Chemistry in the College of Pharmacy at OSU as an associate professor. He served as interim chair of this division from 2002-2004, and from 2004-2005 as division chair during which time he was promoted to professor. In 2014, he joined the University of


Michigan College of Pharmacy as the dean and professor, with tenure.

From 2005-2008, Dean Dalton's appointments were divided between OSU as Kimberly Professor in the College of Pharmacy and entrepreneurial leave from OSU to serve as vice-president of preclinical research and development at GTx, Inc. in Memphis, Tennessee. In 2008, he left OSU to devote full time to drug discovery at GTx, Inc. In 2011, chief scientific officer was added to his title at GTx, Inc. Among his many research and administrative responsibilities at GTx, Inc. were leadership and direct supervision of all aspects of drug discovery and preclinical and product development, including drug discovery, medicinal chemistry, drug metabolism, analytical sciences, safety and toxicology assessment, pre-formulation, and product development teams. He led the intellectual property team, which involved quarterly review meetings, interactions with internal and external patent counsel, annual scientific meetings and publication strategy. His experience in this regard has been extremely valuable in re-envisioning Michigan Drug Discovery and he currently chairs the executive committee for our efforts in this area.

Dean Dalton's interdisciplinary and translational research has focused on the molecular and preclinical pharmacology of selective androgen receptor modulators (SARMs), and novel drugs in the treatment of cancer. SARMs were first discovered in his research laboratories and he is co-inventor on over 300 SARM patents. Over the course of his career in the academy and in industry, he has published over 170 articles in peer-reviewed journals, contributed fifteen book chapters, delivered over 180 meeting abstracts and presentations, and given over 70 invited presentations in North America and Europe. His academic research funding has totaled more than \$15 million, with some of the largest grants funded by the National Institute of Diabetes, National Institutes of Health, and the National Cancer Institute. Viewing industry funding as a valuable supplement to more conventional sources, he maintained and funded numerous academic collaborations during his tenure as chief scientific officer at GTx, Inc. His honors include the American Association of Pharmaceutical Scientist (AAPS) Meritorious Manuscript Award, Pharmaceutical Research in 2000. In 2006, he was elected a fellow of the AAPS, and in 2011, he received the Jack L. Beal Post-Baccalaureate Alumni Award from OSU. In 2018, he received the Rho Chi Society Lecture Award. He now serves on executive boards for the United States Anti-Doping Agency, National Institute of Pharmaceutical Technology and Education, and American Foundation for Pharmaceutical Education.

Dean Dalton has brought openness, inclusion, and new ideas to the College of Pharmacy and in the process helped change the culture of the college to one of transparency and outstanding communication. I am confident that he will continue to lead with energy and vision. I am pleased to recommend the reappointment of James T. Dalton as dean, College of Pharmacy, effective September 1, 2019 through August 31, 2024.

On the recommendation of the Executive Committees of the Department of English Language and Literature, and with the endorsement of the Departments of American Culture, Film, Television, and Media, and Women's Studies, we are pleased to recommend the reappointment of Lisa A. Nakamura as professor of English language and literature, without tenure, College of Literature, Science, and the Arts, effective January 1, 2019.

Lisa Nakamura received her Doctorate at City University of New York in 1996. Her doctoral degree is in English literature and she regularly publishes in journals central to the discipline. Professor Nakamura joined the faculty at Michigan in 2012 and was appointed as professor of women's studies, without tenure, in July 2013 and as the Gwendolyn Calvert Baker Collegiate Professor of American Culture and Screen Arts in December 2013. She has held an additional appointment in the Department of English Language and Literature since 2014.

The Department of English Language and Literature has benefited greatly from Professor Nakamura's appointment. She continues to be a valuable resource to their Ph.D. and MFA graduate students – she has served on multiple dissertation committees. The department's continued expectation is that Professor Nakamura will teach an occasional course for English according to her interests and departmental as well as curricular needs. She will also list some of her courses as meet-togethers.

Faculty in the department are deeply interested in issues of digital textuality and electronic media. This additional appointment will give them the opportunity to continue to develop this area of burgeoning interest. It also allows the department to continue to acknowledge, and cement, a relationship that is already very productive. It also allows Professor Nakamura to spend time with colleagues who are deeply interested in digital media, but approach the

questions from a slightly different disciplinary angle than that deployed by her colleagues in the Departments of Film, Television, and Media, and American Culture.

We are pleased to recommend the appointment of Robert Axelrod as the William D. Hamilton Distinguished University Professor, effective March 1, 2019.

The first Distinguished University Professorships were created in 1947 by the Board of Regents to recognize members of the faculty for exceptional achievement and reputation in their appointive fields of scholarly interest and for their superior teaching skills. Each professorship is named in honor of an eminent individual—preferably one associated with the university—in the scholar’s same general field of interest. An appointment to a Distinguished University Professorship continues to be one of the most prestigious honors conferred by the university upon a member of its faculty.

Robert Axelrod received his B.A. degree in mathematics (with honors) from the University of Chicago (1964), and his M.A. (1966) and Ph.D. (1969) in political science (with distinction) from Yale University. From 1969 to 1974, he was on the faculty as an assistant professor at the University of California, Berkeley. He was appointed in 1974 as an associate professor of political science and as a research associate at the Institute of Public Policy Studies at the University of Michigan. In 1980, he was appointed as a professor of political science and public policy. In 1987, he was appointed as the Arthur W. Bromage Distinguished University Professor of Political Science and Public Policy, and in 2006 he was appointed as the Mary Ann and Charles R. Walgreen Professor for the Study of Human Understanding.

Professor Axelrod wishes to name his distinguished university professorship as the William D. Hamilton Distinguished University Professor.

Professor William D. Hamilton (1936 - 2000) was one of the most significant evolutionary theorists of the 20th century, whose theoretical work also played a key role in the understanding of social evolution. While a professor of evolutionary biology at the University of Michigan from 1978 to 1980, he worked closely with Professor Axelrod and an interdisciplinary team of university faculty who shared an interest in the study of complex adaptive systems, and which today has become the renowned Center for the Study of Complex Systems. Professor Hamilton was a fellow of New College, at Oxford University. He was elected as a fellow of the Royal Society of London and received the Darwin Medal and the Kyoto Prize, among many recognitions for his path-breaking work.

The appointment of Robert Axelrod as the William D. Hamilton Distinguished University Professor recognizes his extensive and outstanding scholarly achievements, his commitment to excellence in education for his students, and his extensive contributions to the University of Michigan and beyond. We are delighted to make this recommendation.

David Blaauw received his B.S. in 1986 from Duke University. He received his M.S. and Ph.D. in computer science from the University of Illinois, Urbana-Champaign in 1989 and 1992, respectively. From 1992 to 1993, Professor Blaauw was with the IBM Corporation in Austin, TX as a development staff member. From 1993 until 2001, he worked for Motorola, Inc. in Austin, TX, where he was the manager of the High Performance Design Technology group and won the Motorola Innovation Award.

Professor Blaauw has published over 550 papers, has received numerous best paper awards and nominations, and holds 60 patents. His research has a threefold focus. He has investigated adaptive computing to reduce margins and improve energy efficiency using a new approach he pioneered, called Razor, for which he received the Richard Newton GSRC Industrial Impact Award and IEEE Micro annual Top-Picks award. He has extensive research in ultra-low-power computing using subthreshold computing and analog circuits for millimeter sensor systems and for high-end servers. His research group and collaborators introduced so-called near-threshold computing, which has become a common concept in semiconductor design. This work also led to a complete computing system design with record low power consumption (nW level) enabling the world's first mm-scale computers. This work was selected by the MIT Technology Review as one of the year's most significant innovations and the mm-scale computers are on display at the Computer History Museum in Mountain View, California. Most recently, he has pursued

research in cognitive computing using analog, in-memory neural-networks and acceleration of computation for gene sequencing for precision health. He was the general chair of the IEEE International Symposium on Low Power, the technical program chair for the ACM/IEEE Design Automation Conference, and serves on the IEEE International Solid-State Circuits Conference's technical program committee. He is an IEEE fellow and received the 2016 SIA-SRC faculty award for lifetime research contributions to the U.S. semiconductor industry. Professor Blaauw currently serves as the director of the Michigan Integrated Circuits Lab.

Camper, Ph.D. as interim chair, Department of Human Genetics, Medical School, effective March 1, 2019. Dr. Camper will assume leadership in the department while a national search commences.

Sally Camper received her Ph.D. degree in biochemistry from Michigan State University in 1983. She completed a fellowship at the Institute for Cancer Research in Philadelphia and joined the faculty at the University of Michigan in 1988 as an assistant professor of human genetics. Dr. Camper was promoted in 1993 to associate professor, and in 1994, received a joint appointment as an associate professor of internal medicine. She was promoted to professor of human genetics in 2000, and professor of internal medicine in 2001. Dr. Camper was appointed as the James V. Neel Professor and chair of the Department of Human Genetics from 2005-2015. She was appointed as the Margery W. Shaw Distinguished University Professor of Human Genetics and Internal Medicine and was awarded the Sarah Goddard Power Award in 2016. Dr. Camper served in numerous administrative roles, including as the director of the University of Michigan Transgenic Animal Core from 1989-2011, and as the associate director of the graduate program in biomedical sciences from 1998-2005.


Dr. Camper was a pioneer in the use of transgenic mice, and is recognized for her contributions to basic research on the genetics of pituitary disorders, hearing and skeletal development. Her research uses two main approaches in birth defects research – sequencing patient DNA to identify novel disease genes and the use of cell culture and animal models, especially the mouse, to understand the mechanism and pathophysiology of disease. Dr. Camper was the founder of the Transgenic Animal Model Core at the University of Michigan, and in this role improved the ability of a large number of researchers to carry out cutting-edge research on the genetic basis of disease. She has been a prolific researcher, receiving funding from the NIH, the March of Dimes, foundations and institutionally. She has published more than 170 peer-reviewed articles.

Dr. Camper has served in important academic and administrative roles throughout her career, as well as establishing herself as an outstanding researcher, teacher and mentor. It is the judgment of the Executive Committee that Dr. Camper is an appropriate candidate to serve in this administrative capacity. I am pleased, therefore, to recommend the appointment of Sally A. Prior to his appointment as an associate professor, with tenure, at the University of Michigan in 2001, Professor Cesnik was the Boeing Assistant Professor of Aeronautics and Astronautics and then an associate professor of aeronautics and astronautics at the Massachusetts Institute of Technology. He has also worked as a research engineer at Embraer S.A. He is the founding director of the Active Aeroelasticity and Structures Research Laboratory. He currently directs the Airbus-Michigan Center for Aero-Servo-Elasticity of Very Flexible Aircraft (CASE-VFA). Professor Cesnik has been an active private pilot since 1981.

His research interests have focused on computational and experimental aeroelasticity of very flexible aircraft; coupled nonlinear aeroelasticity and flight dynamic response in high-altitude long-endurance (HALE) aircraft and advanced jet transport aircraft; aerothermoelastic modeling, analysis and simulation of hypersonic vehicles; active vibration and noise reductions in helicopters. His research also spans the field of structural health monitoring for damage detection in metallic and composite structures, and metamaterials: guided-wave modeling, transducer design, and signal processing.

Professor Cesnik is a fellow of the American Institute of Aeronautics and Astronautics (AIAA) and a fellow of the Royal Aeronautical Society. He serves as AIAA's director for the Aerospace Design and Structures Group and is an elected member of AIAA's Council of Directors. He has over 300 publications as archival journal and conference papers, and several invited lectures in the areas of aeroelasticity, smart structures, structural mechanics, and structural health monitoring.







Joerg Lahann received his B.S. in chemistry from the University of Saarland in 1993. He received his M.S. (chemistry) and his Ph.D. (macromolecular chemistry) from RWTH Aachen, Germany in 1995 and 1998, respectively. Following graduation, Professor Lahann was a post-doctoral associate until 2001 at MIT. He then completed a post-doctoral fellowship at Harvard-MIT between 2002 and 2003. Professor Lahann joined the faculty at the University of Michigan in 2003 as an assistant professor. He was promoted to associate professor in 2008 and to professor in 2012.

Professor Lahann is the founding and current director (since 2012) of the University of Michigan Biointerfaces Institute. It is the mandate of the Biointerfaces Institute to bridge between Engineering, the Physical Sciences, and Medicine and thus facilitate translational research. Professor Lahann also serves on leadership committees for the University of Michigan Forbes Institute for Cancer Discovery, the Rogel Cancer Center, and the recently launched UM Regenerative Medicine initiative.

Professor Lahann is a co-author of more than 250 publications, including papers in *Science*, *Nature Materials*, *Nature Biotechnology*, and *PNAS*, and has contributed to 55 patents and patent

applications. The Lahann group has developed a disruptive technological approach to fabricate anisotropic nano -and micro-carriers using electrohydrodynamic co-jetting. In more than 30 publications over the last 10+ years, they have established electrohydrodynamic co-jetting as a new NP synthesis technology that can produce particles with two or more distinct compartments. Professor Lahann has an h-index of 61; 121 of his publications published after 2014 have been cited more than 10 times by other researchers (i10-index: 121, source: Google Scholar).

Professor Lahann has been selected by Technology Review as one of the top 100 young investigators and the recipient of the 2007 Nanoscale Science and Engineering Award, a NSF-CAREER award, and both a single-PI and a team Idea award (2006 & 2011) from the US Department of Defense. In 2011, he was elected as a fellow of the American Institute of Medical and Biological Engineering. Professor Lahann has mentored 36 graduate students and 30 post-doctoral students. In addition, he served as the research advisor of more than 150 undergraduate students. His average teaching evaluations between 2012 and 2018 are 4.86/5.00 for the quality of the teacher (Q2) and 4.57/5.00 for the quality of the class (Q1).

From 1989-1992, Professor Lantz served as a senior research specialist in the Center for Health Policy and Program Evaluation at the University of Wisconsin, Madison, and also worked as an epidemiologist for the Wisconsin Division of Health, Bureau of Public Health. From 1992-1994, she was a senior researcher at the Marshfield Medical Research and Education Foundation in Marshfield, Wisconsin. Professor Lantz was a Robert Wood Johnson Foundation Scholar in Health Policy Research at the University of Michigan from 1994-96. She joined the Michigan faculty in 1994 as an assistant professor in the Department of Health Management and Policy, School of Public Health, was promoted to associate professor, with tenure, in 2001, and to professor in 2006. From 2008-2011, she was appointed as the S.J. Axelrod Collegiate Professor of Health Management and Policy in the School of Public Health. She was appointed as a

research associate professor in the Survey Research Center in the Institute for Social Research in 2003, and was promoted to research professor in 2006. From 2002-2011, Professor Lantz served as the director and then co-director of the Robert Wood Johnson Scholars in Health Policy Research Fellowship Program, and from 2005 to 2011, she was the chair in the Department of Health Management and Policy in the School of Public Health. 

Dr. Lawrence was the first director of the Kresge Hearing Research Institute from 1961-1983. His pioneering work helped establish the modern field of physiological acoustics. Dr. Lawrence retired from the University of Michigan in 1983 and passed away on January 29, 2007.

Dr. Lawrence was an excellent researcher and outstanding educator and mentor. This professorship will continue his tradition of groundbreaking research and advance the training of young physician scientists. The interim provost and vice chancellor for academic affairs wishes to recommend a change in title of an existing academic administrative title from senior vice provost and dean of graduate programs, to associate provost and dean of graduate programs, Office of the Provost and Vice Chancellor for Academic Affairs, effective March 1, 2019.

Undergraduate and graduate degree programs are offered through five schools/colleges: the College of Arts and Sciences, the School of Management, the College of Health Sciences, the School of Education and Human Services, and the School of Nursing. The University of Michigan-Flint has increased graduate program availability to students which includes providing 21 Masters, and five Doctoral programs across the five units. This combination of high quality liberal arts and professional and graduate programs in an urban institution is distinctive and shapes the institution's culture and opportunities. The changing needs of our graduate student population as well as continued growth on digital learning, has resulted in the need to slightly restructure some positions in academic affairs.

The associate provost and dean of graduate programs will have oversight, as dean for graduate programs, of the Office of Graduate Programs and graduate program curricula and oversight of the Office of Extended Learning (OEL). The position will serve as a member of the Council of Deans, various committees and advisory groups. They will provide leadership and support for academic issues, as the provost requires, support engagement with tri-campus initiatives that relate to academic affairs, serve as the university's Higher Learning Commission Liaison Officer and represent the University of Michigan-Flint with the Michigan Association of State Universities (MASU) and as a member of the Rackham Graduate School Executive Board. In addition, they will serve as the provost's designee for selected faculty and staff grievances, provide leadership and support for other academic issues and facilitate communication and coordination with the Offices of the Provost in Ann Arbor and Dearborn.

This position will report to the provost and is charged with providing advice and counsel to the Provost. They will collaborate with a range of faculty, staff and administrators in planning and implementation programs that enhance the academic list of students and faculty, improve communication and cooperation within academic affairs and across campus, and otherwise advance the academic priorities of the university. We therefore are pleased to recommend the change in title of an existing academic administrative title from senior vice provost and dean of

graduate programs, to associate provost and dean of graduate programs, Office of the Provost and Vice Chancellor for Academic Affairs, effective March 1, 2019.
