Summary of Evaluation

<u>Teaching:</u> Professor Pinto has taught three courses since coming to the University of Michigan. These courses focus on social justice, LGBTQ issues, and implementation science. Professor Pinto is dedicated to social justice and grounds his teaching in Paulo Freire's pedagogy of the oppressed. In emphasizing social justice throughout his courses, he encourages students to develop critical consciousness, and skills needed to address oppression. The courses make a valuable contribution to the SSW curriculum and have positive course and instructor evaluation ratings. Professor Pinto has distinguished himself as a mentor of master's and doctoral students, with particular attention to helping to assure the success of underrepresented students.

<u>Research:</u> Professor Pinto identifies a major gap in translation of knowledge to practice that hinders progress in addressing the complex needs of the millions of people living with HIV. He addresses the translation of science into practice, a major need in the social work profession. He has published 50 peer reviewed publications and five book chapters

Professor Pinto conducts community-based participatory research with community organization partners in the United States, Brazil and Spain. His program of implementation science is guided by diffusion-of-innovation theory with a focus on behavioral interventions and the HIV care continuum. This work has application to other health problems (e.g., diabetes management) characterized by complex treatment regimens and challenges in care coordination. The significance of his research and its scientific merit has been demonstrated in the consistency of funding support he has received for his research. His history of NIH support includes support for his dissertation, a post-doctoral fellowship, a five-year K01 Career Development Award (2007–12) and a five-year R01 (2012–17).

Professor Pinto has outlined a rich future trajectory for his research that includes proposed work in Brazil studying perspectives of community residents on the effectiveness of community health workers (CHWs), and testing interprofessional collaboration training efforts. Future work in the U.S. and Spain will test interprofessional collaboration to deliver care-continuum services.

<u>Service</u>: Professor Pinto has an extensive and uniquely creative record of international, national, university and school level service. Within the school, he has been a member of the Executive Committee, School of Social Work Ph.D. Program Committee, the Diversity, Equity, and Inclusion Committee (DE&I), as well as other committees. He founded the Faculty Allies for Diversity Committee (FADC), which was funded by Rackham and the school's Learning Community initiative. FADC's approach uses social-capital theory that builds capacity for students' professional development.

Within the university, Professor Pinto served on the Search Committee for the Director of Social Work and Spiritual Care for Michigan Medicine; a School of Public Health Search Committee; the Michigan Mixed Methods Research and Scholarship Program; and a Department of Family Medicine Search Committee. Professor Pinto has organized several university-wide symposia. In February 2017, he organized a symposium, "Community Wise," which was attended by 60 participants and demonstrated a community-based intervention that showed promising results in assisting people with histories of incarceration.

Since 2015, Professor Pinto has been a standing member of the Community Influences on Health Behavior (CIHB) study section of the National Institutes of Health (NIH). He also has served on NIH ad hoc review committees: Improving Health and Reducing Premature Mortality (2014); Research Mentoring Programs for HIV/AIDS (2015); and Research Partnerships for Scaling Up

Mental Health Interventions (2016). Professor Pinto also serves as reviewer for 22 scientific journals, and was inducted as a fellow of the Society for Social Work and Research (SSWR) in recognition of his service. Professor Pinto has provided substantial international service including, since his promotion to associate professor, serving as scientific reviewer for the Congreso Nacional, Asociación de Sociología, Spain (2011–present), and Templeton World Charity, Nassau, Bahamas.

External Reviewers:

Reviewer A: "Professor Pinto has a strong curriculum vitae, and the work submitted is of a strong academic standard. His credentials are commensurate with the promotion for which he has been put forward. I have no hesitation in supporting a promotion to Professor of Social Work."

Reviewer B: "Although the paper record would need to include more information about teaching excellence for Professor Pinto to be considered for promotion to professor at my institution, the research and services accomplishments meet, if not exceed, expectations as Professor (with tenure). In conclusion, this is a formidable and exciting record that supports promotion."

Reviewer C: "Professor Pinto's accomplishments are firmly within the range expected of a full professor. As importantly, I am confident that he will continue this trajectory of scholarly output well into the future and become a leader in the field."

Summary of Recommendation:

He has distinguished himself with a solid record as a teacher and mentor and has an extensive record of international, national, university and school level service.
