Summary of Evaluation:

Teaching: As a founding faculty member and coordinator of the Doctor of Education (Ed.D.) program, Professor Ross McClain has been instrumental in course development, program development, and course delivery. This coordination of teaching responsibilities is complex because courses in the Education Specialist (Ed.S.) and Doctor of Education (Ed.D.) programs are co-taught by program faculty and K-12 leaders, yet assistant professor Ross McClain has built solid relationships among the faculty and has indeed found success in her own teaching through this model. She has established herself as a good teacher, capable of reflecting on and growing in her classroom responsibilities.

Research: Professor Ross McClain's book chapter "P.U.L.S.E: Pro-LGBT understanding and learning serves everyone" (2017), which appeared in A Guide to LGBTQ+ inclusion on campus, post-PULSE, provides themes for those in higher education to unpack the crimes such as the one perpetrated on the LGBT community in Orlando. She articulates how essential it is to educate all students in an environment that emphasizes literacy, critical thinking and humanistic scientific inquiry while guiding their development into thoughtful and productive citizens. With this publication, Professor Ross McClain poses herself at the forefront of a movement to examine the relationship between the commission of violence and hatred of historically marginalized groups.

Service: Professor Ross McClain specifies that her commitment to social justice and equity is reflected in her service work to the university. Her leadership role as the program director in the Education Specialist and Doctor of Education programs has been hugely impactful – from development, to report-writing, to supporting new faculty, and beginning the first doctoral graduates (including committee formation, dissertation development), student support and advising, etc. Her first year was subsumed by new program development and NCATE accreditation. She has also supported the department by serving on the Education Curriculum Committee, and now on the Awards and Scholarships Committee.

As I examine her scholarly works by title, I largely see classroom instruction (at the teacher level) and cultural diversity (at a more global level)."


