Summary of Evaluation:

<u>Teaching</u> – Professor Villalobos Ruminott has demonstrated strong teaching in a wide range of undergraduate and graduate courses. He has also shown a high level of dedication to students and the teaching of Latin American studies, with a particular emphasis on the Southern Cone and on 19th- to 21st-century Latin American literature. His undergraduate courses provide a solid literary, cultural, and critical overview of modern and contemporary Latin America. In addition to being considered an excellent teacher, Professor Villalobos Ruminott is also regarded as a highly successful mentor to graduate students. Now in his third year at Michigan, he is stepping onto an increasing number of dissertation committees.

<u>Research</u> – In the area of Latin American Studies, Professor Villalobos Ruminott's research focuses on political theory, cultural criticism, and comparative literature of South and Central America with an interdisciplinary scope. His numerous publications, including his latest book, reveal an interest in a number of different intellectual registers, as well as a commitment to interdisciplinary work, focused primarily at the intersection of politics, philosophy, and aesthetics, especially literature and visual studies. Drawing on cultural politics, theories of violence, and globalization, his latest work can be read both as a critical intervention in which the field's main debates over the course of the last fifteen years are registered, and as the systematic delineation of questions for future engagements. This includes not only a theoretical reflection on violence but also the experience of violence itself, such as the enslavement and domination of the indigenous peoples during the colonial era, the extra-judicial executions of

political prisoners during the Pinochet dictatorship, and the murders of female factory workers on the Mexico-U.S. border in the 1990s, among other important topics.

He has served on the departmental Graduate Committee, Assessment Committee, and French Search Committee, and on the Portuguese/Spanish combined major. He has been the Spanish advisor and a member of several graduate student committees. Professor Villalobos Ruminott has been active in contributing to the intellectual life of the department by bringing scholars to the university and organizing reading groups. Based on all of the above, there is no doubt that Professor Villalobos Ruminott can be described as a responsible, hard-working, and professional colleague in the department.
