ACTION REQUEST

**SUBJECT:** 2013-2014 Fee Assessments for Central Student Government (CSG),  
Student Legal Services (SLS), and School/College Governments

**ACTION REQUESTED:** Approval of the following fee assessments:  
\$7.19 per student per term for CSG (*no change from 2012-13*);  
\$8.50 per student per term for SLS (*no change from 2012-13*); and  
\$1.50 per student per term for School/College governments (*no change  
from 2012-13*).

Background: At the June 2012 Regents' Meeting, the Regents reauthorized a fee of \$7.19 per student per term for CSG and \$1.50 per student per term for School/College governments. At the June 2012 Regents' Meeting, the Regents authorized a fee of \$8.50 per student per term for Student Legal Services.

CSG, SLS and School/College Government Fees: This year, Central Student Government believes that the current fee structure will provide adequate funding for the coming fiscal year (see attached memorandum). The Division of Student Affairs believes that Student Legal Services will have sufficient resources for 2013-2014 under the current fee structure. We believe the school and college government organizations are adequately funded. Therefore, no increase is being requested for CSG, SLS, or the School/College Governments.

Recommendations: I recommend approval of the following fees for 2013-2014: \$7.19 per student per term for Central Student Government, \$8.50 per student per term for Student Legal Services, and \$1.50 per student per term for School/College governments.
