Below is a brief update of our activities, operations, and goals as we continue to serve the students of this University. **Received by the Regents June 16, 2016**

Financial Report - Calendar Year 2015

- Some highlights of the Central Student Government's (CSG) Financial Report for the 2015 calendar year include:
 - \$50,000 <u>increase</u> in allocated funds, and \$427,000 total, to 230 student organizations;
 - \$21,000 <u>increase</u> in allocated funds to University of Michigan Departments, including Michigan Dining and the Central Campus Recreation Building (CCRB); and
 - \$58,000 reduction in Travel, Hosting, and Transportation Fees.

Summer Assembly

• The Summer Assembly continues to hold regular meetings to allocate money to student organizations. Thus far, in its two meetings, the Summer Assembly has allocated \$22,850 to 15 student groups ranging from Multicultural Greek Organizations to the Hispanic Student Dental Association (HSDA). The SSA still has \$7,150 to distribute.

Cross-Student Government Collaboration

• From June 4-6, I attended the National Campus Leadership Council's (NCLC) President Leadership Summit (PLS) in Washington D.C. More than 180 student body presidents from across the country gathered to discuss pressing campus issues, including state higher educational funding, sexual violence, mental health, and the balance between free speech and inclusivity. In addition to connections with many student leaders, I brought back a number of different prospective ideas and initiatives from this summit that the University of Michigan would be well served to implement.

June 2016 Regents' Report

President Schlissel, members of the Board of Regents, and Executive Officers of the University, it is my pleasure and honor to submit the following report to you on behalf of the University of Michigan-Dearborn Student Government (SG). We truly appreciate this opportunity to inform you on all the initiatives Student Government is working on throughout the year.

Commitments to Sexual Assault Prevention In October 2015, UM-Dearborn - in collaboration with Student Government, WGST department, Women's Resource Center, and several departments across campus - won a grant through the state for over \$38,000 to promote sexual assault awareness and prevention programming. We are now in the final stages of committing to summer training programs, which include bystander training, consent training, Title IX training, and SAFE training. Utilizing the train-the-trainer model, a core group of administrators and students will become master trainers, and will educate the campus community throughout this year and beyond. SG has also had the privilege of providing student input in regards to bringing Haven and Haven Plus (for graduate students) to campus. The University has purchased a 3-year contract for the online training software so all incoming students will understand the critical issues of sexual assault, relationship violence, stalking, and sexual harassment – among students, faculty and staff. Lastly, Student Government has continued to advocate for a sexual assault survey to be conducted on campus. A commitment has been made to conduct a survey by February 2017, if not sooner. I am so excited to have been a part of such critical projects.

Student Workers' Satisfaction Survey: There is typically an annual survey distributed to faculty and staff to help evaluate their working environments and provide valuable insight on shared issues to address. Student Government, in collaboration with Human Resources and the Office of Business Affairs, has produced a satisfaction survey specifically for student workers on campus. This will be used to gather valuable data on students' perspectives on working at the University of Michigan-Dearborn. We are currently structuring the benchmarks and implementation methods. It is projected to be conducted in July. We are confident that this survey will not only allow students to feel like valuable workers, but will also allow for data-driven reforms (if found necessary) to promote the best working environments for all campus community employees.

Thank you for taking the time to read this update regarding the work done by the UM-Dearborn Student Government, and thank you for your commitment to the University of Michigan System and its students.
