SUBJECT: Proposed University of Michigan - Flint FY 2017-2018 General Fund Operating Budget, Student Tuition and Fee Rates

ACTION REQUESTED: Approval of FY 2017-2018 General Fund Operating Budget, Student Tuition and Fee Rates

BACKGROUND:

The proposed 2017-2018 General Fund budget for UM-Flint (attached) assumes a 2.3% increase in state funding. The proposed budget assumes a \$450 increase in combined tuition and fees for resident undergraduate students and a 4.4% increase for most graduate students for the 2017-2018 academic year. UM-Flint is moving graduate programs towards market rates. Further details on tuition and fee increases are included in the companion action item.


This budget proposal assumes:

- 3.9% decrease in undergraduate enrollment, 2.0% graduate enrollment increase; and,
- 12.7% increase in institutional financial aid.

The proposed budget includes our state appropriation of approximately \$23.1 million.

We request approval of the Proposed Flint Campus FY2017-2018 General Fund Operating Budget with the accompanying Student Tuition and Fee Rates.
