
Subject: Monthly Investment Report

Background and Summary:


Attached is the Monthly Investment Report for the Long Term Portfolio as of May 31, 2011.

- Page 1 summarizes the assets as of May 31, 2011. Allocations to Alternative Assets (Illiquid) reflect market values as of December 31, 2010, the most recent date available, adjusted for contributions and distributions through May 31, 2011. Alternative Assets (Illiquid) are valued on a quarterly basis. March 31, 2011, data is not available due to the time involved with gathering the requisite information from the partnerships.
- Page 2 reports the performance of the Marketable Securities by asset class for select periods ending May 31, 2011. Performance for Alternative Assets (Illiquid) reported only quarterly, as these investments are valued on a quarterly basis.
