Authorization for the University to Purchase Artwork from Artists James A. Cogswell Jr., Joel L. Cressman, Wendel W. Heers, William A. Lewis, Kathleen McShane Bolton, Janice C. Paul, Elvedin Poskovic, Matthew D. Shlian, and Edward West (University of Michigan Employee/Emeritus, and Artist)

Background:

The University of Michigan C.S. Mott Children's and Von Voigtlander Women's Hospital ("Mott") seeks approval to purchase artwork as part of their art collection on display in the newly constructed Mott replacement hospital. The artists were selected by an Advisory Panel according to guidelines established in Mott's Public Art Policy.

The proposed purchase falls under the State of Michigan Conflict of Interest Statute as the artists listed above are current University employees or emeritus and would be a party to the purchases as artists of the original works. However, the Statute allows the University to enter into such contracts if the following conditions are met:

- a) The public servant promptly discloses any pecuniary interest in the contract to the official body which has power to approve the purchase, which disclosure shall be a matter of record in its official proceedings.
- b) The purchase is approved by a vote of not less than 2/3 of the full membership of the approving body in open session without the vote of the public servant making the disclosure.
- c) The official body discloses the following summary information in its official minutes:
 - i) The name of each party involved in the contract.
 - ii) The terms of the purchase, including duration, financial consideration between the parties, facilities or services of the public entity included in the purchase, and the nature and degree of assignment of employees of the public entity for fulfillment of the purchase.
 - iii) The nature of any pecuniary interest.

The following information is provided in compliance with the statutory requirements contained in Section (c) above:

i) The parties involved in the purchase are the Regents of the University of Michigan, Mott and artists or galleries listed in the attachment.

- ii) The purchase is various pieces of original art for a total of \$321,299.
- iii) The pecuniary interest arises from the fact that the artists, University employees or emeritus, are the artists of the original works purchased by Mott.

The artists have met state law requirements with the disclosure of their pecuniary interest and formal appointment arrangements with the University of Michigan. Requirements, if any, that may be applicable under the Medical School's or OVPR's Conflict of Interest Committee's procedures are separately analyzed and managed.

We recommend that the Board of Regents approve the purchase between the University of Michigan and artists subject to requirements, if any, that either the Medical School's or OVPR's Conflict of Interest Committee may impose.
