background.

The University of Michigan Business Engagement Center seeks approval to transact with Voxel51, LLC for the summer 2018 summer internship support through the Michigan Corporate Relations Network (MCRN), Small Company Internship Award (SCIA).

The proposed agreement falls under the State of Michigan Conflict of Interest Statute as Jason Corso is a University employee as Associate Professor with College of Engineering and would be party to the contract as Member of Voxel51, LLC.

However, the Statute allows the University to enter into such agreements if the following conditions are met:

- a) The public servant promptly discloses any pecuniary interest in the contract to the official body which has power to approve the purchase, which disclosure shall be a matter of record in its official proceedings.
- b) The purchase is approved by a vote of not less than 2/3 of the full membership of the approving body in open session without the vote of the public servant making the disclosure.
- c) The official body discloses the following summary information in its official minutes:
 - i) The name of each party involved in the contract.
 - The terms of the purchase, including duration, financial consideration between the ii) parties, facilities or services of the public entity included in the purchase, and the nature and degree of assignment of employees of the public entity for fulfillment of the purchase.
 - iii) The nature of any pecuniary interest.

The following information is provided in compliance with the statutory requirements contained in Section (c) above:

- i) The parties to the contract are the Regents of the University of Michigan and its Business Engagement Center and Voxel51, LLC.
- ii) The agreement is to transact with Voxel51, LLC for the 2018 summer internship award for a duration of four months at a total cost of \$3,500. Voxel51, LLC will be supplying all the necessary resources and personnel to fulfill this contract. The remaining base contract terms and conditions are typical to those used in Procurement Services standard templates for other similar contracts entered into by the Regents.
- iii) The pecuniary interest arises from the fact that University of Michigan employee, Jason Corso, is Member of Voxel51, LLC.

Jason Corso has met met state law requirements with the disclosure of his pecuniary interest and formal appointment arrangements with the University of Michigan. Requirements, if any, that may be applicable by the supervisor(s) of Jason Corso, under the Medical School's or OVPR's Conflict of Interest Committee's procedures are separately analyzed and managed.

<u>We recommend</u> that the Board of Regents approve the agreement between the University of Michigan and Voxel51, LLC subject to requirements, if any, that the supervisor(s) of Jason Corso or the Medical School's or OVPR's Conflict of Interest Committee may impose.
