On the recommendation of Jay L. Hess, M.D., Ph.D., the Carl V. Weller Professor and Chair of the Department of Pathology, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Kojo S.J. Elenitoba-Johnson, M.D., as Associate Professor of Pathology, with tenure, effective October 20, 2006.

Dr. Elenitoba-Johnson received his medical degree from the University of Lagos, Nigeria in 1988. He completed a residency in anatomic and clinical pathology at Brown University in 1995 and undertook fellowship training in hematopathology at the National Cancer Institute during 1995-97. In 1997, Dr. Elenitoba-Johnson joined the faculty at the University of Utah as Assistant Professor of Anatomic Pathology and was promoted to his current rank of Associate Professor, with tenure, in 2003.

Dr. Elenitoba-Johnson is an accomplished scientist whose research focuses on hematopathology, especially in the studies of lymphomas. He is regarded as one of the leaders in the field of lymphoma biology and pathogenesis. His bibliography reflects 62 peer-reviewed publications in scientific journals, with three additional manuscripts accepted for publication. He also has over 70 abstracts to his credit, as well as 14 chapters in books. Dr. Elenitoba-Johnson's research program is highly regarded, and he has been the principal investigator of a National Cancer Institute award since 2005, with Phase II of this project funded through 2008. He also is principal investigator on an R33 grant supported by the NCI through 2009.

Dr. Elenitoba-Johnson has acquired significant teaching experience involving medical students, pathology residents, graduate students, and postdoctoral fellows. He is an excellent lecturer and a superb mentor as reflected by receipt of two awards for outstanding teaching in anatomic pathology at the University of Utah in 1999 and 2003, respectively. He also serves as director of the fellowship training program in molecular genetics at that institution. At the University of Michigan, it is planned that Dr. Elenitoba-Johnson will be involved in the training of pathology residents and fellows in both hematopathology and molecular pathology and also will participate in graduate student education in the molecular and cellular pathology courses.

He has truly been a leader in this latter area among hematopathologists, and he has also made important contributions in the area of histologic progression of follicular lymphoma and transformation to high-grade lymphoma."

Dr. Elenitoba-Johnson is being recruited to serve as Director of Translational Pathology in the Department of Pathology where he will oversee the development of the division and its resources. He is a Diplomate of the American Board of Pathology in the specialties of Anatomic and Clinical Pathology, Hematology, and Molecular Genetic Pathology. His clinical expertise will be utilized on the diagnostic hematopathology Nationally, Dr. Elenitoba-Johnson is an abstract reviewer for several professional organizations and specialty journals. He also provided similar reviewer activities for the National Cancer Institute.

Dr. Elenitoba-Johnson is an outstanding recruitment to the University of He is an exceptional scientist, diagnostician, medical educator, and administrator. On the recommendation of the Executive Committee of the A. Alfred Taubman College of Architecture and Urban Planning, we are pleased to recommend the appointment of Arthur Christian Nelson as professor of urban planning, with tenure, A. Alfred Taubman College of Architecture and Urban Planning, effective September 1, 2007.

ACADEMIC DEGREES

Arthur Christian Nelson received a B.S. in 1972, a Master of Urban Studies in 1976, and a Ph.D. in 1984, all from Portland State University, Portland, Oregon.

PROFESSIONAL RECORD

Since 1979, Dr. Nelson has been a faculty member teaching in urban and regional planning programs at Kansas State University (1984-85), University of New Orleans (1986-87), Georgia Institute of Technology (1987-2002), and since 2002 he has been a professor, with tenure, and associate director of the Metropolitan Institute at Virginia Polytechnic Institute and State University, Alexandria, Virginia.

SUMMARY OF EVALUATION

During his substantial career, Nelson has exhibited the interesting characteristic of being both focused and eclectic in his scholarship. Broadly speaking, he has studied the theories and public policies of land markets, with a special focus on public policy-constrained land markets. One could also say, however, that he has conducted discrete studies on such important urban planning topics as development impact fees, growth management, infrastructure and transit station location, and housing. His methodological approach has been consistently statistical, relying on cross-sectional and regression analysis to reach the conclusion that contained urban land markets bring benefits in terms of efficiencies and amenities that uncontained (at least by public policy) markets do not produce. He is one of the nation's leading authorities on the implementation of urban containment programs, and one of the nation's most influential voices on the broader issues of sprawl, growth management, and regional form.

On the recommendation of Jay L. Hess, M.D., Ph.D., the Carl V. Weller Professor and Chair of the Department of Pathology, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Megan So-Young Lim, M.D., Ph.D., as Associate Professor of Pathology, without tenure, effective October 20, 2006.

Dr. Lim received the M.D. degree from the University of Calgary in 1988, followed by a residency in anatomic pathology and a research fellowship also at that institution. In 1994, she received the Ph.D. degree in molecular oncology from the University of Calgary (in partnership with the National Cancer Institute). From 1995-98, Dr. Lim undertook fellowship training in hematopathology at the National Cancer Institute, followed by an appointment at the University of Toronto as Assistant Professor of Laboratory Medicine and Pathobiology during 1998-2000. In 2000, she joined the faculty at the University of Utah as Assistant Professor of Pathology and was promoted to her current rank of Associate Professor, with tenure, in 2004.

Dr. Lim's research focus is hematopathology. While at the NIH, she combined her Ph.D. work on metalloproteinases with her clinical studies to show that tumor metalloproteinases (TIMPs) play a major role in tumor invasion and metastasis. Several of her studies have utilized her excellent skills as a hematopathologist to investigate lymphoma heterogeneity. Dr. Lim received the Children's Oncology Group Young Investigator Award during 2002-2003 and was principal investigator on a National Leukemia Research Foundation grant also during that period. She currently holds a Children's Oncology Group translational research grant and is co-investigator on two National Cancer Institute grants. Her bibliography reflects over 60 peer-reviewed publications, with three additional articles in press, as well as four book chapters and over 65 abstracts. She is a member of the editorial board of Laboratory Investigation and is a referee for numerous journals, including the American Journal of Pathology, Cancer, and Experimental Hematology.

Dr. Lim has developed a solid teaching portfolio as demonstrated by her extensive educational contributions as a faculty member at both the University of Toronto and the University of Utah. She has mentored postdoctoral fellows and graduate students and has trained residents in anatomic pathology and fellows in clinical oncology. At the University of Michigan, Dr. Lim will be involved in the training of pathology residents and hematopathology fellows, as well as second-year medical students during the hematology sequence and M4 students rotating on clinical clerkships.

She is certified by the American Board of Pathology in Anatomic Pathology, Hematology, and Molecular Genetic Pathology.

Dr. Lim is an outstanding hematopathologist with an excellent record of accomplishment in research, education, and clinical service. I am very pleased, therefore, to recommend the appointment of Megan So-Young Lim, M.D., Ph.D., as Associate Professor of Pathology, without tenure. A tenure recommendation will be considered after Dr. Lim has acclimated to the academic environment at this institution.

With the support of the governing faculty at the School of Information, the Gerald R. Ford School of Public Policy, and the College of Literature, Science, and the Arts, we are pleased to recommend the additional appointment of Paul N. Courant as Professor of Information, without tenure, School of Information effective September 1, 2006 to August 31, 2011.

Paul N. Courant currently holds the appointment of Arthur F. Thurnau Professor and Professor of Economics and Public Policy, with tenure, in the Department of Economics in the College of Literature, Science, and the Arts. He was awarded a Ph.D. in Economics from Princeton University in 1974. He joined the faculty at Michigan in 1973 in both the School of Public Policy and the Department of Economics in College of Literature, Science, and the Arts. He was promoted to Associate Professor in 1978 then Professor in 1984. He is a Faculty Associate at the Institute for Social Research, and was the Director of the Institute of Public Policy Studies, the forerunner to the Ford School of Public Policy. In 1979-80 he was a Senior Staff Economist on the Council of Economic Advisors. From 1995-1997 he was Chair of the Department of Economics. In 1997-2001 he was the Associate Provost for Academic and Budgetary Affairs and in 2002 became Provost and Executive Vice President for Academic Affairs, a post he completed in 2005.

In addition to his administrative work, Professor Courant has maintained an active record of scholarly publication. He has authored half a dozen books, and over sixty monographs and papers covering a broad range of topics in economics and public policy, including tax policy, local economic development, gender differences in pay, housing, radon, and public health, and relationships between economic growth and environmental policy. Recently he has been engaged in research on the economics of libraries and scholarly publishing and communication. It is this new research thread that attracts Professor Courant to the School of Information, and us to him.

Professor Courant has also been an active teacher, both through undergraduate and graduate courses as well as Ph.D. mentoring. He has taught 14 courses in Economics and Public Policy. He co-authored (with Richard Lipsey and Christopher Ragan) the core book, *Economics*, which is now in its 12th edition. He has been on 55 Doctoral Committees, chairing 15 of them. We look forward to having him more involved with the curriculum in the School of Information and interacting with our Ph.D. students.

We believe that Professor Courant will contribute significantly to the mission of the School of Information in connecting information, technology and people in more valuable ways. We have an excellent cluster of faculty interested in information economics; Professor Courant is a stellar addition to that group and to the faculty as a whole.

Greden, M.D., the Rachel Upjohn Professor of Psychiatry and Clinical Neurosciences and Chair of the Department of Psychiatry, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Patricia J. With the support of the governing faculty of the School of Information and the School of Education, we are pleased to recommend the additional appointment of Barry J. Fishman as Associate Professor of Information, without tenure, School of Information, effective September 1, 2006 to August 31, 2011.

Professor Fishman is currently an Associate Professor, with tenure, in Learning Technologies in the School of Education. He earned his Ph.D. in 1996 from Northwestern University in the School of Education and Social Policy—Learning Sciences. He joined the University of Michigan School of Education in 1997 as an Assistant Professor, and was promoted to Associate Professor, with tenure, in 2004. He has been an active member in the Center for Highly Interactive Computing in Education (hi-ce), which earned him (and others) the Council of Great City Schools Urban Impact Award in 2004 and the Computer World/Smithsonian Laureate award in 2000.

Professor Fishman's research is in the learning sciences and technology in education. He has written extensively about how to train teachers in technology, reducing one of the key barriers to adoption of technologies in schools. He developed "Knowledge Networks on the Web (KNOW)," a web-based system intended to create a self-sustaining community of teachers faced with learning new, complex curricula embodied in technology. It includes technology-rich curriculum materials with supporting materials to help teachers adapt it to their needs. In addition, the participants in KNOW have a chance to converse with each other to exchange hints and best practices on how to use this material. His work has recently been funded by the National Science Foundation in a project entitled, "Teacher Knowledge and Technology." This is a key area in the adoption of technology in one of our nation's key domains—educating our students to use the power of computing to bring rich, fun material into their orbits.

Professor Fishman has published extensively, with 17 journal articles, 8 book chapters, and 14 entries in conference proceedings, plus 8 more white papers. He serves on several national

advisory panels and has contributed to the Michigan efforts in making wireless technology available to students in Michigan and a statewide committee sponsored by Carl Levin recognizing excellence in use of technology in teaching.

Professor Fishman has been active in the School of Information since his arrival at Michigan. His research and courses in information technology and education are of interest to many of the students in the School of Information. He is working with one of our research associate professors, Stephanie Teasley, in strengthening the area of learning sciences, teaching a course together and garnering a set of like-minded Ph.D. students. Professor Litman joined the Law School faculty as Professor in September, 2006. She was a Professor at Wayne State University Law School prior to coming to Michigan. Professor Litman has not only published a great deal, but has also been active in informing policy at the national level. She contributed testimony to hearings before the Senate Committee on the judiciary on people "squatting" on domain names, on intellectual property for a White House Task Force, and on home recordings for a house committee on the judiciary. She has given numerous talks and participated on panels on the broad issues of copyright, intellectual property and how it has all changed since the introduction of digital media.

Professor Litman is clearly engaged already with both students and faculty at the School of Information. People who attended her seminar when she was visiting were very impressed. Faculty have said that her appointment would be a "fantastic addition to SI."

We believe that Professor Litman will contribute significantly to the breadth of the School of Information in her work on intellectual property in the digital age. She will be an incredibly strong addition to the school.

On the recommendation of Marc E. Lippman, M.D., the John G. Searle Professor and Chair of the Department of Internal Medicine, and with the concurrence of the Executive Committee of the Medical School, I am recommending an extension of the leave of absence for Robert J. Cody, M.D., for the period September 26, 2006, through September 25, 2007.

Dr. Cody joined the faculty at the University of Michigan in 1998 as Professor of Internal Medicine, with tenure, in the Division of Cardiovascular Medicine. He is a nationally and internationally recognized leader in heart failure research and management. In September 2005, he was granted a leave of absence to pursue a research opportunity with the corporation, CVRx, Inc., in Minneapolis, Minnesota, which had developed new medical device technology for the management of resistant hypertension. In his role as director of medical affairs, Dr. Cody supervised the completion of the U.S. feasibility study and preparation of a pivotal trial protocol for FDA approval. This technology is now being used in clinical feasibility trials in Europe and the United States, and Dr. Cody currently directs the clinical and medical activities for these trials.

During his absence from the University of Michigan, Dr. Cody has continued to publish in academic journals, and has co-authored two book chapters and numerous abstracts. He also has collaborated with Dr. Matthew O'Donnell, Professor of Biomedical Engineering, to establish a program of biodesign to bring together the schools of Medicine, Engineering, and Business Administration for collaborative research. The first benefit of this interaction was the successful external funding from the Coulter Foundation to support start-up collaborative research of new diagnostic and therapeutic technologies.

The Executive Committee is supportive of Dr. Cody continuing his corporate activities for an additional year. With its endorsement, the Executive Committee concluded that Dr. Cody's work and the knowledge he acquires from this endeavor will be beneficial to his academic career, as well as to the cardiovascular medicine programs at the University of Michigan.

The College of Literature, Science, and the Arts seeks to name an existing collegiate professorship in the name of Charles David Moody, Sr., who was a faculty member at the University of Michigan from 1970 to 1996. He was also Executive Director of South African Initiatives and Vice Provost for Minority Affairs. A stipend funded from College resources will accompany this professorship.

Charles David Moody, Sr. was born in Baton Rouge, Louisiana. He attended Central State University in Ohio where he received his Bachelor of Science. After serving two years as a second lieutenant in the United States Army and working at a variety of jobs, he earned his Master of Education from Chicago Teachers College in 1961 and Doctorate from Northwestern University in 1971.

Professor Moody worked in several Illinois school districts as a teacher and administrator (1959-1970), and was superintendent of schools in Harvey, Illinois (1968-1970). He joined the University of Michigan as Director of the federally-funded Program for Educational Opportunity (PEO) and lecturer in education in 1970. He was appointed assistant professor in 1971 and promoted through the ranks to professor in 1980. He became Vice Provost for Minority Affairs in 1987 and served in this post until 1993 when he was appointed Executive Director of South African Initiatives and Vice Provost Emeritus for Minority Affairs.

Professor Moody founded the National Alliance of Black School Educators and served as President and as a member of its Executive Committee. As Director of PEO he worked hard, both in Michigan and outside the state, to provide assistance to local school district personnel and professional colleagues. He wrote regularly for PEO publications *Title Line* and *Breakthrough*. Over the years, he directed and participated in numerous major workshops and conferences to promote equity in education. His work on issues of high national priority – school desegregation and multicultural education – is highly acclaimed, and his articles have appeared in such journals as *The School Administrator* and *The Journal of Negro Education*.

A distinguished faculty member will be nominated to receive this honor. The initial term of appointment will be for five years with the possibility of renewal.

The Gerald R. Ford School of Public Policy seeks to name an existing collegiate professorship in the name of Harold T. Shapiro, former president of the University of Michigan and of Princeton University. A stipend will accompany this professorship, which will be funded from School resources.

Harold T. Shapiro was born in 1935 in Montreal, Canada. He received his Bachelor's degree from McGill University in 1956 winning McGill's Faculty of Commerce's highest academic honor, the Lieutenant Governor's Medal. He received his Ph.D. from Princeton University in 1964 and joined the faculty at the University of Michigan that same year. Shapiro was a member of the Michigan faculty in the Department of Economics from 1964 to 1988 and also served in the Institute of Labor and Industrial Relations and in the Institute of Public Policy Studies, the precursor to the Gerald R. Ford School of Public Policy. He chaired the Economics Department from 1974 until 1977 and from 1977 until 1980 served as the vice president for academic affairs and chairman of the Committee on Budget Administration. In 1980 he was elected president of the University of Michigan, a position he held until he became president of Princeton University in 1988.

Shapiro's research interests included econometrics, mathematical economics, science policy, the evolution of higher education, and money and banking. His professional activities include memberships in the Conference Board Inc., the Bretton Woods Committee, the Institute of Medicine, the American Philosophical Society, and as a fellow of the American Academy of Arts and Sciences. He is a trustee of the Alfred P. Sloan Foundation, the University of Pennsylvania Medical Center, the Education Testing Service and serves as director of the Dow Chemical Company. In 1996, Shapiro was appointed by President Clinton to chair the National Bioethics Advisory Commission and from 1990 to 1992 he was a member of President Bush's Council of Advisors on Science and Technology.

A distinguished faculty member will be nominated to receive this honor. The initial term of appointment will be for five years, with the possibility of renewal, effective September 1, 2006.

Walgreen, Jr. Professor for the Study of Human Understanding for a five-year renewable term, effective October 1, 2006 through September 30, 2011.

As a result of a generous gift from Charles R. Walgreen, Jr., the Mary Ann and Charles R. Walgreen, Jr. Professorship for the Study of Human Understanding was established by the Regents in 1968. The occupant of the chair is allowed wide discretion in the development of an instructional program at either graduate or undergraduate level, and is to be permitted adequate opportunity for research, writing, public lectures, and service with public or private agencies concerned with the development of understanding between people. The chair has been awarded to distinguished members of the faculty from a number of different departments.

Robert Axelrod received his Bachelor of Arts, with honors, from the University of Chicago in 1964 and Doctorate, with distinction, from Yale University in 1969. Professor Axelrod began his teaching career as assistant professor at the University of California, Berkeley, in 1968 and joined our faculty as associate professor, with tenure, in 1974. He was promoted to professor in 1980 and was appointed professor in public policy in 1995. He has held the Arthur W. Bromage Distinguished University Professor of Political Science and Public Policy since 1989. His appointment to this professorship will be suspended for as long as he holds the Walgreen

Professorship and will resume at the conclusion of his appointment to the Walgreen Professorship.

Professor Axelrod has made fundamental contributions to "the development of understanding between people" in his acclaimed work on conflict, the evolution of cooperation, and the management of complexity. Current research interests include complexity theory and international security. He is best known for his interdisciplinary work on the evolution of cooperation which has been cited in more than 500 books and 4,000 articles. He has written seven books and scores of his papers have been published in top journals (American Political Science Review, Science, and Nature, to name three).

Professor Axelrod was elected to membership in the American Academy of Arts and Sciences (1985), the National Academy of Sciences (1986), the Council on Foreign Affairs (1996), and the American Philosophical Society (2004). He was named a MacArthur Prize Fellow (1987) and the Henry Russel Lecturer (1992). He recently received an honorary degree from Georgetown (2006) and is currently president of the American Political Science Association. Professor Axelrod has consulted and lectured on promoting cooperation and harnessing complexity for the United Nations, the World Bank, the U.S. Department of Defense, and various organizations serving health care professionals, business leaders, and K-12 educators.

Dr. Hirschl received the M.D. degree in 1983 from the University of Michigan and the M.S. degree in clinical research design and biostatistics in 1986, also from this institution. He pursued his general surgery residency training at the University of Michigan and completed a pediatric surgery fellowship at the Children's Hospital of Philadelphia in 1991. Dr. Hirschl joined the University of Michigan faculty as Assistant Professor of Surgery and Associate Director of the Extracorporeal Life Support Program in 1991. He advanced through the academic ranks to achieve the title of Professor of Surgery in 2003.

In July 2005, Dr. Hirschl was named Head of the Section of Pediatric Surgery and Surgeon-in-Chief of the C.S. Mott Children's Hospital. He is board certified in general surgery, pediatric surgery, and surgical critical care. His research and clinical interests are focused on applied informatics and the management of the critically ill patient, especially in extracorporeal life support (ECLS, ECMO), liquid ventilation, and the implantable artificial lung. Dr. Hirschl's expertise in the field is recognized through his scholarly publications, his national activities as an editorial board member, and his leadership positions in professional societies, including chair of the steering committee of the Extracorporeal Life Support Organization.

Dr. Hirschl is a nationally recognized pediatric surgeon who exemplifies the same high principles and characteristics in education, patient care, research, and service as his predecessor, Dr. Coran. I am pleased, therefore, to recommend the appointment of Ronald B. Hirschl, M.D., as the first Arnold G. Coran Collegiate Professor of Pediatric Surgery.

The Law School respectfully requests that the Regents reappoint Professor Christina B. Whitman as the Francis A. Allen Collegiate Professor of Law, effective November 1, 2006 through October 31, 2011.

The Francis A. Allen Collegiate Professorship was established in the Law School in 1990 in honor of a former dean and member of the Law School faculty who was a preeminent scholar in the field of criminal law and criminal procedure. The Professorship is supported by a gift from Joseph Parsons, a 1927 graduate of the Law School, to establish professorships in the Law School.

Professor Whitman earned each of her three degrees from the University of Michigan: her B.A. in English Literature in 1968, her M.A. in Far Eastern Languages and Literatures in 1970, and her J.D. *magna cum laude* in 1974. Professor Whitman joined the Law School faculty in 1976, after the completion of her legal studies and a prestigious clerkship with Justice Lewis F. Powell, Jr., on the Supreme Court of the United States. In 2000 she was appointed Professor of Women's Studies in the College of Literature, Science, and the Arts.

Professor Whitman's scholarship, while varied, has focused on the field of constitutional torts, evaluating the success of and values underlying the scheme of legal liabilities imposed on governmental officers acting within the scope of their official responsibility. Most recently, Professor Whitman served for almost five years as the Associate Dean for Academic Affairs at the Law School. In innumerable ways, Professor Whitman is a dedicated member of the Law School and University communities.

Professor Whitman was a student and joined the Law School faculty during a period in which Francis Allen was a leading professor and mentor. It is particularly fitting that she be

reappointed as the Francis A. Allen Collegiate Professor of Law. The reappointment of Professor Whitman as the Francis A. Allen Collegiate Professor of Law, effective November 1, 2006 through October 31, 2011, appropriately honors Professor Whitman's service to the School and her continued distinction as a scholar and teacher.
