Action Requested: Approval of License Agreement

## Preamble:

A statutory conflict of interest situation was identified by the Office of Technology Transfer while reviewing the technology transfer agreement that then triggered a review by the UMOR Conflict of Interest Review Committee. A plan for management of the possible risks associated with the conflict of interest was then developed and approved by this Committee and agreed to by the parties involved in this plan.

This proposed license agreement ("Agreement") falls under the State of Michigan Conflict of Interest Statute because Professors Todd Austin and Valeria Bertacco are both employees of the University of Michigan ("University") and partial owners of Agita Labs, LLC. The law permits such an Agreement provided it is disclosed to the Board of Regents ("Regents") of the University of Michigan and approved in advance by a 2/3 vote.

## Background:

Dr. Todd Austin, a Professor in the Department of Electrical Engineering and Computer Science – Computer Science and Engineering (EECS – CSE) Division, and Dr. Valeria Bertacco, a Professor in the Department of EECS – CSE, are partial owners of a for-profit company called Agita Labs, LLC (the "Company"). The Company was formed recently to commercialize a new computer system and processor with enhanced security and greatly reduced susceptibility to computer hacking, and desires to license from the University of Michigan the University's rights associated with the following technologies:

UM OTT File No. 2018-323, entitled: "Ensembles of Moving Target Defenses" (Inventors: Todd Austin, Valeria M Bertacco, Mark Gallagher, Baris Can Cengiz Kasikci)

UM OTT File No. 2018-324, entitled: "Displaced and Dilated Address Spaces" (Inventors: Todd Austin, Valeria M Bertacco, Mark Gallagher, Baris Can Cengiz Kasikci)

The Office of Technology Transfer selected the Company as a University partner and negotiated the terms of the proposed Agreement in accordance with University policy and its accepted licensing principles.

## Parties to the Agreement:

The Regents of the University of Michigan and Agita Labs, LLC

# Agreement Terms Include:

Agreement terms include granting the Company an exclusive license with the right to grant sublicenses. The Company will pay a royalty on sales and reimburse patent costs. The University may receive equity in the Company, along with the right to purchase more equity.

The University will retain ownership of the licensed technologies and may continue to further develop them and use them internally. No use of University services or facilities, nor any assignment of University employees, is obligated or contemplated under the Agreement. Standard disclaimers of warrantees and indemnification apply, and the Agreement may be amended by consent of the parties, such as adding related technology. University procedures for approval of these changes will be followed and additional conflict of interest review will be done as appropriate.

## Pecuniary Interest:

The pecuniary interests of Drs. Austin and Bertacco arise from their ownership interests in Agita Labs, LLC.

## Net Effect:

The Office of Technology Transfer has negotiated and finalized the terms of a worldwide exclusive license agreement for patents related to UM OTT File Nos. 2018-323 and 2018-324 for all fields of use. Agita Labs, LLC will obtain use and commercialization rights to the above listed University technologies.

#### Recommendations:

This matter has been reviewed and approved by the UMOR Conflict of Interest Review Committee. In light of this disclosure and our finding that the Agreement was negotiated in conformance with standard University practices, I <u>recommend</u> that the Board of Regents approve the Agreement between the University and Agita Labs, LLC.
