



Tonight's recipient, the 27th, at one point realized she had to make peace with death if she was to continue her work.

A journalist and filmmaker, Safa Al Ahmad [SOFF-ah AL ahck-modd] was determined to make sure that the rest of the world understood what was happening in <u>her</u> part of the world.

In 2014, a populist uprising was taking place in Saudi Arabia's Eastern Province.

The government was repressing all reporting.

Al Ahmad wanted to tell the story, to let the outside hear from the protesters and from the people in the street.

The result was a moving BBC piece, "Saudi's Secret Uprising".

She followed this with a report for PBS on the Houthi (HOO-thi) rebels in Yemen.

Just two weeks after the Houthis took over the capital of Yemen, Sanaa, she entered the city and began filming "The Fight for Yemen."

Other films continued to spotlight the Middle East, particularly Saudi Arabia and Yemen, giving voice to the protesters and those caught in the crisis.

In recording a young boy who says he has not been to school in months, she reports that "Education is extinct in Yemen."

In Taiz, once the cultural heart of Yemen, there is no electricity, minimal water, and strict control by the Houthis (HOO-thees).

Getting water each day for the family falls to the children, some of whom lose their lives in the process.

Her work seeks to clarify, in an objective way, the complicated factions at war and the interests they are fighting over.

To find the truth, she travels and works in the most dangerous situations.

There are car rides in the dead of night to areas controlled by protesters, trips on foot across mountain passes, and visits to families in areas of cities decimated by mortar fire.

All serve to expose what is happening in a place where the government would prefer we don't see what's going on.

Born and raised in Saudi Arabia, Al Ahmad has been reporting on Yemen since 2010.

In 2015 she received the Index on Censorship Freedom of Expression Award for Journalists.

She was awarded the Association for International Broadcasting Award, recognizing her as one of the few journalists reporting for Western news organizations from <u>inside</u> the area, even as the government worked to prevent media from reporting.

She has attached a face and a voice to the toll these conflicts have taken, particularly on those whose lives have been most affected, often transforming their existence from being busy city dwellers to becoming urban scavengers, seeking the barest of necessities of life.

Like all great journalists, she is a champion of the people.

Today's Tip

Just Breathe

If you're managing higher levels of stress these days, there's a tool we all have immedia access to: breathing. It might sound simple, but when done properly, breathing can mal the difference between panic and resilience. Research shows that different emotions are associated with different forms of breathing. For example, when you feel anxious or angry, your breathing becomes irregular, short, and fast. When you feel joy or relaxation your breathing will be regular, deep, and slow. And believe it or not, when you follow breathing patterns associated with different emotions, you begin to feel those corresponding emotions. So next time you're feeling stress start to bubble up, try changing the ratio of your inhale to exhale. When you inhale, your heart rate speeds up When you exhale, it slows down. Take a few minutes and breathe in for a count of four and out for a count of eight — this will calm your nervous system and keep stress at bay By tweaking your breathing, you'll start to feel a bit better.





Just Breathe


In the run-up to the new year, we're resharing some of our favorite tips from 2020.

If you're managing higher levels of stress these days, there's a tool we all have immediate access to: breathing. It might sound simple, but when done properly, breathing can make the difference between panic and resilience. Research shows that

different emotions are associated with different forms of breathing. For example, when you feel anxious or angry, your breathing becomes irregular, short, and fast. When you feel joy or relaxation, your breathing will be regular, deep, and slow. And believe it or not, when you follow breathing patterns associated with different emotions, you begin to feel those corresponding emotions. So next time you're feeling stress start to bubble up, try changing the ratio of your inhale to exhale. When you inhale, your heart rate speeds up. When you exhale, it slows down. Take a few minutes and breathe in for a count of four and out for a count of eight — this will calm your nervous system and keep stress at bay. By tweaking your breathing, you'll start to feel a bit better.

This tip is adapted from "Research: Why Breathing Is So Effective at Reducing Stress," by et al.


