Summary of Evaluation:

Teaching – Professor Ekotto has a strong record of teaching and has a deep commitment to student learning and helping students experience foreign cultures first-hand. She has offered interdisciplinary courses under the rubric of literary theory, literature, and the other arts as well as "Europe and its others." Grounded in Francophone literature in the transatlantic frame, her courses often address issues of race and cultural diversity from a variety of angles. More

recently, her research interest in world cinema, particularly the so-called "third cinema" of the African Diaspora, has been effectively incorporated into her teaching. She also offers courses in the Honors Program and in the Center for Afroamerican and African Studies (CAAS).

Research – Professor Ekotto is an important contributor to the University's profile in French and Francophone studies and in African studies. She has maintained a very solid record of research productivity with fourteen published articles and three forthcoming, three books and one forthcoming, and one co-edited volume and one forthcoming. Her latest book manuscript, *What Color is Black?*: Race and Sex across the French Atlantic (under contract with Lexington Books), explores the relation between the way race is conceptualized in the Francophone world and in transatlantic black movements. She focuses on Les Nègres (The Blacks), the controversial and ground-breaking play by the French writer Jean Genet, which interrogates the concept of blackness and emphasizes the performative nature of race itself. This is a bold and original study which offers an entirely new approach to the subject and to Genet himself.

From 1985 to 1986, Professor Green worked as a postdoctoral fellow at Sandia National Laboratories in ion solid interactions and defect physics. He stayed at Sandia National Laboratories working as a senior member of the technical staff in physical properties of polymers from 1986 through 1991. In 1991, he was promoted to manager working in glass and electronic ceramics research. In 1996, Professor Green joined academia at the University of Texas at Austin as an associate professor in the Department of Chemical Engineering. He was promoted to professor in 1999.

Professor Green's research program examines problems associated with the structure, phase behavior and dynamics of bulk and thin polymer and polymer-based nanocomposite systems. His program on polymer thin films comprises problems in three general categories: (1) wetting, interfacial instabilities and pattern formation, and self-assembly; (2) the influence of confinement and interfacial interactions on the glass transition, diffusion and viscosity, as well as on the phase and ordering transition temperatures of polymer mixtures and block copolymers, respectively; and (3) the organization of nanoparticles (C60 fullerenes, nanotubes, semiconductor and metallic nanoparticles) in thin films. The goal of the program is to develop new rules to design and to tailor properties of thin films for various applications. The second aspect of the research encompasses bulk rheological and dynamic mechanical behavior of polymer-based nanocomposite (organoclays, metal oxides, nanotubes) systems. Professor Green's program is interdisciplinary, cross-cutting different fields, from physical chemistry of surfaces, to the processing of polymers, to the physics of materials. His research group employs a range of experimental tools, including scanning force

microscopy, transmission electron microscopy, neutron scattering, ellipsometry, DMA and rheology, and his group collaborates with a number of theoretical groups within the University of Michigan and elsewhere.

Professor Green has the respect of his colleagues and will continue to provide strong administrative leadership for the department. We therefore recommend the reappointment of Peter F. Green as chair, Department of Materials Science and Engineering, College of Engineering, effective September 1, 2010 through August 31, 2013.

Dr. Morris' primary research interests focus on quality of surgical care, including (1) racial/ethnic/and economic disparities in cancer care and outcomes, (2) processes of care for colon and rectal cancer, and (3) patient centered outcomes in colon and rectal surgery. Most of her work has been based on linked administrative-clinical data, and has primarily focused on processes and outcomes of colorectal cancer care among minority patients. She is actively working to understand multi-level disparities in outcomes in preparation for intervention studies. She is currently PI for a mixed methods study using claims data to understand variations in processes of care and conducting race-concordant focus groups to understand patient perspectives on use of therapy. Understanding disparities in care, described as "inequality in quality", is dependent on meaningful quality measures. Therefore, Dr. Morris has explored and developed new measures of quality in outcomes and processes of care. She will employ students in projects and collaborate with health behavior and health education faculty on research focusing on cancer disparities.

On the recommendation of the Dean, the nominating committee, and the faculty of the School of Natural Resources and Environment, we are pleased to recommend the appointment of Professor Ivette Perfecto as the George Will Pack Professor, School of Natural Resources and Environment, effective January 1, 2010 through December 31, 2014.

In 1930 the Regents of the University of Michigan established the George Willis Pack Professorship upon receipt of a \$200,000 endowment gift. The purpose of the professorship is the "promotion of practical forest land management in the broadest sense of the term." In 1989, the University interpreted the original documentation on the professorship to be that it is to recognize teaching and research in the areas of forest conservation, land use management, and the contribution of natural resources to the national economy. In 2000, the dean of the School of Natural Resources and Environment in consultation with the Provost again revisited the University's position and determined that, while the School needed to make every effort to respect the intent of the donor in assign the professorship, that intent also needed to be understood in view of contemporary approaches and issues of concern in natural resources and the environment. Based on the language of the bequest and the 1989 interpretation, it was determined that the recipient of the professorship should be someone with demonstrated outstanding accomplishments in one or more of the following areas: terrestrial systems, land use management, resources and the economy, and/or ecosystem management. In December 2009 the name of the professorship was changed to the George Willis Pack Professorship.

Professor Perfecto received her B.S. degree in 1977 from Universidad Sagrado Corazon in Puerto Rico, her M.S. degree in 1982, and her Ph.D. in 1989, both from the University of Michigan. After graduating with her doctoral degree Professor Perfecto joined the School of Natural Resources and Environment at the University of Michigan as an assistant professor. She was promoted to associate professor in 1996 and to professor in 2006.

The professorship's purpose dovetails well with Professor Perfecto's own research agenda, which focuses on biodiversity in agricultural landscapes, primarily in the tropics. Her current research, which often involves SNRE master's and doctoral students, is centered on the complex ecological interactions that create the ecosystem service of pest control in coffee agro ecosystems, primarily in the new-world tropics. Professor Perfecto and the students who work with her use a combination of field observations, laboratory experiments and mathematical modeling to uncover the essential ecological connections among diverse components of the system.

Professor Perfecto has created an extensive research record in the area of biodiversity, a record that strengthens the global reach and sustainability focus of the School of Natural Resources and Environment. Her work as an advisor and mentor are equally world-class and deserving of acknowledgment. In recognition of her many accomplishments, we are pleased to recommend the appointment of Ivette Perfecto as the George Willis Pack Professor, School of Natural Resources and Environment, for a five-year term, effective January 1, 2010 through December 31, 2014.

His public health centered research fits well with the interests of many faculty and students and will provide opportunities for our students to engage in state of the art interdisciplinary research.
