With the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Paul P. Lee, M.D., J.D. as professor of ophthalmology and visual sciences, with tenure, effective February 1, 2012, F. Bruce Fralick Professor of Ophthalmology, and chair, Department of Ophthalmology and Visual Sciences, Medical School, effective February 1, 2012 through January 31, 2017.

Academic Degrees:

Dr. Lee received his M.D. degree from the University of Michigan in 1986. He received his J.D. degree from Columbia University, also in 1986.

Professional Record:

Dr. Lee completed an internship in medicine at Beth Israel Hospital at Harvard University from 1986-1987, and a residency at the Wilmer Eye Institute at Johns Hopkins University from 1987-1990. He then completed a glaucoma fellowship at the Massachusetts Eye and Ear Infirmary at Harvard University from 1990-1991. Dr. Lee was appointed as an assistant professor in the Department of Ophthalmology at the University of Southern California in 1991. He was promoted to an associate professor, with tenure, in 1995. In 1999, Dr. Lee was appointed as a professor of ophthalmology, with tenure, at Duke University and was named vice chair of the Department of Ophthalmology. He was granted the title of the James Pitzer Gills, III, M.D., and Joy Gills Professor of Ophthalmology.

Summary of Evaluation:

Dr. Lee's primary research efforts are in improvement in the quality of glaucoma surgery and care, patient-centered care, and health care utilization and policy. He is the principal investigator on an R01 from the National Eye Institute, and a co-investigator on an R01 from the National Institute of Aging. Dr. Lee has over 190 published articles in peer-reviewed journals and has

been invited to present at nearly 200 national and international meetings. He has received several awards for his research, including the Lew Wasserman Merit Award for Research to Prevent Blindness, the Alcon Institute Award, and the Senior Achievement Award from the American Academy of Ophthalmology.

Dr. Lee is regarded as an excellent teacher to medical students, house officers, and fellows. He teaches clinically, specializing in glaucoma, for ophthalmology rotations and applications of social science methods to law and policy. He has been a visiting professor at numerous institutions and has presented workshops and courses at national venues.



In addition, he maintains a clinical practice for complex glaucoma patients.


Summary of Recommendation:



With the endorsement of the Executive Committee of the School of Nursing, I am pleased to recommend the appointment of Anne E. Sales as professor of nursing, with tenure, School of Nursing, effective January 1, 2012.

ACADEMIC DEGREES

Professor Sales received her bachelor of arts in sociology-anthropology from Oberlin College in 1982. She received her diploma in nursing from the Jewish Hospital School of Nursing in 1984. In 1989, she received her master of science in nursing from the University of North Carolina at Chapel Hill and her doctorate in health services research, policy and administration in 1998 from the University of Minnesota.

PROFESSIONAL RECORD

Professor Sales began her academic career as an assistant professor in the Department of Health Services at the School of Public Health and Community Medicine at the University of Washington. She was promoted to associate professor, with tenure, in 2004. In 2006, she took an associate professor, with tenure, position on the Faculty of Nursing at the University of Alberta in Edmonton, Canada where she was promoted to professor in 2009. In addition to her academic roles, Professor Sales was the implementation research coordinator (2002-2006) and acting research coordinator (2004-2005) of the Ischemic Heart Disease Quality Enhancement Research Initiative at the United States Department of Veterans Affairs Health Services Research and Development Service (VA HSR&D). She is currently the deputy chief of the Inpatient Evaluation Center, Office of Quality and Safety at the VA Ann Arbor Healthcare System.

SUMMARY OF EVALUATION

Professor Sales has maintained an active research program and is viewed as a leader in the field of health services research by her nursing and interdisciplinary colleagues. She is interested in broad questions about how people function in work contexts, how work affects daily life and broad outcomes, and specifically within health care, how the work experiences and contexts in which providers offer services affect what happens with the people who receive care. Professor Sales has a strong commitment to her science, and she has an established track record for research. She has been the principal investigator on 15 funded projects of which four are from the Canadian Institutes of

Health Research (CIHR). Professor Sales has published 84 manuscripts (first author on 20) and four book chapters (first author on three) in peer-reviewed journals and books relevant to her program of research. She has conducted numerous important studies on nurse staffing and related topics and has published widely in the most prestigious journals (e.g., *Journal of General Internal Medicine*, *Medical Care*, *Health Services Research*, etc.).

While Professor Sales has held research-intensive roles throughout her career, she has taught or co-taught both undergraduate and master's level courses focused largely on quantitative data analysis. Professor Sales has also provided strong mentorship to master's and doctoral graduate students, trainees, junior faculty, undergraduates, post doctoral fellows and even physicians and demonstrates a passionate commitment to providing ongoing mentorship. Professor Sales' record of service demonstrates her commitment to responsible academic citizenship. She is a nationally-recognized nurse leader as exemplified by her many top-tier service activities.



SUMMARY



On the recommendation of the Executive Committees of the School of Art and Design and the College of Literature, Science, and the Arts, we are pleased to recommend the appointment of David Turnley as associate professor of art and design, without tenure, School of Art and Design, and associate professor in the Residential College, without tenure, College of Literature, Science, and the Arts, effective January 1, 2012.

ACADEMIC DEGREES

David Turnley received a Bachelor of Arts degree in French literature from the University of Michigan in 1977. He holds honorary doctoral degrees from the New School for Social Research (1997) and the University of St. Francis (2000).

PROFESSIONAL RECORD

David Turnley brings to the University of Michigan a distinguished professional career as a photojournalist and photographer, documentary filmmaker, director, and executive producer. In addition, he served as a visiting professor at the University of St. Francis (2011) and since 1987 has led photography workshops in New York, South Africa, and Mississippi.

SUMMARY OF EVALUATION

David Turnley is an award-winning photojournalist and documentary filmmaker, and is regarded by his peers and critics as among the finest of his generation. From the inner city streets of his Indiana hometown, to the unraveling of Apartheid in South Africa, to the fall of the Berlin Wall, to the genocide in Rwanda, to revolutions and social strife throughout the world, he has chronicled the human condition. He is the recipient of numerous awards, including the Pulitzer Prize, two World Press Competition Pictures of the Year awards, the Robert Capa award for bravery in photojournalism, Best Documentary award at the Miami International Film Festival, and the Golden Cine Award. He has published 10 books of his photographs and writings, and his work has been featured in major national and international publications. His current work-in-progress – *Shenandoah, USA* – is a full-length film exploring the events, causes, and effects of the murder of an illegal Mexican immigrant in a small Pennsylvania coal town.

In the classroom, David Turnley has mentored both experienced and novice photographers in visual storytelling and narrative. His courses have facilitated technical development as well as contextual

understanding and conceptual growth. Former students describe him as a compassionate, dedicated teacher who inspires his students to engage deeply with the art of visual storytelling and to connect with their subjects in ways that recognize their intrinsic humanity. His ability to engage both students and faculty in the social and political contexts underlying his creative work, both through specific media and the conversations in which he participates, will be of great value, particularly given the interdisciplinary nature of his appointment.

Dr. Mychaliska is currently co-director of the ECMO program. He has 53 published articles, and has been invited to present at 34 national and international venues.



On the recommendation of John M. Carethers, M.D., the John G. Searle Professor and Chair of the Department of Internal Medicine, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Sanjay K. Saint, M.D. as the George Dock Collegiate Professor of Internal Medicine, Medical School, effective January 1, 2012 through August 31, 2016.





With the endorsement of the Executive Committee of the College of Literature, Science, and the Arts, we are pleased to recommend the appointment of Melanie S. Sanford as the Moses Gomberg Collegiate Professor of Chemistry, College of Literature, Science, and the Arts, for a five-year renewable term, effective January 1, 2012 through December 31, 2016.

Moses Gomberg was a faculty member at the University of Michigan from 1893 until his retirement in 1936. He also served as chair of the Department of Chemistry from 1927 to 1936. The Moses Gomberg Collegiate Professorship in Chemistry was named by the Regents in March 1999. A stipend funded from College resources will accompany this professorship.

Melanie Sanford received her Master of Science from Yale University in 1996 and her Doctorate from the California Institute of Technology in 2001. Professor Sanford began her teaching career as an assistant professor at Michigan in 2003 and was promoted to associate professor, with tenure, in 2007. She was awarded an Arthur F. Thurnau Professorship in 2011 and an LSA John Dewey Award in 2010.

Professor Sanford is widely regarded as an outstanding leader in her field. She is working to revive and enhance approaches to organic synthesis previously set aside because of their technical difficulty. Her research focuses on using metal-based agents, primarily palladium, to catalyze reactions that substitute hydrogen in carbon-hydrogen bonds with other atoms or functional groups. Beginning with a reaction cycle widely regarded as too difficult to control, she developed a mechanism for taming palladium's activity, making practical its application in the laboratory. Her methods enable modification of specific carbon bonds in complex molecules, while leaving other carbon bonds unchanged. These advances have had significant impact on industrial chemistry, particularly in pharmaceuticals, where introduction of bonds like carbon-fluorine is desirable but frequently challenging in practice. Professor Sanford's techniques often decrease the number of reaction steps necessary and increase the yield of the desired molecule. She pays careful attention to minimizing the generation of toxic by-products, thus contributing to the development of "greener" chemistry. She is expanding her research program to include targeted synthesis of molecules with "handedness" — i.e., molecules having


two configurations identical in shape but mirror images in their spatial orientation, like gloves. Limiting synthesis to a single orientation at the outset, rather than trying to separate a two-handed molecular mixture at the end, is a major objective in medicinal chemistry. Through her basic research on organometallic synthesis strategies, Professor Sanford is opening new paths to making important compounds we use every day, while diminishing the environmental impact of their manufacture.

Professor Sanford's work has attracted substantial funding and has received numerous awards, including an American Association for the Advancement of Science Fellowship (2011), John D. MacArthur Fellowship (2011), and an American Chemical Society Award in Pure Chemistry (2010), among many others.



On the recommendation of Alan R. Saltiel, Ph.D., the John Jacob Abel Collegiate Professor and the Mary Sue Coleman Director of the Life Sciences Institute, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of John J. G. Tesmer, Ph.D. as the Cyrus Levinthal Collegiate Professor in the Life Sciences, Medical School, effective January 1, 2012 through August 31, 2016.

The College of Literature, Science, and the Arts recommends that the title of the Elsa Barkley Brown and Robin D.G. Kelley Collegiate Professorship in History and African American and African Studies be changed to the Elsa Barkley Brown Professorship in African American Women's History, effective January 1, 2012.


Elsa Barkley Brown was a faculty member at the University of Michigan from 1991 to 1997. A distinguished faculty member will be nominated to receive this honor. The initial term of appointment will be for five years, with the possibility of renewal. A stipend funded from College resources will accompany this professorship.

Elsa Barkley Brown received her Bachelor of Arts at DePauw University in 1972 and her Doctorate at Kent State University in 1994, where she studied with the legendary figure in African American history, August Meier. Professor Brown began her teaching career as an instructor at the University of Michigan from 1991 to 1994 and as an assistant professor from 1994 to 1997. She joined the faculty at the University of Maryland, College Park, where she is currently an associate professor of history and women's studies.

A leading figure in women's history and African American history, Professor Brown is a much celebrated author of several seminal essays in African American women's history. Her articles and editorial work have garnered her the Anna Julia Cooper Award for Distinguished Scholarship, the Leticia Woods Brown Memorial Prize (three times), the A. Elizabeth Taylor Prize for the best article in southern women's history, and the Martin Luther King Jr. Prize for the best article in African American history. She co-edited the two-volume Major Problems in African-American History and the two-volume Black Women in America: An Historical Encyclopedia. An exacting and nurturing mentor, Professor Brown played a significant role in the training of graduate students at the University of Michigan during the 1990s. She is past president of the Southern Association of Women Historians, and she has been a member of the Executive Council of the American Studies Association, as well as several editorial boards.

We are very pleased to recommend the renaming of the Elsa Barkley Brown Collegiate Professorship in African American Women's History, College of Literature, Science, and the Arts, effective January 1, 2012.

The Medical School seeks to name an existing collegiate professorship for Bradley M. Patten, who was a faculty member at the University of Michigan from 1935 until his retirement in 1959.


The holder of this professorship will be a distinguished tenured faculty member of the Medical School, named by the dean. The initial term of the individual designated to hold the Bradley M. Patten Collegiate Professorship in the Life Sciences will be five years, and the appointment may be renewed.

Dr. Patten received his Ph.D. from Harvard University in 1941. He joined Western Reserve University Medical School as a faculty member in the Laboratory of Histology and Embryology. While at Western Reserve University, Dr. Patten wrote the classic textbook, Early Embryology of the Chick, and the first edition was published in 1920. His second textbook was published in 1927, Embryology of the Pig, which showcased his expertise on mammalian embryology. In 1934, he joined the Rockefeller Foundation as an assistant director for the medical sciences and was responsible for its international fellowship program.

Dr. Patten joined the University of Michigan in 1935 as a professor of anatomy and chair of the Department of Anatomy. In that role, he promoted the growth of gross anatomy, microscopic anatomy, neuroanatomy and embryology. While at the University of Michigan, he wrote two books: Human Embryology and The Foundations of Embryology. Dr. Patten became best known for his cinematography of the developing embryo, as well as his first textbook. His authoritative knowledge earned him service on national committees and symposia on congenital defects of the heart. From 1949-1950, he was the National Sigma Xi Lecturer. During his tenure at the University of Michigan, Dr. Patten served as a member of the University's Senate Advisory Committee, the Medical School Executive Committee, and a number of tributary committees.

Dr. Patten was a trailblazer in the study of embryology. The naming of this professorship will honor his work and recognize his numerous contributions as an outstanding scholar and dedicated teacher while at the University of Michigan. We are pleased, therefore, to recommend the establishment of the Bradley M. Patten Collegiate Professorship in the Life Sciences, Medical School.
