Jakob, Ph.D. as associate professor of biological chemistry, without tenure, Medical School, effective February 1, 2010.

Dr. Jakob received the Ph.D. degree in 1995 from the University of Regensburg in Germany. From 1996-1997, she was a postdoctoral fellow in the Department of Biology at the University of Michigan, followed by an appointment as assistant research scientist in that department from 1997-2001. In 2001, Dr. Jakob was appointed as an assistant professor of molecular, cellular and developmental biology and was promoted to her current rank of associate professor of molecular, cellular and developmental biology, with tenure, in 2007.

Dr. Jakob is a highly effective and exemplary teacher. She devotes a large portion of her effort to teaching undergraduate and graduate students in didactic courses, as well as in the laboratory setting. She has an extensive record of mentoring undergraduate and graduate students, Ph.D. students, and postdoctoral fellows. In addition, Dr. Jakob has served on numerous dissertation committees not only within her department, but in the Department of Biological Chemistry and in the Cellular and Molecular Biology Program for which she currently serves as the associate director. Her research is devoted to answering fundamental questions regarding redox regulation and the role of oxidative stress in host defense and aging. On the recommendation of Karin M. Muraszko, M.D., the Julian T. Hoff Professor and Chair of the Department of Neurosurgery, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of B. Gregory Thompson, M.D. as the John E. McGillicuddy Collegiate Professor of Neurosurgery, effective February 1, 2010.

In the School of Education she designed and taught highly subscribed courses that engage students in appreciating the intersection between educational issues and social justice through first-hand data collection, textual analysis, and ethnographic field work. She has extended her commitment to multicultural education by developing programs such as *Teachers for Tomorrow*, which prepare teachers to work in under-resourced schools. As director of the Sweetland Writing Center, Professor Gere launched a major research program involving longitudinal studies of student writing, and she revised the process by which students are placed into first-year writing courses. In addition, she undertook a curriculum redesign, including the introduction of *New Media Writing*, which focuses on writing in digital environments such as blogs, podcasts, and websites. Colleagues and students remark on the immense personal attention Professor Gere devotes to helping her students improve their writing, especially in how she designs course assignments and comments extensively on essay drafts. She is noted as an enduring mentor who continues to affect students long after they have left the classroom and even the university. As one student wrote, "Professor Gere's class taught me skills that I use in all of my classes. I learned to love writing and enjoyed learning by writing."

In 1988, the Board of Regents established the Arthur F. Thurnau Professorships to recognize and reward faculty for outstanding contributions to undergraduate education. Based on her extraordinary achievements, I am delighted to recommend that Professor Queen be designated a Thurnau Professor.

An inventive adopter of pedagogical technologies and inspiring mentor and colleague, Professor Queen exhibits a "drive to make learning Linguistics accessible to all students." Of her use of blogs, online opinion polls, and videos clips from popular media sources to engage students in relating sociolinguistics to their own lives, a colleague observed, "Clearly, her use of technology transforms her courses." In courses she has designed, such as Language and the Mass Media and Language and Discrimination, Professor Queen fosters the development of multiple perspectives and commitment to diversity. She successfully initiates and sustains complex and often emotionally charged conversations about how people use language as a means of social statement, affiliation, and, sometimes, conflict. Students report that Professor Queen's approach to these courses shapes the way they view and interact with the world. Her engagement with multicultural issues extends beyond the classroom to the curricular level, where Professor Queen has been instrumental in developing a new sub-concentration on Linguistics for a Multicultural World and has been actively involved in initiatives to assess the effectiveness of new teaching technologies. She is also a generous and highly sought-after mentor, advising student research projects on an impressive range of topics. A former honors advisee recalled, "That she gave me the tools I needed to take authorship of my own education marks Dr. Queen as both a mentor and an educator."

For her exceptional teaching and dedication to undergraduate students, I recommend her for a Thurnau Professorship.

In 1988, the Board of Regents established the Arthur F. Thurnau Professorships to recognize and reward faculty for outstanding contributions to undergraduate education. Based on his extraordinary achievements, I am delighted to recommend that Professor West be designated a Thurnau Professor.

Professor West is lauded as a "tireless champion of university arts education." Indeed, his contributions to the students and the curriculum at the School of Art and Design are immense. He launched curricular innovations such as reconceptualizing required core-courses, implementing a fellowship program that invited emergent artists to campus, and increasing opportunities for students to study abroad. And he transformed the school's physical facilities to include a center for print media, a photography studio, and a gallery for undergraduates to benefit from graduate students' work. Present and former students note his honesty, generosity, and compassion in providing feedback on their work and in serving as an ongoing mentor for their studies. They also remark on his acute insight and productive criticism, appreciating how he asks "difficult and pointed questions ... the kind of questions that make [one] face the complicated problems artists encounter as they process their ideas and create work." Professor West demonstrates a genuine and deep concern for creating an inclusive learning environment, treating his students fully as peers and tackling diverse topics in his courses, from the politics of representation in photography to addressing issues of race and ethnicity. The commitment to interdisciplinarity that shapes his artistic work extends to his pedagogy, as he urges students to think across artistic media and also to draw on theories and perspectives from other fields in order to, in the words of one student, "foster an understanding of a connected universe."

For his exceptional teaching and dedication to undergraduate students, I recommend him for a Thurnau Professorship.

It is a pleasure to recommend the appointment of Philip J. Hanlon as provost and executive vice president for academic affairs, Office of the President, for a five-year term, effective July 1, 2010 through June 30, 2015. As the chief academic and budgetary officer, Professor Hanlon will provide leadership to support the University's scholarly enterprise and the planning and implementation of its academic programs. He will collaborate with the president in setting overall academic priorities for the University and will allocate funds to carry forward these priorities. In addition, he will continue to hold the titles of Donald J. Lewis Collegiate Professor of Mathematics, Arthur F. Thurnau Professor, and professor of mathematics, with tenure, in the College of Literature, Science, and the Arts.

Professor Hanlon has been a member of the U-M faculty since 1986, and his appointment as provost reflects his outstanding strengths as a teacher, scholar, administrator and leader. As vice provost for academic and budgetary affairs, Professor Hanlon has been an exceptional leader in guiding academic programs and initiatives affecting all facets of the University. In particular, his command of budgetary issues has been critical to the University's financial stability during an extended period of declining state appropriations.

Professor Hanlon received his A. B. degree from Dartmouth College in 1977 and a Ph.D. degree from the California Institute of Technology in 1981. Prior to coming to the University of Michigan, Professor Hanlon was an instructor in applied mathematics at the Massachusetts Institute of Technology from 1981 to 1983; and he was a Bantrell Fellow at the California Institute of Technology from 1983 to 1986. Professor Hanlon came to the University of Michigan in 1986 as an associate professor of mathematics and was promoted to professor in 1990. From 2001-04, he served as the associate dean for planning and finance in the College of Literature, Science, and the Arts, where he played a lead role in budgeting and academic

planning within the college. During that time, he was responsible for implementing a new incentive-based budget model within the college. In 2004, he was appointed associate provost for academic and budgetary affairs. His title was changed to vice provost in 2007. In this role, he worked closely with the provost on all matters pertaining to the University's general fund budget and on development and support of academic programs and initiatives. He also led a presidential initiative to advance interdisciplinary teaching at the undergraduate level and he has organized and led a campus-wide initiative aimed at making more effective use of space and facilities. Within the Provost's Office, his areas of responsibility have included budget, space and facilities matters, strategic planning and oversight of reviews of the 19 schools and colleges. In addition, he handles academic issues related to student athletes and oversees two of the research institutes that report to the provost.

Professor Hanlon's research interests lie in the areas of algebraic combinatorics, discrete probability, bioinformatics and theoretical computer science. He has published in a number of professional mathematics journals throughout his career. He has received numerous honors and awards including a Sloan Fellowship, a John Simon Guggenheim Fellowship, a Presidential Young Investigator Award and the Henry J. Russell Award in 1990. In 2001, he was named the Donald J. Lewis Collegiate Professor of Mathematics. His dedication to undergraduate teaching has been recognized by an Excellence in Education Award and a Thurnau Professorship. Professor Hanlon also was the founder and first executive director of the Michigan Math and Science Scholars, a thriving summer program for high school students who have a strong interest in math and science.

Professor Hanlon has held visiting positions at several prestigious institutions, including the Isaac Newton Institute in Cambridge, England; the Mittag-Leffler Institute in Stockholm, Sweden; the Institut des Hautes Études Scientifique and the University of Strasbourg, both in France; Oxford University; and the Center for Communications Research at Princeton.

Professor Hanlon's appointment as provost reflects his distinct strengths as a teacher, scholar, administrator and leader. I look forward to the leadership, depth of experience, and vision that he will bring to the University. It is with great enthusiasm that I recommend the appointment of Philip J. Hanlon as provost and executive vice president for academic affairs, effective July 1, 2010 through June 30, 2015.

On the recommendation of the Executive Committees of the Honors Program and the College of Literature, Science, and the Arts, we are pleased to recommend the appointment of Dick Siegel as the Helen L. DeRoy Visiting Professor in Honors, effective February 1, 2010 through April 30, 2010.

In 1981 the Helen L. DeRoy Visiting Professorship in Honors was established to support the University's Honors Program. The Honors Program's DeRoy Visiting Professors Subcommittee selects and nominates distinguished visitors, with preference to those outside the academy, to teach in the Honors Program.

Dick Siegel graduated with honors in English from the University of Michigan, where he was also a Hopwood Award winner. He has achieved renown in an active performance and composing career around the country. A member of the Detroit Music Hall of Fame and the recipient of awards such as multiple Detroit Music Awards and the Kerrville Music Festival's New Folk Award, Mr. Siegel is known for his engagingly unconventional lyrics and a dynamic musical style that incorporates modern folk and jazz. Trained in classical music, he discovered the powerful imagery in Dylan Thomas' and T. S. Eliot's poetry while studying English literature; these influences are still seen in his lyrics, Mr. Siegel was named in WDET's list of the most important and influential artists in the history of Detroit, alongside legends such as Stevie Wonder, and Aretha Franklin. A longtime National Public Radio staple, his songs have been featured on stations such as Austin's KUT, New York's WFUV, and San Francisco's KPFA, as well as syndicated shows including Mountain Stage and All Things Considered.

Mr. Siegel will teach a course entitled "Singing Out of Our Minds": A Songwriting Workshop. At the end of the term, he and his students will present a public performance. This course is part of an endeavor to encourage interdisciplinarity and creativity. Music is a vital part of life for many students and this course seeks to develop that interest in the context of their intellectual lives.

I am pleased to recommend the approval of a title change for Mary Jo Sekelsky from vice chancellor for student services and enrollment management to vice chancellor for student affairs at the University of Michigan-Flint, effective February 1, 2010.

A Student Services Enrollment Management Task Force was convened by Vice Chancellor Sekelsky in 2007. Charged with assessing the division's progress in meeting the vision and mission stated in the University's Strategic Plan, "Engaging Minds, Preparing Leaders: Strategic Plan for the University of Michigan-Flint," this sixteen-member Task Force embarked upon a year-long dialogue involving students, faculty, and staff. Conversations involving more than sixty focus groups, coupled with surveys and existing studies yielded a wealth of information that addressed SSEM's alignment with the Strategic Plan's three pillars: excellence in teaching, learning and scholarship; student centeredness; and engaged citizenship. The Task Force recommended that Division of Student Affairs conveys a more comprehensive, representative description not only of the developmental nature of their work, but also of the varied and diverse ways in which the division interacts with and advocates for the most important members of the campus community – our students. In response to this recommendation, Student Services and Enrollment Management officially changed its name to the Division of Student Affairs.

Vice Chancellor Sekelsky has been part of the University of Michigan-Flint's leadership team since 1984. In July 2005, she was appointed as vice chancellor for student services and enrollment management. Prior to this appointment, she served as interim vice chancellor for student services and enrollment management, filling a void created by the retirement of Dr. Virginia Allen. From 1995 to 2004, she served as the assistant vice chancellor for student services and enrollment management. She has also served as interim dean for student services, director of student life, assistant director for student activities and orientation, and student activities coordinator and academic advisor.

Vice Chancellor Sekelsky obtained her Ed.D. from Wayne State University, her M.A. in guidance and counseling from Oakland University, and her B.A. in psychology from Michigan State University.

As the chief student affairs officer, the vice chancellor for student affairs reports directly to the chancellor and serves on the chancellor's executive team, both as an advocate for student interests and as an advisor in institutional decision making. The vice chancellor provides leadership on all matters related to student affairs. The vice chancellor provides leadership to a division comprised of the following units: Academic Advising and Career Center, Administrative Information Management

Services, Office of Financial Aid, Office of the Registrar, Student Development Center, Office of Student Life, Housing and Residential Life and the Lesbian, Gay, Bisexual and Transgender Center.

Vice Chancellor Sekelsky is a committed advocate of student centeredness and a highly effective manager. I am pleased to recommend her title change from vice chancellor for student services and enrollment management to vice chancellor for student affairs, effective February 1, 2010.
