On the recommendation of the Executive Committees of the Department of Physics and the College of Literature, Science, and the Arts, we are pleased to recommend the appointment of Steven T. Cundiff as professor of physics, with tenure, College of Literature, Science, and the Arts, effective January 1, 2015.

ACADEMIC DEGREES

Steven Cundiff completed his Bachelor of Arts at Rutgers University in 1985. He attended the University of Michigan where he received his Master of Science in 1991 and Doctorate in 1992.

PROFESSIONAL RECORD

Following several post-doctoral appointments, Professor Cundiff joined the faculty at the University of Colorado as an assistant professor (1997-2003) and was promoted through the ranks to professor in 2008. He has been appointed at the National Institute of Standards and Technology since 1979, in the Quantum Physics Division, and as a fellow at the Joint Institute for Laboratory Astrophysics (JILA) at UC-Boulder since 1999.

SUMMARY OF EVALUATION

Professor Cundiff is a senior scientist with an international reputation for his work with lasers, laser spectroscopy, and the study of the optical properties of materials. His work at NIST/JILA opened up new areas of exploration. Inspired by two dimensional-Fourier transform techniques developed in NMR by R. Ernst, he understood the importance of this capability to further understand the higher order correlations present in complex many-body systems. His work is now used by groups around the world interested in this problem as well as by people studying molecular structure. One of his most significant contributions to the field of spectroscopy was his work on the development of optical frequency combs based on mode-locked lasers. Professor Cundiff's contributions to spectroscopy have recently been recognized by his receipt of the William F. Meggers Award in Spectroscopy (2011), awarded by the Optical Society of

America. He served as program co-chair and then general co-chair for the Quantum Electronics and Laser Science (QELS) Conference, and chair or co-chair of numerous other meetings in the area of spectroscopy. At NIST from 2004 to 2009 he led a team of scientists in his capacity as chief of the Quantum Physics Division.

As a fellow at a national laboratory, Professor Cundiff was not required to teach. However, he was also an adjunct member of the University of Colorado's Physics Department and had taught several "special topics" classes. One class focusing on laser techniques that he developed was clearly successful with good response rates and strong scores from students.

On the recommendation of John M. Carethers, M.D., the John G. Searle Professor and Chair of the Department of Internal Medicine, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of MeiLan K. Han, M.D. as associate professor of internal medicine, with tenure, Medical School, effective February 1, 2015.

Academic Degrees:

Dr. Han received her M.D. in 1999 from the University of Washington in Seattle, Washington.

Professional Record:

Dr. Han completed an internship and residency in internal medicine at the University of Michigan from 1999 to 2002. She then completed a fellowship in pulmonary and critical care medicine at Michigan from 2002 to 2005. She was appointed as a clinical assistant professor in the Department of Internal Medicine in 2005 and was promoted to clinical associate professor in 2012.

Summary of Evaluation:

Dr. Han's investigative focus is on end stage lung disease, specifically related to the diagnosis, pathogenesis and treatment of chronic obstructive pulmonary disease (COPD). Dr. Han participates in multiple NIH lung disease networks and serves as the site principal investigator at the University of Michigan for the COPD Clinical Research Network, COPDGene and SPIROMICS networks. She has joined efforts with colleagues in the Department of Radiology to investigate how radiologic assessment can be used to better characterize small airways disease and emphysema in COPD using computerized tomography imaging. This unique collaboration, coupled with access to data through her affiliations with the COPD networks, led to recent publications in *Nature Medicine* and the successful funding of an NIH R01 grant for which she is the principal investigator. Dr. Han has published 65 articles and seven book chapters.

Dr. Han's teaching activities include didactic and clinical teaching of graduate students, medical students, residents, fellows, and faculty. She directs and teaches practicing physicians, patients and community groups through the Lymphangiomyomatosis (LAM) Foundation. She served as a mentor for the MI Clinical Foundations of Medicine sequence. Dr. Han was commissioned by the Office for Women's Health Research and the NIH to create an online course on women's respiratory disease.

They show that she is developing a strong translational research program, especially in patients with diffuse lung parenchymal lung diseases, in particular, chronic obstructive lung disease and interstitial lung diseases. The manuscripts are of excellent quality and have been published in the highly rated peer reviewed journals in her field."

Reviewer D: "She has made novel and significant contributions to our understanding of COPD and IPF. Her focus on clinical phenotypes and gender differences in lung disease are understudied, novel and important areas of research. She has achieved a high level of national and international visibility, and is leading large international groups, chairing international conferences, and serving on national study sections and editorial boards of high caliber journals."





The Law School is pleased to recommend the reappointment of Richard D. Friedman as the Alene and Allan F. Smith Professor of Law, Law School, for a five-year renewable term, effective March 1, 2015 through February 28, 2020.

The Alene and Allan F. Smith Professorship is supported by an endowment established in 1982 with gifts from faculty, alumni, and friends of the Smiths, as well as with funds from the university and the Law School. It recognizes the many contributions Professor Allan F. Smith and his wife, Alene, have made to Michigan during their 35 years of association with the university. Professor Smith joined the faculty of the Law School in 1947. He served as dean of the Law School from 1960 to 1965, as vice president for academic affairs of the university from 1965 to 1974, and as interim president in 1979. He was granted emeritus status in 1982.

Professor Friedman has been a member of the Law School faculty since 1988. He received his A.B. from Harvard College, his D.Phil. from Oxford University as a Marshall Scholar, and his J.D. from Harvard Law School. While in Law School, he was a senior editor of the *Harvard Law Review* and received the Sears Prize (awarded to the top two members of the class). After graduation, Professor Friedman served as a clerk to the Honorable Irving Kaufman of the United States Court of Appeals for the Second Circuit. He practiced law with the firm of Paul, Weiss, Rifkind, Wharton & Garrison for three years before beginning an academic career. He started teaching and earned tenure at the Cardozo Law School before moving to Michigan.

Professor Friedman is an exceptional scholar and teacher. At Michigan, he has taught courses in administrative law, antitrust law, civil procedure, conflict of laws, constitutional law, criminal procedure, and evidence. A prolific researcher, he has published over 50 articles and essays, together with one book, The Elements of Evidence. He is the general editor of the *New Wigmore*, a multi-volume treatise on the law of evidence. Professor Friedman is widely regarded as one of the nation's leading experts on the constitutional right of the criminally accused to confront the witnesses against them and has successfully argued two confrontation clause cases

in the Supreme Court. He has been appointed by the Permanent Committee on the Oliver Wendell Holmes Devise to write the volume on the Hughes Court as part of the Devise's History of the Supreme Court of the United States. Professor Friedman has been elected to membership in the American Law Institute.



On the recommendation of the Dean of the Stephen M. Ross School of Business, we are pleased to recommend the reappointment of Wallace J. Hopp as senior associate dean for faculty and research, Stephen M. Ross School of Business, effective July 1, 2015 through December 31, 2015.

Wallace Hopp received his B.S. in physics from Michigan State University in 1978 and his M.S. in technology and human affairs from Washington University in 1979. He then moved to the University of Michigan, where he was granted a second M.S. in industrial and operations engineering in 1982 and a Ph.D. in industrial and operations engineering in 1984. After receiving his Ph.D., Professor Hopp joined Northwestern University as an assistant professor. He was promoted to associate professor in 1990 and to professor in 1993. Professor Hopp returned to the University of Michigan Stephen M. Ross School of Business in 2007 as professor of operations and management science and was appointed as the Herrick Professor of Manufacturing. He was appointed as the Keith E. and Valerie J. Alessi Professor of Business Administration in 2010 and was subsequently appointed as the Herrick Professor of Business in 2012. Professor Hopp was appointed as the associate dean for faculty and research in 2011, then as the senior associate dean for faculty and research in 2013.

In his role as senior associate dean for faculty and research, Professor Hopp has primary responsibility for the school's academic and research affairs. His leadership in this role has made a profound impact including increasing the size and diversity of our faculty, increasing the level and stability of support for faculty research and our doctoral program, supporting a significant increase in sponsored research in both dollars and numbers of principal investigators, working with our centers and institutes to develop coordinated strategic and tactical plans for each of them, facilitating experiments with new technologies in the classroom, and helping to craft and articulate our school's new mission and pillars. Professor Hopp did all of this while

maintaining his own research productivity and teaching our full-time MBA core course in operations each year.

Professor Hopp's research contribution to the field of operations management is a framework of principles and models that are termed factory physics. In addition to having had a strong impact on the way production and operations management is taught in industrial engineering and business curricula, this framework has provided a rigorous scientific structure for research and practice related to lean manufacturing and supply chain management. His academic publications are many, varied and impactful. His early technical work broadened out over the years in many directions. He is well known for his work on applying queuing theory to manufacturing systems, including influential work on controlled Work in Progress systems (CONWIP) and his more recent work on assortment and supply chain management and workforce agility. He is currently expanding his research agenda to include issues of catastrophic failure in supply chains, innovations and social networks, and human resource management. He has published widely in the academic literature and is past editor-in-chief of the journal *Management Science*. Professor Hopp is co-author of the text Factory Physics, which was named the Institute of Industrial Engineers (IIE) Book of the Year in 1998, and is author of Supply Chain Science. He has won a number of teaching and research awards, including being named a fellow of INFORMS, IIE, the Society of Manufacturing Engineers, the Manufacturing and Service Operations Management Society and the Production and Operations Management Society. Finally, just this year, Professor Hopp was admitted to the prestigious National Academy of Engineering.







I am pleased to recommend the reappointment of Martin A. Philbert as dean, School of Public Health, for a second five-year term, effective January 1, 2016 through December 31, 2020. This recommendation follows an extensive reappointment review process.

Dean Philbert earned his B.Sc. degree in 1984 from the College of Arts and Technology in Cambridge (UK) and his Ph.D. degree in neurochemistry/experimental neuropathology from the London University (UK) in 1987. He was awarded a post-doctoral fellowship in the Neurotoxicology Laboratories at Rutgers University from 1988 to 1990, followed by an appointment as a research assistant professor. In 1995, he joined the University of Michigan faculty in the School of Public Health as an assistant professor of toxicology. He rose through the ranks to professor in 2004. He served as associate chair for research and development in the Environmental Health Sciences Department from 2000 to 2003. As senior associate dean for research from 2004 to 2010, Dean Philbert managed a major building and renovation project at the School of Public Health, while maintaining oversight of a broad range of administrative responsibilities in the school. He also served as interim director of the Center for Risk Science and Communication from 2004 to 2010.

Dean Philbert has maintained a continuously federally funded portfolio of basic research activities throughout his career. Most recently his work has been funded by the National Institutes of Health, the Department of Air Force and the National Cancer Institute. He is the author of more than 150 peer-reviewed scholarly manuscripts, abstracts and book chapters. He is an elected member of the Institute of Medicine of the National Academies of Science (USA), a fellow of the Royal Society of Chemistry (UK), a fellow of the Academy of Toxicological Sciences (USA) and a member of the Division of Earth and Life Sciences of the National Academy of Science (USA). He is the chair of the newly formed US-EPA Chemical Assessment Advisory Committee that provides peer review of risk assessments produced under the auspices of the EPA's Integrated Risk Information System and a standing member of the Agency's Science Advisory Board. Dean Philbert also served a four-year term on the National Advisory Environmental Health Sciences Council of the National Institute of Environmental Health Sciences and provides consultation to the federal agencies on a variety of issues surrounding emerging nanotechnologies, nanomedicine, health and safety.

Since becoming dean of the School of Public Health (SPH) in 2011, Dean Philbert has engaged faculty in developing a clear vision for the school focused on collaboration, innovation and global public health. He has enhanced the school's research productivity, its national and international visibility, and its educational mission through his commitment to providing a curriculum that addresses the needs of a new generation of public health graduates who understand methods for

improving the public's health in the global marketplace. Much of his success in these areas stems from the process he initiated early in his deanship to uncover ways to enhance innovation at SPH—the Innovation Action Plan. One translation of innovation into action has been in student social entrepreneurship; the Solutions to Public Health Challenges competition harnesses the talents of Michigan students to address public health problems. Dean Philbert has also excelled in creating cross-disciplinary research opportunities that enhance the faculty's success in competition for NIH grants; the Momentum Center, a university-wide research initiative to tackle childhood obesity is one example.

Dean Philbert's engaging and charismatic leadership motivates faculty, students, and staff to do their utmost on behalf of the School of Public Health. Given his broad vision of the school, I am confident that Dean Philbert will continue to lead by involving all members of the school's community in shared responsibility for diversity, inclusion, ideas, and innovation. I am pleased to recommend the reappointment of Martin A. Philbert as dean, School of Public Health, effective January 1, 2016 through December 31, 2020.

He has an established interest in diagnosis and treatment of *H. pylori* infection, the most important cause of peptic ulcer disease, and is an expert in clinical trial design. Dr. Chey has been well funded for his research through the NIH, industry, clinical trials, and foundation grants. He has made equally important contributions in functional bowel disease and he is described as one of a handful of thought leaders in this field. Dr. Chey has been very prolific in his field; he has

published 145 peer-reviewed articles, and has been invited to present his research on more than 200 occasions.

Dr. Chey is the director of the Gastroenterology Physiology Laboratory and is a co-director of the Michigan Bowel Control Program in the University of Michigan Health System. He is a co-editor-in-chief of the *American Journal of Gastroenterology* and *Clinical and Translational Gastroenterology*. Dr. Chey has served on the Data and Safety Monitoring Board for the NIH, a Planning Committee for the Veteran's Administration Cooperative Study, and on two Critical Path Institute Patient Reported Outcomes Consortia. His service is far-reaching; he is site director for the Clinical Training Program for GI fellows and junior faculty, and is a member of the Board of Trustees and Publications Committee for the American College of Gastroenterology.



The associate dean for global affairs and community engagement will be responsible for facilitating engagements with external constituents, and have a commitment to local and global partnerships in the areas of teaching, practice and research. Professor Lori has emerged as a key researcher on childbirth issues, midwifery programs, reproductive health, as well as in training programs focusing on interdisciplinary research. She has authored numerous articles, a majority data-based, published or in-press in peer reviewed nursing and interdisciplinary journals. Professor Lori has had 12-funded studies, including as principal investigator (PI), co-PI and co-investigator. This funding has been principally connected to her work with birthing women in Africa aimed to increase the capacity of midwifery and family planning in Ghana, Uganda, and Liberia.

Professor Lori is the current chair of the American College of Nurse-Midwives Division of Global Health, an appointed member of the University of Michigan (U-M) International Affairs Committee, a faculty associate of the U-M Center for Global Health, and a member of the U-M Council on Global Engagement. These positions, and her role as the U-M School of Nursing's



Randy J. Seeley received his Ph.D. degree from the University of Pennsylvania in 1993. He completed a fellowship at the University of Washington, and was appointed as a research assistant professor in psychology there in 1995. Dr. Seeley was appointed as an associate professor of psychiatry at the University of Cincinnati in 1997, and rose to the rank of professor in 2003. He jointly held an appointment as professor of internal medicine, and was director of the Cincinnati Diabetes and Obesity Center. Dr. Seeley joined the faculty at the University of Michigan in 2014, as a professor in surgery and internal medicine.

Dr. Seeley's research focuses on the actions of various peripheral hormones in the central nervous system that serve to regulate food intake, body weight, and the levels of circulating fuels. His recent work targets the identification of molecular underpinnings of the potent effects of bariatric surgery on weight and metabolism. Dr. Seeley has served on numerous NIH review panels and was chair of the Integrative Physiology of Obesity and Diabetes-review panel. Dr. Seeley has received numerous awards for his research, including the Outstanding Scientific Achievement Award from the American Diabetes Association in 2009.


Dr. Seeley is a very dynamic investigator in the field of energy metabolism and ingestive behavior. He is well-respected and accomplished, and an ideal holder for this professorship. Professor Yakusheva earned her B.S. degree from Kazakhstan State University in 1995, a Master of Science in economics from the University of Illinois in 1997, and a Ph.D. in economics from the University of Illinois in 2005. From 2005-2012, she served as an assistant professor in the Department of Economics at Marquette University College of Business Administration; she was promoted to associate professor, with tenure, in 2012. Professor Yakusheva's research is in the areas of health services research and health economics. She focuses on nursing in acute care and social network analysis. 





He is also exploring opportunities for potential collaboration between QCRI and Michigan researchers in the areas of data science, medical computing, and cybersecurity. He has developed a preliminary formal model of both the PHP and HTML codes that can be analyzed using techniques similar to those his research group at Michigan has successfully used in automated hardware verification. His goal for the coming year is to further refine this model and to build a prototype that can automatically check such codes to a) determine if they contain, or b) certify that they are free of XSS vulnerabilities. We believe the University of Michigan will benefit from his continued involvement in this initiative.


The Stephen M. 
The associate dean for specialty masters programs is responsible for oversight and coordination of our one-year specialty masters programs, currently our masters of accounting (MAcc); masters of science in entrepreneurship (MsE); masters of supply chain management (MSCM); and the masters of management (MM) recently approved by the Regents. 



Dr. Fitzbutler published a popular weekly newspaper, the *Ohio Falls Express*, in Louisville for the African American community from 1878 until approximately 1904. He passed away in 1901.




Amanda Sanford was born in Rhode Island in 1838. She moved to Scipioville, New York as a young girl. She completed one year at the Women's Medical College of Pennsylvania in 1869, and trained in Boston under Lucy E. Sewall. She was the first woman graduate from the University of Michigan Medical School in 1871. Her graduation thesis was on puerperal eclampsia and was a thorough review of this dire obstetrical complication which included original research, statistics and case studies. Dr. Sanford maintained her composure during graduation, even though some young men threw paper at her from the gallery during Dr. Henry F. Lyster's address. She later set up private practice in Auburn, New York, the first woman in that city to do so. In 1884, she married Patrick Hickey. Dr. Sanford passed away in 1894.


Dr. Sanford was a trailblazer for women in medicine, and established the University of Michigan Medical School as an institution for all-inclusive medical education. I am pleased, therefore, to recommend the establishment of the Amanda Sanford Hickey Collegiate Professorship in Internal Medicine, Medical School, effective February 1, 2015.



Dr. Leichtman was appointed as a clinical fellow and research fellow at Harvard prior to his appointment as an assistant professor at the University of Michigan in 1989. He rose through the ranks to professor in 2005, in the Department of Internal Medicine. Dr. Leichtman has held many administrative appointments throughout his career here, including his current position as co-director of the Transplant Nephrology Fellowship Program, as medical director of the Kidney Paired Donation Program, and as medical director of the Vascularized Composite Allograft Program.

Eliza Maria Mosher received her M.D. degree in 1875, and studied medicine in London and Paris from 1879-1880 with Amanda Sanford. She was the University of Michigan's first dean of women and was a professor of hygiene, sanitation, and home economics in the Department of Literature, Science, and the Arts from 1896-1902. Dr. Mosher was also the first woman to become a professor at the university. She practiced medicine in Poughkeepsie, New York, and served as resident physician, and later superintendent, of the Massachusetts Reformatory Prison. Dr. Mosher returned to private practice in Brooklyn following her service at the University of Michigan.

Dr. Mosher invented a kindergarten chair to promote better posture in schoolchildren. She took out patents on a bicycle seat, a subway bench, and a corset-like garment that did not impede breathing. She was senior editor of the *Medical Woman's Journal* from 1905-1928.

Dr. Mosher was known as the dean of American medical women. She attained national respect during her career of 52 years. This professorship will honor her achievements. I am pleased, therefore, to recommend the establishment of the Eliza Maria Mosher Collegiate Professorship in Internal Medicine, Medical School, effective February 1, 2015.

On the recommendation of John Carethers, M.D., the John G. Searle Professor and Chair of the Department of Internal Medicine, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the establishment of the Louis Newburgh Research Professorship in Internal Medicine, Medical School, effective February 1, 2015.

This professorship is being established through a gift from the Genzyme Corporation. It will support the research and clinical efforts of a faculty member in the Department of Internal Medicine. The appointment period may be up to five years and may be renewed.

Louis Newburgh joined the faculty at the University of Michigan in 1916 as an assistant professor, and rose to the rank of professor of clinical investigation in the Department of Internal Medicine. He was an expert on nutrition, diabetes, obesity, and other metabolic diseases. His research and treatment of patients with diabetes was considered revolutionary at the time, since insulin was not available. The treatment diet was high in fat, low in protein, and low in carbohydrates, to furnish an adequate diet in which the total available glucose was low enough to avoid glycosuria and the fatty acid-glucose ratio low enough to avoid ketosis. Dr. Newburgh was a phenomenal clinician who had deep compassion for his patients, but was always anxious to get back to his laboratory to increase his knowledge on the areas he was currently studying. He was described as persistent with a compulsive drive to seek the answer.


Dr. Newburgh published over 100 articles during his tenure, and remained at the University of Michigan until his official retirement in 1952. Timothy T. Nostrant received his M.D. degree in 1973 from the State University of New York in Buffalo, and completed an internship and residency in internal medicine, and a fellowship in gastroenterology at the University of Michigan. He was appointed as an instructor of internal medicine here in 1979, and rose through the ranks to professor in 1996.

Dr. Nostrant's research and clinical experience focused on the field of gastroenterology, with particular emphasis on the areas of injection treatment for esophageal motility disorders, cancer surveillance and prevention strategies, new endoscopic treatments for acid reflux disease, and new cytokine directed treatments for irritable bowel syndrome (IBS). He is well published with 100 articles in peer-reviewed journals. Dr. Nostrant is a highly respected clinician, who has received numerous awards, including recognition as a top doctor by the International Association of Internists in 2010, and the Outstanding Clinician Award from the University of Michigan Medical School.

Dr. Nostrant has held numerous leadership positions during his tenure at the University of Michigan, including as associate chief of the Division of Gastroenterology, from 1996-2013, and as associate chief of inpatient services and education from 1983-2013. 



Norman Radin received his Ph.D. degree in biochemistry from Columbia University in 1949. He completed a fellowship at the University of California, Berkley, and at the University of Texas Biochemical Institute in Austin. Dr. Radin came to the University of Michigan in 1960, where he worked for over 30 years, and trained many postdoctoral fellows and students. His research focused on cerebroside components, galactolipids, glycolipids, sphingolipids, and tumor cell metabolism. Dr. Radin invented many laboratory techniques and received nine patents on new chemicals. He wrote over 200 scientific papers, edited various biochemistry journals, and served on many study committees. Dr. Radin was appointed as a professor emeritus of neurochemistry and a research scientist emeritus at the University of Michigan in 1990. Throughout Dr. Radin's career he received several awards, including the Michigan Quest for Technology Award, and the Jacob Javitz Award for Neuroscience.


Dr. Radin passed away in 2013. His research has yielded many beneficial results, and continues to be instrumental in continuing research at the University of Michigan. Professor Fishman's commitment to teaching extends substantially beyond his own students. He shares creative ideas with faculty across campus who attribute their own innovation in large part to their collaboration with him. As one colleague states, "Much of what I do in my teaching owes to what I have learned from him. Barry is a trendsetter and a leader in undergraduate pedagogy on campus."



In 1988, the Board of Regents established the Arthur F. Thurnau Professorships to recognize and reward faculty for outstanding contributions to undergraduate education. Based on her extraordinary achievements, I am delighted to recommend that Professor Kirkland be designated a Thurnau Professor.

An award-winning teacher, Professor Kirkland has established a long record of excellence in teaching across all levels of the curriculum. Her teaching reflects her passion for intellectual exchange and a commitment to diversity that is grounded in her own scholarly activity. In classes on gender and politics and on disability and race policies, she successfully involves students in addressing real-world issues and enables them to make a tangible positive impact. As part of a Gender and Law course, her students researched the accessibility of Michigan's judicial bypass process for minors by surveying all 83 Michigan County courts. Their findings led to an official report distributed to the state courts and organizations, and resulted in policy changes and additional training for court employees. One student reported that the course "awakened me to see the world in a different light," and another recalled it as "the greatest experience of my undergraduate studies." Her mentorship of honors students and undergraduate theses has allowed numerous students to complete superlative work while significantly changing their academic career paths. Moreover, as a director of undergraduate studies, Professor Kirkland secured a grant for the Women's Studies department to establish new research initiatives that support students' learning activities. As one colleague writes, Professor Kirkland "is an exemplary teacher and a model to whom many in our Department have turned for concrete ideas and inspiration in their own teaching."



Professor Lassiter's former students describe his classes as life changing experiences and his teaching as a source of continuing inspiration. Winner of the 2004 Golden Apple Award, Professor Lassiter has excelled at teaching many of the department's large courses, including his signature offering, The History of American Suburbia. In this class, he encourages students to conceptualize familiar urban spaces in terms of their historical development, providing a variety of media for critical inquiry, such as popular songs, films, journal articles, memoirs, and historical novels. His teaching is not limited to the classroom, as Professor Lassiter is one of the department's most sought-after mentors for majors and honors theses. As one student notes, he "opened my eyes to see the world in a cosmopolitan way that I never knew was possible." His dedication to undergraduate education is reflected as well in his commitment to leading the transformation of the History curriculum. One of the most important contributions to this successful process was the creation of a methods course for majors, Doing History, which allows students to practice historical research under academic guidance. Additionally, his leadership has enhanced the diversity of the department's student demographics through the inception of courses that are more visible and hospitable for a wider variety of students. His example and service have transformed the culture of his department into one where corridor conversations about pedagogy flourish and faculty invest significant time and energy into creating new courses and improving old ones. As one of his colleagues summarizes, "Professor Lassiter makes all of us better teachers."

An admiring colleague states that Professor Semrau "is an exceptional teacher, one of the best I have ever observed in my 20 years of teaching." From one-on-one mentoring to the introduction of new, interdisciplinary courses and concentration areas, as well as innovative classroom practices and pedagogy, his commitment to critical thinking, practicality, and student engagement has been unparalleled. A winner of numerous teaching awards, Professor Semrau designs active learning tasks that require students to address real-world, challenging problems. After studying data and reports related to the old U.S. Steel South Works in Chicago, interdisciplinary teams of students in his Sustainable Cities course worked to prepare redevelopment plans taking into consideration a complex array of issues of sustainability, contamination, and legality. A student reports, "The final project was awesome," because it allowed students "to actually apply all the things we have learned throughout the term to a real-world situation." A member of the Graham Environmental Sustainability Institute, Professor Semrau was instrumental in creating the Graham Scholars Program, which provides outstanding students with an innovative, skill-building experience related to sustainability issues. Additionally, in his role as associate director of the Program in the Environment, he introduced a new minor in sustainability. He has approached the design of its curriculum, as he does his classes, from a perspective that encompasses an extraordinarily wide range of disciplines, from engineering to public health, law, and urban studies. Since its inception three years ago, the program has grown to an enrollment of over 500 undergraduate students, due in large part to his efforts.



In 1988, the Board of Regents established the Arthur F. Thurnau Professorships to recognize and reward faculty for outstanding contributions to undergraduate education. Based on his extraordinary achievements, I am delighted to recommend that Professor Wolfe be designated a Thurnau Professor.

Professor Wolfe's exceptional classroom pedagogy, teaching effectiveness, and educational innovations have been recognized by a number of awards. His masterful organization of lecture content and approachability are lauded by numerous students who report that Professor Wolfe is always ready "to help his students and does not stop until everyone's issues are resolved." In similarly enthusiastic terms, colleagues talk about Professor Wolfe's coordination of the sequence of undergraduate organic chemistry courses with an average enrollment of about 1,000 students per semester. As one colleague notes, "this is a leadership role that has a very large impact on the experience of thousands of students." Professor Wolfe's dedication to improving the undergraduate experience in STEM fields is reflected as well in his mentorship of new faculty and post-doctoral teaching introductory courses and his participation in curriculum development. He led a revision and refinement of the curriculum, including the development of a new suite of undergraduate-level special topics courses and an organometallic chemistry course, a critical and emerging interdisciplinary topic. Professor Wolfe has also been a major contributor to UM's efforts to recruit and retain a diverse student body. As a departmental representative in the M-Sci Academies program, he led the development of a new initiative aimed at recruiting talented students from underrepresented groups into a summer undergraduate research program. In addition, he meets frequently with them to provide advice and mentorship as students navigate the program. In describing Professor Wolfe, a student remarks, "Dr. Wolfe's passion for the subject was infectious. It made me constantly want to know more about organic chemistry and often led me to ponder questions outside and beyond the scope of the course in a way that I have never done for another subject."



Professor Sandvig is widely published in the top journals in his field, consistently presents his work at academic conferences and invited lectures, and has secured various external grants from the National Science Foundation, the MacArthur Foundation, and the Social Science Research Council. He was a visiting fellow at the Internet Institute at Oxford University (2002-2003), a fellow at the Stanhope Centre for Communication Policy Research in

London (2002), as well as a resident fellow (2009-2010) and a faculty associate (2010-present) at the Berkman Center for Internet and Society at Harvard University.

Professor Sandvig is an award-winning teacher who was noted at the University of Illinois as one of the "Teachers Ranked as Excellent by Their Students." He has taught a range of undergraduate and graduate courses. He uses a variety of pedagogical techniques to engage students and has experimented successfully with advanced undergraduate and graduate students in the same course. Professor Sandvig's service record consists of university service, service to external scholarly organizations, and public interest advocacy. He serves on numerous editorial boards, has served as an ad hoc reviewer for various journals and university presses, and is an associate editor of *The Information Society*. He also reviews proposals for various granting agencies and has helped organize national conferences in his field.

As a performing musician, the vast majority of Ms. Dixon's scholarly/creative work as a faculty member was as a performer: a soloist, accompanist, and in chamber groups. She used her expertise in piano pedagogy in professional service and outreach by providing clinics, workshops, and presentations in contemporary piano education to piano teachers in the community, state, and region. She was an active local and state member of the National Music Teachers Association serving as chair of the annual state collegiate competition and then for State Certification. She is currently a member of the Kirksville Arts Association and a former member of the Genesee Valley Council for the Arts and Art Reach of Mid-Michigan. Ms. Dixon is the recipient of the Distinguished Service Award at SUNY and Outstanding Advisor for student affairs.
