On the recommendation of the Executive Committee and governing faculty of the Gerald R. Ford School of Public Policy, we are pleased to recommend the appointment of Morela Hernandez as professor of public policy, with tenure, Gerald R. Ford School of Public Policy, effective August 30, 2021.

ACADEMIC DEGREES

Morela Hernandez received her BA in psychology magna cum laude from Rice University in 2001 and her PhD in business administration from Duke University in 2007.

PROFESSIONAL RECORD

Professor Hernandez was the Donald and Lauren Morel Associate Professor of Business Administration (with tenure) in the Leadership and Organizational Behavior area of the Darden Graduate School of Business at the University of Virginia (UVA). She was the academic director of behavioral research at Darden (BRAD Lab) and the co-founder of the Convergent Behavioral Science Initiative (CBSI). She had courtesy appointments at both the School of Medicine and School of Engineering and Applied Science at UVA. She was an assistant professor in the Business School at the University of Washington for seven years before moving to UVA in 2014.

SUMMARY OF EVALUATION

Professor Hernandez is an established behavioral scientist and social psychologist doing important work at the intersection of leadership, management, and diversity. She will contribute substantial depth and breadth to the Ford School's behavioral science expertise, which the faculty decided was a high priority for faculty growth. She is trained as a social and organizational psychologist, and thus adds depth to the knowledge in psychology theories and empirical methods. She conducts research on diversity, and will teach courses on diversity and leadership, for which there is very strong student demand and the school has been looking to fill for many years. The type of courses she has taught in the past – along with her very strong teaching evaluations – suggests that she will be an excellent teacher. She has won a number of awards for her teaching; the most notable is being selected for the 40 Under 40 Most Outstanding MBA Professors by Poets and Quants in 2016. She is enthusiastic to lead and build the school's new Leadership Initiative, a priority for the school. Finally, Professor Hernandez will contribute in a wide variety of ways to our diversity, equity, and inclusion mission

including through her demonstrated commitment to diversity in her research, teaching and service.

EXCERPTS FROM EXTERNAL LETTERS

Reviewer (A) “I was already familiar with some of her publications before conducting this review. In addition to my already positive impression of her work, those papers convince me that she is a talented faculty member who is contributing directly to the organizational behavior (OB) literature, as well as to interdisciplinary work mainly in social psychology that applies to OB principles. Overall, I think that Professor Hernandez is an outstanding scholar, on all important dimensions. I would recommend her appointment.”

Reviewer (B) “In sum, based on my review of her research and teaching record, it appears that Dr. Hernandez has established her identity as a scholar in the field of leadership and diversity and her research pipeline indicates that her contributions are likely to grow in the coming years. It also appears she will be a tremendous value-add to the teaching expertise at Ford School of Public Policy.”

Reviewer (C) “I also want to point out that Morela’s work is both rigorous and relevant. In terms of rigor, her papers typically contain multiple studies, and although it seems her primary methodology is the experiment, she uses field and archival methods as well, so she is well able to establish the validity and reliability of her findings. And in terms of relevance, as someone who studies and teaches leadership, and also currently holds a leadership position in my school, I enjoyed reading her papers as they clearly resonate with my own as well as students’ (MBA, executives) experiences with common traps or challenges of effective leadership.”

Reviewer (D) “Dr. Hernandez has won multiple awards for her research including best paper awards and an award for excellence in research from the Darden School. Her Google scholar citations show that she has received 3,393 citations for her work, 2,393 of which have come in the last five years. She has 8 papers with over 100 citations each, which is an indication that her work is consistently seen as valuable by scholars in the field. I compared her to a cohort of the very top scholars in the

field of Organizational Behavior who got their Ph.D. degrees in the same year or the following year. She would rank in the middle of this group of top scholars, which is a great achievement, especially since some of these individuals have already been promoted to Full Professor.”

Reviewer (E) “One thing that stands out for me when considering Dr. Hernandez’s work is that she has published both first-rate conceptual/theoretical work as well as rigorous empirical research using a range of methodologies. She has co-authored with a number of different people, which is also noteworthy. Further, her work addresses important and relevant issues for organizations, leaders, and society more broadly.”

Reviewer (F) “Across the body of work, Hernandez bring strong theory and methodological skills to research on what ultimately are very practical questions. Asking good questions is a scholarly superpower and in her case, I think gives her the ability to design research that is of strong practical and policy relevance. I note that Hernandez has done considerable executive education and written at least a dozen cases. These experiences suggest to me that she is grounded in organizational problems and aware of how to present and frame important issues. As her appointment is to the rank of Professor, I believe this ability to be not only conversant but well informed about issues of Practice and policy will aid her in making the public scholar contributions expected at this career stage.”

Reviewer (G) “In sum, Dr. Hernandez uses creative and innovative methods in the lab and the field to answer societally significant questions. She goes to great lengths to not only test her theorizing, but also to identify when, why, and how the theorized effects occur.”

Reviewer (H) “As you can see from all of these papers, the work of Professor Hernandez is creative, unique and important. Rather than pursue a niche that someone else has already carved out or tackle a small but relatively less impactful line of research, Professor Hernandez’s approach seems to be to ‘go large.’ She has developed new theories and constructs that have changed the way we think, and, in doing so has shed new insight on significant issues.”

On the recommendation of the Executive Committee of the School of Education, I am pleased to recommend the reappointment of Deborah Loewenberg Ball as the William H. Payne Collegiate Professor of Education, School of Education, for a five-year renewable term, effective January 1, 2021 through December 31, 2025.

This professorship was established in the Provost Office and was named the William H. Payne Collegiate Professorship in Education in December 2004. William H. Payne was the first chair of the “art and science of pedagogy” at the University of Michigan. When President James Angell created a special chair of the art and science of pedagogy in 1879, William H. Payne was an excellent candidate for the position. Professor Payne led the organizational work needed for the newly developed education department. Moreover, as chair, he was a distinctive innovator responsible for the formation of teacher education at Michigan. Principles he pursued include the special disciplinary preparation of teachers, equipping them to understand subjects in ways that would enable them to help others learn those subjects. This phenomenon is an enduring problem of teacher education that Professor Payne understood and sought to solve. A stipend funded from school resources will accompany this professorship.

Deborah Ball received her bachelor of arts, master of arts, and doctor of philosophy degrees from Michigan State University in 1976, 1982, and 1988, respectively. From 1975 to 1988, she was an elementary classroom teacher for the East Lansing Public Schools, and from 1988 to 1992 she was a third and fourth grade mathematics teacher at Spartan Village School in East Lansing. She joined Michigan State University in 1988 as an assistant professor and was promoted to associate professor in 1991. Professor Ball joined the faculty of the University of Michigan in 1996 as a professor. She was appointed as an Arthur F. Thurnau Professor in 2000. Professor Ball served as the dean of the School of Education from 2005 to 2016.


Professor Ball is an expert on teacher education, with a particular interest in how professional training and experience combine to equip beginning teachers with the skills and knowledge needed for responsible practice. Her research focuses on the nature and demands of communication, broadly defined, in the work of teaching mathematics that aims to develop strong mathematical identities in children. Defining her program of research is a commitment to understanding how teaching can disrupt legacies of oppression, systemic racism, and anti-Blackness in this country and to building broad capacity for using teaching as a powerful lever for justice.

Professor Ball is the founding director of TeachingWorks, working to ensure that all students have skillful teachers who are committed to and able to support their growth. She leads the development of teacher preparation and support that result in skillful beginning teaching that centers content learning and disruption of injustice and racism. Through national partnerships, TeachingWorks supports efforts to identify and learn practices of teaching that are particularly “high-leverage” for beginning and early career teachers and to support teacher educators in learning practice-based methods to prepare beginning teachers.

Professor Ball has authored or co-authored more than 150 publications and has lectured and made numerous major presentations around the world. Her research has been recognized with several awards and honors including the Felix Klein Medal for Lifetime Achievement in Mathematics Education Research, International Commission on Mathematics Instruction, and International Mathematics Union (2017). She has served on several national and international commissions and panels focused on policy initiatives and the improvement of education, including the National Mathematics Advisory Panel and the Michigan Council for Educator Effectiveness. She is a fellow of the American Academy of Arts and Sciences, the American Mathematics Society, and the American Educational Research Association, and an elected member of the National Academy of Education.



The dean of the School of Nursing is pleased to recommend the reappointment of Debra L. Barton as the Mary Lou Willard French Professor of Nursing, School of Nursing, effective June 1, 2021 through May 31, 2024.

The Mary Lou Willard French Professorship in Nursing was established in June 1999. The School of Nursing was the recipient of a generous gift from Mary Lou Willard French. This endowed professorship will continue to be used to further research focused on nursing care for cancer patients and their families. Appointments to this professorship may be up to five years and are renewable.

Debra Barton received her bachelor's degree in social work from the University of Illinois, Champaign-Urbana in 1979. She received her associate's degree in nursing from Parkland College in 1985; her masters of science in nursing, adult health from the University of Illinois, Champaign-Urbana in 1991; and her PhD in nursing from Indiana University in 2002. Professor Barton joined the faculty at the University of Michigan in 2014 as a professor of nursing, with tenure, in the School of Nursing, and as a professor of psychiatry, without tenure, in the Medical School. She was appointed as the Mary Lou Willard French Professor of Nursing in 2014. In 2018, she was appointed as the associate dean for research in the School of Nursing.

Professor Barton is a consummate researcher who is highly committed to advancing the science of symptom management in patients with cancer. She has furthered the frontier of knowledge by examining the underlying physiology of symptom presentation, and she has tested pharmacologic, behavioral, and complementary treatments for reducing a variety of symptoms, including chemotherapy-induced peripheral neuropathy, hot flashes, and fatigue. Professor Barton has conducted studies funded by the National Cancer Institute (NCI), its National Cancer Clinical Trials Network, the National Institutes of Health (NIH), National Institute of Nursing Research, the Breast Cancer Research Foundation, and the Department of Defense.

Professor Barton has published over 134 papers in a wide array of journals, including some of the most respected journals in oncology: *Journal of Clinical Oncology*, *Journal of National Cancer Institute*, *Clinical Pharmacology and Therapeutics*, *Cancer*, *Supportive Care in Cancer*, and *Oncology Nursing Forum*; 10 book chapters; and 46 research abstracts and proceedings. She has a reputation for excellence as a researcher, and her work is recognized by her peers at the national and international level. She is a fellow in the American Academy of Nursing, an honor that is based on her contribution to the field. Professor Barton's expertise as a scientist is recognized by her appointment to multiple NIH federal review panels and her prior role as editor-in-chief for the NCI PDQ® Supportive and Palliative Care information summaries. She has given 31 national and 26 international presentations.

Professor Barton is an outstanding citizen of the nursing community and has made impressive contributions to the nursing profession, and to the broader scientific community. Most notably, she has established a track record as a leader in scientific organizations at the national level including being a peer reviewer for the NIH, and leader within the ONS. She served as a leader in the American Society of Clinical Oncology, an interdisciplinary scientific organization with more than 30,000 members, most recently as a member of the supportive care guidelines advisory group member. She has been active in the Alliance for Clinical Trials in Oncology, a national clinical trials network sponsored by the NCI that consists of nearly 10,000 cancer specialists at hospitals, medical centers, and community clinics across the United States and Canada.



The dean of the School of Nursing is pleased to recommend the reappointment of Jody R. Lori as associate dean for global affairs and community engagement, School of Nursing, for a three-year term, effective July 1, 2021 through June 30, 2024.

Jody Lori earned her Bachelor of Nursing Science and her Master of Science in nursing degrees from the University of Michigan in 1980 and 1992, respectively. She received her Doctor of Philosophy in nursing from the University of Arizona in 2009. She is a certified nurse midwife. She was appointed as the associate dean for global affairs and community engagement in 2015.

She has authored numerous articles, a majority databased, published or in-press in peer reviewed nursing and interdisciplinary journals. Professor Lori has been the principal investigator (PI), co-PI and co-investigator.

Professor Lori has been an invaluable asset to the School of Nursing with her efforts to reignite the global affairs agenda of the school by introducing innovative ideas. I am pleased to recommend the reappointment of Warde Manuel as the Donald R. Shepherd Director of Intercollegiate Athletics, effective March 14, 2021 through June 30, 2026.

With the support of Mr. Manuel's leadership as the athletic director, Michigan Athletics has excelled in the classroom and on the fields of play. Michigan set an athletic department record with its 2020 NCAA Graduation Success Rate (GSR) report with a four-year average GSR of 94 percent and 15 of the 25 varsity athletic programs earning perfect GSR scores. A school-record of 405 student athletes were recognized in the 2019-20 academic year as Academic All-Big Ten Conference, which goes to student athletes who carry a cumulative GPA of 3.0 or above.

In the realm of athletic competition during Mr. Manuel's tenure as the athletic director, Michigan has won 40 Team Conference Championships, nine individual NCAA Champions, a Women's NIT Championship in 2017, and national runner-up finishes in women's cross country (2016), men's basketball (2018), and baseball (2019). In 2019, Michigan achieved a second-place national finish in the NACDA Director's Cup, marking the highest ranking ever for UM in this overall honor for collegiate athletic achievement.

Off the field, Mr. Manuel revamped the Athletic Department's Diversity, Equity, and Inclusion Strategic Plan, highlighted by a five-year strategic vision around education and student-led opportunities. He has championed the voices of student athletes and empowered student leaders in 2020 to launch the department's initiative for unity and diversity through sport, leading to unified messages for Social Justice Awareness on all UM uniforms. He is one of 16 UM representatives on the Big Ten Conference Anti-Hate and Anti-Racism Coalition.

Mr. Manuel is a three-time Michigan alumnus and two-sport athlete who played football under Bo Schembechler. Prior to Mr. Manuel's return to the university, he spent nearly four years as the director of athletics at the University of Connecticut. Under his leadership, the University of Connecticut's teams won six NCAA national championships and several teams posted perfect single-year scores in the NCAA's Academic Progress Rate, marking a dramatic academic improvement at the school. From 2005 to 2012, Mr. Manuel led a 20-sport program at the State University of New York (SUNY) at Buffalo. From 1996-2005, Mr. Manuel served in several


roles within Michigan's athletic department. In 2000, he was appointed as an associate athletic director with oversight responsibility for operational facets of the university's athletic program including Michigan's football and men's basketball programs.

Mr. Manuel has been recognized for a number of awards, including the Under Armour Athletic Director of the Year by the National Association of Collegiate Directors of America in 2015 and the Opportunity Award by the Women's Sports Foundation in 2007. Over the course of his career, he also served on a number of national and athletic conference committees and boards.

Mr. Manuel has earned three degrees from the University of Michigan: BGS (1990); MSW (1993) and MBA (2005). From 1990-1993, he was a coordinator of the university's Wade H. McCree Jr. Incentive Scholarship Program.



She is currently working on case-control studies of gene-environment interaction, two-phase studies, and longitudinal studies. Her methodological research is funded by NSF and NIH. Professor Mukherjee is involved as a co-investigator in several R01s led by faculty in internal medicine, epidemiology and environment health sciences at the university. Her collaborative interests focus on genetic and environmental epidemiology, ranging from investigating the genetic architecture of colorectal cancer in relation to environmental exposures to studies of air pollution on pediatric asthma events in Detroit. It is clearly evident that her research is of very high caliber, is relevant to practical problems, and is prolific.

Professor Mukherjee received the Excellence in Teaching Award from the School of Public Health in 2012 and was a 2015 recipient of the University of Michigan Faculty Recognition

Award. She is an elected member of the International Statistics Institute and a fellow of the American Statistical Association.

Professor Mukherjee is a highly respected colleague who will provide strong and effective leadership for the department. With the endorsement of the School of Nursing, we are pleased to recommend the reappointment of Michelle L. Munro-Kramer as the Suzanne Bellinger Feetham Professor of Nursing, School of Nursing, effective June 1, 2023 through May 31, 2024.

The Suzanne Bellinger Feetham Professorship in Nursing was established in May 2012. Suzanne Bellinger Feetham is an alumna of the University of Michigan School of Nursing and is an internationally recognized leader who has affected policy change through her leadership positions in academia, health systems and the Federal government.

Michelle Munro-Kramer received a BSN with a specialization in health promotion in 2003 from Michigan State University. She received a MS with certifications as a family nurse practitioner and nurse midwife, and a PhD in nursing and women's studies certificate from the University of Michigan in 2006 and 2013, respectively. She joined the faculty at the University of Michigan School of Nursing in September 2015 as an assistant professor. She was appointed as the Suzanne Bellinger Feetham Professor of Nursing in 2019.

Professor Munro-Kramer's program of research focuses on trauma, comprehensive care of vulnerable populations, and missed opportunities for care within domestic and international contexts. Her research projects approach these topics using a trauma-informed and patient-centered lens. She uses mixed methods and participatory action research to understand the experiences of vulnerable populations in order to inform future intervention development. Professor Munro-Kramer is currently adapting and piloting a web-based app focused on healthy relationships and sexual violence using a life skills perspective. She is also working on adapting and piloting a primary prevention sexual violence intervention to the University of Cape Coast in Ghana. Her global health fieldwork has included Ethiopia, Ghana, Liberia, and Zambia.

Professor Munro-Kramer has established a reputation as an expert in gender-based violence as reflected by the following invitations. She was invited to join the Michigan Domestic and Sexual Violence Prevention and Treatment Board as an expert in sexual violence. This

organization will be developing and delivering statewide training for therapists/counselors. She was invited to give a presentation to a large group of retirees at the Osher Lifelong Learning Lecture Series and to be a keynote speaker at the Michigan Abolitionist Project's Empower Conference.

Professor Munro-Kramer developed the first undergraduate elective course at the university focused on gender-based violence, Gender-Based Violence: From Theory to Action (HS 404/WS 404). The course is cross-listed to include students from across the campus and incorporates lectures as well as experiential hours where students apply the principles from the course by attending community events and trainings related to gender-based violence. Professor Munro-Kramer received funding to gather a group of faculty on campus to discuss teaching about gender-based violence using engaged learning. She also does regular guest lectures on screening for intimate partner violence in practice, sexually transmitted infections, postpartum care, and reproductive health physiology.

I am pleased to recommend the reappointment of Kenneth Resnicow as the Irwin M. Rosenstock Collegiate Professor of Public Health, School of Public Health, effective February 1, 2021 through May 31, 2025.

This professorship was established through the Provost Office and was named the Irwin M. Rosenstock Collegiate Professorship in Public Health in December 2010. A stipend from school resources will accompany this professorship.

Professor Rosenstock provided leadership in developing the school's research and teaching program in health behavior and health education. He was internationally known for being one of the developers of the Health Belief Model, a theory to explain health-related behavior that is widely applied today in public health interventions.

Kenneth Resnicow holds a B.A. (1980) in psychology and philosophy from Yeshiva College and a Ph.D. (1985) in health psychology from Albert Einstein College of Medicine and the Ferkauf Graduate School. From 1985-94, he served as a senior research scientist, in the Division of Health Promotion Research at the American Health Foundation, while also serving as an adjunct assistant professor in the Department of Health Education at Columbia University Teachers College. Professor Resnicow joined the faculty at Emory University Rollins School of Public Health in 1995 as an associate professor and was promoted to professor in 1999. He joined the University of Michigan faculty in 2003 as a professor of health behavior and health education.

Professor Resnicow is a highly successful and productive behavioral sciences researcher well recognized both nationally and internationally. He is an internationally recognized expert in design and evaluation of health promotion interventions and motivational interviewing (MI) and is a leading expert in conceptualizing and designing culturally sensitive community-based interventions for health promotion. He is also an expert in community-based interventions for

nutrition, physical activity, and smoking prevention in minorities. Professor Resnicow specializes in theory-based tailoring including ethnic identity and self-determination theory. His research interests include the design and evaluation of health promotion programs for special populations, particularly cardiovascular and cancer prevention interventions for African Americans; understanding the relationship between ethnicity and health behaviors; and motivational interviewing for chronic disease prevention.

Arun Agrawal received his doctorate in political science from Duke University in 1992. He was an assistant professor at the University of Florida (1993-1997) and Yale University (1997-2002) before being promoted to an associate professor at Yale (2000) and continuing on as an associate professor at McGill University (2002). He joined the Michigan faculty as an associate professor, with tenure, in 2003 and was promoted to professor in 2008.


Professor Agrawal's research focuses on international development, sustainability and environment, and natural resource governance, all of which are viewed from a political science lens. He has written critically on indigenous knowledge, community-based conservation, common property, population resources, and environmental identities. In addition to his two published books, Professor Agrawal's recent work has appeared in *Science*, *Proceedings of the National Academy of Sciences*, *Conservation Biology*, and *Development and Change*, among other journals.

Professor Agrawal teaches a large number of undergraduate and graduate courses in the School for Environment and Sustainability. In addition to his continuing mentoring of graduate students, he would like to help train students whose interests in environmental issues and development-related topics intersect with his research interests. Professor Agrawal may enhance these student interactions by serving on these students' committees or working as an advisor to undergraduate students. There is also potential to cross-list his courses for even further interaction with political science students.







On the recommendation of Dee E. Fenner, M.D., the Bates Professor and chair of the Department of Obstetrics and Gynecology, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Sawsan As-Sanie, M.D., M.P.H. as the Robert K. Ferguson and Virginia A. Ferguson Professor of Obstetrics and Gynecology Medical School, effective March 1, 2021 through August 31, 2026.

The Robert K. Ferguson and Virginia A. Ferguson Professorship in Obstetrics and Gynecology was established in 2019 through a generous gift from the Robert K. Ferguson and Virginia A. Ferguson estate. It is intended that the holder will be a faculty member in the Department of Obstetrics and Gynecology who is committed to providing exceptional clinical care to women while teaching and mentoring medical students and residents. The appointment period is up to five years and may be renewed.

Sawsan As-Sanie received her M.D. degree in 1998 from Johns Hopkins University. She completed a residency in obstetrics and gynecology at the Cleveland Clinic at Case Western Reserve in 2002. Dr. As-Sanie was appointed as a clinical lecturer in 2003, and completed a National Institute of Child Health and Development (NICHD) T32 fellowship in reproductive health, and a fellowship in minimally invasive gynecologic surgery and chronic pelvic pain in 2005 at the University of North Carolina, Chapel Hill. She concurrently completed an M.P.H. degree in 2004, also at that institution. Dr. As-Sanie was appointed as a K12 Building Interdisciplinary Research Careers in Women's Health (BIRCWH) scholar and a lecturer in the Department of Obstetrics and Gynecology at the University of Michigan in 2005. In 2008, Dr. As-Sanie was appointed as an assistant professor and, in 2017, was promoted to associate professor.

Dr. As-Sanie focuses clinically on the comprehensive care of women with complex gynecological conditions, including endometriosis, chronic pelvic pain, uterine fibroids, abnormal uterine bleeding and benign ovarian masses. She is the most experienced endoscopic and robotic surgeon in benign gynecology in the Department of Obstetrics and Gynecology and provides high quality care to women with advanced pelvic pathology. Her research focuses on the promotion of improvements in the healthcare of women with chronic pelvic pain and endometriosis, by pursuing clinical and translational research in the epidemiology, physiology, and treatment of endometriosis and other pelvic pain disorders. Dr. As-Sanie is particularly interested in elucidating the mechanisms involved in the


initiation and maintenance of chronic pelvic pain and post-surgical pain, with a focus on endometriosis-associated pelvic pain. She has been well-funded for her research through the NIH, foundations and institutional grants. She is currently a co-principal investigator of an NIH R01 grant that investigates how the peripheral and central nervous system correlates with persistent post-hysterectomy pain.

Dr. As-Sanie has forged an important collaboration with Dr. Daniel Claw, an internationally recognized pain researcher and the director of the University of Michigan Chronic Pain and Fatigue Research Center. Through this collaboration, she has led several studies that were the first to conclusively demonstrate that a centralized pain phenotype, similar to fibromyalgia, is present in some women with endometriosis and/or chronic pelvic pain (CPP). Her research group was the first to publish functional neuroimaging data that provides insight into the underlying neurobiological mechanisms of CPP. Dr. As-Sanie has published 62 peer-reviewed articles, and is a highly-sought after speaker, with 84 national, regional, and international presentations to her credit, including in Italy, South Africa, Turkey and Spain.

Dr. As-Sanie has exceptional service contributions, including her role as the director of the University of Michigan Endometriosis and Chronic Pelvic Pain Center since 2005. She was appointed as the fellowship director for Minimally Invasive Gynecologic Surgery in 2009, and the director of Minimally Invasive Gynecologic Surgery in 2011. She was also appointed as the co-division chief of the Department of Gynecology in 2019. Dr. As-Sanie has received numerous awards for her teaching, including the Silver Speculum Award in 2014 and 2020, and the Token of Appreciation from Medical Students in 2018. She is an elected member of the American Gynecologic and Obstetrical Society, and received the Endometriosis Special Interest Group Prize Paper award from the American Society for Reproductive Medicine in 2020.

Dr. As-Sanie has demonstrated excellence as a clinician, researcher, and scholar. She has strong service institutionally, nationally and internationally, and is well-respected as an educator. She is a fitting candidate for this prestigious professorship. I am pleased, therefore, to recommend the appointment Sawsan As-Sanie, M.D., M.P.H. as the Robert K. Ferguson and Virginia A. Maya Barzilai received her doctorate from University of California, Berkeley in 2009. She joined the Michigan faculty in 2009 as an assistant professor and was promoted to associate professor, with tenure, in 2017.

Professor Barzilai researches modernist Hebrew, German, and Yiddish literature, twentieth-century German Jewish thought, translation theory, and Weimar film. Her first book, Golem: Modern Wars and Their Monsters (NYU Press, 2016), is a cross-cultural and intermedial study of the clay golem, traditionally an animated servant or protector. Her work on the golem narrative in twentieth-century film and literature led to another book publication, a short manuscript entitled The Golem, How He Came into the World, which appeared in the German Film Classics Series at Camden House (2020). Her current scholarship focuses on the processes of translation that formed and informed Hebrew writing in the early to mid-twentieth century. She is currently working on a third manuscript, entitled Translation beyond Zionism: Hebrew-German Literary Exchanges, which explores how Hebrew-German scriptural translation continued to shape twentieth-century literary translation discourses and practices, from and into Hebrew. In recent years, Professor Barzilai has been presenting and publishing collaborative work with colleagues at other institutions and has published peer-reviewed essays in Hebrew, enhancing her presence in Israeli academia and forging ties with research groups at Tel-Aviv University and Ben-Gurion University.


Professor Barzilai has played a strong mentoring role to graduate students in the Department of Comparative Literature over the last decade and many graduate students apply to the department

with the goal of working under her supervision. Professor Barzilai has become an important and deeply appreciated interlocutor for faculty and graduate students alike. Her expertise in critical translation studies is particularly welcome, as the department has been steadily expanding its offerings and activities in that field. Her graduate seminars such as “The Task of the Self-Translator” and “Sacred Languages, Secular Translations” have been cross-listed in the Department of Comparative Literature. Additionally, Professor Barzilai is a participant in the department’s ambitious Mellon-funded Sawyer Seminar dedicated to translation in the multilingual Midwest, where she is slotted to lead one of the workshops.

Since 2017, she has served on the Translation Studies Committee, and helped award prizes for undergraduate translation projects, approve graduate student capstone projects, and provide feedback on post-doctoral job applications. 
Nicolas Cornell received his Bachelor of Arts in philosophy from Harvard University in 2004, his Juris Doctorate from Harvard Law School in 2010, and his doctorate in philosophy from Harvard Law School in 2014. Following an appointment as an assistant professor at the Wharton School of the University of Pennsylvania, Professor Cornell joined the Michigan faculty in the Law School in 2017 as an assistant professor and was promoted to professor, with tenure, in 2020.

Professor Cornell teaches and writes in the areas of contract law, moral philosophy, remedies, and private law theory. His work seeks to connect issues in normative ethics with questions about the foundation of private law doctrine. His work has appeared in peer-reviewed philosophy journals, including “The Possibility of Preemptive Forgiving” (*Philosophical Review*, 2017) and “Wrongs, Rights, and Third Parties” (*Philosophy and Public Affairs*, 2015) as well as top law reviews including “A Complainant-Oriented Approach to Unconscionability and Contract Law” (*University of Pennsylvania Law Review*, 2016) and “A Third Theory of Paternalism” (*Michigan Law Review*, 2015).

On the recommendation of the Executive Committees of the Department of Political Science and the College of Literature, Science, and the Arts, and with the endorsement of the Gerald R. Ford School of Public Policy, we are pleased to recommend the appointment of Christian Davenport as the Mary Ann and Charles R. Walgreen, Jr. Professor for the Study of Human Understanding, College of Literature, Science, and the Arts, for a five-year renewable term, effective January 1, 2021 through December 31, 2025.

As a result of a generous gift from Charles R. Walgreen, Jr., the Mary Ann and Charles R. Walgreen, Jr. Professorship for the Study of Human Understanding was established by the Regents in 1968. The occupant of the professorship is allowed wide discretion in the development of an instructional program at either graduate or undergraduate level, and is to be permitted adequate opportunity for research, writing, public lectures, and service with public or private agencies concerned with the development of understanding between people. The professorship has been awarded to distinguished members of the faculty from a number of different departments. Appointments to this professorship may be up to five years and may be renewed.

Christian Davenport received his doctorate in political science from Binghamton University in 1992. He was an assistant professor at the University of Houston (1992-1996) before being promoted to an associate professor at the University of Colorado, Boulder (1996-1999). He continued on as an associate professor at the University of Maryland, College Park in 1999 and was promoted to professor in 2006 where he stayed until he joined the faculty at the University of Notre Dame (2008-2012). Professor Davenport joined the Michigan faculty as a professor, with tenure, in 2012. He is also a faculty associate at the Center for Political Studies and a research professor at the Peace Research Institute Oslo.

Professor Davenport's research focuses on three related topics: violent conflict within states; state repression; and human rights. Professor Davenport is unmatched among political scientists in developing data that enable the systematic study of heretofore hidden populations. He has published four single-authored books, three edited volumes, 48 peer-reviewed articles, one special issue, 12 articles in edited volumes, and has three books underway. His work has been cited over 8,300 times and among his top most cited works are pieces centering on state repression, human rights violations, the Black Panther Party, the policing of protest movements in the U.S., and contentious politics more generally. Professor


Davenport has won a huge array of awards, ranging from his first award in 1992, the Keeper of the Flame Award given by the Malcolm X Lovers Network, to his 2018 election as a fellow, American Academy of Arts and Sciences.

Professor Davenport's classroom teaching centers on his research topics and for many students, the experience in his classroom is life-changing. He carries his teaching outside of the classroom and outside of the university. Most notably, his co-taught course grew into a podcast, "A Pod Called Quest," a podcast that discusses injustice and solutions to injustice. Professor Davenport is deeply committed to diversifying the discipline. He built a mentorship community for African-American scholars in comparative politics and international relations. Professor Davenport is a constant and effective force in this work both within the department and the discipline at large.

In the Department of Political Science, Professor Davenport builds institutions to study topics between comparative politics and international relations. He has built the Conflict, Peace, Research and Development Group, which is a powerful group of faculty, graduate students, and undergraduates who examine questions of state repression and violence, civil wars, ethnic conflict, and the like. This is an active and engaged group that quickly becomes part of these scholars' identities; over the last five years, graduate students from this group have gone onto tenure track positions at Georgia Tech, Dartmouth, the London School of Economics, Emory, and Washington University. Professor Davenport is currently serving on three dissertation committees and regularly supervises tremendously successful senior theses in the department.



Professor Griffin began his instructional career as an assistant professor at Denison University in 2012, and was promoted to associate professor in 2018. He joined the Michigan faculty as an associate professor, with tenure, in 2020.

Professor Griffin is a leading interdisciplinary scholar in the areas of U.S television media and sexuality studies with a topical emphasis on LGBTQ+ audiences. He researches questions of transmedial aesthetics, power, and identity formation, drawing on queer theory and sexuality studies along with textual analysis and archival research. His book, Feeling Normal: Sexuality and Media Criticism in the Digital Age, presents five chronologically organized chapters establishing the 1990s as a critical transitional moment for both LGBTQ+ sexual cultures and the move from analogue to digital circuits of production and consumption. Professor Griffin currently has two manuscripts in progress and has published eight peer-reviewed journal articles, with two under review at *New Media and Society* and the *International Journal of Cultural Studies*, along with four book chapters. He has held a leadership role with the Society for Cinema and Media Studies, the primary professional organization for members of the film, television, and media community. Professor Griffin's theoretical and methodological approach to the study of media is anchored in the humanities and like many faculty in the department, he is invested in questions of justice as they pertain to media cultures.

Professor Griffin's contribution to the Department of Film, Television, and Media will broaden the department's courses in the area of gender, sexuality, and media, one of the most popular topics for both graduate and undergraduate students. Graduate students have already been in contact with him to include him as part of their dissertation committee. Professor Griffin is very active in the field of media studies, having served as an associate editor for the journal *Communication, Culture, and Critique*, as well as on the editorial boards of *Film Criticism* and *Queer Studies in Media & Popular Culture*. 



This work is highly innovative and provides substantial promise to and hope to individuals who otherwise face incredible fear about with the onset of what may signal a progressive and unrelenting cognitive and functional decline. He is well-funded through the NIH, foundations and institutional grants. Dr. Hampstead has published 61 peer-reviewed articles, and has been invited on numerous occasions to present his research nationally and internationally.

Dr. Hampstead's work is held in very high esteem within the Department of Psychiatry, the Michigan Alzheimer's Disease Research Center (ADRC), and among national and international

peers who conduct research on cognitive impairment and dementia. In addition to his critical role as the clinical core leader of the ADRC, he has played a critical role in optimizing the partnership of the Michigan ADRC with Michigan State University, Wayne State University, and the Michigan Center for Urban African-American Aging research. These collaborations ensure that the work of the ADRC better reflects the broad, diverse population affected by the dementias, and better incorporates a diverse and representative group of research subjects in the work of the ADRC. Only in this way will research findings be more widely generalizable. The effort to reduce health disparities, particularly in minority and other underserved populations, is a critical imperative and major challenge we face in all areas of medicine. Dr. Hampstead and his team are helping to reduce and address those disparities in the aging segment of the population.

At the departmental level, there is a high investment in research work, which seeks to study the neurobiologic underpinnings of brain disorders including major psychiatric illnesses, cognitive impairment and the dementias. It is important to understand the impact of these disorders on the individual, their caregivers and the community, and to support translational work that develops better treatments to improve the functional ability of individuals dealing with related conditions. Dr. Hampstead is an exemplar of faculty who does that type of translational work and has been importantly placed in such a key role in the Department of Psychiatry and in the Michigan Alzheimer's Disease Research Center (ADRC). I am pleased, therefore, to recommend the appointment Benjamin Hampstead, Ph.D. as the Stanley Berent, Ph.D. Collegiate Professor of Psychology, Department of Psychiatry, Medical School, effective February 1, 2021 through August 31, 2026.



The dean and the Executive Committee of the School of Dentistry are pleased to recommend the appointment of Hera Kim-Berman as the Robert W. Browne Professor of Orthodontics, School of Dentistry, for a five-year renewable term, effective January 1, 2021 through December 31, 2025.

This Robert W. Browne Professorship in Dentistry was established in February 2002 by a gift from Dr. Robert W. Browne, a distinguished School of Dentistry alumnus and supporter. In February 2020, this additional endowed professorship was established. The intent of the initial professorship is that it be used as a rotating title, to be awarded to a selected School of Dentistry faculty member for a period of five years, with renewable terms possible. This additional endowed professorship in orthodontics will adhere to the same guidelines.

Hera Kim-Berman earned her DDS from State University of New York at Stony Brook School of Dental Medicine, her Certificate in Orthodontics from Harvard School of Dental Medicine in 1994, and her Masters of Medical Science in Oral Biology from Faculty of Medicine, Harvard University. From 1992-1994, she was a visiting scientist at Massachusetts Institute of Technology Materials Science and Engineering. From 1994-1997, she was an assistant professor, and from 1997-1998, an associate professor in the Department of Orthodontics at West Virginia University. From 1998-2014, Professor Kim-Berman worked in private practice in Bayside, New York. In 2014, she joined the University of Michigan School of Dentistry as a clinical assistant professor, and in 2020, she was promoted to clinical associate professor.

Professor Kim-Berman is leading educational activities in virtual reality across the school. She has created a virtual dental library of human teeth that allows students to view the virtual contents from anywhere. In these studies, she has collaborated with the College of Engineering, external enterprises, and faculty colleagues to create an educational tool based on a virtual reality patient for corrective jaw surgery. Her interest in digital dental technology has led her to be an emerging global leader in the use of virtual reality and 3-D printing for dental education. Since joining the University of Michigan, she has received two university grants, and four private industry grants, to investigate the use of these technologies and their effect on student learning. The results of these projects have led to nine publications and one book chapter. Professor Kim-Berman has been invited to give numerous research seminars and lectures at the national and international levels on dental topics

using virtual reality approaches. She has presented multiple continuing education courses relating to dental orthodontics, cleft lip, and palate treatment at the state, national and international levels, and has one patent on an extra oral nasal molding headgear appliance for treatment of cleft lip and palate patients.


Professor Kim-Berman is the program director of Graduate Orthodontics, program director of Graduate Pediatric Orthodontics, and has served multiple times as the interim clinic director of Graduate Orthodontics. She also serves as the director of Continuing Education in the Department of Orthodontics and Pediatric Dentistry. Professor Kim-Berman serves on numerous department and school level committees including five faculty search committees, is the chair of the Graduate Orthodontics Admission Committee (2016-present), and is a member on the Craniofacial Fellow Admissions Committee (2016-present). She is a journal reviewer for the *Journal of Dental Research*, *Journal of Dental Education*, *The Angle Orthodontist*, and the *American Journal of Orthodontics and Dentofacial Orthopedics*. Professor Kim-Berman is on the Commission on Dental Accreditation as a site visitor for Orthodontics and Dentofacial Orthopedics, Clinical Fellowship.

Professor Kim-Berman is highly regarded by students and peers for her dedication, expertise and knowledge. At the School of Dentistry, she has been involved in seventeen didactic and clinic orthodontic and pediatric dentistry courses at the graduate student level, of which she has served as course director for twelve. She has restructured numerous courses to enhance the student learning experience and has developed two new courses to meet emerging demands and ensure the School of Dentistry remains at the forefront of graduate orthodontic education.

Her expertise as a highly effective educator in orthodontic and cleft palate treatments, paired with her interest in virtual reality in dental education sets her at the cutting edge of new and exciting ways that dental students around the globe will learn dentistry in future years. As a result of her national recognition as a superb orthodontist, she recently was accepted in the Edward H. Angle Society, Eastern Component, a prestigious orthodontic society that strives to promote excellence in orthodontics and foster, support, encourage, and advance the dental profession and the profession of orthodontics.

Over the past six years, she has vastly expanded efforts to engage UM students and faculty in mathematics outreach programs for K-12 students in surrounding areas. These efforts both redress educational inequities and bring more diverse students to UM. Her current role as the director of the notoriously challenging Honors Math sequence has made those classes a place of mutual respect. As one student says, it is “too easy for math to become a competition of cleverness and speed, and Professor Koch makes sure students know such attitudes have no place in her classes.” This welcoming attitude, along with her outreach and encouragement, has created a culture that shows undergraduates that the “mathematics community is a fun, vibrant, and magical place - it’s alive.”

Since 2005, Professor Lewis has collaborated with faculty colleagues on creating programs that draw students into interdisciplinary quests to understand the human mind. A central figure in creating the cognitive science undergraduate major, he has directed the Weinberg Institute which houses it since 2017. Drawing on courses in Computer Science, Linguistics, Psychology, and Philosophy, the new program has become one of the top 15 majors in LSA in just six years. Remarkably, its growth has not drawn students away from existing majors. Instead, it is welcoming and empowering new students to explore these fields, especially women. In addition to playing administrative roles, Professor Lewis designed the major's gateway course, Cogsci 200, a unique feature of which is that students actually learn to use and apply advanced algorithms that are central to the field from the outset of their studies. Professor Lewis's innovations also include arranging central campus peer tutoring for particularly challenging computer science courses and exploring the human side of science by discussing the lives of scientists and the contributions of Michigan students and faculty to the field. The following student comment is typical, "I am leaving the course with a strong understanding of this field, pride in my school (shoutout to all of the incredible faculty and alumni that are pioneers in the field), and excitement for my future."

The dean and the Executive Committee of the School of Dentistry are pleased to recommend the appointment of Noriaki Ono as the James E. Harris Collegiate Professor of Dentistry, School in Dentistry, for a five-year renewable term, effective January 1, 2021 through December 31, 2025.

The James E. Harris Collegiate Professorship in Orthodontics was established in October 2008. James E. Harris had a long and strong relationship with the University of Michigan stretching over six decades as a student, faculty member, chair and an alumnus. Professor Harris earned his AB in anthropology in 1950 and his DDS in 1954 from the University of Michigan. He completed his MS in human genetics in 1960 and another MS in orthodontics in 1963 after which he became an assistant professor in the School of Dentistry. He rose quickly through the ranks to professor and chair of the Department of Orthodontics in 1968, a position he held for fourteen years.

Noriaki Ono earned his DDS in 2003 and his PhD in Philosophy in 2007 from Tokyo Medical and Dental University. In 2012, he became an instructor in the Endocrine Unit at Massachusetts General Hospital and Harvard Medical School. In 2014, he became an assistant professor at the University of Michigan School of Dentistry and was promoted to associate professor in 2020.

Professor Ono's research focuses on the fundamental characteristics of skeletal stem cells that play important roles in bone growth, maintenance, and repair, with the ultimate goal of having an impact on bone regeneration. He has been awarded \$2.8 million in federal funding since being at the University of Michigan and has thirty-six peer-reviewed publications in high impact journals such as *Bone*, *Nature Cell Biology*, *Cell Stem Cell*, *Journal of Clinical Investigation*, and *PNAS*. He has eight book chapters, 64 abstracts and has been invited to speak at sixteen national and international professional meetings such as the 9th International Orthodontic Congress, American Society for Bone and Mineral Research Annual Meetings, and European Calcified Tissue Society Annual Congress. He has been invited to present at eighteen conferences at other institutes and universities and four at the University of Michigan. Professor Ono has developed collaborations within the School of Dentistry, the Center of Organogenesis, and the Michigan Integrative Musculoskeletal Health Core Center. Professor Ono is a creative and ambitious investigator who is committed to excellence. He is a generous colleague, willing to offer his assistance in solving experimental challenges to colleagues and the many students whom he mentors.


Professor Ono provides vital teaching in the pre-doctoral, graduate and PhD programs at the School of Dentistry. Currently, he is the course director of four graduate didactic courses and an instructor in

three other graduate and PhD didactic courses. Additionally, he contributes significantly by teaching in the pediatric dentistry orthodontic clinic and the pre-doctoral orthodontic clinic. He has been the primary mentor of seven MS student research projects and has been on seven additional Master's Thesis committees. He mentored seven PhD student projects, one DDS student, three undergraduate students, and seven post-doctoral fellows of which he was the primary mentor to six. His post-doctoral fellows have been fully independent with numerous publications supporting Professor Ono's commitment to research training. Additionally, he is currently participating as a mentor in the faculty launch program of a new junior investigator on campus.

Professor Ono's contributions to service supports the school's service mission. From 2016-2019, he served as the co-director of the orthodontic graduate research program. In 2019, he was appointed as the director of the orthodontic graduate research program carrying a high-level of responsibility and student research engagement. Additionally, in the department, he is a member of the Resident Admissions Committee and is an oral comprehensive examiner. At the school level, he has served on the Grievance Hearing Board for the tenure track faculty, Task Force for School of Dentistry Indirect Cost Use, Dentistry Research Committee, Research Day Judge, two tenure-track faculty searches, the faculty search for the associate dean for research, and 12 dissertation committees. At the university level, he serves on the Organogenesis Seminar Series Organizing Committee, and at the national and international level, he is a member of the American Association for Dental Research Edward H. Hatton Awards Committee, and the International Federation of Musculoskeletal Research Societies Scientific Program Committee. He is on the *Journal of Bone and Mineral Research* editorial board and is a manuscript reviewer for numerous journals, such as *PLOS Genetics*, *Nature Communications*, *International Journal for Molecular Sciences*, *JBMR Plus*, *Stem Cells*, and *Journal of Bone and Mineral Research*. Professor Ono was a grant reviewer for the French National Research Agency, the Generic Call of Proposals, and the American Association of Petroleum Geologists (2019), National Institutes for Health, Skeletal Biology Development and Disease Study Section (2020), and the United Kingdom Biotechnology and Biological Sciences Research Council (2020).

Professor Ono is a dedicated teacher, brilliant scientist and well-rounded service contributor at the School of Dentistry. It is with great pleasure that we recommend the appointment of Noriaki Ono as the James E. 



Searle Professor, and chair of the Department of Internal Medicine, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of David J. Pinsky, M.D. as the Cyrus and Jane Farrehi Professor of Cardiovascular Research, Medical School, effective February 1, 2021 through August 31, 2026.

The Cyrus and Jane Farrehi Professorship in Cardiovascular Research was established in January 2004 through a generous gift and pledge from Dr. and Mrs. Cyrus Farrehi. The gift was made in recognition of the Farrehi family's commitment to support the quest for new knowledge in the broad area of cardiovascular function and diseases. 
Dr. Pinsky joined the faculty at the University of Michigan in 2003 as a professor of internal medicine, as the J. Griswold Ruth, M.D., and Margery Hopkins Ruth Professor, and the director of the Samuel and Jean Frankel Cardiovascular Center. Dr. Pinsky was appointed to a secondary appointment in molecular and integrative physiology in 2004. His research is focused on understanding how natural blood vessel defense mechanisms may be amplified to protect in conditions such as stroke, heart attack, or organ transplantation. Dr. Pinsky's work focuses on a protective enzyme which lines blood vessels, amplifying a natural defense mechanism against unchecked inflammation and coagulation. His laboratory was the first to directly measure nitric oxide in the beating heart, and to discover that very small amounts of carbon monoxide may actually protect blood vessels following flow interruption. His team has also discovered a fundamental new mechanism by which white blood cells control their own destiny in the vicinity of a clotted vein or in a cholesterol-choked artery, in the heart or brain. Dr. Pinsky's goal is to

understand, amplify and harness a blood vessel's natural defenses in order to develop novel diagnostic and therapeutic strategies for the treatment of heart attack, stroke, and other vascular diseases.

Dr. Pinsky is an inventor on over a dozen patents and author of more than 200 scientific papers and book chapters. He is an elected member of multiple honorary scientific societies, including the American Society for Clinical Investigation, American Association of Physicians, American Clinical and Climatological Association, and the Association of University Cardiologists. He has served on and chaired numerous national peer-review and strategy panels for the American Heart Association, Department of Defense, and National Institutes of Health, and is a sought-after presenter of his research internationally.

Dr. Pinsky is an outstanding clinician-scientist in cardiovascular disease research, with strong institutional leadership. He is a fitting candidate for this prestigious professorship. I am pleased, therefore, to recommend the appointment David J. Pinsky, M.D. as the Cyrus and Jane Farrehi Professor of Cardiovascular Research Medical School, effective February 1, 2021 through August 31, 2026.



Croatian, Korean and Arabic, as well as many undergraduate honors students who worked on syntactic theory, Minimalism, and syntactic change.



Stephen Pollock received his B.S. from Cornell University in 1958, his M.S., and his Ph.D. from the Massachusetts Institute of Technology in 1960, and 1964, respectively. He was a faculty member in the Department of Operations Analysis at the Naval Postgraduate School from 1965 to 1969 and joined the faculty at the University of Michigan as an associate professor in 1969. He was promoted to professor in 1974. He also held a research scientist position in the Institute of Public Policy Studies from 1977 to 1982. Professor Pollock served as the chair of the Department of Industrial and Operations Engineering from 1981 to 1990, and chaired many college and university-wide governance committees. In 1992, he received the Stephen S. Attwood Award, the highest honor awarded to a faculty member by the College of Engineering. From 2002 until his retirement, Professor Pollock served as the advisor of the Global Leadership Honors Program, and from 2003 until his retirement, he served as the director of the Financial Engineering Program.

Throughout his career, Professor Pollock was involved in applying operations research and decision analysis methods to understand and influence a variety of operational phenomena. He authored over 60 technical papers, co-edited two books, and served as a consultant to over 30 industrial, governmental and service organizations. Professor Pollock served as an associate editor and area editor of *Operations Research*, senior editor of *IIE Transactions*, associate editor of *Management Science* and on the editorial boards of other journals. He served on various advisory boards for the National Science Foundation, as a member of the Army Science Board and on the Committee on Applied and Theoretical Statistics of the National Research Council (NRC), and as a chair and member of NRC panels. Professor Pollock's honors include president of the Operations Research Society of America in 1986, the 2001 INFORMS Kimball Medal for contributions to operations research and the management sciences, and selection as fellow of INFORMS, fellow of the American Association for the Advancement of Science, fellow of the Michigan Society of Fellows, and a member of the National Academy of Engineering. He was appointed as the Herrick Professor of Manufacturing in 2000.

The College of Engineering is pleased to have an opportunity to honor Stephen M. Pollock by establishing a collegiate professorship in his name. The initial term of appointment will be for five years with the possibility of renewal.


As the chief government relations official of the university, Mr. Kolb will be responsible for providing university-wide leadership, strategic vision, and effective management of UM's government relations programs at the local, state, and federal levels. He will oversee the Office of Government Relations comprised of the federal, state and community relations offices as well as the state outreach unit, the Economic Growth Institute and UM's participation in the University Research Corridor.

Mr. Kolb currently serves as the state budget director for the State of Michigan. He was appointed to this role in January of 2019, by Governor Whitmer. Mr. Kolb is responsible for coordinating all aspects of the state's \$60 billion budget, from the development of the budget, to the final decisions required for signature by the governor, and all supplemental appropriations. He oversees the Center for Educational Performance and Information, the Office of Financial Management, and the SIGMA support organization. From 2009-2018, Mr. Kolb served as the president and CEO of the Michigan Environmental Council (MEC), a non-profit coalition of more than 60 environmental organizations. Under his leadership, the MEC secured millions of dollars in state funding for programs to prevent lead poisoning; elevated public transit in Michigan's transportation funding plan; blocked a state plan to deregulate certain toxic chemical emissions; advanced clean energy legislation and developed a clean water toolkit for residents. In 2015, Governor Rick Snyder appointed Mr. Kolb to co-chair the Flint Water Advisory Task Force, which investigated the city's drinking water crisis and provided recommendations to prevent similar disasters statewide. Mr. Kolb's distinguished career in public service includes three terms in the Michigan House of Representatives (2001-2006), Ann Arbor City Councilmember (1993-2000) and Ann Arbor Mayor Pro-tem (1994-2000).

Mr. Kolb holds a B.S. from the University of Michigan in natural resources. He is a former member of the external advisory board for UM's Erb Institute; the Detroit Community Health Assessment Steering Committee, the Michigan League of Conservation Voters and the Michigan Sea Grant Advisory Committee.



During his residence at Michigan, Professor McClean will teach either one three-credit course or two mini-courses on age, political institutions, and/or social welfare in Japan. Additionally, he will give a public lecture for the Center for Japanese Studies' Noon Lecture Series as well as at other institutions.



The Myron and Margaret Winegarden Visiting Professorship was originally established in September 2001 and renamed as the Myron and Margaret Winegarden Professorship in May 2020. The Myron and Margaret Winegarden Professorship recognizes tenured University of Michigan-Flint faculty members who have demonstrated and will continue to achieve the highest levels of scholarship, teaching excellence, contributions to pedagogy, and social impact, and bring national recognition to the University of Michigan-Flint. Recipients awarded this professorship will have a five year, renewable term limit.

Terrence Horgan holds a Master of Arts degree in educational and counseling psychology from the University of Missouri (1994), and he received his Ph.D. in experimental psychology from Northeastern University in 2001. Professor Horgan joined the faculty and the University of Michigan-Flint as an assistant professor in 2004, was promoted to associate professor, with tenure, in 2010, and to professor in 2016.

As a scholar, Professor Horgan's experimental psychological research can be broadly categorized as being in the domain of social cognition, the investigation of the cognitive processes involved in making sense of the social world. He is undoubtedly the most well-cited scholar in psychology at UM-Flint with 24 peer-reviewed publications in top journals, whose work is frequently lauded for its "rigor and creativity in design." He was the 2019 recipient of the campus' Scholarly Achievement Award and has received grants in excess of \$21,000 to support his work. He is a co-author of a textbook, Nonverbal Communication in Human Interaction, 8th edition (due out in the 9th edition in 2021), widely recognized as the "gold standard" in this field. He is published in several of the top journals in his field, including *Journal of Personality and Social Psychology*, *Journal of Social Psychology*, *Journal of Social and Personal Relationships*, *Sex Roles*, *Journal of Nonverbal Behavior*, *Personality and Social Psychology Bulletin*, and the *Annual Review of Psychology*. Over the years, Professor Horgan continues to expand his research in systematic and programmatic ways.

Professor Horgan is an exemplary model of a mature teacher-scholar and mentor. He has worked with more than 59 students in research mentorship during his career, including bringing nine students to the level of co-authorship with him in peer-reviewed articles, as well as more than a dozen others to authorship of conference papers or posters. Many of his former students have earned masters or doctoral degrees. His course materials, student evaluations, and peer evaluations reveal a rich variety of theoretical materials and real-world examples which form the basis for highly interactive and engaged learning experiences. Professor Horgan has taught some of the most challenging courses in the psychology curriculum, and he consistently receives high marks for the quality and accessibility of his teaching. He has amply demonstrated that he continues to develop and refine his already-strong pedagogy, both in the classroom and online.

Professor Horgan is an outstanding departmental colleague, whose collaborative style has served him well over the years. He has expanded his service within the department and assumed leadership roles as needed, throughout his tenure. Professor Horgan has chaired tenure track and lecturer search committees and frequently is relied upon to mentor new faculty within the department regarding both teaching and research activities. His service has expanded beyond the Psychology Department to include membership on the College of Arts and Sciences Strategic Plan Taskforce, the Nominating Committee, and the Research and Creative Activity Committee, which he co-chaired in 2010-2011 and chaired in 2012-2013, and the Scholarships and Awards Committee in 2016-2019. He has also served on several promotion and tenure committees for the College of Health Sciences and has been a faculty mentor for numerous years through the Mentoring Program administered through the Office of the Provost. 



Amy Yorke received her B.S. from the University of Michigan-Flint in 1991, her M.P.T. from the University of Michigan-Flint in 1993, and her Ph.D. in interdisciplinary health sciences from Western Michigan University in 2013. Professor Yorke joined the University of Michigan-Flint as an assistant director of clinical education and instructor in 2008, was promoted to assistant professor in 2013, and to associate professor, with tenure in 2017. Professor Yorke has served as the associate director of community engagement since 2017.

Professor Yorke is an active researcher and scholar and has successfully achieved grant funding and disseminated a total of six scholarly projects at local and national conferences and in peer-reviewed journals having 29 peer-reviewed publications with two additional manuscripts under review and eight additional manuscripts in development. She has received four external grants to support her research and service work. In 2019, Professor Yorke initiated the Integrating Knowledge Translation (iKNOW) Lab. Since that time, the lab has grown to include three additional faculty members (two from UM-Flint, one from Wayne State University) and three students (two Doctoral of Physical Therapy, one dual-degree Doctoral of Physical Therapy, Ph.D. in Physical Therapy) currently engaged in five active projects. iKnow projects have

focused on working with health care organizations to standardize the physical therapy assessments utilized in patients with neurological conditions in order to improve care.

Professor Yorke has excelled as a teacher and has established a significant record of accomplishment as a scholar of interprofessional education and rehabilitation. In addition to receiving multiple teaching awards, Professor Yorke was recognized as a Distinguished Fellow of the National Academies of Practice in 2020.

Professor Yorke has made significant service contributions to the community, profession, and university. She has very skillfully managed to interweave her service, teaching, and scholarship with a focus on multiple sclerosis and other neurologic disorders. Professor Yorke has developed programming for the Michigan Chapter of the National Multiple Sclerosis Society and incorporated student service-learning projects with her service work. She also spearheaded a new teaching format for her neurologic rehabilitation course that provides rehabilitation services to persons with neurologic disorders in the Flint community while gaining practical learning experiences for the physical therapy students. Within her profession, Professor Yorke has served on the American Academy of Neurology Multiple Sclerosis Quality Measure Development Workgroup. She has been heavily involved in service at all levels of the university with a special focus on student recruitment, admissions, and teaching excellence. Professor Yorke's service is consistently of high quality.




