## **ACTION REQUEST**

Subject: Regental Action Required Under the State of

Michigan Conflict of Interest Statute

<u>Action Requested:</u> Authorization for the University to transact with Arbor Medical Innovations,

LLC (University of Michigan Employees, Steven E. Harte, Ph.D., Member and

Partner, Grant Krueger, Member).

## Background:

The University of Michigan Department of Anesthesiology seeks approval to purchase from Arbor Medical Innovations, LLC ten customized AcuWand devices.

The proposed agreement falls under the State of Michigan Conflict of Interest Statute as Steven E. Harte, Ph.D., is a University employee as Associate Professor of Anesthesiology with the Department of Anesthesiology and would be party to the contract as member and partner of Arbor Medical Innovations, LLC and Grant Kruger is a University employee as Associate Research Scientist with the Department of Mechanical Engineering and would be party to the contract as member of Arbor Medical Innovations, LLC.

However, the Statute allows the University to enter into such agreements if the following conditions are met:

- a) The public servant promptly discloses any pecuniary interest in the contract to the official body which has power to approve the purchase, which disclosure shall be a matter of record in its official proceedings.
- b) The purchase is approved by a vote of not less than 2/3 of the full membership of the approving body in open session without the vote of the public servant making the disclosure.
- c) The official body discloses the following summary information in its official minutes:
  - i) The name of each party involved in the contract.
  - ii) The terms of the purchase, including duration, financial consideration between the parties, facilities or services of the public entity included in the purchase, and the nature and degree of assignment of employees of the public entity for fulfillment of the purchase.
  - iii) The nature of any pecuniary interest.

The following information is provided in compliance with the statutory requirements contained in Section (c) above:

- i) The parties to the contract are the Regents of the University of Michigan and its Department of Anesthesiology and Arbor Medical Innovations, LLC.
- ii) The agreement is for a one time purchase at a total cost not to exceed \$5,942. Arbor Medical Innovations, LLC will be supplying all the necessary resources and personnel to fulfill this contract. The remaining base contract terms and conditions are typical to those used in Procurement Services standard templates for other similar contracts entered into by the Regents.
- iii) The pecuniary interest arises from the fact that University of Michigan employees, Steven E. Harte, Ph.D., is member and partner, and Grant Krueger is member of Arbor Medical Innovations LLC.

Steven E. Harte, Ph.D., and Grant Krueger have met state law requirements with the disclosure of their pecuniary interest and formal appointment arrangements with the University of Michigan. Requirements, if any, that may be applicable by the supervisor of Steven E. Harte, Ph.D., and Grant Krueger, under the Medical School's or OVPR's Conflict of Interest Committee's procedures are separately analyzed and managed.

<u>We recommend</u> that the Board of Regents approve the agreement between the University of Michigan and Arbor Medical Innovations, LLC subject to requirements, if any, that the supervisor of Steven E. Harte, Ph.D., and Grant Krueger or the Medical School's or OVPR's Conflict of Interest Committee may impose.
