Subject: Monthly Investment Report

Background and Summary:

Attached is the Monthly Investment Report for the Long Term Portfolio as of December 31, 2023.

The report includes a change in format. Real Estate and Natural Resources have been combined into one asset class called Real Assets to reflect the changing underlying exposure that now includes a meaningful amount of overlap between the two asset classes and adds investments in Infrastructure as a third asset class. The benchmark for Real Assets is a weighted composite benchmark of the three underlying asset classes.

- Page 1 summarizes the assets as of December 31, 2023. Allocations to alternative assets (Illiquid) reflect market values as of September 30, 2023, the most recent date available, adjusted for contributions and distributions through December 31, 2023.
- Page 2 reports the performance of Marketable Securities by asset class for select periods ending December 31, 2023.
- Page 3 reports the performance for the entire portfolio by asset class as of September 30,
 2023. The investment performance of Alternative Assets is reported with this one quarter lag in order to gather the requisite information from the limited partnerships.
- Page 4 summarizes the assets as of September 30, 2023.
