On the recommendation of the Executive Committees of the Departments of Women's Studies and Political Science, and the College of Literature, Science, and the Arts, we are pleased to recommend the appointment of Leela Fernandes as professor of women's studies, with tenure, and professor of political science, without tenure, College of Literature, Science, and the Arts, effective September 1, 2010.

ACADEMIC DEGREES

Leela Fernandes received her Bachelor of Arts from the University of Michigan in 1987. She attended the University of Chicago where she completed her Master of Arts in 1989 and her Doctorate in 1994.

PROFESSIONAL RECORD

Professor Fernandes began her teaching career as a visiting assistant professor at Oberlin College (1994-1995) before being appointed as an assistant professor (1996-2001) at Rutgers University. She was promoted to associate professor (2001-2008) and to professor (2008-2010) at Rutgers.

SUMMARY OF EVALUATION

Professor Fernandes has established her reputation as a productive scholar and teacher of gender and political science in India. She is the author of three monographs, two edited collections, ten peer-reviewed articles, and nine book chapters. She currently sits on the Cambridge University Press editorial board, is associate editor of *Signs* (2005-2010), and South Asia editor of *Critical Asian Studies* (2007-2012). Her research focus is to revisit some of the theoretical premises of feminist transnational studies in ways that will advance the questions, methods, and curriculum of the field and of the Department of Women's Studies.

Consistently above her departmental mean, Professor Fernandes particularly excels in undergraduate seminars and graduate teaching. She has participated in 19 dissertation committees and is increasingly serving as chair.





On the recommendation of the Executive Committees of the Department of Classical Studies and the College of Literature, Science, and the Arts, we are pleased to recommend the appointment of Celia E. Schultz as associate professor of classical studies, with tenure, College of Literature, Science, and the Arts, effective September 1, 2010.

ACADEMIC DEGREES

Celia Schultz received her Bachelor of Arts from the Pennsylvania State University in 1992. She attended Bryn Mawr College where she completed her Master of Arts in 1994 and her Doctorate in 1999.

PROFESSIONAL RECORD

Professor Schultz began her teaching career as a visiting lecturer at Bryn Mawr in spring 2000. She was appointed as a visiting lecturer at Johns Hopkins University (2000-2001) and as an assistant professor (2001-2008) and an associate professor (2008-2010) at Yale University. At Yale she was also the director of graduate studies (2006-2008). Professor Schultz is a member of the Committee for Ancient History in the American Philological Association (2008-2011) and of the Steering Committee of the Women's Classical Caucus (2008-2012).

SUMMARY OF EVALUATION

Professor Schultz has obtained an impressive international reputation in Roman history with a particular focus on Roman religion. Her book, *Women's Religious Activity in the Roman Republic*, is an important contribution that has received excellent reviews. She drops the traditional assumptions about women's religious life being concentrated on women's cults and looks at the whole range of evidence, the literary sources, the inscriptions, and the archaeological record. Professor Schultz also has co-edited one book and has published articles on a variety of topics. Her current project is a commentary on Cicero's *De Divinatione* and is in process.

Professor Schultz has taught a variety of classes, including authors important to the Department of Classical Studies – Cicero, Livy, and Sallust, for example – and classes in translation. Students give her very strong ratings even though the course load is heavy. She has also directed three dissertations.





Dr. Liberzon received the M.D. degree from Sackler Medical School at Tel Aviv University in 1986. Following an internship and a research fellowship in Haifa, Israel, he came to the University of Michigan to pursue residency training in psychiatry during 1988-1992. That same year, he joined the faculty at this institution as assistant professor of psychiatry and advanced through the academic ranks to achieve his current title of professor of psychiatry in 2005. He received a joint appointment as professor of psychology in 2007.





On the recommendation of the Dean and Executive Committee of the Stephen M. Ross School of Business we are pleased to recommend the reappointment of William S. Lovejoy as the Raymond T. J. Perring Family Professor of Business Administration, Stephen M. Ross School of Business, effective June 1, 2010 through May 31, 2015.

This professorship was established by the Regents in June 2000 and is funded in part by stocks and additional gifts from Raymond Perring. The Perring professorship was established in part to honor the memory of Professor Robert Rodkey, Raymond Perring's first professor in the Business School, and a life-long friend.

Professor Lovejoy received his B.S. degree and his M.Eng. degree from Cornell University in 1973 and 1974, respectively, and his Ph.D. degree from the University of Delaware in 1983. Following completion of his Ph.D., he was an assistant professor for three years at the Georgia Institute of Technology, then moved to Stanford University where he was an assistant and then an associate professor. He joined the University of Michigan Ross School of Business faculty as a professor in 1994 and was jointly appointed as professor of art and design, without tenure, in the School of Art and Design, in 2007.

Before being appointed as the Raymond T. J. Perring Family Professor of Business Administration, Professor Lovejoy held the title of John Psarouthakis Research Professor in Manufacturing Management. He served as the chair of the operations and management science area in the Ross School of Business from 1995-2007. He has also been a faculty fellow with the Tauber Institute for Global Operations, and in 1997 won that Institute's Student Advisory Board teaching award. In addition, Professor Lovejoy has been awarded the *Operations Research* Associate Editor Meritorious Service Award

in 1999, the Ross School of Business MBA Teaching Excellence Award in 1999-2000, the Ross School of Business Victor Bernard Teaching Leadership Award in 2006, the Ross School of Business Andy Andrews Service award in 2009 as well as the Provost's 2009 Teaching Innovation Prize.

Professor Lovejoy has a strong research record in the areas of product development, inventory and operational control, and managing congestion and complexity. He has a lengthy publication record in the profession's top journals and is a referee for many scholarly journals. He has continued an active program of research in addition to his teaching responsibilities. Professor Lovejoy is a much-respected senior scholar and an excellent citizen of the School.

The Dean and the Executive Committee of the Stephen M. Ross School of Business enthusiastically support the reappointment of William S. 



On the recommendation of Bishr Omary, Ph.D., M.D., the H. Marvin Pollard Professor of Gastroenterology, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the establishment of the John A. Faulkner Collegiate Professorship in Physiology, effective March 1, 2010.


This collegiate professorship is made possible through a generous gift agreement from John A. and Margaret I. Faulkner. The establishment of this collegiate professorship will recognize the lifetime achievements of Dr. Faulkner who currently is the longest serving active faculty member at the University of Michigan. Dr. Faulkner will be retiring in June 2010, after 50 years of service at the University of Michigan. This professorship will support the research efforts of a senior faculty member in the Department of Molecular and Integrative Physiology. The initial term for the Faulkner Collegiate Professor will be five years, and the appointment may be renewed.

Dr. Faulkner received the M.Sc. and Ph.D. degrees in physiology from the University of Michigan in 1956 and 1962, respectively. During 1960-1966, he was a faculty member in the School of Education at this institution. In 1966, Dr. Faulkner joined the Medical School faculty as an associate professor of physiology, and he achieved his current rank of professor of molecular and integrative physiology in 1971. He received a joint appointment as professor of biomedical engineering in 1997.


Dr. Faulkner is considered one of the pioneer investigators in the fields of muscle physiology, aging, and bioengineering. Institutionally, he has received many awards including the Distinguished Faculty Achievement Award, and the Bioengineering Program's Glenn Edmonson Award. In 2009, he was the honored recipient of the University of Michigan's Lifetime Service Award. 

Moyad Research Professorship in Urology, Medical School, effective March 1, 2010.

This research professorship is made possible through a generous gift agreement from the Thompson Foundation and Mr. Phil F. Jenkins. Robert and Ellen Thompson and Phil Jenkins, friends and patients of Dr. Moyad, wish to acknowledge the numerous contributions of Robert and Eva Moyad through the establishment of a professorship in their name. The recipient of this research professorship will be a tenured faculty member in the Department of Urology. The initial term for the Moyad Research Professor will be five years, and the appointment may be renewed.

The story of Robert and Eva Moyad is one in which medicine, language, art, hard work, love, compassion and the traditions of two distinct cultures are woven into a rich and enduring tapestry. Their extraordinary partnership has saved and shaped lives in their family, the community, and throughout the world.

Dr. Robert Moyad was born and raised in a medical family in Teheran, Iran. At one point, his family counted 13 physicians among them, including his father, who, aware of the opportunities that awaited his children outside his country, sent each of them abroad for their university educations. In 1954, Robert arrived at the University of Vienna for his pre-medical studies. It was there in a student cafe that he met the woman with whom he would spend his life.

Eva Kotronoch also was the child of a physician. Her father, a hard-working Viennese internist exhausted by the trials of wartime medicine, had urged her to abandon thoughts of a medical career. He died when she was 16, and Eva, a brilliant student, turned her attention toward languages. After a year at the Sorbonne studying French, she entered the University of Vienna, determined to become a simultaneous translator. Robert and Eva married in 1962 and moved to the Detroit, Michigan area where Robert undertook a rotating internship at St. John Hospital. After Robert completed his internship, the Moyads moved to Cleveland, Ohio, where Robert pursued his urology training at Case Western Reserve University. Eva quickly realized that good language instructors were in short supply in the United States and began teaching German and French—a fulfilling freelance career that was to continue for many years.

In 1967, Dr. Moyad opened his own clinical practice in Ypsilanti, Michigan. Not long after, he received a call from renowned University of Michigan urologist, Dr. Jack Lapidus, who asked Dr. Moyad to assist in the training of urology residents. Dr. Moyad spent the next few years overseeing residents at Wayne County General Hospital, the Ann Arbor VA Healthcare System and the University of Michigan. He maintained his connection with the University of Michigan throughout a long and highly successful urological practice during which he was named chief of surgery first at Beyer Hospital in Ypsilanti, then at Saline Community Hospital. He also served as head of the Department of Urology at St. Joseph Mercy Hospital.

Though Eva Moyad put her career on hold to raise the couple's three sons, Andrew, Mark, and Tom, she still found time to earn a master's degree in language and literature from Eastern Michigan University. She continued teaching and tutoring, served as a docent at the University of Michigan Museum of Art for 20 years, and was president of the Washtenaw County Medical Auxiliary. She was a member of the Volunteers for the International Hospitality group at the University of Michigan and later became president of that organization.

The Moyad Professorship is being established in honor of Robert and Eva Moyad for their overwhelming generosity of spirit and kindness, their devotion to their children and family, and their dedicated service to the community. I am very pleased, therefore, to recommend the establishment of the Dr. Robert H. and Eva M. Moyad Research Professorship in Urology.

On the recommendation of Michael W. Mulholland, M.D., Ph.D., the Frederick A. Collier Distinguished Professor and Chair of the Department of Surgery, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the establishment of the M. Haskell Newman Collegiate Professorship in Plastic Surgery, effective March 1, 2010.


This collegiate professorship is being established through gifts, pledges, and departmental resources. It will recognize the achievements of Dr. Newman and is intended to focus on the discipline of pediatric plastic surgery in the areas of research, clinical application, and teaching. The recipient of this collegiate professorship will be a tenured faculty member of the Section of Plastic Surgery in the Department of Surgery. The initial appointment period for the Newman Collegiate Professor will be five years, and the appointment may be renewed.

Dr. Newman received the M.D. degree from the University of Tennessee in 1962. He then came to the University of Michigan where he trained in general surgery, completed a residency in otorhinolaryngology, and received an M.S. degree in physiological acoustics. After serving in the U.S. Army Medical Corps during 1968-1971, he returned to the University of Michigan as an assistant professor of otorhinolaryngology until 1975. He then elected to train in plastic surgery, completing a residency at the University of Michigan, followed by a fellowship in craniofacial surgery at the University of Toronto. He rejoined the faculty at the University of Michigan as an assistant professor in the Section of Plastic Surgery in 1977. Dr. Newman became a clinical assistant professor in 1981, was promoted to clinical associate professor in 1991, and achieved the rank of clinical professor of surgery in 1998. Dr. Newman retired from the active faculty in 2007 and holds the title of clinical professor emeritus of surgery.

During the course of his outstanding and distinguished career, Dr. Newman gained a national reputation for his expertise in the areas of pediatric plastic surgery, cleft lip and palate surgery, adult maxillofacial surgery, and aesthetic surgery. A much admired member of the teaching faculty in the Section of Plastic Surgery, Dr. Newman has been recognized by every graduating resident as a major influence on their clinical training. In his current role as a clinical professor emeritus of surgery, Dr. Newman continues to support the educational and clinical programs of the Section of Plastic Surgery at the University of Michigan.


The professorship will honor Dr. Newman and will acknowledge his numerous contributions to the specialty of plastic surgery and to the University of Michigan. I am very pleased, therefore, to recommend the establishment of the M. Haskell Newman Collegiate Professorship in Plastic Surgery.
