
February 2011 award activity both in number and dollar value are below that of February 2010. However year-to-date totals show a very slight decline in dollar value despite the number of total awards decreasing by nearly 8%. Last year's activity was significantly influenced by the ARRA funding. This year the amount of ARRA funding is insignificant. However award values remain relatively strong in FY 2011 even without the support of ARRA activity. The large increase in research expenditures on the next page is caused by some accounting transfers which will be adjusted in next month's report.


