We are pleased to recommend the reappointment of Peggy Burns as assistant dean for advancement, College of Literature, Science, and the Arts, for a five-year term, effective July 1, 2013 through June 30, 2018. Her responsibilities will not include teaching obligations.

In her role as assistant dean for advancement, Ms. Burns has demonstrated exceptional leadership during the last five years, driving significant results for LSA Development, Marketing, and Communications. Ms. Burns has effectively integrated development, marketing, and communications with the focus on creating a culture of giving and engagement for the nation's preeminent public liberal arts college. Under her leadership LSA over-achieved the Michigan Difference campaign goal by \$50M, raising \$350M. In January of 2009, she launched a post-campaign to continue momentum with LSA donors. This post-campaign effort raised \$112M. Her leadership has gained national recognition and the LSA Advancement Operation is often benchmarked as the best in the country.


Revenue goals have been overachieved in all areas: endowment, expendable, bequest, and annual giving. Much of this success can be attributed to Ms. Burns' organizational expertise and strategic planning processes. Some of her other significant accomplishments include numerous CASE awards for the *LSA Magazine*, implementation of a college-wide web content management system, restructuring of the LSA Campus Day events, and integration of scholarship fundraising and donor stewardship. LSA Development, Marketing, and Communications is a true advancement operation which leverages every opportunity to drive incremental revenue.

In her role as assistant dean, Ms. Burns has worked closely with people and groups within the college—as well as with individuals and groups in the larger university community—to implement new initiatives and to measure the college's effectiveness in meeting these goals. She has demonstrated the great value of her position to the college and consistently uses her strengths to participate in a variety of college and university service. She is viewed by her peers campus-wide as a collaborative knowledge source and someone always willing to offer help and support.




The Dean and the Executive Committee of the College of Literature, Science, and the Arts are pleased to recommend the reappointment of Tiya A. Miles as chair, Department of Afroamerican and African Studies, College of Literature, Science, and the Arts, effective July 1, 2013 through June 30, 2014.

Tiya Miles received her Bachelor of Arts from Harvard University in 1992, Master of Arts from Emory University in 1995, and Doctorate from the University of Minnesota in 2000. Professor Miles began her teaching career as an assistant professor at the University of California, Berkeley in 2000 and joined our faculty as an assistant professor in 2003. She was promoted to associate professor, with tenure, in 2007, and to professor in September 2011. Professor Miles was awarded with a Collegiate Professorship in January 2012. She was appointed as director of the Center for Afroamerican and African Studies in July 2011. When the center reorganized into a department in September 2011, her title then became chair.


Professor Miles' scholarship lies in African American and Native American literature. She recently received the A. Elizabeth Taylor Prize for the best article in southern women's history given by the Southern Association for Women Historians (2010), the National Council on Public History Book Award (2011), the Native American and Indigenous Studies Association Ten Most Influential Books of the First Decade of the 21st Century Prize (2011), and the Georgia Historical Society Lilla M. Hawes Book Award (2011). The House on Diamond Hill: A Cherokee Plantation Story, was published in 2010 by the University of North Carolina Press. Her first book, Ties That Bind: The Story of an Afro-Cherokee Family in Slavery and Freedom (University of California Press, 2005) was awarded the Frederick Jackson Turner prize by the Organization of American Historians and the Lora Romero Distinguished First Book prize by the

American Studies Association. Most notably, Professor Miles received a MacArthur Fellowship in 2011.



The Dean and Executive Committee of the School of Dentistry are pleased to recommend the reappointment of Charlotte M. Mistretta as the William R. Mann Professor of Dentistry, School of Dentistry, effective April 1, 2013 through March 31, 2018.

This professorship provides a memorial to Professor William R. Mann, dean of the School of Dentistry from 1962 to 1982, and an outstanding member of the faculty for 41 years. This professorship recognizes outstanding intellectual leadership and nationally recognized achievement in research, teaching and service.

Professor Mistretta received her MS and PhD in biological science from Florida State University in 1968 and 1970, respectively. She joined the University of Michigan School of Dentistry as a senior research associate in 1972, was appointed as an assistant research scientist in 1974, an associate research scientist in 1976, and a research scientist in 1982. In 1991, she was appointed as a professor in the School of Dentistry. She served as the director of Oral Health Sciences PhD Program from 1993-2010. Additionally, Professor Mistretta has held appointments in the Center for Human Growth and Development on the primary research track (1975-1976), associate professor, with tenure, (1975-1983), professor (1983-2002) in the School of Nursing, and interim director of the Center for Nursing Research (1985-1988.) She was named the William R. Mann Professor of Dentistry in 2003. She was appointed as associate dean for research and PhD training in November 2005. Subsequently, responsibility for PhD training has been reassigned and Professor Mistretta focuses her efforts in the research arena.

Professor Mistretta is an outstanding researcher in the area of taste development and related areas of neurosensory and chemoreception phenomena. She is the recipient of numerous national awards including the 2010 Kerry-Manheimer Award for Significant Advances and Outstanding Scientific Achievement in Chemosensory Sciences. She has held continuous funding as the principal investigator on her NIH grant, Development of the Sense of Taste, since 1988 with prior funding for this project from the NSF. Currently, she is a co-principal investigator on two additional grants through the NIH. In 2010, Professor Mistretta received a CRLT award for developing a Thematic core for Neurobiology in Oral Health and Disease in the School of

Dentistry's DDS curriculum. Since 1970 she has a continuing record of peer-reviewed journal publications and an extensive number of invited lecturers nationally and internationally.

Professor Mistretta is an active teacher in the pre-doctoral DDS program and maintains a high level of mentoring in the masters, PhD and post-doctoral student levels. She serves on several master's thesis and PhD dissertation committees.

Professor Mistretta has a long record of service at the university, national and international levels. Recently, she has served as a member to the National Institute of Deafness, National Committee Development of Plasticity Federal Liaison Committee. She has also served on the Provost's University Advisory Committee for School of Nursing, Post-doctoral Network Group at the Rackham Graduates School and the North Campus Research Complex Research Program Peer Review Committee. Her participation on committees within the School of Dentistry has been extensive throughout her career and recently includes service on the Dean's Vision Implementation Team, Academic Review Board I and many ad-hoc committees.

We are very pleased to recommend the reappointment of Charlotte M. Mistretta as the William R. Mann Professor of Dentistry, School of Dentistry, effective April 1, 2013 through March 31, 2018.

We are pleased to recommend the appointment of Daniel Crane as the Frederick Paul Furth, Sr. Professor of Law, Law School, effective March 1, 2013 through June 30, 2018.

The Furth Professorship is intended to support the salary and expenses of a professor in the Law School who shall be awarded the title of Frederick Paul Furth, Sr. Professor of Law, in accordance with University policies. The Furth Professor of Law shall be nominated by the Dean of the Law School and appointed in accordance with University policy and practices concerning faculty appointments. The nominee appointed shall hold the professorship for a five-year term, renewable, indefinitely.

It is preferred, but not required, that the Furth Professor of Law shall specialize in the area of antitrust law or civil procedure. If the professorship is unfilled, the dean may use the income to support a visiting scholar.

Daniel A. Crane received his B.A., *magna cum laude*, from Wheaton College in 1991 and his J.D. from the University of Chicago Law School in 1996. After graduation, Professor Crane was a law clerk for Judge Kenneth L. Ryskamp, U.S. District Court for the Southern District of Florida in 1996. He then practiced law with the Morgan, Lewis & Bockius law firm from 1997-1999 and in 1999 he went to the law firm of Paul, Weiss, Rifkind, Wharton & Garrison LLP. Professor Crane joined the Benjamin N. Cardozo School of Law in 2003. He joined our faculty in 2009 as a professor, with tenure.

Professor Crane is a nationally recognized expert on antitrust law, who also teaches courses on contracts and intellectual property. His highly regarded scholarship has focused primarily on antitrust and economic regulation, with a special emphasis on the institutional structure of antitrust enforcement, predatory pricing, and the antitrust implications of various patent rules and practices. His work has been published in a number of top-tier law reviews, including those at the Universities of Michigan, Chicago, California, Texas, Cornell and Vanderbilt. He has an exciting new book on the institutional structure of antitrust enforcement forthcoming with Oxford University Press. He is routinely engaged as an expert consultant on high-profile antitrust matters.

Professor Crane is a successful classroom teacher, and he is a leading mentor on campus for our many students interested in the general field of business law. He also has developed an admirable record of service since joining our faculty, for example, serving on our very important personnel hiring committee two years in a row with one as chair. Professor Crane has earned the respect of his faculty colleagues and students alike, and has taken on a quiet leadership role within the Law School.


I am pleased to recommend the appointment of Thomas A. Finholt as acting dean, School of Information, effective July 1, 2013 through December 31, 2013. Dean Jeff MacKie-Mason will be away from campus during this time for a previously planned commitment.

Thomas A. Finholt received his Bachelor of Arts in history from Swarthmore College in 1983 and his Doctorate in social and decision sciences from Carnegie Mellon University in 1993. Professor Finholt joined the faculty at the University of Michigan as an assistant professor in the Department of Psychology in 1991. He transferred to the School of Information as an assistant research scientist in 1997. He was promoted to senior research scientist in 2001. He then became a research associate professor in 2003 and was promoted again in 2007 to research professor. In 2009 he was promoted to professor. Professor Finholt served as the associate dean for research and innovation from 2006 to 2010. In 2010, he assumed the role of senior associate dean for faculty, and became the senior associate dean for academic affairs in 2012.

Professor Finholt's research focuses on the design, deployment, and use of cyberinfrastructure in science and engineering. He was a co-developer of the world's first operational collaboratory and the inaugural director of the NSF's summer research institute for the science of socio-technical systems. Professor Finholt is currently focused on an NSF-funded effort to measure and model energy consumption across technologies used to form and maintain social networks, including transportation and information systems.

I am pleased that Professor Finholt has agreed to serve the School of Information as acting dean for the duration of Dean MacKie-Mason's absence. With his years of experience as a faculty member and knowledge of school administration gained through service as senior associate dean, I am confident that the school will maintain its momentum over the next semester. I enthusiastically recommend this appointment, effective July 1, 2013 through December 31, 2013.

On the recommendation of John M. Carethers, M.D., the John G. Searle Professor and Chair of the Department of Internal Medicine, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of David A. Fox, M.D. as the Frederick G.L. Huetwell and William D. Robinson, M.D. Professor of Rheumatology, Medical School, effective March 1, 2013 through August 31, 2018.

The Frederick G.L. Huetwell and William D. Robinson, M.D. Professorship in Rheumatology was established in 1995, through a generous gift from the estate of Mr. Huetwell, who was a lifelong friend of the University of Michigan. Dr. Robinson was responsible for the creation of the Division of Rheumatology in the Department of Internal Medicine at the University of Michigan. He practiced medicine, trained medical students, and expanded the horizons of biomedical knowledge for over 54 years.


David A. Fox received his M.D. from Harvard University in 1978. He completed an internship and residency at Peter Bent Brigham Hospital and was an Arthritis Foundation Research Fellow at the Dana-Farber Cancer Institute in Boston. Dr. Fox became an assistant professor in internal medicine at the University of Michigan in 1985, and rose through the ranks to professor, with tenure, in 1995. He was appointed as chief of the division of rheumatology in 1991, and as director of the University of Michigan Rheumatic Disease Research Core Center in 2001.

Dr. Fox is nationally and internationally recognized as an expert and leader in the field of rheumatology. His research focuses on defining and characterizing pathways of human T cell activation, and the role of these pathways in the pathogenesis of autoimmune diseases. He has studied the interactions between lymphocytes and cells of the joint lining, and has also helped to develop new treatments for rheumatoid arthritis and systemic lupus.

Dr. Fox has a strong record of funding support and has served as the director of the University of Michigan Hybridoma Core since 1987, which has produced hundreds of novel monoclonal antibodies that have advanced research and generated intellectual property for the institution. He has published 110 articles, and co-authored one book. Dr. Fox is a staff physician at the Veterans Administration Hospital, and has received numerous awards throughout his career for his research and mentoring, including the Chairman's Award for Outstanding Service to the Department.



Dr. Franzblau was promoted to associate professor of internal medicine, without tenure, in 2000. Since 1997, he has held an appointment as an associate research scientist in the Center for Ergonomics, Department of Industrial and Operations Engineering, College of Engineering. In January 2011 he was appointed as associate dean for research in the School of Public Health.

Dr. Franzblau is an outstanding mentor and innovative teacher whose courses are critical to the curriculum in the department and the school. In his capacity as an occupational physician, he has also played a leading role in the teaching and mentoring of occupational medicine residents. He

has provided significant service to the department and school, including service on the school's advisory committee on academic programs and the executive committee. At the university level, Dr. Franzblau has played an especially important role in the Health IRB where he has served as co-chair. He also worked on the University of Michigan Dioxin Exposure Study.

Dr. Franzblau has conducted high quality research across a range of occupational health issues and has published extensively in a broad range of prestigious journals. He is recognized both nationally and internationally for his scholarly contributions on various aspects of work-related musculoskeletal disorders, biological monitoring of chemical exposure, occupational neurological disease, occupational respiratory disease and environmental exposure assessment for dioxins and other persistent environmental chemicals. The external funding for his research has been significant and consistent.

His academic administrative experience includes a significant number of program directorships both various and long-term. From 1995-2003 he was director of the UM Occupational Medicine Residency Program. He directed the Occupational Medicine Program in the UM Education and Research Center from 1998-2003, and served as director of that center from 2000-2001. From 2001-2003 he directed the UM Occupational Injury Prevention Research Training Program, and from 2004-2005 he was interim director of the Occupational and Environmental Epidemiology Program in the School of Public Health. In addition, Dr. Franzblau served in the School of Public Health as associate chair of the Environmental Health Science Department from 2004-2005 and serves at present as the school's associate dean for research, overseeing total research funding in 2011-2012 of over \$66 million.

Given his broad experience across the university, I am confident that Dr. Franzblau will provide leadership in academic and budgetary matters. I recommend his appointment with enthusiasm, effective May 6, 2013 through June 30, 2018.



We are pleased to recommend the appointment of Ellen D. Katz as the Ralph W. Aigler Professor of Law, Law School, effective March 1, 2013 through June 30, 2018.

The Ralph W. Aigler Professorship of Law was established in 2000, with support from Jack and Margaret Sweet of Dallas, Texas.

Professor Katz received her B.A. *summa cum laude* from Yale College in 1991, and her J.D. from Yale Law School in 1994. After graduation, Professor Katz served as a law clerk to Judge Judith W. Rogers of the U.S. Court of Appeals, DC Circuit in 1994. In 1995 she was an appellate staff attorney for the Civil Division of the U.S. Department of Justice. In 1996 she was a law clerk for Justice David H. Souter, U.S. Supreme Court. In 1998 she was an appellate staff attorney for the Environment & Natural Resources Division of the U.S. Department of Justice. Professor Katz joined the Law School in 1999 as an assistant professor and was promoted to professor, with tenure, in 2004.

Professor Katz is one of the leading scholars in the nation focusing on voting rights and rules governing participatory democracy more generally. Among other things, her work has thoughtfully explored the constitutionality, operation and implications of the Voting Rights Act with a special emphasis on Section Five's protection for racial minority voting power. Her participation and presence is frequently sought around the country for academic and policy-focused conferences on these topics. Her scholarship has generally influenced the academic and public debates over voting rights protection, and her work on Section Five has directly influenced judicial interpretation of the Act. Indeed, a recent study of every single federal court decision interpreting and implementing Section Five is expected to be featured prominently in a case that the Supreme Court of the United States will decide later this year. She is frequently sought after by the media for her expertise in this field.


Professor Katz is also a consummate colleague and university citizen. She has developed a cultish following among students, and has directly involved scores of them in her scholarly and policy-influencing projects. She is also widely respected among her peers as having wonderful

administrative judgment, and indeed she just finished serving admirably as the chair for the Law School's dean search committee.





I am pleased to recommend for Regental approval the appointment of Laurie K. McCauley as dean of the School of Dentistry, for a five-year renewable term, effective September 1, 2013 through August 31, 2018. This recommendation follows a broad search conducted by a search advisory committee.

Laurie McCauley earned all of the following degrees from The Ohio State University: her B.S. degree in 1980, her D.D.S. degree in 1985, her M.S. degree in dentistry in 1988, and her Ph.D. degree in veterinary pathobiology in 1991. She was engaged in private practice limited to periodontics in Marysville, Ohio from 1988-1991. In 1992 she joined the University of Michigan School of Dentistry faculty as an assistant professor and rose through the ranks to professor in 2001. In 2002 she was appointed as an associate professor of pathology in the Medical School and became a professor in 2009. From 2002 to 2012, Professor McCauley served as chair of the Department of Periodontics and Oral Medicine in the School of Dentistry.

Professor McCauley's academic appointments and professional experience include visiting scientist at the Institut de Génétique et de Biologie Moléculaire et Cellulaire in Strasbourg, France from 1998-1999; William K. and Mary Anne Najjar Professor of Periodontics from 2002 to the present; visiting scientist at the École Normale Supérieure in Lyon, France from 2005-2006; visiting professor at the Center for Experimental Therapeutics and Reperfusion Injury, Brigham and Women's Hospital, Harvard Medical School during 2012-2013; and continuing private practice limited to periodontics with the UM Dental Faculty Associates from 1992 to the present.

Professor McCauley has a very impressive portfolio of research and professional leadership. She has more than 120 high quality peer-reviewed publications in the biomedical literature in the areas of hormonal controls of bone remodeling, cancer metastasis to bone, and craniofacial regenerative medicine. She has sustained independent funding as principal investigator from the National Institutes of Health for nineteen years. She is a fellow in the American Association for the Advancement of Science, a diplomat of the American Board of Periodontology, and a fellow in both

the American College of Dentists and the International College of Dentists. She is only the second dentist in the history of the American Society for Bone and Mineral Research (ASBMR) to be elected to its council and she has been selected as the co-chair of the ASBMR 2013 annual meeting scientific program. Among the many recognitions of her research are the inaugural Paula Stern Achievement award, an esteemed award of the ASBMR, in 2010, and a distinguished scientist award from the International Association for Dental Research in 2011. She has consistently contributed to the profession as a peer reviewer and member of many editorial boards including those of the *Journal of Dental Research*, *Osteoporosis International*, and the *Journal of Bone and Mineral Research*. She is currently finishing a 5 year term as associate editor of the latter.

Laurie McCauley has been committed to education throughout her career. She edited a textbook published in 2012 on craniofacial mineralized tissues. Under her leadership as department chair, a new graduate program in oral pathology and a new e-learning dental hygiene degree program were established; in addition, a graduate program in periodontics was extremely successful, garnering numerous awards from the American Academy of Periodontology. She has mentored numerous graduate students who have gone on to tenure-track faculty positions and numerous junior faculty who have received independent research funding and promotion. She has led efforts that ensure processes are in place to secure consistency in teaching in her department. She has also given over 150 presentations world-wide on research and pedagogy. In 2010 she was awarded the William J. Gies Award sponsored by the American Dental Education Association and the American Academy of Periodontology for outstanding contributions to literature and education in periodontology.

Professor McCauley is a seasoned academic administrator, having served ten years as chair of a large multidisciplinary department in the School of Dentistry. During this time she oversaw the successful merger of her department and another, and successfully increased departmental endowment and research funding many-fold. Her service to the School of Dentistry, the University of Michigan, national and international professional committees, and to her civic community is extensive.

I am very pleased that Professor McCauley will assume the leadership of the School of Dentistry. She brings a unique blend of clinical experience, research achievement, pedagogical leadership, and administrative success to the position of dean. She will set measurable expectations for excellence and quality and will guide the School of Dentistry to accomplish mutual goals that continue to elevate its stature as an international leader in dental research, education, and service. We are pleased to recommend the appointment of Nina A. Mendelson as the Joseph L. Sax Collegiate Professor of Law, Law School, effective March 1, 2013 through June 30, 2018.

Professor Sax is a world-renowned environmental law expert who taught at the University of Michigan from 1966 to 1986 as the Philip A. Hart Distinguished University Professor. Professor Sax's writings on the public trust doctrine and "takings" have frequently been cited by the U.S. Supreme Court and remain definitive in the field. He is often called the father of environmental law and advocacy.

After earning a Bachelor of Arts degree from Harvard University and a Juris Doctor degree from the University of Chicago, Joseph Sax began his career working for the U.S. Department of Justice and in private law practice in Washington, D.C. In 1962, Professor Sax joined the law faculty of the University of Colorado, and in 1966, he joined the faculty of the University of Michigan. Twenty years later, Professor Sax left Michigan and joined the University of California – Berkeley's Boalt School of Law faculty, where he is the James H. House and Hiram H. Hurd Professor Emeritus of Environmental Regulation.

Professor Sax is currently a fellow of the American Academy of Arts and Sciences, and his awards and citations include the Distinguished Faculty Achievement Award from the University of Michigan, the Elizabeth Haub Environmental Prize of the Free University of Brussels, the Audubon Society's Conservationist of the Year Award, the William O. Douglas Legal Achievement Award from the Sierra Club, and the Environmental Quality Award of the U.S. Environmental Protection Agency.

Professor Mendelson earned an A.B. *summa cum laude* in economics from Harvard University in 1986, and a J.D. from Yale Law School in 1989. After law school, Professor Mendelson was a law clerk for Judge Pierre N. Leval, U.S. District Court, Southern District of New York in 1989. In 1990 clerked for Judge John M. Walker, Jr., U.S. Court of Appeals, Second Circuit. From 1991-1994, Professor Mendelson practiced law with the firm of Heller, Ehrman, White & McAuliffe; in 1994 work on the Senate Committee on Environment & Public Works. From 1995-1999 she worked for the Department of Justice, Environment & Natural Resources

Division. Professor Mendelson joined our faculty in 1999 as an assistant professor and was promoted to professor, with tenure, in 2004.


Professor Mendelson is a nationally-acclaimed expert on administrative law, with a special emphasis on environmental law; she also teaches a course on legislation and legislative processes. Her scholarship has focused on the possibilities and pitfalls of presidential supervision of the administrative state, entrenchment of promulgated administrative agency rules, and theories and norms of agency interpretation of statutes. A recently published scholarly article titled *Disclosing Political Oversight of Agency Decision Making* earned her a national award bestowed by the American Bar Association's Administrative Law Section for the year's best scholarly article on any topic concerning administrative law. As a result of her highly-regarded work, she was invited to serve as a public member of the Administrative Conference of the United States, a congressionally-created federal advisory committee that counsels all branches of the federal government concerning the need for procedural reforms.

Professor Mendelson has offered outstanding service to the Law School. She was asked to chair the school's standing curriculum committee for an unprecedented three years in a row, reflecting the dean's and faculty's confidence that she uniquely could guide the school through a time of tumultuous change in the legal profession by advocating for an updating of our first-year and skills-based curriculum. She has also ably served the profession, for example, by serving multiple years on the American Bar Association's Section on Administrative Law and Regulatory Policy. She is one of the faculty's most dependably civic-minded colleagues.





Professor Norris' research interests include application of femtosecond optical techniques to the physics of semiconductor nanostructures, in developing new ultrafast optical and optoelectronic measurement techniques, THz generation and measurement, plasmonics in nanostructures, and novel methods for biological imaging and in vivo sensing. He has published approximately 160 refereed journal publications and book chapters. Professor Norris has received many honors and awards including the College of Engineering David E. Liddle Research Excellence Award in 2012 and was named fellow, American Physical Society in 2005 and fellow, Optical Society of America in 2000.



We are pleased to recommend the appointment of Professor William J. Novak as the Charles F. and Edith J. Clyne Professor of Law, Law School, effective March 1, 2013 through June 30, 2018.

The Charles F. and Edith J. Clyne Professorship was established in the Law School in 1987 and was created pursuant to the bequest of Edith J. Clyne, the widow of Charles F. Clyne, a member of the Law School Class of 1902. The Professorship is funded by an endowment from the estate of Edith J. Clyne.

Professor Novak received his B.A. and M.A. degrees from Case Western Reserve University, and his Ph.D. from Brandeis University. His first academic appointment was in 1991 as an assistant professor of history at The University of Chicago. He was promoted to associate professor at the University of Chicago in 1997. He became a member of the Law School's faculty in September 2009 as a professor, with tenure.

Professor Novak is an exceptional legal historian. Professor Novak is actively engaged in a number of academic and service activities related to the field of legal history. He serves on numerous editorial boards of top journals and serves on various prominent professional societies. He also participates in an incredible number and array of academic conferences around the country. At the university, he is part of a triumvirate of renowned faculty members which directs a program on Law, Race and History and mentors a

large number of students interested in these fields. He has become a powerful intellectual voice among the law faculty participating in scholarly conversation at workshops and symposia.




The Jerome W. Conn Collegiate Professorship was established in 2012, through donor and departmental funds. Dr. Conn was the first division director of Metabolism, Endocrine, Nutrition and Diabetes at the University of Michigan. He was credited with the discovery of Conn's Syndrome, or hyperaldosteronism, which is a disorder stemming from an adrenal tumor, that produces too much aldosterone.

William E. Rainey received his Ph.D. degree from the University of Texas Southwestern Medical Center in 1985. He completed a fellowship in Grenoble, France, and was a Fogarty International Postdoctoral Fellow in Lyon, France. Dr. Rainey became a research instructor at the University of Texas and rose through the ranks to professor, with tenure, in 2003. He held an appointment as a professor at the Medical College of Georgia in 2005, and joined the faculty at the University of Michigan in 2012 as a professor of molecular and integrative physiology and internal medicine.

Dr. Rainey is an internationally known expert in the area of endocrinology, particularly related to adrenal physiology and tumors. His research focuses on the mechanisms regulating normal adrenal gland function, as well as causes of diseases associated with adrenal steroid excess or deficiency. He has published over 160 articles, and has been invited to present at numerous national and international venues. Dr. Rainey has held positions on numerous scientific journals and currently serves as managing editor of the *American Journal of Physiology* and *Endocrinology*. He is a permanent ad hoc member for the NIH and is on the editorial board of *Endocrinology and CardioRenal Medicine*.






This endowed professorship was established by ERIM in 2000 to support the teaching and scholarship of a distinguished faculty member in the College.





The University of Michigan currently recognizes 230 distinguished senior faculty members by awarding unendowed Collegiate Professorships. Twenty-five of these awards were initially approved by the Regents in 1973. The number of professorships has gradually expanded since 1981, bringing the total to its current level of 230.

Collegiate Professorships are typically named for deceased or retired members of the faculty. Faculty are appointed to these professorships by the Regents upon recommendation of the Provost and the Dean, based on unit selection criteria. Appointments are generally for five-year, renewable terms. Holders typically receive an annual stipend of \$3,000. The first thirty professorships created in 1973 and 1981 are funded from an unrestricted endowment fund. Professorships created since that time are funded from unit resources.

The Collegiate Professorships continue to be an important means of honoring distinguished faculty and have contributed significantly to the University's ability to retain some of its most prestigious faculty. I respectfully request that the Regents approve the creation of 50 additional Collegiate Professorships bringing the total to 280. The Professorships will be held in the Office of the Provost for distribution to the Schools and Colleges as needed. These additional Professorships will be funded from unit resources.

We are pleased to recommend that the title of the Helen Herzog Zell Professorship in Fiction be changed to the Nicholas Delbanco Visiting Professorship, College of Literature, Science, and the Arts, effective March 21, 2013.


Chicago philanthropist Helen Zell, a 1964 graduate of the University of Michigan's Department of English Language and Literature, became involved in the College of Literature, Science, and the Arts Master of Fine Arts (MFA) in the Creative Writing Program in 2001, when she endowed the department's first visiting professorship in fiction. Named the Helen Herzog Zell Professor, it drew visiting professor Nancy Reisman to campus in 2001. Professor Reisman's debut novel, the *First Desire*, was named a 2004 *New York Times* Notable Book and received the 2005 Goldberg Prize for Jewish Fiction by Emerging Writers from the Foundation for Jewish Culture. She was the first of many to hold this position.

Ms. Zell has now requested that the professorship be renamed as the Nicholas Delbanco Visiting Professorship. The change is intended to honor Professor Delbanco, the Robert Frost Distinguished University Professor of English Language and Literature, and one of the first directors of the Creative Writing Program. He continues to teach in the program.


Ms. Zell's dedication and support of the program has grown significantly over the ensuing years. In 2004, Ms. Zell committed \$10 million in seed funding to the program to fuel its growth. In the past nine years the program has earned recognition as one of the top writing programs in the country. Ms. Zell recently donated \$50 million to the program, the largest single gift ever allotted to a writing program and the largest gift ever to the College of Literature, Science, and the Arts. In recognition of her support, the program has been renamed the Helen Zell Writers' Program.

In recognition of Helen Zell's request, we are pleased to recommend that the title of the Helen Herzog Zell Professorship in Fiction be changed to the Nicholas Delbanco Visiting Professorship, College of Literature, Science, and the Arts, effective March 21, 2013.





Dr. McGuire joined the faculty at the University of Michigan in 1983 as a professor of surgery and the section head of urology. He became associate chair of the Department of Surgery in 1988, and was appointed as director of the division of urology in 1993. Dr. McGuire spent six years in Houston at the University of Texas Health Science Center and returned to the University of Michigan in 1999, where he headed the division of neurology and pelvic reconstructive surgery until 2007. He is the Reed Nesbit Professor of Urology, a distinction that was bestowed upon him in 2007.






