Subject: Regental Action Required Under the State of  
Michigan Conflict of Interest Statute

Action Requested: Authorization for the University to extend an agreement with ArborMetrix  
(University of Michigan Employee, Dr. Justin Dimick, Co-Founder and Part  
Owner)

Background:

The University of Michigan Department of Surgery seeks approval to extend an agreement with ArborMetrix to provide a measurement and reporting platform to support the quality improvement initiative titled the Michigan Trauma Quality Improvement Program (MTQIP). The current agreement expiration date will remain intact. This request seeks to include the optional participation of non-state of Michigan hospitals.

The proposed agreement falls under the State of Michigan Conflict of Interest Statute as Dr. Justin Dimick is a University employee as Professor of Surgery with the Department of Surgery, Division of General Surgery and would be party to the contract as Co-Founder and Part Owner of ArborMetrix.

However, the Statute allows the University to enter into such agreements if the following conditions are met:

- a) The public servant promptly discloses any pecuniary interest in the contract to the official body which has power to approve the purchase, which disclosure shall be a matter of record in its official proceedings.
- b) The purchase is approved by a vote of not less than 2/3 of the full membership of the approving body in open session without the vote of the public servant making the disclosure.
- c) The official body discloses the following summary information in its official minutes:
  - i) The name of each party involved in the contract.
  - ii) The terms of the purchase, including duration, financial consideration between the parties, facilities or services of the public entity included in the purchase, and the nature and degree of assignment of employees of the public entity for fulfillment of the purchase.
  - iii) The nature of any pecuniary interest.


The following information is provided in compliance with the statutory requirements contained in Section (c) above:

- i) The parties to the contract are the Regents of the University of Michigan and its Department of Surgery and ArborMetrix.
- ii) The agreement will include the optional participation of non-state of Michigan hospitals at an annual fee of \$3,000 per participating hospital. The university will pay ArborMetrix directly, while Blue Cross Blue Shield of Michigan will reimburse the university for these fees. ArborMetrix will be supplying all the necessary resources and personnel to fulfill this contract. The remaining base contract terms and conditions are typical to those used in Procurement Services standard templates for other similar contracts entered into by the Regents.
- iii) The pecuniary interest arises from the fact that University of Michigan employee Dr. Justin Dimick is Co-Founder and Part Owner of ArborMetrix.

Dr. Justin Dimick has met state law requirements with the disclosure of his pecuniary interest and formal appointment arrangements with the University of Michigan. Requirements, if any, that may be applicable by the supervisor of Dr. Justin Dimick under the Medical School's or OVPR's Conflict of Interest Committee's procedures are separately analyzed and managed.

We recommend that the Board of Regents approve the agreement between the University of Michigan and ArborMetrix subject to requirements, if any, that the supervisor of Dr. Justin Dimick or the Medical School's or OVPR's Conflict of Interest Committee may impose.
