Subject: Central Student Government (CSG) Report

President Schlissel, members of the Board of Regents, and Executive Officers of the University,

We are pleased and honored to submit the following report to you on behalf of CSG:

As the last CSG report that Amanda and Saveri have the opportunity to deliver, we wanted to reflect on the lessons we have learned from the COVID-19 pandemic. Even as vaccination distribution increases and the threat of the virus decreases, we believe these problems are pressing. They were present before COVID-19, were exacerbated by COVID-19, and they will affect students after COVID-19.

1. **Mental Health:** This is probably the most important issue for students right now. The isolating effects of COVID-19 only worsened the mental health of our students. The University must work with a diversity of students to reimagine the provision of mental health resources on our campus and find ways for the University to alleviate students' mental health burden.
2. **Climate Action:** The effects of global warming are increasing every day, and the University has an obligation to its community to be a leader in this realm. I am excited to learn of the new, bold steps the University is taking to achieve carbon neutrality and rethink its investment structure. We must ensure these actions are swift, transparent and collaborative.
3. **Affordability and Accessibility:** The cost of attending higher education has only increased despite the financial implications of the pandemic. We must increase the affordability and accessibility of attending the University of Michigan. This means extending the Go Blue Guarantee to the Flint and Dearborn campuses, ensuring that the "Cost of Attendance" for students accurately reflects their lived experiences, and including students more meaningfully in University budgetary processes.
4. **DEI & Anti-Racism:** We have to recognize how our institution is complicit in bolstering and actively creating an environment that challenges students of color, more than their white peers. Measures implemented to protect students of color will always protect all students on campus, and there needs to be a sense of urgency in the face of racial injustice.
5. **Shared Governance:** Finally, the University should be doing more to ensure that all stakeholders are included in important decisions. This means undergraduate, graduate and professional students, RAs, GSIs and GSSAs, lecturers, nurses and healthcare workers, staff, and more. We must meaningfully engage these groups *during* the policymaking process.

We are proud of the work we did to support students during this unprecedented year. Despite being 100% virtual, we were able to implement projects and successfully advocate for policies which we believe enhanced the student experience. We hope that, looking to next year, you all will continue to engage CSG leaders in these important conversations. It has been quite the honor for us to serve in these roles this year, and we want to thank all of you who worked with us for your support.

We are optimistic and excited for all that is to come at the University of Michigan in the future.
