On the recommendation of the Department of Social and Administrative Sciences and with the endorsement of the College of Pharmacy Executive Committee and the School of Public Health, we are pleased to recommend the appointment of Rajesh Balkrishnan as associate professor of social and administrative sciences, with tenure, College of Pharmacy, and associate professor of health management and policy, without tenure, School of Public Health, effective June 1, 2009.

ACADEMIC DEGREES

Professor Balkrishnan received his BS in pharmaceutical sciences (1995) from the University of Bombay, India, and his MS in pharmaceutical policy (1997) and his PhD in health outcomes/pharmaceutical health services research (1999) both from the University of North Carolina at Chapel Hill.

PROFESSIONAL RECORD

Professor Balkrishnan joined the faculty at Wake Forest University School of Medicine as assistant professor of social sciences and health policy in 1999. In 2000 he was given the additional appointment of associate in internal medicine and surgery, and in 2001 he was appointed as an assistant professor of dermatology and named a Brooks Scholar in Academic Medicine. In 2003 he moved to the University of Texas as associate professor of management and policy sciences, associate professor of dermatology, and co-director of the Center for Dermatology Research. Professor Balkrishnan moved to The Ohio State University in 2005, where he was appointed as the Merrell Dow Professor of Pharmacoeconomics and Outcomes Research, associate professor of pharmacy practice and administration, associate professor of health services and management, and associate professor of internal medicine.

SUMMARY OF EVALUATION

Professor Balkrishnan is a highly qualified quantitative health services researcher whose work generally focuses on the application of statistical methodology in examining issues related to effectiveness of medical care delivery and health outcomes in chronic disease. His research has examined diverse topics related to evidence-based managed care, risk adjustment of health outcomes, quality of primary care, patient safety, economic evaluation of newly introduced pharmaceuticals and patient-centered outcomes evaluation (specifically focused on patient trust, satisfaction and adherence behavior). In particular, he has a strong disease-specific research interest in outcomes evaluation in dermatological conditions and chronic diseases and the study of outcomes related to controller pharmacotherapy, especially in diabetes, psoriasis, and asthma, as well as significant research interests in geriatric populations. He is extremely productive and has been successful at attracting external funding for his work, as well as presenting his

work and publishing the results in quality journals. His work is consistently cited, and he is well-known in his field of expertise. Professor Balkrishnan is a successful and dedicated teacher. His participation in graduate and professional courses has been enthusiastically received by students, and his teaching has been rated as outstanding. His graduate students were awarded the best student research paper presentation at the International Society of Pharmacoeconomics and Outcomes Research (ISPOR) annual meeting twice (2006 and 2008), as well as the best student research paper at the Hayes Annual Research Forum at The Ohio State University in 2006. Professor Balkrishnan is a member of several professional organizations and serves as a member or chair of numerous professional committees. He currently serves on five journal editorial boards and is a reviewer on over 30 journals. He will chair the grant program proposal review board for the Behavioral Sciences and Epidemiology National Study Section of the American Heart Association in 2009 and has been invited to serve as a consultant on projects conducted in industry, education, and government. He has been an active citizen of his school and university.







With the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the reappointment of David J. Fink, M.D., professor and chair of the Department of Neurology, as the Robert W. Brear Professor of Neurology, effective May 1, 2009.


The Brear Professorship was established in December 2001, through a bequest from the estate of Mr. Robert W. Brear, with the directive that the gift be used to benefit the Department of Neurology.

Dr. Fink received the M.D. degree from Harvard Medical School and pursued a neurology residency at the University of California, San Francisco. He first joined the faculty at the University of Michigan in 1982 and attained the academic rank of associate professor of neurology, with tenure, in 1988. In 1994, he relocated to the University of Pittsburgh as a visiting professor and then was appointed as professor of neurology in 1995 at that institution. Dr. Fink returned to the University of Michigan in 2004 as professor and chair of the Department of Neurology. He also was named the Robert W. Brear Professor of Neurology at that time.

Dr. Fink's recent research has focused on gene therapy to the central nervous system. He has been very well funded throughout his career and currently is the principal investigator on two grants from the National Institutes of Health, two merit awards from the Department of Veteran Affairs, and a grant from the Juvenile Diabetes Research Foundation, as well as corporate grants for clinical trials. His bibliography reflects over 130 peer-reviewed articles, with numerous chapters in books and abstracts. His expertise is well recognized, and he is often invited to present his work at national and international venues.



An additional appointment in Women's Studies was approved by the Regents in 2002, and an appointment as chair of the Department of Romance Languages and Literatures from 2003 to 2006. She also served for two years as graduate chair in Women's Studies, for three years as a senior fellow in the Michigan Society of Fellows, and as a member of the Rackham Executive Board in 2003. She has served as an associate dean for academic programs and initiatives in the Horace H. Rackham School of Graduate Studies from 2006 to 2009.

Professor McCracken's research interests lie in the area of medieval French literature. She has, however, become increasingly interdisciplinary and focused on issues of gender and sexuality in Old French literature and medieval literature. Selected publications include The Curse of Eve, the Wound of the Hero: Blood, Gender, and Medieval Literature (2003), The Romance of Adultery: Queenship and Sexual Transgression in Old French Literature (1998); and articles in

Cambridge Companion to the Arthurian Legend, *French and Francophone Masculinities*, *The Cambridge Companion to Medieval French Literature*, *Romanic Review*, *Yale French Studies*, *Exemplaria*, *The Arthurian Yearbook*; and various collections of essays. She is chief editor of *Feminist Theory Reader* (2007) and co-editor of *Constructing Medieval Sexuality* (1997) and, with Basil Dufallo, *Dead Lovers: Erotic Bonds and the Study of Premodern Europe* (2006). Her teaching, research, and professional service have equipped her well to carry out the duties of associate dean.

We are confident that Professor McCracken will continue to provide strong and effective encouragement and leadership for academic program development, interdisciplinary initiatives, and graduate education more generally. We are therefore pleased to recommend the reappointment of Peggy S. McCracken as associate dean for academic programs and initiatives in the Horace H. Rackham School of Graduate Studies for a two year term, effective August 1, 2009 through July 31, 2011.

funded by the National Institutes of Health entitled "Establishing the Prevalence of Incontinence."



On the recommendation of the Executive Committee of the College of Engineering and with the endorsements of the Department of Surgery and the Department of Biomedical Engineering, I am pleased to recommend the joint appointment of Margaret V. Westfall as associate professor of biomedical engineering, without tenure, Department of Biomedical Engineering, College of Engineering, effective September 1, 2009.

Professor Westfall received her B.A. in biology from Colorado College in 1978 and her M.S. in microbiology from the University of Montana in 1981. She received her Ph.D. in physiology from Loyola University of Chicago in 1989. Immediately following graduation, Professor Westfall served as a postdoctoral fellow at the University of Illinois at Chicago. In 1993, Professor Westfall came to the University of Michigan as a postdoctoral fellow in the Department of Physiology. From 1998 to 2000, she held an appointment as an assistant research scientist. In 2000, she accepted the position of assistant professor of surgery and was promoted to associate professor, with tenure, in 2008.

Professor Westfall's lab is interested in understanding how muscle contraction is regulated by the multimeric troponin complex in striated muscle. Troponin is located within the thin filament and it is known to be critical for regulating Ca²⁺-activated contraction in striated muscle. An important focus of current research efforts in this area of muscle biology is to better understand how molecular interactions among troponin subunits act to regulate muscle contraction. The inhibitory troponin subunit, troponin I (TnI), plays a critical role in this process by inhibiting tension development until Ca²⁺ binds to regulatory sites on the Ca²⁺ binding subunit, troponin C. Recent advances in molecular biology have allowed Professor Westfall's lab to further define the role of TnI in Ca²⁺-activated contraction in the intact myofilament of adult cardiac myocytes. Using viral-mediated gene transfer into adult cardiac myocytes, we have examined the effects of two different TnI isoforms on tension development and found that different isoforms of TnI strongly influence myofilament Ca²⁺ sensitivity and pH sensitivity. More recently, the domains within TnI which influence these myofilament functions have been investigated by making chimeras of the two isoforms. This approach has the potential to provide a better understanding of functional TnI domains and the important interactions among thin filament proteins that are necessary for the regulation of muscle contraction. Ultimately, the knowledge gained from these studies may lead to an improved understanding of pathophysiological conditions in the heart and to better treatment of these conditions.

With this additional appointment, Professor Westfall is ideally suited to assist the Department of Biomedical Engineering by her active involvement with research and students. I am pleased to recommend the joint appointment of Margaret V. Westfall as associate professor of biomedical engineering, without tenure, Department of Biomedical Engineering, College of Engineering, effective September 1, 2009.




Dr. Chandler obtained his M.D. degree from the University of Michigan in 1971, and completed an internship and residency in neurosurgery also at this institution. Dr. Chandler advanced through the academic ranks to achieve the title of professor of neurosurgery in 1989. 




Dr. McGillicuddy attended Dartmouth Medical School, receiving a bachelor of medical sciences degree in 1964. He continued his education at the Harvard Medical School, obtaining the M.D. degree in 1966. He completed an internship and one year of general surgery residency at the Medical College of Virginia in Richmond, Virginia. He then served on active duty with the United States Navy, including service in Viet Nam with the First Marine Division, completing his service obligation in 1970. From 1970-1974, Dr. McGillicuddy was a resident in neurosurgery at the University of Michigan, and joined the faculty at this institution in 1976. He was promoted through the academic ranks to achieve the title of professor of neurosurgery in 1998. He retired from the active faculty in 2007 and currently holds the title professor emeritus of neurosurgery.

Dr. McGillicuddy's initial career interests were focused on cerebrovascular surgery, cerebral vasospasm, cerebral ischemia and states of increased intracranial pressure. His bibliography reflects numerous publications and presentations in these areas. Later in his career, Dr. McGillicuddy directed much of his attention to the practice of reconstructive spinal surgery, and he assisted in the establishment of the spinal surgery program at the University of Michigan. His work is now focused on brachial plexus injuries, thoracic outlet syndrome, and obstetric brachial plexus palsy. Dr. McGillicuddy is a Diplomate of the American Board of Neurological Surgery.

Dr. McGillicuddy was elected as a fellow of the American College of Surgeons in 1979. He has held numerous leadership positions in professional organizations, including the Neurosurgical Society of America, the Society of University Neurosurgeons and the American Heart Association of Michigan. During his tenure at the University of Michigan, he ably served on educational and clinical committees for his department, the school, and hospital.






