On the recommendation of the Executive Committees of the Department of History and the College of Literature, Science, and the Arts, we are pleased to recommend the appointment of Pamela Ballinger as the Fred Cuny Professor of the History of Human Rights for a five-year renewable term, effective September 1, 2011 through August 31, 2016, and associate professor of history, with tenure, College of Literature, Science, and the Arts, effective September 1, 2011.

ACADEMIC DEGREES

Pamela Ballinger received her Bachelor of Arts from Stanford University in 1990 and her Masters of Philosophy from Cambridge University in 1991. She attended the Johns Hopkins University where she completed her Master of Arts in 1994 and Doctorate in 1999. She was a fellow at the Center for Advanced Study in the Behavioral Sciences at Stanford University (2009-2010) and is currently a Burkhardt Fellow at the American Academy in Rome (2010-2011).

PROFESSIONAL RECORD

Professor Ballinger began her teaching career as an assistant professor at Bowdoin College in 1998 and was promoted to associate professor in 2004. She served as chair of the Department of Sociology and Anthropology from 2006 to 2009.

SUMMARY OF EVALUATION

Professor Ballinger is an accomplished researcher in the historical and cultural study of southeastern Europe. Her work addresses issues central to the emergence after 1945 of "international human rights" as a discourse and practice in contemporary politics and world affairs. In her first book, *History in Exile: Memory and Identity at the Borders of the Balkans* (2003), Professor Ballinger focuses on the issues of national identity in a border region of the eastern Adriatic. Her current book-in-progress, *Forgotten Refugees: Decolonization, Displaced*

Persons, the Reconstruction of Italy, studies the movement of Italian refugees after World War II. A further book, tentatively entitled *The Shores of Capitalism: Ownership, Access, and Sovereignty in Postsocialist Croatia* will emerge from work she is currently conducting. The establishment of the Fred Cuny Professorship, and the recruitment of Professor Ballinger to fill it, successfully bolsters the University's capacities as a premier site for the history of human rights, European history, and Russian, East European and Eurasian studies at the Weiser Center for Europe and Eurasia, where she will be welcomed as a faculty associate.

Matthew Evans received his Bachelor of Arts from Vassar College in 1995. He attended the University of Texas at Austin where he completed his Master of Arts in 1998 and Doctorate in 2004.

PROFESSIONAL RECORD

Professor Evans began his teaching career as an assistant professor at New York University in 2004. He was appointed as a visiting assistant professor at Yale University in 2010.

SUMMARY OF EVALUATION

Professor Evans is a historian of ancient philosophy who specializes in Platonic ethics; however his work encompasses moral psychology and metaphysics as well as the works of Epicurus. He is recognized by his peers as one of the most exciting researchers in his field. His work is incisive, rigorous, and fair-minded. Two of his recent papers have appeared in the best specialist journals and a third in a highly selective collection. A co-authored paper is forthcoming in one of the top journals in the field of ethics. Professor Evans held a Laurence S. On the recommendation of the Chair of the Department of Biostatistics, and with the endorsement of the Executive Committee of the School of Public Health, we are pleased to recommend the appointment of Timothy D. Johnson, Ph.D. as associate professor of biostatistics, with tenure, School of Public Health, effective September 1, 2011.

Academic Degrees

Professor Johnson received a BS degree in mathematics at the University of California, Riverside in 1984 and an MS degree in mathematics from the same university in 1986. In 1997, he received a PhD degree in biostatistics from the University of California, Los Angeles.

Professional Record

Professor Johnson joined the UCLA Department of Biomathematics as a senior statistician in 1997 and in 1998 he was given a faculty appointment as assistant adjunct professor of biomathematics. He joined the University of Michigan in 2001 as an assistant research scientist in the Department of Biostatistics and was promoted to research associate professor and adjunct associate professor of biostatistics in 2006.

Summary of Evaluation

Bayesian inference is the framework that guides Professor Johnson's theoretical work. He has three methodological interests, and his primary collaborators at the U of M are in radiology and radiation oncology. His main interest is statistical image analysis, in particular the analysis of fMRI and qMRI data. His contributions include joint and/or hierarchical (2-stage) modeling in which the error from the first stage is incorporated into the second stage and the model accounts for spatial correlation. His long-term goal is to develop a fully Bayesian spatiotemporal model for individual- and group-level image analysis.

Professor Johnson has authored or co-authored 66 articles that have appeared or were recently accepted by peer-reviewed journals; he is the first author of six. Thirty-six of those papers have appeared or been accepted since 2006, the year he was promoted to his current position at the U-M. Of those 36 papers, Professor Johnson is the first author of three, and his doctoral student advisees are the first authors of five. He has also co-authored three peer-reviewed chapters, one as the first author.

As a member of the research faculty, 85% of Professor Johnson's salary is supported by extramural grants, most of which now come from studies with colleagues in radiology and radiation oncology. He was the principal investigator of an R01 grant on "Nonparametric inference for neuroimaging data," which ended in December 2009. Currently, Professor Johnson is biostatistics core director on three projects: two program projects (P01s) involving tumor imaging, for which he is the coprincipal investigator; and a center grant (P50) involving *in vivo* imaging of neoplasia. These three grants currently account for 62% of his salary; another 23% comes from several other smaller grants for which he is a co-investigator or the project biostatistician. In addition, he submitted an application as the principal investigator in October 2010 to study "Bayesian spatial process modeling of neuroimaging data," which would support 25% of his salary, and he is involved in 10 other grant applications that are pending.

Although teaching is not a requirement for research faculty in the School of Public Health, Professor Johnson has taught one course each year since 2001. He has received good-to-excellent student ratings, ranging from 4.06 to 5.00, for his more advanced courses in Applications of Stochastic Processes (Biostat 680), Analysis of Categorical Data (Biostat 695), Applied Bayesian Inference (Biostat 682), and Advanced Bayesian Modeling and Computation (Biostat 830).

Professor Johnson has an excellent record mentoring PhD students in biostatistics. He has chaired or co-chaired seven dissertation committees, including four students who have already graduated, and he has served on eight other dissertation committees. Some of his students have been supported by his grants, and his students have had considerable success in their graduate studies.

Professor Johnson has a solid record of service to the Department of Biostatistics and the University of Michigan. He has served on at least one departmental committee each year since 2001, including Computing, Admissions, Candidacy, a faculty search, and the Executive Board for the Biostatistics Training in Cancer Research training grant. He also served on the Comprehensive Cancer Center Scientific Protocol Review Committee for six years, and currently represents faculty in the School of Public Health on the U-M Senate Assembly. Professor Johnson is a reviewer for several peer-reviewed journals, including 15 this past year, in the fields of biostatistics, medical imaging, and statistical computation; and he served as an associate editor for the *Bulletin of the International Society for Bayesian Analysis*.

Peter McIsaac received his Bachelor of Science from the University of Michigan in 1990 and his Doctorate from Harvard University in 1996.

PROFESSIONAL RECORD

Professor McIsaac began his teaching career as a lecturer at Tufts University and at Harvard University in 1996. He was appointed at Duke University as a visiting assistant professor in 1998 and as an assistant professor in 1999. He then joined the faculty at York University as an assistant professor in 2007 and was promoted to associate professor in 2009. He has been appointed as a visiting associate professor at Michigan since 2009.

SUMMARY OF EVALUATION

Professor McIsaac's scholarship takes place at the intersection of modern German literature and culture, museum studies, science and technology, and cultural policy. His first book was published in 2007 by Penn State University Press and he is currently writing a book-length manuscript on the "secret" German pre-history to *Body Worlds*, a contemporary exhibition of human corpses that has broken attendance records and generated controversy around the world. Part of this work appeared in the 2007 volume *Museums & Difference*. Additional work in progress focuses on gender and performativity in anatomy exhibitions around 1900, the visual archive of Gottfried Benn's early poetry, and shifts in German cultural policy resulting from European Union integration and globalization. He serves on the editorial boards of *The German Quarterly* and *German Politics and Society*.

On the recommendation of John M. Carethers, John G. Searle Professor and Chair of the Department of Internal Medicine, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the reappointment of Charles F. Burant, M.D., Ph.D. as the Dr. Robert C. and Veronica Atkins Professor of Metabolism, Medical School, effective April 1, 2011 through August 31, 2015.

The Dr. Robert C. and Veronica Atkins Professorship in Metabolism was established in 2006 through a generous gift agreement from the Robert C. Atkins Foundation and is intended to support research in the area of metabolic diseases. This professorship is intended to support the research efforts of an outstanding investigator seeking to understand the complex biology of metabolism, especially as it relates to diabetes, nutrition and obesity, and to develop new treatment strategies for these conditions.

Dr. Burant is a leader in the field of diabetes and metabolism research as is evidenced by his being awarded two NIH R01 grants and an American Diabetes Association award during the past five years. His national and international reputation is reflected by his numerous invited talks and publications. Dr. Burant has served as editor and primary author of the official American Diabetes Association's book *Medical Management of Type 2 Diabetes*. He is also a member of the American Diabetes Association Oversight Committee. In 2008, Dr. Burant was named Researcher of the Year by the Michigan Affiliate of the American Diabetes Association. Recently, he was named a University of Michigan A. Alfred Taubman Scholar.

Dr. Burant mentors multiple students and fellows, and serves as director of the Postdoctoral Translational Scholars Program for the Michigan Institute of Clinical and Health Research. He is director of the Fellowship Program in Metabolic Diseases and director of the University of Michigan Center for Metabolomics and Obesity.

Dr. Burant continues to make significant contributions to the educational, research and service missions of the University of Michigan Medical School. I am pleased, therefore, to recommend the reappointment of Charles F. Burant, M.D., Ph.D. as the Dr. Robert C. and Veronica Atkins Professor of Metabolism, Medical School, effective April 1, 2011 through August 31, 2015.

I am pleased to recommend the reappointment of Paul N. Courant as university librarian and dean of libraries, effective February 29, 2012 through August 31, 2013.

Paul Courant has worked locally as well as nationally to improve library collaboration and public policy, benefitting scholarship and teaching. As university librarian, he has improved university library efficiencies and reduced costs while increasing the use of library expertise and resources for broader university purposes. His focus on library economics, rationalization of the number of libraries on Ann Arbor campus, and sound management practices provided opportunities to improve services. Repurposed space and other resources made gallery exhibits and public display of special collections materials possible, drawing thousands.

Dean Courant is recognized nationally as a thought leader in scholarly publication, particularly in digitization. His influence in this area, as well as library collaboration and public policy, has brought national attention to the University Library at U-M. He has worked to ensure that the cultural record is preserved and accessible through collaboration with other major universities to establish the HathiTrust Digital Library, which now has more than 50 member libraries and is an essential part of the national library infrastructure, particularly for digitized public domain works. Along with his work on the HathiTrust Digital Library, Dean Courant is on the Board of the Council for Library and Information Resources and the Council for Research Libraries. He recently joined the Board of Trustees of ARTstore, a digital library founded by the Andrew W. Mellon foundation. He was a member of the Blue Ribbon Task Force on Sustainable Digital Preservation and Access, funded by the National Science Foundation and the Andrew W. Mellon Foundation, in partnership with the Library of Congress, the Joint Information Systems Committee of the United Kingdom, the Council on Library and Information Resources, and the National Archives and Records Administration.

Dean Courant has served as provost and executive vice president for academic affairs, as associate provost for academic and budgetary affairs, as chair of the Department of Economics, and as director of the Institute of Public Policy Studies (predecessor of the Gerald R. Ford

School of Public Policy). He served as a senior staff economist at the Council of Economic Advisers from 1979 to 1980 and as a member of the Technical Advisory Committee for the Congressional Budget Office in 1987-88.

Dean Courant holds a BA in history from Swarthmore College (1968); an MA in economics from Princeton University (1973); and a PhD in economics from Princeton University (1974).

Under Paul Courant's effective leadership, the University of Michigan Library has become more efficient as well as grown in stature. His work in scholarly publication, economies of libraries and archives, public policy and the effect of information technologies has had international influence.

Professor Smith graduated from the University of Michigan with an A.B. (economics) in 1981. He received his Ph.D. in economics from Texas A & M University. With the approval of the Executive Committee of the School of Public Health, we are pleased to recommend the reappointment of Jeremy M.G. Taylor as the Pharmacia Research Professor of Biostatistics, School of Public Health, effective July 1, 2011 through June 30, 2016.

The purpose of the Pharmacia Research Professorship, established in 1996, is to support research and instruction in the area of biostatistics in public health. It is designed to promote development and elaboration of statistical methods sensitive to the complexities of population data regarding salient health problems.

Professor Taylor received a B.A. in mathematics in 1978 from Cambridge University, England, and a Ph.D. in statistics from the University of California at Berkeley in 1983. He joined the departments of biostatistics and radiation oncology at UCLA in 1981, and held appointments as adjunct assistant professor, assistant professor in residence, associate professor in residence, and professor in residence (1993-1998). He joined the University of Michigan faculty in 1998 as professor of biostatistics and professor of radiation oncology. Professor Taylor also serves as associate director for biostatistics at the University of Michigan Comprehensive Cancer Center, and is a research professor in the Center for Computational Medicine and Bioinformatics. He has held the Pharmacia Research Professor of Biostatistics since 2006.

Professor Taylor has made remarkable methodological contributions in many areas of research including models for AIDS data analysis and methods for the analysis of prostate cancer. He has a tremendous record of publication in the top statistical and biomedical journals, including *Biometrics*, *Biometrika*, and *Journal of the American Statistical Association*. Professor Taylor has worked in various areas of statistics and biostatistics, including Box-Cox transformations, longitudinal and survival analysis, cure models, missing data, smoothing methods, surrogate and

auxiliary variables. He has been heavily involved in collaborations in the areas of radiation oncology, cancer research and bioinformatics. More recent applied work has been concerned with methods for combining multiple biomarkers, methods for analyzing data from gene expression arrays and design of phase I trials in oncology. His fundamental work on the modeling and analysis of survival models with a cure fraction is widely known and often referenced as is his work on marker processes in the context of cancer research. He has also been extremely effective in getting his research funded through grants from NIH and other organizations.

Recognition of Professor Taylor's accomplishments by the scientific community is evident in his having received prestigious awards, including the Mortimer Spiegelman Award from APHA, the Michael Fry Award from the Radiation Research Society, and the School of Public Health Excellence in Research Award. He is a fellow of the American Statistical Association and has extensive editorial experience, including associate editorships for the *Journal of the American Statistical Association* and for *Lifetime Data Analysis*.

Professor Taylor has served the School of Public Health and the University of Michigan with great distinction. His reappointment to this professorship will be a well deserved recognition of his valuable contributions. We are pleased to recommend the reappointment of Jeremy M.G. Taylor as the Pharmacia Research Professor of Biostatistics, School of Public Health, effective July 1, 2011 through June 30, 2016.

Sara Blair earned her Bachelor of Arts degree with highest honors in English and philosophy at the University of Virginia in 1982, did postgraduate studies in the sociology of literature at the University of Essex in 1983-1984, and completed her Doctorate at Stanford University in 1989. She served as an assistant professor at the University of Virginia from 1989-1995, was the director of the Modern Studies Program there from 1989-1992, and was an associate professor (with tenure) in the Department of English from 1995-1999. She has served on the faculty of the Bread Loaf School of English since 1995. Professor Blair joined the faculty at the University of Michigan as a visiting associate professor during the 1996-97 academic year, was a visiting associate professor at the California Institute of Technology in 1998-99 and returned to the University of Michigan as an associate professor (with tenure) in 1999. In 2007 she was promoted to professor of English language and literature; she has also served as a faculty associate in both American Culture and Judaic Studies since that time. Professor Blair served as the director of graduate studies in the Department of English from 2008-2011, is the founder of and has served as faculty director of The Visual Culture Workshop since 2006, and was the director of the English Honors Program from 2000-2005.

Professor Blair's research interests lie in the areas of late nineteenth and twentieth century American literature, American studies, photography and visual culture, and modernism and modernity. Selected publications include Documentary Redefined (forthcoming in 2011) which she has co-authored with Eric Rosenberg; Harlem Crossroads: Black Writers and the Photograph in the Twentieth Century (2007); Henry James and The Twentieth Century (2007); Henry James and The Oxford Handbook of Global Modernism, The Oxford Historical Companion to Henry James, Modern Fiction Studies, and The Cambridge Companion to Ralph Ellison, among others.

Professor Blair's teaching, research, and administrative service have equipped her well to carry out the duties of associate dean. Dr. Borjigin received the Ph.D. degree in neuroscience from Johns Hopkins University in 1994. From 1994-1996, she completed a postdoctoral fellowship in neuroscience, also at that institution. She continued her research training at Johns Hopkins and at the Carnegie Institution of Washington in Baltimore, Maryland, before joining the faculty at the University of Michigan in 2003 as an assistant professor of molecular and integrative physiology. Dr. Borjigin is a nationally renowned physiologist with expertise in circadian rhythms and the interaction between sleep and circadian processes. Her work directly relates to the activities of the multidisciplinary Sleep Disorders Program. She has long-standing research collaborations with physiology faculty related to the investigation of the interaction of sleep and circadian rhythms with stroke. With the support of the faculty, I am pleased to recommend the appointment of Professor Caroline Constant as the Emil Lorch Collegiate Professor of Architecture and Urban Planning, A. Alfred Taubman College of Architecture and Urban Planning, effective September 1, 2011 through August 31 2014.

In 1906, architecture was established as a program in the Department of Engineering, and Emil Lorch was appointed as the chair. Throughout his 34-year career at Michigan, Professor Lorch developed a nationally recognized program known for innovation, design and technology. The Emil Lorch Collegiate Professorship in Architecture and Urban Planning was established by the Regents in August 1977 to honor the founder of this college.

Professor Constant received her undergraduate education at Vassar College and a Master of Architecture from Princeton University in 1976. Prior to joining the Taubman College in 2001, she taught at the University of Maryland, Harvard University and the University of Florida. During her career she has also held visiting critic and visiting professor appointments at Catholic University of America, the University of Miami, Rice University, Berlage Institute in Amsterdam, and the University of Minnesota where she was the Cass Gilbert Visiting Professor of Architecture.

Professor Constant has a strong record of creative achievement that spans scholarly publication, including books, articles, book chapters, presentations, lectures, design and exhibit organization. She is highly regarded as a scholar whose work is centered at the interdisciplinary intersection of architecture, landscape architecture and the decorative arts. Her work challenges the traditional boundaries between architecture and landscape, between theory and practice. Her book on the early Modernist architect Eileen Gray is credited with uncovering Gray's previously overlooked role on several notable Modernist commissions.

Currently, Professor Constant is completing work on another book, *The Modern Architectural Landscape*, which examines disciplinary intersections between architecture and landscape architecture in contemporary Western design practices and the historic antecedents of this phenomenon. It challenges prevalent interpretations of the modern architectural project by foregrounding its social and cultural foundations in landscape.

In addition to her teaching and writing, Professor Constant is fully involved in the life of the college and a leader in all forms of faculty service. Junior faculty give her high praise for the mentoring and guidance she offers to them.

To recognize Carole Constant for her significant scholarly contributions, for her outstanding service activities within the Architecture Program and the college, and for her constructive mentorship of junior faculty, we recommend her appointment as the Emil Lorch Collegiate Professor of Architecture and Urban Planning, A. Alfred Taubman College of Architecture and Urban Planning, effective September 1, 2011 through August 31, 2014.

This was followed by a fellowship in vitreoretinal diseases and surgery at the Bascom Palmer Eye Institute at the University of Miami. In 1986, he was named adjunct assistant professor of biology at Penn State University and during the same year was named clinical instructor of ophthalmology at the University of Pittsburgh. In 1991, he joined the regular faculty at Penn State as assistant professor of ophthalmology and was promoted through the ranks, achieving the title of professor, with tenure, in 1999. The Dean and Executive Committee of the School of Public Health are pleased to recommend the appointment of Kyle L. Grazier as chair, Department of Health Management and Policy, for a three-year term, effective July 1, 2011 through June 30, 2014.

Professor Grazier received a B.S. degree from Valparaiso University in 1973, an M.S. degree from Notre Dame in 1976, and both an M.P.H. and a Dr.P.H. degree from the University of California in 1978 and 1981, respectively.

Upon completion of her doctoral degree, Professor Grazier was appointed as an assistant professor at the Yale University School of Medicine, where she was promoted to associate professor in 1986. From 1987 until 1992, Professor Grazier held the position of assistant professor, King Sweesy and Robert Womack Chair in Medical Research and Public Health at the University of California School of Public Health. From 1992-1997, she served as associate professor of health care finance and program director in the Sloan Program in Health Services Administration, Department of Human Service Studies, Cornell University. Professor Grazier joined the University of Michigan in 1997 as associate professor of health management and policy, with tenure, and was promoted to professor in 2003. In 2006 she was appointed as a professor in the Department of Psychiatry at the Medical School. She is an associate director of the University's NIH Clinical and Translational Science Award Program, MICHR, where she is responsible for the Evaluation Core.

Professor Grazier teaches graduate courses in corporate finance, insurance and payment systems, and case studies in healthcare management. She consistently receives high student evaluation ratings for her courses. Professor Grazier has also taught extensively in international and national executive programs.

One major area of Professor Grazier's research is in health care finance, with special emphasis on the effect of managed care arrangements and risk adjustment methods on mental health and substance abuse services, costs, and quality of care. Under sponsorship from the Center for Healthcare Research and Transformation, she is studying the impact of changes in the federal behavioral health parity law, and conducting a meta-analysis of depression and primary care. Supported by the Robert Wood Johnson Foundation, she identified models of integrated services for vulnerable populations. She has just completed a study of health plan choice behavior, funded by AHRO and BCBS-M Foundation.

Professor Grazier's service is exemplary. Dr. Shanley's clinical interests include management of pediatric hypoxemic respiratory failure and of severe sepsis and septic shock. His research interests span the entire spectrum from basic science investigation on the role of the phosphatase PP2A in modulating inflammatory signal transduction to translational research examining the genomics of pediatric sepsis, regulation of host innate immune responses, and elucidating the molecular mechanisms of immune paralysis

via novel, epigenetic mechanisms. Among numerous clinical and translational research activities, Dr. Shanley is examining the effect of tight glucose control on the immune response in children undergoing oxidant stress related to cardiopulmonary bypass. He is actively participating as site PI for two additional NIH-sponsored clinical trials in hypertension management and sedation management of children with prolonged mechanical ventilation (RESTORE). Dr. Shanley also serves as site PI for two major networks: NIGMS-supported Genomics of Pediatric SIRS/Sepsis and PERSEVERE Study network and the NICHD-sponsored Collaborative Pediatric Critical Care Research Network (CPCCRN). Within each of these research domains, Dr. Shanley has been involved in the day-to-day mentoring of numerous post-doctoral trainees from a variety of clinical subspecialties and research departments.

Coller Distinguished Professor and Chair of the Department of Surgery, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the establishment of the Edward B. Diethrich, M.D. Research Professorship in Biomedical Engineering and Vascular Surgery, Medical School, effective April 1, 2011.

This professorship is being established by Edward B. Diethrich, M.D. to support the disciplines of biomedical engineering and vascular surgery. He specializes in general, thoracic and cardiovascular surgery, and is a fellow of the American Colleges of Angiology, Cardiology, Surgery and Chest Physicians and the International College of Angiology. In 2001, the Edward B. Diethrich Vascular Surgical Society was established by the Arizona Heart Institute's former vascular surgical fellows in recognition of Dr. Diethrich's accomplishments.

With the unanimous approval of the Executive Committee and the assistant and associate deans of the School of Kinesiology, we seek to establish a Kinesiology Collegiate Professorship in the name of the late Stephen J. Galetti, who was a professor of kinesiology from 1958 until his retirement in 1988. A stipend will accompany this professorship, which will be funded from School resources.

Stephen J. Galetti guided the development and served as chair of Kinesiology's Sport Management and Communications program. His legacy, the University of Michigan Sport Management Program, is an international leader in the field.

Professor Galetti began his professional career at the University of Michigan as the coordinator of student teaching and director of the Youth Fitness Program. His life's work was promoting physical fitness and health, with particular emphasis on children. It was that passion that led him to veer from competitive athletics to focus on providing meaningful sports and physical activity experiences for all—athletes and non-athletes alike. In the latter stages of his career at the University of Michigan, he enthusiastically led efforts to establish a vital, new curriculum in sport management that provided unique theoretical foundations and practical experiences for Michigan students in the growing business of sport.

Service to his field played a large part in his professional life. On the state level he served as the president of the Michigan Association of Health, Physical Education, Recreation, and Dance (MAHPERD) and chaired the Michigan Council on Physical Fitness and Health for 10 years. MAHPERD awarded him the Distinguished Service Award in recognition of his outstanding commitment and dedication to the field. He received the Lifetime Achievement Award from the School of Kinesiology.

A distinguished faculty member will be nominated to receive this honor. The initial term of appointment will be for five years with the possibility of renewal.

The Law School recommends that the title of the Wade H. McCree Jr. Collegiate Professorship in Law be changed to the Wade H. and Dores M. McCree Collegiate Professorship in Law, Law School, effective May 1, 2011. Wade and Dores were married in the mid-1940s until Wade's death in 1987.

The Wade H. McCree, Jr. Collegiate Professorship in Law was established by the Regents in July 1990. Professor McCree was a distinguished member of our faculty from 1981 until his death. Professor McCree began his career as a practicing lawyer after earning an A.B. degree in 1941 from Fisk University and his J.D. in 1948 from Harvard Law School. His career in public service included duty as a circuit judge in Wayne County, Michigan, as a United States District Judge, and a United States Circuit Judge. He served as solicitor general of the United States under Presidents Carter and Regan. He was part of the generation that brought black lawyers into successful participation in all branches of the legal profession; his career and successes were a vitally important part of the transformation, and added to his unique contributions to the law school.

Dores M. McCree earned her B.A. degree in sociology from Wayne State University and a M.A. degree in library science from Simmons College in Boston, Massachusetts. Early in her career, she held such positions as research assistant for Harvard's Massachusetts General Hospital and library director for the Wayne County General Hospital. In the late 1950s, Mrs. McCree left the workforce to care for her children, but she remained very active in the community through involvement with such organizations as Jack and Jill of America, the Detroit Study Club, the Historical Society of the United States District Court for the Eastern District of Michigan, the Friends School in Detroit, and the Michigan Opera Theatre. According to her family, Mrs. McCree was "[An] early feminist and did not believe in the least, the old dictum that a woman's place was in the home."

Following that principle, Mrs. McCree became very active counseling law students at the U-M. She was a beloved member of the U-M learning community for decades and in a variety of roles. Students who came into contact with her will remember her influence all their lives. Colleagues who knew her will remember her many skills and contributions to making the Law School a better place. Along with her countless accomplishments, the caring interest she took in the lives

of so many law students has earned her a place of honor alongside her husband in the Law School's history.

In recognition of Dores McCree's many contributions, the Law School is pleased to recommend that the title of the Wade H. McCree, Jr. Collegiate Professorship in Law be changed to the Wade H. and Dores M. McCree Collegiate Professorship in Law, Law School, effective May 1, 2011.

On the recommendation of Michael W. Mulholland, M.D., Ph.D., the Frederick A. Coller Distinguished Professor and Chair of the Department of Surgery, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the establishment of the John R. Pfeifer Collegiate Professorship in Vascular Surgery, Medical School, effective April 1, 2011. This will be established as a term-of-years professorship.

This professorship is being established by a donor gift, and will be continued through donated funds, to support the discipline of vascular surgery. It is intended to focus on research, clinical application and teaching within the Department of Surgery, Section of Vascular Surgery. The first holder of the professorship will be a tenured faculty member of the Department of Surgery in the Section of Vascular Surgery. The appointment period for the John R. Pfeifer Collegiate Professorship in Vascular Surgery may be up to five years, and the appointment may be renewed as the donor renews.

John R. Pfeifer earned his M.D. in 1958 from the University of Saskatchewan College of Medicine. He completed his residency at the Henry Ford Hospital in Detroit in 1967. Dr. Pfeifer became an associate professor of surgery at Wayne State University and established a practice in vascular surgery at Providence Hospital. The Providence Surgery Program became a fully approved surgical residency program under his direction. Dr. Pfeifer's work focuses on venous disease, and his venous practice became the largest in the nation.

In 2000, Dr. Pfeifer joined the faculty at the University of Michigan as a professor of surgery and founding director of the Division of Venous Disease. This marked the first academic venous disease division in the United States. He trained academic vascular teams from 15 universities; both in treatment of venous diseases and methods of establishing a venous division in a university setting.

Dr. Pfeifer published numerous articles and book chapters. He was a founding member of the Midwestern Vascular Surgical Society and presented at over 100 symposiums devoted to the treatment of venous disease. Dr. Pfeifer was admired and appreciated by the young physicians he trained and had a significant impact on the Department of Surgery before he passed away in 2009.

This professorship will recognize the achievements of Dr. Pfeifer, and continue his work in vascular surgery. I am pleased, therefore, to recommend the establishment of the John R. Pfeifer Collegiate Professorship in Vascular Surgery, Medical School, effective April 1, 2011.
