With the endorsement of the Executive Committee of the School of Nursing, I am pleased to recommend the appointment of Colwick Wilson as associate professor of nursing, without tenure, School of Nursing, effective September 1, 2012.

ACADEMIC DEGREES

Professor Wilson received his bachelor of arts in theology from Caribbean Union College in 1983. He received his master of arts in leadership and counseling from Eastern Michigan University in 1988. In addition, he received a masters of arts in sociology as well as a doctorate in sociology from the Department of Sociology at the University of Michigan in 1997 and 2003, respectively.

PROFESSIONAL RECORD

Professor Wilson began his academic career as a professor in the Department of Counseling and Family Sciences at Loma Linda University in 2002. While at Loma Linda University, Professor Wilson held positions as associate chair (2007-2009) and later chairman (2009-2011) for the Department of Counseling and Family Sciences. In January 2012, Professor Wilson was appointed as a lecturer in the University of Michigan, School of Nursing.

Professor Wilson has held a dry appointment as an adjunct faculty associate at the Research Center for Group Dynamics (RCGD) at the University of Michigan since 2007. In January 2012, he was appointed as an assistant research scientist at the University of Michigan, School of Nursing.

SUMMARY OF EVALUATION

Professor Wilson is an expert in advanced qualitative methods, who has disseminated his research and scholarly work through 17 publications since 2003 with 15 manuscripts under review and two books slated for release in 2012. The majority of publications are data based and multi-authored, which is recognized as reflecting his skill of collaborating with colleagues in a

variety of disciplines. Professor Wilson has established a program of research focused on the influence of social factors on health status in the United States and the Caribbean region. From a substantive perspective he has focused on illuminating how a number of social and structural processes (religion, income, class) impact an array of health promoting and health damaging behaviors across population groups in both national and international contexts. Professor Wilson is an experienced researcher and productive scholar and is advancing our knowledge about how race, ethnicity, and social class are conceptualized, how they are linked to health and other outcomes, and how inequalities are perpetuated within institutions and within people's daily lives.

Professor Wilson has a strong and diverse teaching portfolio in statistics, health promotion and behavior, and research design. His major contribution to the teaching mission has been in teaching statistics to interdisciplinary students. He has taught a variety of courses at both the undergraduate and graduate level and has more than 34 years of teaching experience. His teaching philosophy is student-centered and reflects the mutuality and responsibility in facilitating learning experiences. Professor Wilson's record of service also demonstrates his commitment to responsible academic citizenship. He has a track record of contributing to his department, the larger university, and to the profession.

The Crosby-Kahn Collegiate Professorship in Neurosurgery and Neuroanatomy was established in 1993 to recognize the significant contributions made by Dr. Elizabeth C. Crosby and Dr. Edgar A. Kahn to the University of Michigan Medical School. Dr. Crosby was an internationally recognized authority in neuroanatomy and was the Medical School's first female professor. Dr. Kahn was the first full-time resident in neurosurgery at this institution and was named chair of Neurosurgery in 1949. Dr. Crosby worked closely with Dr. Kahn for over 30 years bringing her neuroanatomy background into the clinic setting.



He currently serves as both the director of the Crosby Neurosurgical Laboratories and as associate chair for research in the Department of Neurosurgery. 
collaboration with the Multiples Consortium which is a multi-centered research group studying the perinatal morbidity and mortality of multiple pregnancies.



Dr. Roger A. Berg received his B.S. in 1957, and his M.D. in 1961 from the University of Michigan. He completed an internship and residency at the Montefiore Hospital and Medical Center in New York in 1965. He was a captain in the United States Marine Corp from 1965–1967, and received the bronze star. Dr. Berg was chief of Radiology at the U.S. Army Hospitals in Saigon, Vietnam and Ft. Belvoir, Virginia during his term with the USAMC. He then was appointed as attending radiologist for Morristown Memorial Hospital, and from 2004-2007, was appointed as a clinical assistant professor of radiology at the University of Medicine and Dentistry in New Jersey.


Dr. Berg was a second-generation alum from the University of Michigan. His father, Dr. Albert Berg was also a medical school graduate from the university in 1932. He valued the opportunities that his degree afforded him during the Great Depression. Dr. Albert Berg passed a sense of gratitude to his son, and the importance of giving back. This professorship is the successor to previous funds established by Dr. Roger Berg at the University of Michigan. In 1984, he was instrumental in establishing the Roger A. Berg Prize in Radiology, which is awarded each year to a fourth-year medical student. In 1986, Dr. Berg, along with his two brothers, created the Eve and Albert Berg Memorial Loan Fund, that has since transitioned into a scholarship fund. In 1991, he established an endowed scholarship fund named after his anatomy professor, Russell T. Woodburne.


Dr. Berg participates in an annual endowed lectureship at the university, which further exemplifies his commitment to this institution, medical students, and faculty. This professorship will recognize Dr. Berg's contributions and legacy. I am, therefore, pleased to recommend the establishment of the Roger A. Berg, M.D. Radiology Research Professorship, Medical School, effective April 1, 2012.

Cook Distinguished Professor of Business Economics), the professorship was approved more broadly for business administration by the Regents in 1983, with the purpose of advancing business theory and practice in all business disciplines. It is unclear why the word "distinguished" was dropped from the title when this change occurred.




Mr. Cupp received a B.A. in journalism and public relations from University of Oklahoma in 1987.

I am pleased to recommend the appointment of Seong B. Hong as the Rosalyn Saltz Collegiate Professor of Education, School of Education, for a five-year renewable term, effective September 1, 2012 through August 31, 2017.

The Rosalyn Saltz Collegiate Professorship in Education was established by the Regents in March 2012. A stipend from school resources will accompany this professorship. As the first professor in Early Childhood Education at UM-Dearborn, Professor Rosalyn Saltz developed high quality programs for educators of young children, and she also created a supportive environment where young women could bring their children while they pursued their college education. She established a campus child care center in 1971, and that nascent effort has now developed into the nationally recognized Early Childhood Education Center (ECEC) that is at the forefront of research and teacher education, as well as being a premier site for early childhood education.

Since her appointment in 1998, Professor Hong has been recognized nationally for her teaching and scholarship. Her continuing development in these arenas serves as a model for both peers and students. Professor Hong's work in early childhood learning and development is exceptional. She maintains an active research agenda in the area of young children's critical thinking and is recognized nationally as an expert in the *Reggio* curriculum—an internationally acclaimed collaborative approach to early childhood education. Her work is published in widely read national and international journals, reaching a broad audience that includes practitioners and researchers. Her unique research agenda addresses the development of inquiry activities with young children. Documentation of these activities employs research methodology that cannot easily be quantified as it is based on the collection and analyses of video recordings of young children's interactions.

Since 2007, Professor Hong has served as the early childhood program coordinator. Through this position she has thoughtfully guided and mentored pre- and in-service education students with close supervision of their field placements at the University of Michigan-Dearborn's Early

Childhood Education Center (ECEC). Upon her hire at the University of Michigan-Dearborn, Professor Hong became the *Reggio* inspired curriculum advisor for the Early Childhood Education Center. The ECEC has benefited directly from Professor Hong's expertise in *Reggio* curriculum; it is an exceptional early childhood program because of the guidance provided by Professor Hong. As of January 2012, she has taken on further responsibility as the director of the Early Childhood Education Center.

Professor Hong serves on local and national committees recognized for providing leadership in the field of early childhood and constructivist education. Her contributions to the development of new degree programs/majors have been significant, benefitting the School of Education and its capacity to provide leadership in undergraduate and graduate education. She has also provided strong leadership for the development of the M-portfolio in the School of Education. Additionally, she continues to be an active member of the university community serving on the Faculty Senate, Senate Council, Promotion and Tenure Committee, Research Support Committee, LEO Professional Grants Committee, and the Leadership Committee for University of Michigan's Committee for Children.

I am pleased to recommend the appointment of Seong B. Hong as the Rosalyn Saltz Collegiate Professor of Education, School of Education, for a five-year renewable term, effective September 1, 2012 through August 31, 2017.

The Dean and the Executive Committee of the College of Engineering and Computer Science, with the endorsement of the Provost and Vice Chancellor for Academic Affairs, are pleased to recommend the appointment of Pravansu S. Mohanty as the Paul K. Trojan Collegiate Professor of Engineering, College of Engineering and Computer Science, for a five-year renewable term, effective September 1, 2012 through August 31, 2017.

Paul K. Trojan was a professor of metallurgical engineering in the Department of Mechanical Engineering from 1961 until his retirement in 1998. The Paul K. Trojan Collegiate Professorship in Engineering was established by the Regents in March 2012 to acknowledge his long, exemplary service as a teacher, researcher, and administrator in the College of Engineering and Computer Science.

Pravansu S. Mohanty received a bachelor of engineering in materials science from the University of Rajasthan, Jaipur, India, in 1988; a master of technology in materials science from the Indian Institute of Technology, Kanpur, India, in 1990; and a Ph.D. in materials science from McGill University, Montreal, Quebec, Canada, in 1994. He then undertook post-doctoral studies through 1995 and 1996 at the University of Illinois at Urbana-Champaign, where he also served as a research associate. Following two years as a research scientist at the University of Michigan in Ann Arbor, he joined the Department of Mechanical Engineering at UM-Dearborn as an assistant professor in 1999; he was promoted to associate professor in 2004 and in 2010 achieved the rank of professor.

Professor Mohanty's research interests include laser/plasma-aided materials processing, nanomaterials synthesis, and engineered materials design. He has actively pursued funding opportunities to support his research, receiving over \$12M from federal agencies such as the Army, Navy, DOE, and NSF as well as from private industries. Through these grants he has been able to support undergraduate students, graduate students, and research scholars in addition to establishing the infrastructure base—e.g., founding the Additive Manufacturing Process Laboratory—to support these activities. He has published over 100 journal and conference

papers, many of them invited, and a number of patents have been filed based on his research. His patents have resulted in a spinoff company, Csquared Innovations Inc., which has been awarded the Next Generation Manufacturing Award (\$25,000) through a national competition and the Michigan Clean Energy Prize (\$50,000) from the governor.

His research interests also inform his teaching activities. He developed a well-received course on nanoscience and nanotechnology, and he has incorporated some of the concepts of material behaviors at the microscopic level into the core engineering materials courses that he regularly teaches. He consistently receives high scores (>3.5 out of 4) in the end-of-semester student evaluations of teaching effectiveness, and he continues to refine his teaching methods in response to the changing needs of students and developments in pedagogical tools (e.g., use of multimedia technology to present animations illustrating the properties of materials at the microscopic level).

Professor Mohanty's record of service both to the engineering profession and to the college and university is impressive as well. A member of the American Society of Metals (ASM), the Thermal Spray Society (TSS), the Laser Institute of America (LIA), and TMS, he has served on several committees within these organizations as a member and as a chair, and he has organized and served as the chair of sessions—as well as having been an invited speaker—at multiple conferences. He has been a reviewer for a number of highly regarded professional journals and acted as a panelist and reviewer for NSF and DOE. At UM Dearborn, he has been an active member of several department-, college-, and university-level committees, including the Faculty Senate and the college's Executive Committee and Ph.D. Council.

Given his record as a researcher, teacher, and active member of the university and professional communities, all achieved in less than thirteen years, we are pleased to recommend the appointment of Pravansu S. Mohanty as the Paul K. Trojan Collegiate Professor of Engineering, College of Engineering and Computer Science, for a five-year renewable term, effective September 1, 2012 through August 31, 2017.
