I am pleased to recommend for Regental approval the appointment of James T. Dalton as dean, College of Pharmacy, for a five-year renewable term, effective September 1, 2014 through August 31, 2019, and professor of pharmaceutical sciences, with tenure, effective September 1, 2014. This recommendation follows an international search conducted by a search advisory committee.

James Dalton earned a B.S. degree in pharmacy from the University of Cincinnati in 1986; in 1990 he earned a Ph.D. degree in pharmaceutics and pharmaceutical chemistry from The Ohio State University (OSU). He was a pharmacist intern and staff pharmacist at Kettering Medical Center in Kettering, Ohio from 1982-1988. From 1991-1992, he was a post-doctoral fellow in the Division of Pharmaceutics and Pharmaceutical Chemistry at OSU. In 1992 he joined the Department of Pharmaceutical Sciences at the University of Tennessee as an assistant professor. He was promoted to associate professor in 1997 and tenured in 1998. In 2000, Professor Dalton joined the Division of Pharmaceutics and Pharmaceutical Chemistry in the College of Pharmacy at OSU as an associate professor. He served as interim chair of this division from 2002-2004, and from 2004-2005 as division chair during which time he was promoted to professor.

From 2005-2008, James Dalton's appointments were divided between OSU as Kimberly Professor in the College of Pharmacy and entrepreneurial leave from OSU to serve as vice-president of preclinical research and development at GTx, Inc. in Memphis, Tennessee. In 2008, he left OSU to devote full time to drug discovery at GTx, Inc. In 2011, chief scientific officer was added to his title at GTx, Inc. Among Professor Dalton's many research and administrative responsibilities at GTx, Inc. are leadership and direct supervision of all aspects of drug discovery and preclinical and product development, including drug discovery, medicinal chemistry, drug metabolism, analytical sciences, safety and toxicology assessment, pre-formulation, and product development teams. He also plays a leadership role in all Phase I, Phase II and Phase III clinical studies, serves as the scientific representative during interactions with the Food and Drug Administration and European regulatory authorities, leads the intellectual property team, and has served as senior scientific liaison to pharmaceutical industry partners of GTx.

Professor Dalton's interdisciplinary and translational research has focused on the molecular and preclinical pharmacology of selective androgen receptor modulators (SARMs), and novel drugs in the treatment of cancer. SARMs were first discovered in Professor Dalton's research laboratories and he is co-inventor on all SARM patents. Over the course of his career in the academy and in industry, Professor Dalton has published over 150 articles in peer-reviewed journals, contributed twelve book chapters, delivered over 165 meeting abstracts and presentations, and given over 60 invited presentations in North America and Europe. His academic research funding has totaled more than \$15 million, with some of the largest grants funded by the National Institute of Diabetes, National Institutes of Health, and the National Cancer Institute. Viewing industry funding as a valuable supplement to more conventional sources, he has maintained and funded numerous academic collaborations during his tenure as chief scientific officer at GTx, Inc. His honors include the American Association of Pharmaceutical Scientist (AAPS) Meritorious Manuscript Award, Pharmaceutical Research in 2000. In 2006 he was elected a fellow of the AAPS, and in 2011 he received the Jack L. Beal Post-Baccalaureate Alumni Award from OSU.

James Dalton's commitment to teaching and mentoring is equally impressive. His understanding that one of the most important roles of the faculty is to nurture the next generation of pharmacy leaders underlies his history of dedication to pharmacy education. In addition to over thirteen years of teaching at the University of Tennessee and OSU, Professor Dalton has mentored numerous postdoctoral trainees, graduate student trainees, and undergraduate students and twice received the Excellence in Teaching award. At both universities, he served on curriculum committees; at OSU, he served on the Pharm.D. program committee for seven years. With his background as pharmacist, pharmaceutical scientist and faculty member, Professor Dalton is committed to working closely and collaboratively with pharmacy faculty and other disciplines to improve experiential education and identify a broad array of experiences for both PharmD and PhD students.

Professor Dalton brings a unique background in both the academy and industry at a time when new approaches will be needed to address challenges facing the College of Pharmacy in areas such as research funding, space constraints, and the changing landscape of pharmacy practice. I am confident that James Dalton will lead the college's constituents in a spirit of collaboration to achieve their shared goal of excellence in research, teaching and service. I recommend his appointment with great enthusiasm.

I am pleased to recommend for Regental approval the appointment of Andrew D. Martin as dean, College of Literature, Science, and the Arts, for a five-year renewable term, effective July 1, 2014 through June 30, 2019, and professor of political science, with tenure, effective July 1, 2014. This recommendation follows an international search conducted by a search advisory committee.

Andrew Martin earned an A.B. degree in mathematics and government, *cum laude* and with high honors, from the College of William & Mary in 1994. In 1998, he earned a Ph.D. degree in political science from Washington University in St. Louis. He taught at Stony Brook University in New York for two years before returning to St. Louis to join Washington University's political science department as an assistant professor. In 2004, he was promoted to associate professor of political science with tenure and given a courtesy appointment of professor in the School of Law. In 2006, Professor Martin became a full professor in Arts and Sciences and the School of Law. He was appointed the Charles Nagel Chair of Constitutional Law and Political Science in 2013.

Professor Martin brings extensive administrative experience acquired through a variety of positions at Washington University. Early in his time with the political science department (2003-2005), he served as director of graduate studies; one of his major achievements in that role was a revised curriculum and a restructured administration to decrease time to degree and improve student outcomes. From 2006 to the present he has been the founding director of the Center for Empirical Research in the Law, an interdisciplinary research center in the School of Law that supports the application of sophisticated empirical methodology to legal studies research. As chair of the Department of Political Science from 2007-2011 he helped recruit six outstanding faculty members, led his colleagues in revamping the undergraduate curriculum to improve the quality of undergraduate research, and worked hard to distinguish the department as one with both a supportive academic environment and excellence in scholarship and teaching. In 2012 he accepted the appointment as vice dean of the School of Law, which he continues to hold. In this role, Professor Martin works closely with the dean and other senior administrators on budget, fundraising, curriculum, enrollment management, student services, and placement. In addition, he is primarily responsible for the data infrastructure and analytics capacity used extensively in admissions, budgeting, financial aid, and placement.

Andrew Martin's expertise is in the study of judicial decision-making, with special emphasis on the Supreme Court and the lower federal courts. He also works extensively in the field of political methodology and applied statistics. He has published in a number of prominent law reviews and leading

social science and applied statistics journals, including the American Political Science Review, the American Journal of Political Science, Political Analysis, the Journal of Legal Studies, and Statistical Science. Professor Martin is a frequent presenter at conferences and workshops throughout the country. His research has been supported by the National Science Foundation, the MacArthur Foundation, and the National Institutes of Health. He has been the principal investigator on eight grants from the National Science Foundation. Professor Martin was elected as a fellow of the Society for Political Methodology in 2012. With his collaborator, Kevin M. Quinn, Andrew Martin developed the Martin-Quinn Scores that are widely used to measure ideology on the U.S. Supreme Court.

Professor Martin is involved in multiple professional organizations. He has supervised the design and implementation of the website for the political methodology section of the American Political Science Association for over a decade, and has served on a number of important committees for the Society for Political Methodology. He served as the chair of the Law & Social Sciences Section of the Association of American Law Schools from 2009-2010. He was the associate editor and then acting co-editor of *Political Analysis* during 2007-2009. Professor Martin has received the Harold Gosnell Prize for the best work of political methodology presented at a political science conference and the Statistical Software Award from the Society for Political Methodology.

In addition to teaching graduate and undergraduate courses in political methodology in Arts & Sciences at Washington University, Professor Martin teaches courses in the law school on judicial decision-making and social science and statistics for lawyers. He regularly teaches the required quantitative political methodology course for all political science majors. He has mentored over twenty doctoral students, and received the Outstanding Faculty Mentor Award in 2011 from the Graduate School of Arts & Sciences. In 2013, Professor Martin received the Distinguished Faculty Award from the Washington University Alumni Board of Governors. He also offers workshops on social science research methods for judges, prosecutors, and legal academics.

Professor Martin brings a stellar international reputation in his academic discipline, a commitment to academic administration, and a tireless advocacy for the liberal arts to foster collaboration within the College of Literature, Science, and Arts, and across the university. I am confident that Andrew Martin will build on the college's extraordinarily strong foundation to empower faculty to achieve their greatest potential; to further strengthen our undergraduate and graduate programs; and to advance the university's commitment to diversity, excellence and access. On the recommendation of the chair of the Department of Epidemiology, and with the endorsement of the Executive Committee of the School of Public Health, we are pleased to recommend the appointment of Celeste Leigh Pearce, Ph.D. as associate professor of epidemiology, with tenure, School of Public Health, effective September 1, 2014.

Academic Degrees

Professor Pearce received her M.P.H. degree from the University of Michigan in 1995 and her Ph.D. degree from the University of Southern California, Los Angeles in 2002.

Professional Record

Professor Pearce held a visiting scientist appointment shared between the Broad Institute of MIT and Harvard and Massachusetts General Hospital from 2002 until 2005. In 2005, she was appointed as an assistant professor of research in the Department of Preventive Medicine at the University of Southern California (USC). She was appointed as an assistant professor in the Department of Preventive Medicine at USC in 2008.

Summary of Evaluation

Professor Pearce's work is diverse, encompassing cancer prevention, cancer genetics and cancer survivorship with a particular focus on ovarian cancer. She has gone beyond traditional epidemiology to study the genetic causes of these cancers and has made important contributions in our understanding of the role of hormones and genetics in causing ovarian and breast cancer, and their link to endometriosis. Based on her research portfolio and interests, she will have strong links to the Cancer Center which will help to transform the profile of cancer epidemiology for both the department and the school. Professor Pearce has gained national recognition for her role in the Ovarian Cancer Association Consortium (OCAC) where she serves as a member of the steering committee. This international collaboration will continue to provide her with data, support, visibility, and publications. In addition to an impressive publication record, Professor Pearce has an extensive history of research funding. She is clearly both a leader and a valued collaborator in her field.

Professor Pearce has an excellent teaching record and will be key in contributing to the teaching of our core epidemiology curriculum in addition to courses in cancer epidemiology. She has taught the principles of epidemiology to non-majors and enjoys the challenge of making epidemiology interesting and accessible to non-majors. Her teaching evaluations are excellent and the written comments from students generally praised her organization, liveliness, and dedication to students. Professor Pearce has done some doctoral mentoring, with one student who has graduated and two more in the pipeline. She will undoubtedly enhance the department's and school's visibility with respect to cancer epidemiology.

Professor Pearce has professional activities and national service consistent with her appointment at the University of Southern California. She has been closely involved in the educational mission of her department, serving on the admissions committee, curriculum committee, and screening exam committee. She has held several leadership positions in the Ovarian Cancer Association Consortium. Professor Pearce has also provided national service through journal and grant reviews.

Excerpts from External Reviewers

Reviewer (A): "Dr. Pearce has achieved national and, indeed, international recognition in her field. Although [my institution] does not have an exactly equivalent career structure, I have no doubt that Dr. Pearce would [be] a strong candidate for a similar tenured position in the University."

Reviewer (B): "Through her work, she has made important scientific contributions on the understanding of both genetic and non-genetic (primarily endometriosis, exogenous hormones) risk factors for ovarian cancer, as well as interactions. Dr. Schlissel received his B.A. degree from Princeton University in 1979 and his M.D. and Ph.D. in physiological chemistry in 1986 from Johns Hopkins University. Following his medical residency from 1986 to 1988 at the Johns Hopkins Hospital, he was a post-doctoral research fellow from 1988 to 1991 at the Whitehead Institute for Biological Research at the Massachusetts Institute of Technology. In 1991, he joined the faculty at Johns Hopkins as an assistant professor of medicine and was promoted to associate professor in 1995. In 1999, he joined the faculty at the University of California, Berkeley as an associate professor and was promoted to professor in 2002 and held the position of dean of biological sciences in the College of Letters & Science from 2008 to 2011. In 2011 he was appointed as a professor of biology and provost at Brown University.

Dr. Schlissel is a nationally recognized researcher whose work has focused on the developmental biology of B lymphocytes, the cell type in the immune system that secretes antibodies. His work has led to a detailed understanding of genetic factors involved in the production of anti-bodies and how mistakes in that process can lead to leukemia and lymphoma. He is the author or co-author of over 100 scientific publications and his work has been cited in the literature nearly 9,000 times. He has served as a member of the Howard Hughes Medical Institute Scientific

Review Board, was elected to the American Society of Clinical Investigators in 1998, and was elected as a fellow of the AAAS (American Association for the Advancement of Science) in 2013.

I am recommending the reappointment of Ronald F. Zernicke as dean, School of Kinesiology, effective January 1, 2015 through June 30, 2016.

Prior to coming to U-M, Dean Zernicke was the executive director of the Alberta Bone and Joint Health Institute. At the University of Calgary, he was a Wood Professor in Joint Injury Research in the Faculty of Medicine, professor and dean of the faculty of kinesiology, and professor in the Schulich School of Engineering. Dean Zernicke earned his BA degree in liberal arts from Concordia University Chicago in 1970, and MSc in biomechanics and PhD in biomechanics and anatomy from the University of Wisconsin in 1972 and 1974, respectively. His research focuses on the adaptation of bone to exercise, disuse, diet, and disease, and on joint injury and post-traumatic osteoarthritis. He has authored more than 550 peerreviewed research publications and abstracts, and three books. At Michigan, he was the founding director of the U-M Bone and Joint Injury Prevention and Rehabilitation Center. As a respected scholar and leader in the kinesiology community, he has fostered exceptional collaboration on the U-M campus and beyond.

During his first term, Dean Zernicke led important improvements for the school including a revised undergraduate curriculum with the addition of a new major in Health and Fitness, the successful recruitment of new faculty, and a re-organized administrative structure. Under his leadership, the school established a strong foundation as a national and international leader in education and research in physical activity, health and wellness, and sport management. After careful consideration, Dean Zernicke has decided not to seek reappointment for a second five-year term, but will instead serve a short term before returning to the faculty. I therefore recommend the reappointment of Ronald F. Zernicke as dean, School of Kinesiology, effective January 1, 2015 through June 30, 2016.

On the recommendation of David J. Fink, M.D., the Robert Brear Professor and Chair of the Department of Neurology, and with concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Hiroko H. Dodge, Ph.D. as the Milton and Carolyn Kevreson Research Professor of Neurology, Medical School, effective April 1, 2014 through August 31, 2019.

The Milton and Carolyn Kevreson Research Professorship in Neurology was established in 2013, through a generous gift from the Milton L. Kevreson estate. It is intended to promote research, teaching and clinical care in the field of Alzheimer's disease in order to help further the goals of the Alzheimer's Disease Center.

Dr. Dodge received her Ph.D. from Pennsylvania State University in 1992 and completed a fellowship at Carnegie Mellon University. She was appointed as an assistant professor at the University of Pittsburgh, and in 2005, and as an assistant professor at Oregon State University. Dr. Dodge was appointed as an associate professor in the Department of Neurology at the Oregon Health and Science University in 2009, with concurrent adjunct appointments at the University of Pittsburgh and Shiga University of Medical Science in Japan. She joined the faculty at the University of Michigan in 2010 as an adjunct research associate professor and was appointed as a research associate professor in 2014.

Dr. Dodge's research focuses on dementia prevention, distinguishing normal cognitive aging from pathological cognitive decline, cross-national comparative studies of healthy cognitive aging and applying demographic methods to clinical studies. Her scholarship in the area of gerontology and dementia epidemiology has gained international recognition. Dr. Dodge serves as director of the Biostatistics and Data Core at the Oregon Alzheimer's Disease Center, and in this role has been responsible for the data management and statistical sections of the competitive P30 Center grant for the Oregon ADC. On a national level, Dr. Dodge has served on the Scientific Review Committee for the National Alzheimer's Coordinating Center, and is chair of the Data Core Steering Committee for that organization. She also chairs the statistical subcommittee for the NACC Neuropsychological Tests Working Group. She has published 75

articles, and has written one book. Dr. Dodge has been well funded by the NIH and NIA for her research.

Dr. Dodge is an internationally known expert in Alzheimer's disease. She has utilized innovative approaches for early detection of dementia and its effective treatment. Her research aligns with the goals of the Alzheimer's Disease Center and with the intent of this professorship. I am pleased, therefore, to recommend the appointment of Hiroko H. Dodge, Ph.D. as the Milton and Carolyn Kevreson Research Professor of Neurology, effective April 1, 2014 through August 31, 2019.

On the recommendation of John M. Carethers, M.D., John G. Searle Professor and Chair of the Department of Internal Medicine, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Grace Elta, M.D. as the H. Marvin Pollard Collegiate Professor of Gastroenterology, Medical School, effective April 1, 2014 through August 31, 2019.

The H. Marvin Pollard Collegiate Professorship in Gastroenterology was established in 1995 as a memorial to Dr. Pollard, who served as chief of gastroenterology in the Department of Internal Medicine at the University of Michigan from 1940-1972. This collegiate professorship was created to support the research activities of the chief of gastroenterology and other initiatives within the Division of Gastroenterology.

Dr. Elta received her M.D. degree from the University of Michigan in 1977. She completed an internship here and a residency and fellowship at Tufts New England Medical Center in Boston. She was appointed as an instructor at the University of Michigan in 1982 and rose through the ranks to a professor in 1997. Dr. Elta serves as the director of the Medical Procedures Unit, and as associate chief of Clinical Programs. Her research focuses on pancreatic and biliary tract disease, inflammatory bowel disease, and interventional endoscopy. She has published over 90 peer-reviewed articles, and has received over 100 invitations to present her research at regional, national and international venues.

Dr. Elta has been recognized nationally through her service. She was president for the American Society for Gastrointestinal Endoscopy, and was named an ASGE Distinguished Educator in 2013. She received the American Gastroenterological Association Council Section Research Mentor Award in 2012 and in 2013, the AGA Distinguished Clinician Award. Dr. Elta has been named to serve as the *Digestive Disease Week* Council chair. She was an inaugural member of the Department of Internal Medicine Clinical Excellence Society, and was recipient of the Dean's Outstanding Clinician Award at the Medical School.

Dr. Elta is an outstanding forerunner in the field of gastroenterology and continues to display exceptional skills as a clinician, educator and administrator. I am pleased, therefore, to recommend the appointment of Grace Elta, M.D. as the H. Marvin Pollard Collegiate Professor of Gastroenterology, Medical School, effective April 1, 2014 through August 31, 2019.

Searle Professor and Chair of the Department of Internal Medicine, and with concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Dinesh Khanna, M.B., B.S. as the Frederick G.L. Huetwell Professor of Rheumatology, Medical School, effective April 1, 2014 through August 31, 2019.

The Frederick G.L. Huetwell Professorship in Rheumatology was established in 2012 through a generous gift from the estate of Frederick G.L. Huetwell. This professorship is intended to support research of a tenured faculty member in the Division of Rheumatology in the Department of Internal Medicine.

Dr. Khanna received his M.B., B.S. degree from the University College of Medical Sciences and Guru Teg in New Delhi, India in 1995. He completed a residency in Internal Medicine at Wright State University in Dayton, Ohio in 2000, and completed a fellowship in rheumatology at the University of California, in 2003. He was appointed as a clinical instructor at UCLA in 2003-2004, and was appointed as an assistant professor in 2004-2007 at the University of Cincinnati. In 2007, Dr. Khanna was appointed as an assistant clinical professor and clinical director of the Scleroderma Clinic at UCLA. He was appointed as an assistant professor-inresidence at that institution in 2008. In 2011, he joined the faculty at the University of Michigan as an associate professor, with tenure, and as director of the Scleroderma Program in the Department of Internal Medicine.

Dr. Khanna's work in scleroderma and other rheumatic diseases has focused on development of new outcome measures, innovative clinical trials, and development of professional guidelines. His scholarly productivity has been extraordinary, with 155 peer reviewed publications. He is a national and international leader in the clinical investigation of scleroderma, well ahead of any other clinical investigator of his generation. Dr. Khanna has been well-funded by the NIH and industry through grants and clinical studies. He is an associate director of a key project in an

application of a Clinical Autoimmunity Center of Excellence Award, given by the National Institute of Allergy and Infectious Diseases to the University of Michigan. This center grant is one of only four clinical ACE awards to be funded throughout the country.

Dr. Khanna is an extraordinarily energetic, productive and successful member of the faculty. His vision is to transform our clinical understanding of scleroderma and to develop and implement effective and definitive treatments for this previously refractory disease. I am pleased, therefore, to recommend the appointment of Dinesh Khanna, M.B., B.S. as the Frederick G.L. Huetwell Professor of Rheumatology, Medical School, effective April 1, 2014 through August 31, 2019.

He has served as an editorial board member and reviewer for many scientific journals and has published 75 peer-reviewed articles. Professor Sellers received his BS degree in psychology in 1985 from Howard University, and his PhD in personality psychology in 1990 from the University of Michigan. After receiving his doctorate, Professor Sellers accepted a position as an assistant professor at the University of Virginia; he was promoted to associate professor in 1997. In 1997, Professor Sellers joined the University of Michigan as associate professor of psychology, was promoted to professor in 2002, and in 2003 became chair of the personality and social context area in the Department of Psychology. In 2007, he assumed the role of associate chair of the Department of Psychology, and in 2011, was named chair of the Department of Psychology. He was also named the Charles D. Moody Collegiate Professor in the same year. Since 1997, Professor Sellers has also served as a faculty associate in the Research Center for Group Dynamics at U-M's Institute for Social Research. He is a co-founder of the Center for the Study of Black Youth in Context in the College of Literature, Science, and the Art, and since 2009 has served as a professor, without tenure, in the School of Education.

Professor Seller's primary research interests have focused on the role of race in the psychological lives of African Americans. He and his graduate student have developed a conceptual model of the structure and processes associated with the significance and meaning that African Americans attribute to the significance and meaning of race in their lives. He has published extensively in the areas or racial identity, racial discrimination, and racial socialization and their impact on psychological well-being, physical health, and educational outcomes. In addition to this work, Professor Sellers has also published research on the life experiences of college student-athletes.

with a particular interest in policies and practices that enhance the psychological well-being and educational opportunities for this unique student population.

In his new role as vice provost, Professor Sellers will provide strategic leadership for programs and policies that result in increased access and success for all students, the recruitment and retention of diverse faculty, and the development and expansion of academic programs that prepare all students for success in a diverse world. He was recognized in 2012 with a Lifetime Achievement Award from *HR Magazine* for being the "father of modern human resources." He has won numerous other lifetime achievement awards, been recognized as a leading thinker in the human resource profession, and been listed among the top 50 thinkers in global management. He edited *Human Resource Management* 1990 to 1999 and is on the board of directors at Herman Miller and board of trustees at Southern Virginia University. He has consulted and conducted research with over half of Fortune 200 companies.

She began her Doctor of Social Welfare Program at City University of New York in 1990 and completed this program in December 2003. She has co-authored a number of publications and her record of presentations and workshops is impressive. Her experiences as a medical social work administrator serve to enrich her teaching and have resulted in her reputation as an effective classroom instructor. I am pleased to recommend establishment of the Samuel A. Graham Dean, School of Natural Resources and Environment, effective May 1, 2014.

The University of Michigan has received a gift commitment from the Graham Foundation for the School of Natural Resources and Environment (SNRE) to endow the deanship in the name of former SNRE professor, Samuel A. Graham.

A 1914 graduate of the University of Minnesota, Professor Samuel A. Graham received a master's degree from Cornell University in 1916, and a doctorate from Minnesota in 1921. Professor Graham arrived on campus in 1927. He was a faculty member at the then named School of Natural Resources, as well as the College of Literature, Science, and the Arts (zoology), for 34 years. Professor Graham is considered to be the founder of North American forest entomology and insect ecology. In 1929, Professor Graham authored the first, and widely used, textbook on forest entomology, "Principles of Forest Entomology" which, ultimately, had three editions.

In 1953, the University of Minnesota awarded Professor Graham its Outstanding Achievement Award. In 1964, he received the Society of American Foresters Award for Achievement in Research. At the news of Professor Graham's passing in 1967, then Dean R. K. Arnold of the School of Natural Resources said, "As a professor, he directed in total the largest number of graduate students in the history of the school. Today they are found in every country of the world. He was one of the first to bring principles of ecology to bear directly on resource management. It can truly be said that he was 10 to 20 years ahead of his time." In 2004, the Entomological Society of America awarded Professor Graham their Founders Memorial Award, recognizing that, "He witnessed the birth and flowering of many modern sciences, particularly forest ecosystem, and landscape ecology."

I am pleased to recommend establishment of the Samuel A. Graham Dean, School of Natural Resources and Environment, effective May 1, 2014.

On the recommendation of Bishr Omary, Ph.D., M.D., Professor and Chair of the Department of Molecular and Integrative Physiology, Professor of Internal Medicine, and the H. Marvin Pollard Professor of Gastroenterology, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the establishment of the Carl J. Wiggers Collegiate Professorship in Cardiovascular Physiology, Medical School, effective April 1, 2014.

This professorship is being established through contributions from the Department of Internal Medicine and the Medical School on behalf of the Department of Molecular and Integrative Physiology. It will support the efforts of an accomplished faculty member in the Department of Molecular and Integrative Physiology with emphasis on cardiovascular research. The appointment period may be up to five years and may be renewed.

Carl J. Wiggers, M.D. was internationally renowned for his work on cardiac research, which included studying vascular control of cerebral, coronary and pulmonary circulation, registration of heart sounds and murmurs, interpretation of electrocardiographic measurements, ventricular dysrhythmias, and the coronary circulation. He received his M.D. from the University of Michigan in 1906, and was subsequently appointed as an instructor of physiology. He remained here until 1911. Dr. Wiggers was a faculty member at Cornell University from 1911-1918 and moved to Western Reserve University to chair the Department of Physiology. He established, and was the first editor of *Circulation Research*, which is the premier scholarly journal in the field of cardiology. Dr. Wiggers authored seven books and more than 300 articles. His contributions were recognized by receiving the highly prestigious Albert Lasker Award in 1955.

Dr. Wiggers was most famous for authoring the Wiggers diagram, which is commonly used in the teaching of cardiovascular research. This professorship will honor his status as a world renowned physiologist. I am pleased, therefore, to recommend the establishment of the Carl J. Wiggers Collegiate Professorship in Cardiovascular Physiology, Medical School, effective April 1, 2014.
