Summary of Evaluations:

<u>Teaching</u> – Professor Smock is a dedicated and highly effective teacher. Recipient of an Excellence in Education Award, she brings to the classroom a level of enthusiasm, organization, and accessibility that students, especially undergraduates, find both energizing and intellectually stimulating. Her courses are interactive and pedagogically innovative, such that students report coming away with a greater appreciation of not only the immediate subject matter but the general process of learning. She has taught a range of courses at both the graduate and undergraduate level, always earning outstanding student evaluations. She is also a hard-working and dedicated mentor to countless students.

Research – Professor Smock is a nationally recognized leader in family demography, and her presence in our faculty is a big part of our Department's national pre-eminence in that area. A highly productive scholar, she has authored or co-authored more than a dozen refereed publications in the last five years alone. She has made singularly important contributions to our understanding of union formation dynamics, the consequences of marital dissolution, and the sources of cohabitation. Her work has addressed important and pressing policy issues related to the American family, and her expertise is frequently sought by wider publics in the print and electronic media.

Her service to the national discipline is also extensive, capped by her recent election to Chair the 700-member Family Section of the American Sociological Association (ASA).
