Summary of Evaluation:

Teaching – Professor Zaborowska has been a successful instructor who has taught a wide range of classes at all levels. She has been extremely responsive to the curricular needs of the Program in American Culture and her teaching in the fields of African American literature, gender and manhood, and space and place make significant contributions to curricula in both units. Her overall record is excellent. Classroom evaluators praise her presentation style, her use of technology, and her dedication to Michigan students. She is an exceptional mentor and has played an important role in graduate admissions and curricular discussions. As a frequent participant in workshops, cross-unit public presentations, and programmatic initiatives, she is a regular and important contributor to the instructional environment of the College.

Research – Professor Zaborowska's scholarship is rich and exciting. Her first book, *How We Found America: Reading Gender through East-European Immigrant Narratives* (University of North Carolina Press, 1995), remains an important marker in the literature on immigration, women's writing, and the literary imagination of the self. Her current manuscript, *James Baldwin's Turkish Decade*, uses interviews, archival research, as well as literary and visual analysis to unearth a largely ignored chapter in the life of this great African American writer. In addition to these two monographs, Professor Zaborowska has explored her broader interests in three edited or co-edited volumes and a number of articles, chapters, and essays.

Service – Professor Zaborowska has been an important participant in the Program in American Culture's external review and long-range planning processes. She has served as a member and as chair of the Graduate Admissions Committee while managing the graduate student presentation workshop. In CAAS, her emphasis has been work on the Honors Program. She has also participated in a number of important programs across this campus, including the Institute for Research on Women and Gender, the International Institute, the Center for Russian and East European Studies, and the Global Feminisms Project. Widely known throughout Europe's African Americanist community, her service commitments extend to the international arena, as she is a frequent participant in the life of European institutions for American and African American studies. These broader contributions make her service profile an exceptional one.
