# Summary of Evaluation:

**Teaching:** Professor Fry is a creative, innovative, dedicated, and responsive teacher. She teaches using online and traditional modalities and is effective in both. She consistently updates, recreates, and improves her syllabi, her approaches, and her assignments. She is available and helpful to students; she is popular with the students. She is challenging and creative; her goal is to 'support her students' learning while having high expectations for their successes. Engaged in frequent teaching enhancement opportunities (both as presenter and participant), Professor Fry has a commitment to consistently work on improving her teaching. As director of the Physical Therapy Department, she has been equally vigilant to the excellence of the curricula; new programs (transitional DPT) and revamped programs (DPT) have been introduced under her supervision.

**Research:** Since her promotion to associate professor in 2003, she has published ten peer-reviewed articles and two are in submission. She has authored two national practice guidelines. She has made 43 presentations at the national level, delivered 39 state and regional presentations, and delivered 10 international presentations. Her research addresses clinical manifestations of Multiple Sclerosis and articles that examine pedagogy. Professor Fry serves regularly as a reviewer for *Archives of Physical Medicine and Rehabilitations, Journal of Neurologic Physical Therapy, Journal of Physical Therapy Education*, and *Physical Therapy*.
