Summary of Evaluation:

Teaching - Professor Boland has taught a wide range of undergraduate and graduate courses at the interface of linguistics and psychology. She has created a series of courses that provide a thoughtful progression of theoretical, empirical, and research-design experiences for students and that form the core of the psycholinguistics curriculum in both departments. As reflected in her syllabi and the response from her students, she puts tremendous energy, enthusiasm, and thoughtful pedagogy into her classes. She has supervised or mentored sixteen graduate students as well as a large number of undergraduate students, who were participants in independent study courses, carrying out honors theses, or part of the Undergraduate Research Opportunities Program.

Research - Professor Boland's research requires expertise in two distinct fields and this interdisciplinary approach is central to addressing her research questions. She is particularly well-known for her critical analysis of the literature, the logic and creativity of her empirical studies, and the applicability of the findings. She has developed and carefully validated methods that have dramatically improved her research conclusions. Each journal article is a multiexperimental study that reaches important and often surprising conclusions.

Service – Professor Boland's service record is exemplary. Her contributions, both nationally and in local environments, demonstrate her leadership and commitment. Departmental service has been divided equally between her two departments, and in all of these roles she has been masterful in meeting the needs of the position, and in gathering faculty to work toward their mutual goals. She has accumulated a record of service to the profession that identifies her as an important colleague within the field. High regard for her research has led to editorial responsibilities for two journals and service on the editorial boards of two other journals.
