On the recommendation of the Executive Committee of the School of Dentistry, I am pleased to recommend the appointment of Jian-Guo Geng as associate professor of dentistry, with tenure, School of Dentistry, effective July 1, 2010.

ACADEMIC DEGREES

In 1983, Professor Geng received a BA degree from Shanghai Medical University. In 1988 he received a combined MD/PhD degree also from Shanghai Medical University. From 1989 to 1992 he was a postdoctoral fellow at the University of Oklahoma Health Sciences Center, then from 1992 to 1998 he was a research scientist at Upjohn, in Kalamazoo, Michigan. He returned to Shanghai from 1998 to 2003 where he worked at the Chinese Academy of Sciences, Institute of Biochemistry and Cell Biology. In 2003, he was appointed to the rank of assistant professor in the Department of Medicine, Hematology Section at the University of Minnesota and in 2009 he was promoted to associate professor, with tenure.

PROFESSIONAL RECORD

Professor Geng has been involved with laboratory research for his entire academic career. His research is focused on cell adhesion and migration of leukocytes, platelets, endothelial cells and tumor cells for their functional roles in inflammation, thrombosis and cancer growth and metastasis. He is particularly interested in identifying molecular targets critical in the pathogenesis of these diseases and searching for small molecular weight compounds for specific modulation of their functional activities for treating inflammation, thrombosis and carcinogenesis.

He is a principal investigator on two National Institutes of Health (NIH) grants funded from 2005 to 2013 for \$2,750,000. His research has resulted in 52 peer-reviewed articles, seven as first author and 24 as last and corresponding author that demonstrates his mentorship of junior scientists. In addition, he has eight review articles and four patents. These publications and

patents represent a continuous and consistent effort over more than 22 years. This work has been presented in a wide range of public scientific forums.

EXCERPTS FROM EXTERNAL REVIEWS

Reviewer A:

“In terms of scientific productivity, his publication record is very solid and sustained. His *vitae* lists 47 peer-reviewed publications, nearly all of which are in very highly ranked journals including *Nature Immunology*, *Journal of Biological Chemistry*, and *Blood*. A number of his original published works are highly cited, and overall his published reports are cited upwards of 100 times each year. In my opinion, his research contributions and productivity appear to be outstanding for an investigator at his academic level.”

His fellows and students have moved to highly reputable universities, a reflection on Dr. Geng’s achievement and ability in teaching and education.”

“Dr. Geng has been successful in obtaining research funding. Currently, he has two NIH R01 grants, which is impressive given the very tough funding environment at the NIH. This accomplishment reflects the importance of his research and the recognition by his peers in the related field.”

I would anticipate that he would be an outstanding addition to the University of Michigan who would strengthen your institution’s ongoing interest in cell-cell interactions/tumor stromal biology. I would have no reservations about his ability to be promoted to associate professor with tenure at my institution.”


PROFESSIONAL SERVICE ACTIVITY

Professor Geng has served as an *ad hoc* reviewer, for the ELB (erythrocyte and leukocyte biology) study section of the NIH; 2007-2010, the Leukocyte Biology study section of Imperial Cancer Fund, UK; 2008, and most recently the Thrombosis study section of NHLBI; 2009. He is a member of several important professional societies such as the American Association of Immunologists and the American Society of Cell Biology. He is on two editorial boards for *Cell Adhesion and Migration* and *Cell Research*. Additionally, he is a reviewer for multiple scientific journals; of most significance are the *Journal of Immunology*, *Journal of Biological Chemistry* and the *Journal of Cell Science*.

SUMMARY OF RECOMMENDATION


Professor Geng currently holds two R01s with a third proposal currently in review and is funded by NIH through 2013. Professor Geng has existing ongoing collaborations with faculty at the University of Michigan. Professor Geng will bring senior academic leadership to the School of Dentistry and the University. I am pleased to recommend the appointment of Jian-Guo Geng as associate professor of dentistry, with tenure, School of Dentistry, effective July 1, 2010.

On the recommendation of Valerie P. Castle, M.D., the Ravitz Foundation Professor and Chair of the Department of Pediatrics and Communicable Diseases, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Debbie S. Gipson, M.D. as associate professor of pediatrics and communicable diseases, with tenure, Medical School, effective May 1, 2010.

Dr. Gipson received her M.D. degree from Indiana University in 1989, followed by pediatric residency training also at that institution. From 1993-1995, she served in the National Health Service Corps in the state of Washington, and then undertook a pediatric nephrology fellowship during 1995-1998 at the University of Washington, Seattle, while simultaneously completing her master's degree in epidemiology at that institution. In 1999, Dr. Gipson was appointed as an assistant professor of medicine and pediatrics and an assistant professor of epidemiology at the University of North Carolina. In 2006, she became an associate professor in medicine and pediatrics, with tenure, at that institution and also held an appointment as an adjunct associate professor in the School of Public Health. In December 2009, Dr. Gipson came to the University of Michigan and was appointed as a clinical associate professor of pediatrics and communicable diseases.

Dr. Gipson's research has focused on two areas of clinical and translational research: 1) focal segmental glomerulosclerosis (FSGS), a form of nephrotic syndrome, and 2) neurodevelopment and chronic kidney disease. She has achieved a national reputation for her clinical research focused in these areas. Her bibliography reflects 35 peer-reviewed publications, as well as seven book chapters and more than 50 abstracts. She has presented locally, regionally, and nationally and has an impressive history of past and current grant activity for clinical research, including leading roles on five National Institutes of Health grants. Since coming to the University of Michigan, Dr. Gipson has continued her work with interventional clinical trials

and registries in nephrotic syndrome, as well as her studies on neurodevelopmental outcomes in children with chronic kidney disease.

Prior to her appointment at the University of Michigan in 2009, Dr. Gipson served as pediatric nephrology fellowship director at the University of North Carolina, and, in this role, she developed the curriculum for the fellowship program. She has taught medical students, residents and fellows while performing her clinical responsibilities and has been a research mentor to numerous trainees. Dr. Gipson will have similar educational responsibilities in the Division of Pediatric Nephrology at this institution.



Dr. Gipson has been a team leader for several international outreach medical missions to Kenya, Zambia, and Brazil. Dr. Gipson’s clinical expertise is related to chronic kidney disease in children in both the inpatient and outpatient settings. She has been referenced in *Best Doctors in America* and *Who’s Who in America*. Dr. Gipson is board certified in pediatrics and pediatric nephrology.



On the recommendation of the Chair of the Department of Environmental Health Sciences and with the endorsement of the Executive Committee of the School of Public Health, we are pleased to recommend the appointment of Andrew D. Maynard, Ph.D. as the Charles and Rita Gelman Risk Science Professor, effective September 1, 2010 through August 31, 2015, and professor of environmental health sciences, with tenure, School of Public Health, effective September 1, 2010.

Academic Degrees

Professor Maynard received a Ph.D. in 1992 from the University of Cambridge in the UK, focusing on aerosol physics.

Professional Record

Professor Maynard served as a scientific officer and then head of the control section of the Health and Safety Executive in the UK, a government organization similar to CDC's National Institute for Occupational Safety and Health (NIOSH). From 2000 to 2005, he served as a senior service fellow and then team leader at NIOSH, before moving to his current position at the Woodrow Wilson International Center for Scholars where he is chief science advisor for the Project on Emerging Nanotechnologies.

Summary of Evaluation

The overarching theme of Professor Maynard's research has involved development, evaluation and implementation of effective emerging technologies, particularly nanotechnologies, and their safety to workers and the public. His studies began by addressing problems involving air-borne particles and aerosol dynamics, particularly new methods for measurement and evaluation of exposure to toxins and protection against their potential health impacts. This work also included quantitative and simulation modeling of exposure. More recently, he has become involved in evaluation of, and public health policy issues surrounding, nanotechnologies and nanoparticles. In his curriculum vitae, Professor Maynard has listed 63 published peer-reviewed articles in scientific journals since 1993, 50 of which have appeared in the past decade. In addition to his peer-reviewed publications, Professor Maynard also has co-edited two scientific books and

written 10 chapters in other volumes, again all within the past decade. This is testament to his rising influence on nanotechnology development and safety policy, and his reputation among scientists working on such problems. In addition, he has had experience working with representatives of industry, non-governmental organizations and the public, all aimed at enhancing informed decision making. Professor Maynard has established a reputation among his peers as a highly regarded scholar and policy analyst, and as a thoughtful and articulate advocate for careful, scientific evaluation of risk.

Because Professor Maynard has not been working in positions where teaching is expected or even possible, he has had little opportunity to engage students in traditional academic settings. Despite having little in the way of a formal pedagogic record, he has presented nearly 200 invited lectures and addresses since 2000, mostly to scientific, research, and policy symposia, forums or professional organizations. In addition, he has provided formal testimony and briefings to a number of government bodies. Professor Maynard's contributions to teaching should make valuable additions to the curriculum, especially those involving nanotechnology and risk evaluation.

Many of Professor Maynard's recent accomplishments have been in the area of service to governments and the field of environmental health policy. Since 2006 he has served as an editorial board member on three research journals and, in the past two years, on four national nanotechnology policy review panels.

ACADEMIC DEGREES

Vonnice McLoyd received her Bachelor of Arts from Talladega College in 1971. She attended the University of Michigan where she completed her Master of Arts in 1973 and Doctorate in 1975.

PROFESSIONAL RECORD

Professor McLoyd began her teaching career as an assistant professor at the University of Massachusetts in 1975. She joined our faculty in 1978 as an assistant professor and was promoted to associate professor, with tenure, in 1988 and professor in 1991. She also held appointments on the research scientist track (associate research scientist, 1988-1991; research scientist, 1991-2002). She moved to the University of North Carolina where she was appointed as a professor and a research scientist (both in 2002), and has held the title of Stephen Baxter Distinguished Professor since 2006.

SUMMARY OF EVALUATION

Professor McLoyd's research is considered to be among the best and most important in the fields of child and adolescent development. The quality of Professor McLoyd's research has led to nearly continuous funding from a variety of governmental sources, including the National Institutes of Health and the National Institute of Child Health and Human Development (NICHD). The Law School respectfully requests that the Regents approve the reappointment of Donald H. Regan as the William W. Bishop, Jr. Collegiate Professor of Law, Law School, effective September 1, 2010 through August 31, 2015.

The William W. Bishop, Jr. Collegiate Professorship was established in 1990 and was named in honor of the former Edwin DeWitt Dickinson University Professor of Law, a 1931 graduate of the Law School who was a member of the faculty from 1948 until 1976. The Professorship is supported by funds from a gift of Joseph H. Parsons, a 1927 graduate of the Law School and a prominent Detroit attorney. Professor Regan was named the first holder of the William W. Bishop, Jr., Collegiate Professorship in 1990.

Professor Regan has been a member of the Law School faculty since 1968 and a professor of philosophy since 1983. He received his B.A. degree in mathematics in 1963 from Harvard University, and his LL.B. degree in 1966 from the University of Virginia Law School. He was a Rhodes Scholar and received a B.Phil. from Oxford in 1968. In 1980 he earned a Ph.D. in philosophy from the University of Michigan. Professor Regan has received numerous distinguished fellowships and lectureships in the United States and abroad. He is a member of the American Academy of Arts and Sciences.

Professor Regan is known for his contributions to philosophy and to constitutional law. His book, Utilitarianism and Co-operation won the Franklin J. Matchette Prize of the American Philosophical Association. His book-length monograph on the dormant commerce clause is a classic in the field. He continues to write path-breaking work in both ethics and in constitutional law. Professor Regan is an interdisciplinary scholar whose work represents the highest quality within each discipline as well as breadth of intellectual engagement.



The Law School respectfully requests that the Regents approved the reappointment of Mathias W. Reimann as the Hessel E. Yntema Professor of Law, Law School, effective September 1, 2010 through August 31, 2015.

The Hessel E. Yntema Professorship was established in the Law School in 1976. Professor Yntema was a distinguished member of the Law School faculty for almost 30 years, from 1933 until his retirement in 1961. He was one of the leading scholars of comparative law and conflicts of law with an international reputation. The Hessel E. Yntema Professorship was established as part of a program established by the Regents entitling the dean to recommend one appointment named after a former colleague; Professor Yntema was selected by Dean Theodore St. Antoine after a poll of the faculty.

Professor Reimann began his legal work in Germany. He took his First State Exam at the University of Freiburg in 1978 with high honors, his Second State Exam through the State of Baden-Württemberg in 1981 again with high honors, and received his Doctor iuris utriusque from the University of Freiburg in 1982 *summa cum laude*. In 1983 he earned an LL.M. degree from the University of Michigan Law School. He began his academic career as a lecturer in Law at the University of Freiburg. In 1985 he joined the University of Michigan Law School faculty as an assistant professor. Professor Reimann was promoted to associate professor in 1987, and to professor in 1990. From 1996-1999, he also held a chair as professor of private law, Legal History and Comparative law at the University of Trier. He has been a visiting professor at the Universities of Münster, Freiburg, Frankfurt, and Freiburg in Germany, and at the University of Paris I.

Professor Reimann is a leading scholar of comparative law. He has written numerous books and articles in both English and German, including the co-edited volume *The Reception of Continental Ideas in Common Law World 1820-1920* and *Conflict of Laws in Western Europe. A Guide Through the Jungle*. He has done research at the European University Institute in Florence through a Jean Monnet Fellowship and currently serves as a member of the Board of Editors of the *American Journal of Comparative Law*, a journal founded by Professor Yntema.


Professor Reimann received the L. Hart Wright Outstanding Teaching Award in 1993-1994 by a vote of his students.

Professor Reimann's work is in the University of Michigan Law School tradition of excellence in international and comparative law. His work in comparative law and conflicts of law makes him a truly worthy successor of Hessel E. Yntema and to earlier holders of the chairs such as Eric Stein and John Jackson.



On the recommendation of the Dean and Executive Committee of the Stephen M. Ross School of Business, we are pleased to recommend the appointment of Wayne E. Baker as the Robert P. Thome Professor of Business Administration, Stephen M. Ross School of Business, effective September 1, 2010 through August 31, 2015.

The Thome Professorship was established by the Regents in 2008 upon a generous gift from the Robert P. Thome (pronounced Tōmie) Trust to support the teaching, research and related activities of the appointed incumbent. Mr. Thome received his AB in 1937 and his MBA in 1938, both from the University of Michigan. He worked for the Washington Post from 1947-1978 retiring as the Post's treasurer. He often spoke fondly about his experience at the University of Michigan and the University's role in effectively preparing him for his life and career. He was an active alumnus until his death on December 10, 2007 at the age of 92.

Professor Baker received his B.S. in 1974 and M.A. in 1976 from Northern Illinois University and his Ph.D. in sociology in 1981 from Northwestern University. He joined the University of Michigan Ross School of Business as associate professor of organizational behavior and human resource management, with tenure, in 1995 and was promoted to professor in 1999. Professor Baker was named the Jack D. Sparks – Whirlpool Corporation Research Professor of Business Administration in 2008. Before joining Michigan, he was an assistant and associate professor of business policy and sociology at the University of Chicago, Graduate School of Business.

Professor Baker is one of the best known scholars in the field of social capital. He was one of the first scholars to empirically demonstrate the social basis of markets, and since then has established his reputation as someone who does empirically rigorous and theoretically creative research on the social network mechanisms underlying organizations. He has continuously


published articles in the leading journals in management and sociology and is known to be a top academic scholar on networks and markets, networks and organizational crime and interorganizational networks. More recently he has opened up a whole new domain of inquiry in network theory that focuses on energy networks and their impact. In addition to publishing well-regarded scholarly articles on social networks, he has published several books, the most recent detailing findings from the highly visible Detroit Arab-American Study, of which he was a lead investigator.

Professor Baker is an excellent teacher and has contributed to the Ross School in other ways such as serving as the director of the Center for Positive Organizational Scholarship, and serving as the chair of the Ross School's teaching committee.



Castle, M.D., the Ravitz Professor and Chair of the Department of Pediatrics and Communicable Diseases, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the appointment of Janet R. Gilsdorf, M.D. as the Robert P. Kelch, M.D. Research Professor of Pediatrics and Communicable Diseases, Medical School, effective May 1, 2010 through August 31, 2015.

This professorship was establishment in June 2009 to honor Dr. Robert Kelch and to recognize his numerous contributions to the University of Michigan and to the specialty of pediatrics.

Dr. Gilsdorf received the M.D. degree from the University of Nebraska at Omaha and then completed a pediatric internship and one year of pediatric residency at Baylor University before serving as a pediatric consultant at the United States Public Health Service Indian Hospital in Owyhee, Nevada and as a clinical supervisor at the Yukon-Kustokwim Health Care Center in Bethel, Alaska. After completing her pediatric residency at the Valley Medical Center in Fresno, California, she then undertook a fellowship in pediatric infectious diseases at the University of Minnesota during 1979-1982. Dr. Gilsdorf came to the University of Michigan as an assistant professor of pediatrics and communicable diseases in 1982 and was promoted through the ranks to achieve her current title of professor in 1995. In 1997, she received a joint appointment as professor of epidemiology in the School of Public Health. Dr. Gilsdorf is the director of the Division of Pediatric Infectious Diseases and co-director of the Center for Molecular and Clinical Epidemiology of Infectious Diseases. She is a diplomat of the American Board of Pediatrics and the National Board of Medical Examiners.


Dr. Gilsdorf's laboratory studies *H. influenza* pathogenesis, using a molecular epidemiologic approach to identify virulence genes associated with otitis media, chronic obstructive pulmonary disease (COPD), pharyngeal colonization, and sharing (transmission of)


bacteria from person to person. Her research in bacterial pathogenesis is fostered by successful collaborations with colleagues in the School of Public Health. Dr. Gilsdorf's bibliography reflects over 80 peer-reviewed manuscripts in prestigious scientific specialty journals. She has served as a journal reviewer for over 20 of the most highly regarded publications in pediatric medicine and has been a grant reviewer for the National Institutes of Health, the Department of Veterans Affairs, and the March of Dimes.

Dr. Gilsdorf also has earned acclaim for her creative writing and has penned a number of manuscripts which assess the changes and fluctuations of modern medical practice. Many of these have been published in the *Journal of the American Medical Association*. Her writing titled "Off to the Left" earned her the Creative Medical Writing Award for Prose from the *Journal of General Internal Medicine*. In 2006, Dr. Gilsdorf published "Inside Outside" which chronicled her own battle with breast cancer from a physician's point of view.





The James E. and Sarah A. Degan Professorship is supported by an endowment created as a result of a bequest by the late Sarah A. Degan, a long-time resident of Detroit.

Professor Hathaway received an LL.B. degree (with honors) in 1979 from Osgoode Hall Law School of York University, an LL.M degree and a J.S.D. degree from Columbia University School of Law in 1982 and 1987, respectively. After working at the Canadian Department of Justice for a couple of years, in 1984 he joined the faculty of the Osgoode Hall Law School of York University as an assistant professor of law. He was promoted to an associate professor in 1988 and to professor in 1996. Professor Hathaway joined the University of Michigan Law School faculty as a professor in 1998, and since that time has also been the director of the Law School's Program in Refugee and Asylum Law. He also remains a senior visiting research associate at Oxford University's Refugee Studies Centre.

Professor Hathaway is a leading authority on international refugee law. His scholarship is regularly cited by the most senior courts of the common law world, and it constitutes the point of departure for much other work in this field. He is the author of a leading treatise on the definition of refugee, The Law of Refugee Status (Butterworths, 1991) and is the editor of the influential Reconceiving International Refugee Law (Kluwer, 1997). Professor Hathaway has also provided training on refugee law to academic, non-governmental, and official audiences in Europe, North America, Asia, and Africa, and is a regular lecturer at both the International Secretariat of Amnesty International and the European Council on Refugees and Exiles.



The Handleman Professorship was established by the Regents in 2008 upon a generous gift from the Joseph and Sally Handleman Charitable Foundation to support the research and/or teaching of the appointed incumbent relating to marketing innovations. Joseph Handleman was born August 5, 1905 and was the son of late Philip Handleman, founder of the Handleman Company which is currently based in Troy, Michigan. Joseph was an internationally known sales consultant and business manager. He established himself as a business pioneer in the distribution of health and beauty products to supermarkets. Today the Handleman Company remains an industry leader. Joseph was married to Sally Handleman for 69 years. Joseph died on February 28, 2005 followed by his wife Sally on December 6, 2006. The Handlemans are survived by their three daughters and many grandchildren and great-grandchildren.

Professor Krishnan received his B.S. in 1984 and M.C.A. in 1987 from the University of Delhi in New Delhi, India and his M.S. in 1993 and Ph.D. in Industrial Administration in 1996 from Carnegie Mellon University. He joined the University of Michigan Ross School of Business as a lecturer in 1996 and was appointed as an assistant professor in 1997, was promoted to associate professor, with tenure, in 2000, and to professor in 2004. Professor Krishnan was a Michael R. and Mary Kay Hallman Faculty Fellow from 2000-2010. Since 2004 he has served as the area chair of the Business Information Technology area at the Ross School of Business.





He began his career as a lecturer then as an assistant professor at the University of Pennsylvania from 1982-1990, then joined the Ross School of Business faculty in 1990 as an assistant professor. He was promoted to associate professor, with tenure, in 1996 and to professor in 2003.

Professor Lanen is an expert in the areas of analytical and empirical managerial accounting research. In particular his scholarship is focused on understanding firms' cost management decisions. His recent work seeks to better understand what are known as "sticky costs." He has a strong reputation for quality field work and is known as an original and creative thinker making important contributions to the field. Professor Lanen was the winner of the 2006 Notable Contribution to Management Accounting Literature Award for the paper "Using Electronic Data Interchange (EDI) to Improve the Efficiency of Accounting Transactions."


Dr. Pipe has made a number of scientific contributions to the field of hemostasis and coagulation. His laboratory studies the biology of the factor VIII clotting protein. This protein, when deficient, is a cause of hemophilia - a devastating bleeding disorder in childhood. The over-arching goal of Dr. Pipe's research has been to develop a biological therapeutic that overcomes the current limitations of present factor replacement therapies. Dr. Pipe's research program is funded by the National Institutes of Health through an R01 grant in which he serves as the principal investigator. He also is co-investigator on several other grants. His bibliography

reflects 56 peer-reviewed articles, published or in press, as well as 65 abstracts. Dr. Pipe has achieved an international reputation for his work as evidenced by the numerous invited lectures he has presented in this country and abroad. He also has received several research awards, including the 2002 Sutherland Award for Outstanding Faculty Research from the Midwest Society for Pediatric Research.



I am pleased to recommend for Regental approval the appointment of Joseph Rosa as director of the University of Michigan Museum of Art (UMMA) for a five-year renewable term, effective July 1, 2010. This recommendation follows an international search conducted by a search advisory committee.

Mr. Rosa received a Bachelors of Architecture, with honors, from the Pratt Institute, a M.S. in architecture and urban design from Columbia University's Graduate School of Architecture, Planning, and Preservation, and was a Ph.D. candidate in the Department of Art and Archaeology. He has worked in the architectural firms of Gwathmey Siegel and Associates, Peter Eisenman, and Agrest & Gandelsonas. When he joined the Art Institute of Chicago in 2005 as the John H. Bryan Curatorial Chair of Architecture and Design, he began to expand the department's vision and mission to be regional, national, and international in scope and to aggressively build its art holdings. He played a key role in strategic outreach and fundraising, overseeing two auxiliary committees composed of large boards. He was extremely successful in curating exhibitions, building collaborative relationships between the Art Institute and its community, and planning programs that embodied the vision of the Institute.

Prior to joining the Art Institute of Chicago, Mr. Rosa was the Helen Hilton Raiser Curator of Architecture and Design at the San Francisco Museum of Modern Art (SFMOMA), the curator of architecture at the Heinz Architectural Center at the Carnegie Museum of Art in Pittsburgh, PA, the chief curator at the National Building Museum in Washington, DC, and the director of the Columbia University Architecture Galleries.

Joseph Rosa is the author of 14 books and his writings have appeared in *Praxis, Architectural Design, Assemblage, Casabella, The History of Photography Journal, Oculus, Architektur & Bauforum, and Progressive Architecture*. He has curated over 30 exhibitions on contemporary architecture and design. He is also a noted scholar on the architect Albert Frey, the first disciple of Le Corbusier to build in America, and Julius Shulman the highly acclaimed 20-century architectural photographer. Mr. Rosa has been a visiting scholar at The Getty Center for the History of Art and the Humanities, a recipient of grants from the National Endowment for the Arts and the Graham Foundation for Advanced Studies in the Fine Arts. He has also taught at Columbia University, California College of the Arts, Catholic University, the University of California Berkeley, Southern California Institute of Architecture (SCI-ARC), University of Illinois at Chicago, and the University of Chicago.

I am confident that Mr. Rosa is the right person to lead the University of Michigan Museum of Art during this period of renewed excitement and opportunity, one year after its internationally acclaimed expansion and restoration opened to the public. He has the experience, the creativity, and the energy needed to direct UMMA, one of the crown jewels of our campus, in its contributions to the academic life of the University and its broad outreach to community audiences. 

Professor Zhu received his B.Sc. in physics from Peking University, P.R. China in 1996. He received his Ph.D. in statistics from Stanford University in 2003.



CURRENT TITLES: Chancellor, and Professor of Philosophy, with tenure, College of Arts, Sciences, and Letters, University of Michigan–Dearborn

TITLE BEING RENEWED: Chancellor, University of Michigan–Dearborn

EFFECTIVE DATES: July 1, 2010 through June 30, 2015

I am pleased to recommend the reappointment of Daniel E. Little to a third five-year term as chancellor of the University of Michigan–Dearborn, effective July 1, 2010 through June 30, 2015. Chancellor Little will act as the chief executive officer for the Dearborn campus and as an executive officer of the University.

I submit this recommendation following completion of a rigorous standard reappointment review. The review process involved extensive, thoughtful input from faculty, students, staff, and alumni of UM–Dearborn, as well as from leaders and citizens in the Dearborn community. I visited the Dearborn campus in February for discussion with a number of campus leadership groups and with members of the campus community in open forum. I was delighted with the level of interest and engagement by the various constituencies of UM–Dearborn. Following my own analysis of the extensive information that I received, I have discussed my findings at length with Chancellor Little and have shared them with the Regents. It is upon the basis of this review that I recommend the chancellor’s reappointment.


Chancellor Little assumed the chancellorship of the Dearborn campus in July 2000, and he has been a very effective leader during his first and second terms. During the past five years under Chancellor Little’s leadership, the campus has made much progress in realizing its vision as a “Metropolitan University.” New undergraduate and graduate programs have been created in each of the schools and colleges, including the first two Ph.D. programs, in the College of Engineering and Computer Science, and a new Ed.D. program in the School of Education. Chancellor Little has overseen expansion and enhancement of the Early Childhood Education Center, in collaboration with Oakwood Healthcare System, as well as establishment of the Institute for Local Government. Under his leadership, research productivity of the Dearborn faculty has markedly increased. Enrollments have also increased, with first-time-in-college enrollments growing more than 30 percent since 2004, and transfer enrollments growing 14 percent in the same period. Civic engagement is a key theme for the campus, enhanced by the new Center for Civic Engagement, which involves faculty and students. Chancellor Little has himself been an exemplar of engagement, cultivating strong community ties and partnering with numerous community stakeholders in a variety of ways.

UM-Dearborn is financially stable and has a secure foundation for its educational programs through vigilant financial management, cost reductions, enrollment growth and moderate tuition increases. Chancellor Little has recruited outstanding senior administrators. Under new institutional advancement leadership, the campus exceeded its Michigan Difference campaign goal by 10 percent (\$44 million).

The future of UM-Dearborn is bright and the opportunities are great. I am confident that under Chancellor Little's leadership, the campus will continue to develop its unique assets and further enhance its already outstanding educational, research, and service contributions to the region and the state. I look forward to working with Chancellor Little and his colleagues in the years ahead.

It is with great enthusiasm that I recommend the reappointment of Daniel E. Little as chancellor of the University of Michigan-Dearborn, effective July 1, 2010 through June 30, 2015.

The Department of Behavioral Sciences, the Dean of the College of Arts, Sciences, and Letters, and the Provost and Vice Chancellor for Academic Affairs, recommend the reappointment of Nancy Howells Wrobel as chair, Department of Behavioral Sciences, College of Arts, Sciences, and Letters, for a three-year term, effective July 1, 2010 through June 30, 2013.

Professor Wrobel graduated *Magna Cum Laude* in 1978 from Hiram College and received a M.A. in clinical psychology from the University of Dayton in 1983. She was awarded a Ph.D. in clinical psychology by Wayne State University in 1988. She joined the University of Michigan-Dearborn in 1989 as a visiting assistant professor and was appointed as assistant professor of psychology in the Department of Behavioral Sciences in 1990. Professor Wrobel was promoted to associate professor, with tenure, in 1996 and to professor in 2009.

Professor Wrobel's major area of research throughout her academic career has been in the field of diagnostic assessment, in particular, the accuracy and validity of assessment across age, gender, diagnostic type, and ethnic or cultural background. She has recently been involved in the validation of mental health screening tests for elderly Arab-Americans.

Professor Wrobel has been a member of the Behavioral Sciences Executive Committee, the Distance Learning Faculty, and the Agenda for Women, and has served as the College Ombudsperson. She has worked on search committees for several campus-wide positions and recently chaired the search for the director of admissions.

We are very pleased to recommend the reappointment of Nancy Howells Wrobel as chair, Department of Behavioral Sciences, College of Arts, Sciences, and Letters, for a three-year term, effective July 1, 2010 through June 30, 2013.

The Department of Mathematics and Statistics, the Dean of the College of Arts, Sciences, and Letters, and the Provost and Vice Chancellor for Academic Affairs, recommend the appointment of Michael A. Lachance as chair, Department of Mathematics and Statistics, College of Arts, Sciences, and Letters, for a three-year term, effective July 1, 2010 through June 30, 2013.

Professor Lachance earned his Bachelor of Arts from the University of Evansville in 1975, and his Master of Arts and Ph.D. from University of South Florida in 1977 and 1979, respectively. He was appointed as assistant professor of mathematics at the University of Michigan-Dearborn in 1979, promoted to associate professor, with tenure, in 1984, and to professor in 1989.

Although he is a challenging instructor, his students also find him motivating and encouraging. He has made many contributions to the mathematics curriculum and is a major force behind the success of the applied mathematics courses.

Professor Lachance's recent articles have appeared in the *Proceedings of the International Conference on Technology in Collegiate Mathematics* and *Mathematics Monthly*. He has served as the mathematics program advisor and on the Executive Committees of the Department and the College. His professional affiliations include the Society for Industrial and Applied Mathematics and the American Mathematical Society.




