Summary of Evaluations:

Teaching - Professor Cole is a committed and talented teacher of graduate and undergraduate students. She has served on committees for sixteen completed dissertations and is advising eight committees in psychology, women's studies, sociology, education, and communication studies. She has worked with thirteen undergraduate students on honors theses, independent studies, and in the context of the Undergraduate Research Opportunities Program. She has taught eleven different courses, from a large introductory lecture to first-year seminars to graduate seminars on qualitative research methods. She has demonstrated pedagogical commitment by taking on the large introductory lecture course in women's studies where she has provided focus and coherence, an arena for teaching graduate students how to lecture, and an occasion for undergraduates to learn about political activism.

Research – Professor Cole has become a leading figure working at the intersection of psychology, women's studies, and African American studies, bringing feminist theory to psychology and empirical research methods to women's studies. Her work is unusual in the degree to which it addresses theoretical, methodological, and empirical issues simultaneously. The concept of intersectionality is central to Professor Cole's understanding of gender, race, and social class as socially constructed identity categories, and key to her ongoing research focused on women's political thought and activism, students' experience of race in higher education, and the consequences of women's feminine traits and behaviors. She has published thirteen journal articles in prestigious journals in psychology and women's studies, three book chapters, and she has edited a special issue of the *Journal of Social Issues*.

Service – Professor Cole has actively engaged in service at all levels of the university. She has served on every standing committee in women's studies and has made important contributions as a member of several search committees. She has been area chair for the joint women's studies/psychology doctoral program. In CAAS, she engaged in a major revision of the undergraduate curriculum, proposed and sheperded through the graduate certificate program, and served as associate director. She has served on the LSA Curriculum Committee, the Rackham Executive Board, and on grant and fellowship review committees for the Institute for Research on Women and Gender, and the National Center for Institutional Diversity. Nationally she has served on several editorial boards of journals and on divisions of the American Psychological Association.
