Summary of Evaluation:

<u>Teaching</u> – Professor Forsdyke's teaching at the undergraduate and graduate levels is innovative, multidisciplinary, and strong on the foundations. In her role as an undergraduate instructor, her courses range from elementary language instruction to large lecture classes covering the breadth of Greek civilization. She teaches a course on slavery that fulfills the race and ethnicity requirement and incorporates advanced technologies and interactive modules into her large introductory lecture course. She has made changes to the graduate curriculum and participates in international collaborative teaching as well. She has served as chair or co-chair of five graduate dissertations and has acted as a member for an additional five.

Research – Professor Forsdyke specializes in early Greek history and culture, drawing methods from anthropology and political theory as well as classical philology. Her first book, <u>Exile</u>, <u>Ostracism and Democracy</u> was published in 2006 by Princeton University Press. Her second book manuscript, <u>Slaves Tell Tales</u>, focuses on non-elite members of society and how they interacted with institutions of the state. Professor Forsdyke has continued to publish articles, mostly as chapters in edited volumes, and she has a further volume on slavery underway.
