# Summary of Evaluation:

<u>Teaching</u> – Professor Conley is a successful teacher in courses that range from large enrollment to smaller undergraduate courses and graduate seminars. In her teaching, like her research, Professor Conley asks students to reflect on popular assumptions, including their own, and to interrogate them in light of the research. She makes great use of activities, outside speakers and where appropriate, combines academic materials with those drawn from popular culture. She developed a new course on the psychology of sexuality and consistently receives excellent ratings from students. Professor Conley demonstrates exemplary practices in the pedagogy of her lab group. She explicitly lays out graded expectations for students at each level, from undergraduate students first encountering research up through the pre-candidate and candidate levels of doctoral studies.

Research – The quality, quantity, and impact of Professor Conley's research is excellent. Her work focuses on gender, sexuality, and stereotypes. Professor Conley's research model is an excellent exemplar of interdisciplinary work that melds dominant approaches in psychology and women's studies. She has critically questioned assumptions about race and gender using psychological, empirical methodologies. In so doing she has refocused the intellectual discourse and research priorities of the field. Since arriving at Michigan her productivity has been outstanding with four papers in the flagship journals in her field. She has presented at national and international meetings and at universities, including joint presentations with her students.

## Reviewer (A)

"Given the substance and quality of her papers, Professor Conley would surely obtain tenure within my department. She is, in many respects, the leader in her field... Though there are other researchers who study sexuality as part of a larger agenda (e.g. the transmission of HIV), Professor Conley has made the study of sexuality a focus point in and of itself (e.g. sexual orientation, gender differences, monogamy... In that respect, she is at the forefront of this field. She thus has my highest recommendation; she is truly one of a kind."

"She is one of the most visible scholars [of her cohort] in the area today. Her research productivity over the past decade has been noteworthy, especially considering the lack of major external funding for her work. This is not a reflection on her work, but rather is characteristic of the state of sexuality research in the United States. Her publication record in the past 15 years is outstanding. ... I note that she is sole author on only two publications, but this does not concern me. Her contribution across the published work is clear; the clarity of conceptualization, sharply drawn research questions, innovative and multi-faceted methods, and clear writing style. Many of her co-authors are her students, a testimony to her mentoring and to her desire to help them launch their research careers."

"She is certainly a stellar researcher. She is able to identify important research questions, design carefully craft studies to test her ideas, and publish her results in premier journals. ... She is an impressive model for social psychologists."
