Summary of Evaluation:

<u>Teaching</u> – Professor Hayes' teaching record is exceptional. He has contributed greatly to the excellence in the French program by designing new courses, and by innovating and diversifying the French curriculum. His undergraduate and graduate courses cover the Francophone world understood in its broadest context. They allow undergraduate students to familiarize themselves with national literary and cultural traditions from North and Central Africa to the Caribbean and to the American south. His contributions to graduate studies are strong and he receives high student ratings in these classes. He is also an excellent mentor, graduate advisor, and has contributed significantly to development of the undergraduate curriculum in Portuguese.

<u>Research</u> – Professor Hayes is a scholar of Francophone literature and culture, understood in historical, anthropological, and literary terms. His research is highly innovative and he has made many significant contributions to the field. His second book, <u>Queer Roots for the Diaspora</u>, <u>Ghosts in the Family Tree</u> (under submission), will cross boundaries and cultural landscapes in order to open up conversations about the meaning of history itself. He is also co-editor of a volume of essays and is working on a third book project entitled <u>Reading Across the Color Line</u>: <u>Racialization in the French Americas</u> that explores representations of race in the French Americas.
