Summary of Evaluation:

<u>Teaching</u> – Professor Mallette excels as a teacher as well as a dedicated advisor and mentor of undergraduate and graduate students. Her teaching record is solid and she offers a large variety of courses in Italian culture and literature, as well as in Great Books and in the Department of Near Eastern Studies. Professor Mallette has been actively involved in mentoring graduate students and in less formal reading groups, which attests to her open commitment to pedagogy and mentoring at all levels. She has been active in promoting interdisciplinary values in her teaching and including her scholarship in her courses.

Research – Professor Mallette has become a major figure in Italian Medieval studies and Mediterranean studies. Her research has greatly helped to shape the new emerging field of Mediterranean Studies and her work is an indispensable resource. Professor Mallette has a strong record of publications and participation in international conferences. Her published work to date and in progress are milestones, and her advocacy of a non-nationalist philology for exploring the Mediterranean is broadly admired. She is currently working on a third book manuscript, titled Lingua franca in the Mediterranean. This book studies the strategies languages use to transcend the boundaries that language creates. Several articles from this project are already forthcoming and scholars in her field have situated them as path breaking work.

"Most scholarship in the area of medieval Mediterranean Studies is either historical, or, when it does focus on literature, is primarily concerned with documenting cases of contact and potential influence. In European Modernity and the Arab Mediterranean, however, Mallette has undertaken something that is quite a bit more sophisticated and intriguing.
