## **Summary of Evaluation:**

<u>Teaching</u> – Professor Szpiech has demonstrated teaching excellence in a wide range of undergraduate and graduate courses. His undergraduate courses provide a solid historical, cultural, and linguistic overview of Medieval Iberia, and help students familiarize themselves with its major literary, cultural, and social trends. Professor Szpiech has a high level of commitment to students and is an outstanding mentor and advisor. He has worked with numerous students in the Undergraduate Research Opportunities Program (UROP), and he has collaborated with graduate students by participating in their dissertation committees and professional training.

Research – Professor Szpiech's area of expertise is the borderland of translation and conversion internal to the Abrahamic religions of the Iberian Peninsula. He is particularly interested in the conditions of religious contact across cultures, always highlighting the tensions and polemics involved in conversion from one religion to another. He has already had a real impact on the field with his articles, participation in conferences and international collaborative projects, and his recently published book shows considerable promise for the future. His second book is based on dialogues with the broad concerns of pre-modern history and religion in Europe, clearly recognizing that translation lies at the heart of all cultural interactions both then and now.
