Summary of Evaluation:

Teaching: Dr. Zivin is the associate director of the National Institute of Mental Health T32 Geriatric Mental Health Services Research Fellowship. The program is one of four sites nationwide. Over the past several years she has served as a mentor for T32 post-doctoral fellows as well as those from the VA Advanced Research Fellowship Program, a competitive training grant program based at the National Serious Mental Illness Treatment Resource and Evaluation Center (SMITREC), Ann Arbor VA. Dr. Zivin is the associate director for Research Training in the Geriatric Psychiatry Section. She works closely with clinical fellows, who often have minimal research experience, in their psychology or psychiatry training programs. She teaches and mentors fellows in developing their research and methodological skills and assists with their overall career development, including publishing multiple peer-reviewed papers. She provides presentations to faculty and trainees in the department to explain goals and methods of health services research and to increase opportunities for collaboration.

Research: Dr. Zivin's research focuses on vulnerable populations, specifically older adults and veterans. Her primary interest is in generating research to improve the health and well-being of depressed individuals. She has developed scholarship in the study of detection, treatment, and outcomes for depressed patients, focused substantively on both mortality and employment, and methods to longitudinally assess depression status, treatment adherence, and cost effectiveness of care using large clinical, epidemiological, and population-based studies. This research is clinically applied and targets the identification of risk factors for depression as well as policy-relevant methods to improve care. She is the principal investigator on a career development award, Level 2, "VA depression treatments: practice, policy, and cost effectiveness." She is the principal investigator on a VA Merit Award, "Risk of death among Veterans with depression." Dr. Zivin has published over 80 peer-reviewed papers (30 as first author and over 10 as senior

author). Many of these papers involved collaborations with junior faculty or post-doctoral mentees. She has received funding as the principal investigator on two multi-year VA grants in addition to local and pilot grant funding. She is a co-investigator on NIH and VA funded grants. She has provided testimony before the United States Congress regarding findings from suicide research among depressed veterans. She published one of the first assessments of the impact of depression on productivity among patients treated in the University of Michigan Department of Psychiatry. She has also conducted and published additional assessments documenting substantial unemployment among working-aged depressed Veterans in advance of new presidential initiatives to support employment needs of returning Veterans. Dr. Zivin's collaborations provided evidence supporting the need for, and limited use of psychotherapy for depressed Veterans prior to a major VA initiative designed to provide additional training and staff for these services. Dr. Zivin's award-winning research has documented unmet needs for access to prescription medications even after the initiation of the Medicare Part D prescription drug benefit among depressed disabled and older adults.

Service: Dr. Zivin is an investigator in the Serious Mental Illness Treatment Resource and Evaluation Center (SMITREC) with a major role in shaping the national evaluation of the VA mental health care system. She has been actively involved in the current evaluation of VA initiatives to integrate mental health treatment into primary care for depressed Veterans. This ongoing evaluation project is the largest study ever undertaken of patient- and system-related factors associated with collaborative care for depression in the United States or worldwide. This work involves data-based research, publishing and dissemination of findings, and shaping VA policies on depression treatment. She works closely with national VA leaders, including the national implementation and national evaluation directors. In addition, she has engaged in local

service as the associate director for Research Training in the Geriatric Psychiatry Section, Department of Psychiatry as well as national service, including leadership roles in the American Association of Geriatric Psychiatry and the Health Policy and Statistics Section of the American Statistical Association. In those leadership roles, as well as for the behavioral health section of Academy Health, she has been a frequent conference abstract reviewer. She is a peer-reviewer for scientific journals and participates in grant reviews. Dr. Zivin was the recipient of the “Michigan Road Scholar” from the Office of the Provost in 2010. She received the Barry Lebowitz Early Career Scientist Award from the American Association for Geriatric Psychiatry for the best original work by an early career investigator for “Cost-related medication nonadherence among beneficiaries with depression following Medicare Part D,” published in the *American Journal of Geriatric Psychiatry*.

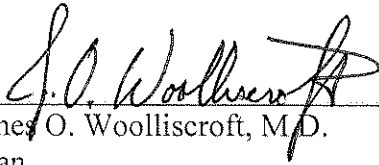

Summary of Recommendation:

Dr. Zivin has an impressive track record in obtaining funding and is making an impact on improving health policies and health system initiatives on diagnosis, treatment, and outcomes of

mental disorders. Her research skills in evaluating systems of care designed to improve treatment of depression, particularly in vulnerable populations such as veterans and older adults is an asset to the Department of Psychiatry, and the VA SMITREC within the Health Services Research and Development Center of Excellence. She has been an outstanding mentor, and has provided relevant data to inform clinicians, policymakers, and other stakeholders to assist them in addressing the needs of vulnerable mentally ill individuals. She has worked successfully to support local and national organizations with similar objectives. With a prominent role in our national training programs, Dr. Zivin is well positioned to train the next generation of both VA and non-VA mental health researchers. I therefore enthusiastically recommend Kara Zivin, Ph.D. for promotion to associate professor of psychiatry, with tenure, Department of Psychiatry, Medical School.
