With the endorsement of the Executive Committee of the School of Music, Theatre & Dance, we are pleased to recommend the appointment of Timothy P. McAllister as associate professor of music (saxophone), with tenure, effective September 1, 2014.

#### ACADEMIC RECORD

Professor McAllister received his B.M. (with honors in 1995), M.M. (1997) and D.M.A. (2002) from the University of Michigan. In 1995, he received the Albert A. Stanley Medal awarded to the highest performing graduating BM student as voted on by the faculty. In 1997, he received the Earl V. Moore Award presented to the highest performing graduate student as voted on by the faculty. Other prestigious honors include the Paul C. Boylan Alumni Award and the State University of New York Chancellor's Award for Excellence in Creative Activities.

#### PROFESSIONAL RECORD

Professor McAllister began his academic career at the University of Michigan as a graduate teaching assistant in saxophone and wind conducting from 1995 through 1997. From 1997 through 2006, he first served as an assistant then associate professor of saxophone at the Crane School of Music; tenure was granted in 2002. He then joined the faculty at the University of Arizona School of Music (Herberger Institute School of Music) as an assistant professor of saxophone from 2006 through 2008, and was promoted to professor in 2011. In 2012, he was appointed as associate professor of saxophone, with tenure, and co-director of the Institute for New Music at Northwestern University.

#### SUMMARY OF EVALUATION

Professor McAllister is considered one of America's premier concert saxophone performers and a champion of contemporary music. His solo, orchestral, and chamber music recordings appear on the Naxos, Albany, Summit, Equilibrium, Centaur, OMM, G.I.A. Publications, New Focus, AUR, New Dynamic and Innova labels. He has been featured multiple times on National Public Radio's *Performance Today*, Dutch National Radio, BBC, WQXR-NYC, WNYC, and various



PBS affiliates throughout the U.S. He is credited with over 150 premieres of new works by eminent and emerging composers worldwide. Mark Stryker of the *Detroit Free Press* has recognized his albums as among the top classical saxophone recordings, and his recording of Pulitzer-Prize winning composer William Bolcom's Concert Suite for Alto Saxophone and Band received multiple Grammy Award nominations in three major categories.

## PROFESSIONAL ACTIVITY

Since 2001, he has appeared frequently on major chamber music series nationwide as soprano saxophonist of the PRISM Quartet, including repeat performances each season in venues such as New York City's Merkin Hall, Whitney Museum, Miller Theater, (Le) Poisson Rouge, Symphony Space, Zankel Hall at Carnegie Hall, Philadelphia's Museum of Art, Trinity Center, World Café Live, PNC Bank/Presser Recital Hall at the Settlement School, and the Painted Bride Arts Center. In October 2009, he appeared as saxophonist with the Los Angeles Philharmonic for Maestro Gustavo Dudamel's Inaugural Gala concert performing the world premiere of Pulitzer Prize and multiple Grammy winning composer John Adams' major new work, *City Noir* (released on DVD by Deutsche Grammophon), and performed the work with the orchestra throughout its May 2010 U.S. Tour, with appearances in San Francisco, Chicago, Phoenix, Philadelphia, and New York City's Avery Fisher Hall at Lincoln Center.

Professor McAllister has been a soloist with numerous nation-wide orchestras as well as the Royal Band of the Belgian Air Force, the United States Navy Band, and at the XIII World Saxophone Congress. He has appeared as guest saxophonist in the wind sections of the Toronto Symphony, Detroit Symphony Orchestra, Oregon Symphony, Houston Symphony, Phoenix Symphony, Tucson Symphony, New World Symphony and Opera Colorado. Professor McAllister has performed with notable big bands, and in many regional music theater and studio orchestra touring productions, having appeared with numerous entertainers including Broadway icon Patti LuPone.

In August 2013, he gave the World Premiere of John Adams' Saxophone Concerto - hailed by *The Sydney Morning Herald* as "an astonishing performance" - with the Sydney Symphony Orchestra under the baton of the composer in the Sydney Opera House. Subsequent United States premieres and international performances throughout 2013 and 2014 occurred with the Baltimore and Sao Paulo State (Brazil) symphonies, along with a recording of the Concerto and *City Noir* for Nonesuch Records with David Robertson and the Saint Louis.



With the endorsement of the Executive Committee of the School of Music, Theatre & Dance, we are pleased to recommend the appointment of Danielle Belen as associate professor of music (violin), without tenure, School of Music, Theatre & Dance, effective September 1, 2014.

#### ACADEMIC RECORD

Ms. Belen received a B.M. in violin performance from the University of Southern California Thornton School of Music, and also earned a professional studies certificate from the Colburn Conservatory of Music in Los Angeles, California.

#### PROFESSIONAL RECORD

Ms. Belen has been a member of the string faculty at the Colburn School of Performing Arts and Colburn Academy since 2008. Additionally, she has been the chamber music director of the Colburn School of Performing Arts since 2010. Ms. Belen is also the current concertmaster for the New West Symphony, and continues to perform at prestigious music festivals around the nation.

#### SUMMARY OF EVALUATION

Ms. Belen has already established an outstanding record of extraordinary teaching, exemplary entrepreneurial initiative, and experience as an accomplished concert soloist and concertmaster of numerous orchestras. As a performer, she has soloed with orchestras including the Cleveland Orchestra, San Francisco Symphony, Atlanta Symphony Orchestra, National Repertory Orchestra, and the Boston Pops. As a chamber musician, she has performed at numerous festivals, as well as performing at her own summer camp and festival in California Center Stage Strings. In 2008, Ms. Belen was awarded first place in the senior division of the Sphinx Competition.

#### PROFESSIONAL ACTIVITY

Ms. Belen is considered by many to be one of the most successful violin teachers in the country. Her students have gone on to study at major institutions such as Indiana University, University of Southern California, Northwestern University, and the Colburn Conservatory with teachers such as

Almita Vamos, Alex Kerr, and Robert Lipsett. Her students have also performed well in competitions, winning the very prestigious Klein and Stulberg International Competitions as well as numerous national and local competitions. Her students have also appeared as soloists with the Fort Worth Symphony, New West Symphony, and the New York Philharmonic.

Beyond her remarkable teaching and performing skills, Ms. Belen has a passion for bringing music to children and communities that might not have access to the highest level of teaching. She has led classes in high school and elementary classrooms across the United States, primarily in low-income areas for beginning students and non-music students. She is a strong advocate for community engagement events that help to build future audiences and contributing to the health of society at large. Most recently, she worked with the famed violinist Midori as part of an outreach initiative in downtown Los Angeles' Skid Row. Ms. Belen is a frequent performer at hospitals, high schools, retirement homes and community centers. She is the founder and artistic director of Center Stage Strings, a camp for a wide range of talented young musicians who provide free concerts to the community.



On the recommendation of the Medical School Executive Committee, I am pleased to recommend the appointment of Michael M.E. Johns, M.D. as professor of otolaryngology—head and neck surgery, without tenure, Medical School, effective June 2, 2014.

Dr. Johns received his bachelor's degree and continued with graduate studies in biology at Wayne State University. He received his M.D. degree from the University of Michigan in 1969 and remained at Michigan for his internship and residency. He subsequently joined the Medical Corps of the U.S. Army. Following army service, he joined the faculty of the University of Virginia in 1977 as an assistant professor and rose to the rank of professor. In 1984, he was recruited to Johns Hopkins University as professor and chair of otolaryngology—head and neck surgery. In 2007, he joined the faculty at Emory University.

Dr. Johns is an otolaryngologist who has been recognized for his work in head and neck cancer surgery and the study of treatment outcomes. His curriculum vita reflects 175 publications on a range of topics including epidemiology, diagnosis, and treatment of head and neck cancer. His administrative activities include serving as dean of the Johns Hopkins School of Medicine from 1990 to 1996, and vice president of the medical faculty at Johns Hopkins University, and as chancellor of Emory University from 2007 to 2012. Dr. Johns was elected to the Institute of Medicine of Medicine in 1993, is a fellow of the American Association for the Advancement of Science, and serves on the editorial board for the *Journal of the American Medical Association*.



Dr. Fink joined the faculty at the University of Michigan in 1982. In 1994, he left the university to relocate to the University of Pittsburgh, and returned to the University of Michigan in 2004 as a professor, with tenure, and chair of the Department of Neurology. Dr. Fink's research is focused on the development of recombinant viral vectors for the treatment of diseases of the nervous system. With his collaborators, he has created recombinant replication-incompetent herpes simplex vectors that efficiently transduce sensory neurons in the dorsal root ganglion. He has used these vectors to explore the pathophysiology of nerve degeneration in polyneuropathy, and mechanisms involved in the development of chronic pain. He has taken one of these vectors to the first clinical trial of gene therapy for pain, and has two other vectors in preclinical development; for treatment of neuropathic pain, and for prevention of chemotherapy-induced neuropathy.

Dr. Fink is well-funded for his research through the NIH. He has published more than 170 peer-reviewed articles and holds four patents. He is a member of the League of Research Excellence at the University of Michigan and received the VISN 4 Research Award from the Department of Veterans Affairs. Dr. Fink has held numerous national and international positions, including as a member of the French National Agency Review Panel, Chair of the NIH ZRG1 BDCN-J Special Emphasis Panel, and as chair of the NIMH RFP-10-017 Review Panel. He has served as an associate editor of *Neurotherapeutics* and is a member of the AAMC Council of Faculty and Academic Societies.



Professor Banaszak-Holl received her B.A. degree in sociology from the University of Chicago in 1986 and her M.A. and Ph.D. degrees from Cornell University in 1989 and 1991, respectively. She did a post-doctoral fellowship from 1992-1994 at the Center for Gerontology and Health Care Research, Brown University and held the position of assistant professor in the Department of Community Health and Center for Gerontology and Health Care Research at Brown University from 1994-1995. She joined the Department of Health Management and Policy faculty in 1995 as an assistant professor and was promoted to associate professor, with tenure, in 2003.


Professor Banaszak-Holl has studied inter-organizational dynamics and the impact of business strategy, implementation processes, and managerial culture on health outcomes of health delivery organizations for almost 20 years. She seeks to develop multidisciplinary approaches to understanding change in health services organizations and collaborates with other social scientists, physicians, nurses, and other clinical professionals. She is currently studying how quality of care in nursing homes is affected by chain acquisition in a study funded by the National Institute on Aging and is working on a larger project to facilitate implementation of better infection control practices across US nursing homes (with principal investigator, Sanjay Saint and his team) as supported by the Agency for Healthcare Research and Quality (AHRQ).

She has published broadly in health services and management literature, which includes over 50 articles and an edited volume on Social Movements and the Transformation of American Healthcare. Her research has appeared in the top health services journals including *Health Services Research*, *Social Science and Medicine*, and *Medical Care* and in top management journals, including *Administrative Science Quarterly* and *Industrial and Corporate Change*. Her research has been funded by the National Institute on Aging, Agency for Healthcare Research and Quality, and Blue Cross Blue Shield of Michigan Foundation.

Professor Banaszak-Holl has been an active member of the school and department committees. She has served on the school's executive committee, the advisory committee on academic programs and the school symposium committee. Departmental service includes the committee on competency model development, committee on residential masters program, committee on doctoral HSOP program and committee on MHSA/MBA joint program, to name a few.

By virtue of her academic credentials as well as her teaching and administrative experience, Professor Banaszak-Holl is highly qualified to deal with the duties of this position. 



Dr. Beard joined the faculty at the University of Michigan in 2013 as a professor, with tenure, in the Department of Molecular and Integrative Physiology.

Dr. Beard is an international authority in the areas of systems biology and computational bioengineering as related to cardiac and metabolic function modeling. He has received continuous funding for this important research from the NIH and the NSF. Dr. Beard serves as a member of the editorial board for multiple top-journals, including the *Journal of Biological Chemistry*, the *American Journal of Physiology, Heart and Circulatory Physiology*, and *Physiological Genomics*. He is an associate editor of *PLoS Computational Biology*, and is a member of two NIH review panels. Dr. Beard has established an international presence through his service as a member of the Scientific Advisory Committee for the Netherlands Consortium for Systems Biology, the Scientific Advisory Board for European Framework Programme 6 Project, and the Scientific Advisory Board for the International Study Group for Systems Biology. He has published 110 articles, written two books, and has been invited to present his

research nationally and at international venues including the Netherlands, United Kingdom and New Zealand.

Dr. Beard is a fitting holder of this professorship, as his interests are closely aligned with that of Dr. Wiggers, in the field of cardiovascular-directed research. With the endorsement of the Executive Committee of the School of Dentistry, I am pleased to recommend the appointment of Charlotte M. Mistretta as associate dean for research, School of Dentistry, effective June 1, 2014 through August 31, 2014.

Professor Mistretta received her MS and PhD in biological science from the Florida State University in 1968 and 1970, respectively. She joined the University of Michigan, School of Dentistry as a senior research associate in 1972. She was appointed as an assistant research scientist in 1974, an associate research scientist in 1976, and a research scientist in 1982. In 1991 she was appointed as a professor in the School of Dentistry. She served as the director of the Oral Health Sciences PhD Program (1993-2010.) Additionally, Professor Mistretta has held appointments in the Center for Human Growth and Development on the primary research track (1975-1996), associate professor, with tenure, (1975-1983), professor (1983-2002) in the School of Nursing, and interim director of the Center for Nursing Research (1985-1988.) She was named the William R. Mann Professor of Dentistry in 2003. She was appointed as associate dean for research and PhD training in November 2005 and has been serving in that role since then. Subsequently, responsibility for PhD training has been reassigned and Professor Mistretta will focus efforts in the research arena.

Professor Mistretta is an outstanding researcher in the area of taste development and related areas of neurosensory and chemoreception phenomena. She is the recipient of numerous national awards including the 2010 Kerry-Manheimer Award for Significant Advances and Outstanding Scientific Achievement in Chemosensory Sciences. She has held continuous funding as the principal investigator on her NIH grant, Development of the Sense of Taste, since 1988 with prior funding for this project from NSF. Currently she is a co-principal investigator on two additional grants through NIH. In 2010, Professor Mistretta received a CRLT award for Developing a Thematic Core for Neurobiology in Oral Health and Disease in the Dental School DDS curriculum. Since 1971 she has a continuing record of peer-reviewed journal publications and an extensive number of invited lectures nationally and internationally.


Professor Mistretta is an active teacher, teaching in the predoctoral DDS program, but primarily serving as mentor to masters, PhD and post-doctoral students. She serves on several masters' thesis and PhD dissertation committees.

We are pleased to recommend the appointment of Marie Lynn Miranda as the Samuel A. Graham Dean, School of Natural Resources and Environment, effective May 1, 2014 through December 31, 2016, with the possibility of renewal.

This endowed deanship was established in April 2014 by the Graham Foundation in memory of Samuel A. Graham. A 1914 graduate of the University of Minnesota, Professor Samuel A. Graham received a master's degree from Cornell University in 1916, and a doctorate from Minnesota in 1921. Professor Graham arrived on campus in 1927. He was a faculty member at the then named School of Natural Resources, as well as the College of Literature, Science, and the Arts (zoology), for 34 years. Professor Graham is considered to be the founder of North American forest entomology and insect ecology. In 1929, Professor Graham authored the first, and widely used, textbook on forest entomology, "Principles of Forest Entomology" which, ultimately, had three editions.

Marie Lynn Miranda earned her A.B. degree from Duke University in 1985 and her M.A. and Ph.D. degrees in economics from Harvard University in 1988 and 1990, respectively. She joined the faculty of Duke University as an assistant professor of public policy in the Sanford Institute of Public Policy in 1990. In 1995, she transferred her faculty appointment to the Nicholas School of the Environment where she was an assistant professor of the practice of environmental policy and director of undergraduate programs. In 1999, she was promoted to associate professor of the practice of environmental policy, and became a faculty member in the Integrated Toxicology Program and founding director of the Children's Environmental Health Initiative. From 2000-2005, Professor Miranda held the Dan and Margaret Gabel Chair in Environmental Ethics and Sustainable Environmental Management, one of Duke's fixed term endowed chairs. In December 2007, she became an associate professor (with tenure) of environmental sciences and policy and pediatrics. In July 2011, she was promoted to professor in the Nicholas School and the Department of Pediatrics.

In 2012, Professor Miranda became dean and professor of the School of Natural Resources and Environment at the University of Michigan. Dean Miranda has devoted much of her professional career to research directed at improving the health status of disadvantaged populations, particularly children, and continues to hold an active research portfolio. In her term as dean she has made headway on curricular reform for the master's program, restructured the Ph.D. program, and re-energized the sense of community among faculty, students and staff. Her record of accomplishment in research and leadership of the School of Natural Resources and Environment indicates that she exemplifies the expectations of this deanship.


