### Summary of Evaluation:

Teaching – Professor Pires teaches courses that train students in linguistic theory and guide them in using empirical data to evaluate formal theoretical models of cognitive representations. His teaching is essential to the department's undergraduate and graduate curricula in syntax, and the undergraduate curriculum in semantics; it contributes as well to student training in comparative linguistics, language acquisition, and bilingualism. This wide-ranging course repertoire is important to the language component of the college's ongoing cognitive science initiative. As a mentor, Professor Pires is a proactive advisor who is very favorably viewed by his advisees. He is frequently sought out as an undergraduate honors thesis advisor and doctoral dissertation chair. He also regularly engages in research partnerships with students through the Undergraduate Research Opportunities Program and other programs.

Research – Professor Pires is one of the world's leading theoreticians in the study of Portuguese syntax. Recently his research program broadened to include theoretically informed experimental investigations of first and second language learners' acquisition of syntactic structures. He also studies language change, especially the role of children in creating new syntactic constructions. Conducting research that falls within the intersection of theoretical syntax, experimental psycholinguistics, and historical linguistics requires mastering three entirely distinct research methodologies. The innovation of his work derives from new insights that emerge precisely because of this important intersection. Particularly significant is a recent series of acquisition studies that test predictions of his earlier work and inform theories of formal syntax, language change, and language development. These studies, done in collaboration with a strong team of researchers led by Professor Pires, have resulted in a set of tightly interconnected articles in top-tier journals, book chapters, and published conference proceedings, as well as a co-edited volume

on syntactic studies of children's and adult's acquisition of Portuguese. The next phase in this high-profile, highly productive research agenda is a sole-authored book on comparative syntax, under contract with Cambridge University Press.

It is especially commendable that Professor Pires is investing in the future of the discipline through his numerous efforts to improve the undergraduate and graduate experience for linguistics students at the university, national, and international levels.

"...Pires is an important scholar, working on some of the most exciting issues in contemporary linguistics: those which sit at the juncture between our understanding of the human genetic capacity for language (so-called 'Universal Grammar'), the empirical study of the process whereby humans come to possess specific instantiations of this capacity ('language acquisition'), and the observed variability across time of these specific instantiations ('language change')."

"There is substantial evidence of intensive research activity leading to quality publications in three major areas of research, at least one of which is new and highly beneficial for the Department's ability to attract more funding as well as its profile and international image. The potential problem of overstretch is tempered by the unified approach adopted such that findings in one area naturally feed into research projects in other areas. There is also clear evidence that the activity is likely to remain as intense and lead to quality publications in the future."

## Summary of Recommendation:

Professor Pires has established an excellent research program addressing core issues in linguistic theory with powerful experimental evidence. His teaching and leadership roles reflect his broadbased, innovative approach to the discipline and his intellectual engagement with students and their work. The Executive Committee of the College of Literature, Science, and the Arts and I recommend that Associate Professor Acrisio M. Pires be promoted to the rank of professor of linguistics, with tenure, College of Literature, Science, and the Arts.
