Vickie Jeanne Larsen, assistant professor of English, Department of English, College of Arts and Sciences, is recommended for promotion to associate professor of English, with tenure, Department of English, College of Arts and Sciences.

Summary of Evaluation:

Teaching – Taken together, Professor Larsen's range of courses, her range of pedagogical skills, and her range of related activities show her to be an innovative and engaged teacher. She has taught a breadth of courses that cover topics from the 200 level (The Bible as Literature) to the graduate level (Topics in British Literature). Across this set of classes, the response of students and peer observation is consistently positive about the skill of Professor Larsen as a teacher. Her teaching practice is highly intentional, and she puts a daily plan on the board so that students remain oriented toward a holistic goal. Student course evaluations suggest that the decisions Professor Larsen makes about her classes are effective, with the great majority of students agreeing or strongly agreeing that her courses are excellent. Professor Larsen has pursued continuous improvement in her pedagogical practice, whether through participating in campus workshops on experiential learning, engaged scholarship, or teaching observation; or by getting hands-on practice in medieval book-making techniques in Ann Arbor. Her contributions to assessment have been strong and consistent, both in her significant efforts on the Department of English Assessment Committee, and in her extensive work with colleagues on learning outcomes for General Education assessment.

Research – Professor Larsen has focused her scholarship on two primary areas; medieval feminist literature (principally Shewings by Julian of Norwich) and how that book has been interpreted by subsequent readers in the 15th, 16th, and 17th centuries, and early book analysis. This second area involves the techniques involved in actually making books and how those books are used socially across different time periods. In each of these topical areas, Professor Larsen has published in highly regarded journals that clearly move forward the understanding of the topics. All of the external reviewers agree on the quality and importance of her scholarship, calling it, variously, "significant," "innovative and important," "new and powerful," "outstanding," and "notable." Professor Larsen has a well-defined and clearly articulated research agenda to extend her scholarship in the sub-discipline of medievalism.

In professional service, Professor Larsen's most significant contribution has been her work as treasurer and membership coordinator for The Society for Medieval Feminist Scholarship since 2011. Overall, Professor Larsen has been an excellent academic citizen of the Department of English, the College of Arts and Sciences, and the University of Michigan-Flint.
