Summary of Evaluation:

<u>Teaching</u> – Professor Rivero is one of Screen Arts and Cultures' most respected and popular teachers. Students appreciate her ability to inspire them to focus on television practices beyond the U.S. and to study shows with a new sensitivity toward racial, ethnic, and gender issues. Her teaching evaluations are outstanding, and students note that she is a skillful and enjoyable instructor. Her courses and seminars attract students from across the college as well as the School of Music, Theatre & Dance. Professor Rivero has served on eight dissertation committees. She has also compiled professionalization guidelines for her Ph.D. students to help demystify the process prior to defending one's dissertation, and to assist with the difficult professional navigation afterwards. Few colleagues advocate so well for their students.

Research – Professor Rivero is a leading figure in three areas: television studies, Latino/a studies, and feminist/gender studies. Few people master that level of interdisciplinarity in a way that is historically grounded and transnationally contextualized with sophistication and grace. Since joining the faculty at Michigan, Professor Rivero has published a new monograph (forthcoming from Duke University Press), a co-edited collection, three refereed journal articles, five book chapters, and five shorter publications. Her next project on the Colombian television industry will assuredly enhance her already-high profile.

Service – Professor Rivero has been an active citizen in Screen Arts and in American Culture, where until 2014 she held a budgeted appointment. She served on six major committees in American Culture, including the Executive Committee and the Latino Studies Board. In Screen Arts she chaired a major search committee that resulted in two hires, and served on both the graduate and undergraduate committees. She is currently serving on the Screen Arts self-study in anticipation of its upcoming external review. Beyond Michigan, Professor Rivero has been equally active in several disciplinary fields. She is an elected member of the Executive Committee of the Society for Cinema and Media Studies, media studies' largest and most prestigious organization, and recently began a term as co-editor of the influential Journal of Communication. She has also reviewed numerous essays and book manuscripts.
