Summary of Evaluation:

Teaching: Professor Adler-Milstein joined the University of Michigan (UM), School of Information (UMSI) during the launch of the Master of Health Informatics (MHI) program and thus had the opportunity to create and offer entirely new courses in her area of interest. The first of these courses, “Critical Policy Issues in Health IT,” was first offered in fall 2011 and plays a pivotal role in the MHI curriculum. The course focuses on the dynamic technological environment in health care organizations which has been made more complex by the recent federal initiatives relating to health information technology policy. In the course, Professor Adler-Milstein and her students examine real-world cases that raise policy, ethical, information privacy, and security issues of critical importance to patients and health care organizations. Professor Adler-Milstein has offered this course three times and the mean student ratings for both Q1 and Q2 have exceeded 4.75 each time. Her second course, “Managing Health IT,” lies at the intersection of management science and health information technology. It is a required course in the MHI curriculum. In this course, she employs the Harvard Business School case-based teaching approach, which has proven to be very successful. Professor Adler-Milstein has offered this course twice, in the fall 2013 and 2014 semesters. In “Managing Health IT,” the mean student rating across Q1 and Q2 have also exceeded 4.75. Her ratings as an instructor approach the top of the scale. The consistency of the ratings demonstrates that Professor Adler-Milstein is an excellent teacher whose pedagogical methods are very effective.

Research: Professor Adler-Milstein’s scholarship has relevance in a number of fields. She has published in the top journals in several disciplines including policy (*Health Affairs*), health

informatics (*Journal of the American Medical Informatics Association*), medicine (*Annals of Internal Medicine* and *American Journal of Managed Care*) and management (*Management Science*).

In total, Professor Adler-Milstein has published 41 peer-reviewed articles and was the first or senior author on 33 of them. Her publications are broadly cited; three peer-reviewed publications have garnered over 100 citations each. Altogether, her papers have more than 1,500 citations. This quantity is impressive, but the letter writers also commented on the quality of the scholarship.

Professor Adler-Milstein has successfully obtained substantial research funding from diverse agencies, such as the US Agency for Healthcare Research and Quality, the California HealthCare Foundation, The Commonwealth Fund, and Department of Health and Human Services – Office of the National Coordinator for Health IT.

Professor Adler-Milstein's national reputation is also evident from the influential awards she has received for her research: the New Investigator Award from the American Medical Informatics Association (2014); the Seema S. Sonnad Emerging Leader in Managed Care Research Award from the *American Journal of Managed Care* (2015); the Top 10 Influential Women in Health IT designation from Fierce Health IT; the Impact Accelerator Award from the Institute for Health Policy and Innovation, University of Michigan (2015); and the Henry Russel Award for Outstanding Junior Faculty from the University of Michigan (2015).

Recognition of Professor Adler-Milstein's work extends beyond academia. In March 2015, she testified before the United States Senate Committee on Health, Education, Labor, and Pensions. The topic of the hearing was "America's Health IT Transformation: Translating the Promise of Electronic Health Records into Better Care."

Service: Professor Adler-Milstein complements her teaching and research with significant levels of mentoring master's (primarily MHI) students, and research supervision of three doctoral

students who are primarily pursuing the Ph.D. degree through the Department of Health Management and Policy (HMP) in the School of Public Health. Her Ph.D. students are making consistent progress under her supervision and she regularly publishes with them. Her supervision of Ph.D. students reflects good use of her joint appointment. Her efforts in this regard sustain, in our view, an important link between the UM Schools of Information and Public Health. At the School of Information, Professor Adler-Milstein has been an important member of the Master of Health Informatics Program Committee since 2011, and has been involved in recruiting MHI and Ph.D. students. She has also co-led a faculty search committee and served on three search committees in total. She was also elected by fellow faculty members to the Dean's Advisory Committee.
