## Summary of Evaluations:

<u>Teaching</u> – Professor Campbell is a highly experienced teacher who has taught the full range of undergraduate and graduate classes—from large introductory courses to small advanced graduate seminars. Across these diverse learning environments, he has given careful thought to enhancing student engagement and has been an innovator in the use of technologies in the classroom. Student evaluations show that he is a serious and engaged teacher. Professor Campbell advises a number of Ph.D. students, serving them well as an attentive mentor.

Research - Professor Campbell is a recognized leader in his focus on social and cultural phenomena related to mobile communication. It would be virtually impossible for a reviewer of this new and evolving field of scholarship NOT to draw on and cite the theories and findings of his papers, chapters, and articles. Professor Campbell started to work in the field before it was even recognized as an active area of scholarship. Since 2011, when he was promoted to associate professor, he has published 27 publications, twelve of which are articles in impactrated peer-reviewed journals and many of the remaining are in the top journals in his field. In 2011, he co-edited a well-received book on mobile communication. In 2015, he received a contract from Oxford University Press to publish his sole-authored book entitled, Mobile Communication and Social Connectedness.

"...Professor Scott Campbell has devoted himself to a clear research program on mobile communication, with evolving interests but a central focus on mobile communication affordances and use, and their relation to networks and civic discourse. ... His work is very thoughtful and substantive, as well as able to distinguish important but overlooked differences in influences and outcomes (such as smaller vs larger homogenous networks, public and private space, and content and form of use)."
