Professor Bottino earned his DDS in 2001 and his MS in 2005 from Paulista University, Brazil. He received a certificate in operative dentistry and biomaterials in 2002 from Universidade Estadual Paulista, Brazil. In 2010, he earned his PhD from the University of Alabama.

PROFESSIONAL RECORD

Professor Bottino was appointed as an assistant professor of dental biomaterials in 2010 and was promoted to associate professor of dental biomaterials, with tenure, in 2016 at Indiana University. Academic Degrees:

Professor Elliott received his Ph.D. degree in social work in 2008 and his M.S.W in 2005 from George Warren Brown School of Social Work, Washington University in St. Louis, Missouri. In 1995, he earned his B.S. in psychology from Geneva College, Beaver Falls, PA.

Professional Record:

Professor Elliott joined the faculty of the University of Pittsburgh as an assistant professor (tenure track) from 2008-2011. He then joined the School of Social Welfare, University of Kansas as an assistant professor (tenure track) from 2011-2013. He was the founding director of the Assets and Education Initiative at the University of Kansas from 2011 – 2017. In 2013, he was promoted to associate professor, with tenure, at the School of Social Welfare, University of Kansas and in 2017 he was promoted to professor.

Summary of Evaluation:

As a leader in research on Children's Savings Accounts (CSAs), college debt and more broadly wealth inequality, Professor Elliott conducts research that addresses an important social work and social policy issue: the relationship between family assets and child educational outcomes, including the impact of family savings. As a tool for promoting college attendance and completion among low income youth and families, including families of color, the CSA addresses wealth inequality. Professor Elliott is the founding director of the Center on Assets, Education, and Inclusion (AEDI) at Kansas University and has produced an impressive record of 46 juried publications in highly respected journals. His publications have been cited 1093 times according to Google Scholar. The impact of his work is demonstrated in an h-index of 19. Professor Elliott's research has been supported by over \$1.8 million in grants in the past five years.

Professor Elliott has an extensive track record of service to Kansas University, the community, and the profession. He makes an enormous contribution to his profession by serving on the editorial board of Journal of Children and Poverty and regularly reviewing articles for high impact journals such as Advances in Applied Sociology, American Education Review, Children and Youth Services Review, Economics and Education Review, and the Journal of the Society for Social Work and Research among others. He also serves on the advisor board as part of a project to develop a human needs index with the Center on Philanthropy at Indiana University and The Salvation Army. Recently, he served as a co-chair on a design team to make CSAs a sustainable funding model for higher education for the College Promise Campaign, and he serves on the national Campaign for Every Kid's Future as a committee member. He also regularly does pro bono advising for states, cities, and foundations across the country that are interested in starting up a Children's Savings Account program. Some examples are: New York State, Massachusetts, Vermont, Rhode Island, Colorado, New York City, the City of Oakland, and the Kaufmann Foundation.

Professor Elliott consistently exceeds expectations in the domains of teaching and mentorship. Professor Elliott taught "Advanced Quantitative Research Methods I" from 2014 – 2016, a course focused on quantitative research methodology and related inferential statistics. His ability to stimulate the students' interest and engage and challenge the students is evident in his very strong student evaluations of teaching (SET) scores. As evidenced by SET and student comments. students find him to be knowledgeable, well prepared, and inspiring. Although ratings of this course were average in the first year, the evaluations were stronger in the second two years. SET scores for this course in 2016 are above 4.0 on a scale of 1-5 on key domains of "content and materials were useful and organized," and above 4.5 for "available, responsive and helpful," and "acquired knowledge and skills that the course promoted." Professor Elliott has an excellent track record of mentorship of graduate students in their scholarly development. He shows strong commitment to mentorship by utilizing methods to link research, statistics and practice together to empower the students by using an experiential learning approach. Actively engaged in reaching each student, Professor Elliott notes "Multiple assignments allow for the opportunity to provide feedback to individual students based on their experience and knowledge pushing some to go beyond what they knew was possible and providing others with the extra instruction needed to reach a new level of expertise and knowledge".

ACADEMIC DEGREES

Professor Racine received a B.A. in music, elementary education from the University of Michigan-Flint in 1983. In 1989, she earned a M.M. in vocal performance also from the University of Michigan. Professor Racine began her academic career as a lecturer in the School of Music, Theatre & Dance, University of Michigan in 1985. She advanced through the lecturer ranks and was appointed as a clinical assistant professor of music in 1998. In 2004, she was promoted to the rank of clinical associate professor of music.

PROFESSIONAL RECORD

Professor Racine continues to be one of the most sought after voice teachers in the department of voice and she continues to teach an overload of applied students. She has an international reputation as a teacher of voice for musical theatre and is a regular clinician and consultant on Broadway and on London's West End, as well as prestigious training program at Tanglewood and Interlochen. Many of Professor Racine's students have achieved a high degree of success with noteworthy careers on Broadway, as well as in theatre, television and film, all resonating with the ideals of the Department of Entrepreneurship, Career Empowerment and Arts Leadership (EXCEL), and the versatility required in our field today. An example of her success in teaching is currently reflected in one of her former students, Gavin Creel, who has received two Tony nominations and is performing in the new 2017 Broadway production of *Hello, Dolly!*. Our school's Musical Theatre program is without question the top such program in the nation

and Professor Racine has played a key role in helping create this success. Professor Racine's excellence in the studio is also reflected in a high level of student rankings, feedback directly solicited from her students, as well as in the success of her former students. In recognition of her exemplary teaching, Professor Racine was awarded the school's prestigious 2005 Harold Haugh Award for excellence in studio teaching. On the recommendations of the Executive Committee and the Search Committee of the School of Social Work, we are pleased to recommend the appointment of Matthew J. Smith as associate professor of social work, with tenure, School of Social Work, effective September 1, 2017.

Academic Degrees:

Professor Smith received his Ph.D. degree in sociology from University of Wisconsin – Madison in 2006. He earned his M.P.E. from Washington University in St. Louis School of Medicine, Department of Psychiatry in 2008 and his M.S.W. in social work in 2000 and B.S. in psychology both from University of Illinois at Urbana-Champaign.

Professional Record:

Following a post-doctoral fellowship at Washington University in St. Louis, Department of Psychiatry, and a post-doctoral fellowship at Northwestern University, Department of Psychiatry and Behavioral Sciences, Professor Smith joined the faculty of the Department of Psychiatry and Behavioral Sciences at Northwestern University. He was an assistant professor (research track) from 2009-2015 and an assistant professor (clinician-educator track) from 2015-2016. He was a lecturer for the School of Professional Studies from 2014-2017 and an associate professor in the Department of Psychiatry and Behavioral Sciences from 2016-2017.

Summary of Evaluation:

Professor Smith's research focus is on generating new knowledge to improve treatment and outcomes for individuals with severe mental illness (schizophrenia), and developmental disabilities, as well as their caregiving families. One of his most notable accomplishments is the study of caregiving burdens for Latina and African American children with developmental disabilities. Findings from this study highlight the need for culturally sensitive interventions to support parents of ASD children. His research in the NIH-funded intervention, "Virtual Reality Job Interview Training" is a computer-based simulation designed to help individuals with psychiatric disabilities enhance their interviewing skills. The results of his two studies report that trainees improved their interviewing skills and access to job offers. This body of work

received high profile national media coverage, and he is pursuing a large scale evaluation of this intervention. Professor Smith has produced an impressive record of publications in highly respected journals with an interdisciplinary focus across many cognate areas including psychiatry, psychology and social work. He has published over 39 papers in top tier journals and was the first author on over 20 of them. In 2016, Professor Smith was awarded a \$2.1 million for a four-year study to pursue his evaluation of Virtual Reality Job Interview Training (VR - JIT). He has received funding from agencies such as NIMH, the Kessler Foundation, Northwestern University and the National Institute on Alcohol Abuse and Alcoholism.

Professor Smith has an extensive track record of service to Northwestern University, the community, and the profession. Professor Smith's service to the Department of Psychiatry and Behavioral Sciences' Clinical Psychology Ph.D. program includes interviewing candidates for residency, student advising for the MSCI program, mentoring junior faculty, and assistance in writing and submitting research proposals for departmental research faculty and staff. He also served on the department's Committee for Addiction Psychiatry. His service to the university includes membership on the Institutional Review Board from 2009-2016. He makes an enormous contribution to his profession by regularly reviewing for more than thirty high impact journals such as the *Journal of the American Medical Association, Schizophrenia Bulletin, American Journal of Psychiatry, Journal of Autism and Developmental Disorders* and *Journal of Vocational Rehabilitation*. Professor Smith regularly presents his research on positive sibling caregiving and job interview preparation, using virtual reality technology, to the leading consumer and advocacy organizations in the field. National Alliance on Mental Illness has sponsored presentations of his research on regional and national levels.

As evidenced by student evaluations of teaching (SET) and student comments, students find him to be knowledgeable, well prepared, and enthusiastic. As the student advisor of the Master of Science in the Clinical Investigation Program, Professor Smith developed a course "Clinical Research Design, Methods, and Grant Writing" to provide a more robust training experience for the students. By using student feedback and input, he implemented continuous review and improvement. Although ratings of this course were average in the first year, the evaluations were strong in the second two years. SET scores for this course are above 4.5 on a scale of 1-5 on key domains of "overall rating of this course," "overall rating of the instruction," and "how much you learned." Professor Smith also taught "Introduction to Biostatistics" course through the School of Professional Studies. SET Scores for this course in 2016 are above 5.0 on a scale of 1-6 on key domains as "overall rating of the instruction" and "how much you learned in this course". Professor Smith has an excellent track record of mentorship of graduate students and Clinical Psychology Ph.D. students in their professional and scholarly development. He shows strong commitment to mentorship as he has mentored thirteen BS-level research assistants who worked on research projects in his lab. Ten of these mentees are now Ph.D. students across the country in psychology and neuroscience programs and two are in medical school. He also served as the primary mentor for fifteen students in their independent study courses and as a primary advisor for two Ph.D. students.

ACADEMIC DEGREES

In 1983, Professor Toppin received a bachelor of music degree in piano, with a minor in organ and piano pedagogy, from the University of North Carolina at Chapel Hill. She then attended Peabody Conservatory of Music earning a master of music in piano in 1985, and a second master of music in voice in 1986. In 1990, Professor Toppin received a doctor of musical arts in voice from the University of Michigan.

PROFESSIONAL RECORD

Professor Toppin's teaching history began as an instructor at both Eastern Michigan University and at Bowling Green State University from 1989 through 1990. In 1990, she joined East Carolina University, Department of Music, as an assistant professor, and was promoted within this institution to associate professor (1995-1999), and to professor (1999-2010). In 2010, she was recruited to the University of North Carolina at Chapel Hill as a tenured professor of music, the position she currently holds. Professor Toppin recently sung as a soloist for former President Obama at the White House, and at the new American Embassy in Havana. Her performance career includes success at numerous vocal competitions including the Metropolitan Opera, the Munich International Competition in Germany, and many others. She has received critical acclaim for her operatic, orchestral, and oratorio performances in the United States, Czech Republic, Scotland, Japan, China, Uruguay, Sweden, the Caribbean, Bermuda, New Zealand, England, and Spain. She has appeared in recital on concert series including Carnegie Hall, Lincoln Center, Merkin Hall, Beijing Concert

Hall, Shanghai Opera House, Licieu Theatre in Barcelona, Spain and the International Albeniz Festival in Camprodon, Spain. Orchestral appearances include: the Norrköping Symphony (Sweden), the Manhattan Chamber Orchestra, the Chicago Sinfonietta, the Czech National Symphony, Mälmo Symphony Orchestra, (Sweden), Tokyo City Orchestra (Japan), The Montevideo Philharmonic (Uruguay), the Scotland Festival Orchestra (Aberdeen, Scotland), the Honolulu, Bermuda, Petersburg, Fayetteville, Fairfield, Toledo, Canton, North Carolina, Charlotte, Lafayette, Erie Chamber and Raleigh Chamber Symphony Orchestras, The Bach Aria Group, Phoenix Bach Consort, and the Washington DC Bach Consort with conductors such as: Paul Freeman, Richard Aulden Clark, Justin Brown, James Meena, and Gearhart Zimmerman.

She toured for seven seasons in "A Gershwin party" with pianist Leon Bates and tenor William Brown. The trio appeared on such series as the Minnesota Pops Cabaret Concert, Spivey Hall Concert Series in Atlanta and NPR's Performance Today. She is currently a member of "Gershwin on Broadway" with baritone Robert Sims and pianist Leon Bates for Joanne Rile Artist Management. She has created and tours in many other recitals such as: Music of African American composers; Music of Women composers; Pictures from an Exhibition (a visual show interacting art with music); and Music of Spanish composers on college campuses around the US such as Universities of Mississippi, Alabama, Michigan, Georgia, Miami, California, Oregon, North Carolina, Denver, New York University, Morehouse, Spelman, Duke, Michigan State, Tufts, and Emory. Additionally, she has been successful as a recording artist with numerous compact disc recordings including two new CDs released in 2015, *Frühlingsglaube* (music for soprano and fortepiano) and *George Shirley: A Spiritual Collection*.

In demand as a presenter and guest clinician for masterclasses, in the summer she teaches for programs in Bogota, Colombia (The National Conservatory of Music), Amalfi, Italy (The Amalfi Coast Music Festival) and Baltimore, Maryland, (The Baltimore Summer Opera Workshop). She is the director of the non-profit organization Videmus which promotes the music of African American concert composers through recordings, performances, and educational programming. Through Videmus, she administers annually the George Shirley African American Art Song and Opera Aria Competition in Michigan.

Professor Toppin has received numerous honors and awards including the Legacy Award from the National Opera Association in 2015; this award is in recognition of progress toward the goal of ethnic and racial diversity in professional opera. She has also been bestowed the Board of Governors Award for Excellence in Teaching at UNC, a school of music teaching/scholar award, and an alumni distinguished professor teaching award both from East Carolina University.

Professor Toppin has also enjoyed success with published scholarly work, several of these are in varying stages of completion. Her service profile is prolific and includes being appointed commissioner of the North Carolina African American Heritage Commission (appointed by Governor McCrory), various appointments with the North Carolina Arts Council (appointed by the governor), appointments within the National Association of Negro Musicians, and she is a voting member of the National Academy of Recording Arts & Sciences for the Grammy Awards, among other positions noted in her curriculum vitae. Additionally, Professor Toppin holds professional memberships in the National Association of Teachers of Singing, American Cultural Association, Association for the Study of African American Life and History, and the College Music Society.

SUMMARY OF EVALUATION

During Professor Toppin's visit to the University of Michigan, she provided a recital program that was varied and eclectic, with informal, contextual, spoken notes that constituted a model of programming for students. Her inclusion of numerous works written for her and examples from her project of inviting composers outside the African-American heritage to explore their own ethnicity in music was an ideal demonstration to our students of the inclusivity for which we strive. In the master class, she engaged the students musically, creatively and intellectually. Her work demonstrated that the subtleties of singing language are organic to good vocal technique and stylistic nuance. Students were very enthusiastic about the detailed, personal style of her teaching and the positive changes they experienced in their singing under her instruction. As a committee member noted, "There is no doubt that she is a wonderful teacher." Although her own vocal instrument is a lyric coloratura, she demonstrated her ability to work easily with other voice types.

On the recommendation of the dean of the Stephen M. Ross School of Business, we are pleased to recommend the appointment of Gwen Yu as associate professor of accounting, with tenure, Stephen M. Ross School of Business, effective September 1, 2017.

ACADEMIC DEGREES

Professor Yu completed both her Ph.D. in accounting and her M.A. in applied economics at the University of Michigan in 2010. She completed her B.A. in business administration at Yonsei University in Seoul, South Korea, in 2002.

PROFESSIONAL RECORD

Professor Yu was an assistant professor (2010-2015) at Harvard Business School, and is presently the MBA Class of 1962 associate professor of business administration at Harvard Business School.

SUMMARY OF EVALUATION

Professor Yu is recognized as a very productive and energetic scholar with great promise for the future. Over the course of her career (a little over six years), she has published a total of seven articles in top refereed journals (six in "A" and one in "A" - journals) and has written six working papers (four under review at top journals). Notably, Professor Yu's research has been published not only in top-tier accounting journals but also in prestigious economics and finance journals, indicating the broad applicability of her research.

Professor Yu's research focuses on the challenges facing firms and investors when dealing with different information environments in a global economy. Specifically, motivated by the increasing trends of global expansion and cross-border investments, Professor Yu's research examines how systematic differences in information environment across the globe affect real and reporting decisions by firms and individual investors. Her research includes in-depth examinations of the drivers of cross-border information frictions (e.g., differences in rules, regulations, managers' cultural background, and communication strategies), how firms attempt to overcome these frictions (e.g., by cross-listing in more developed markets), and the role of information intermediaries (e.g., financial analysts) in alleviating these frictions.

Professor Yu has taught a variety of courses across several academic programs. Students' evaluations of her teaching in the demanding environment at HBS have been highly favorable. Outside the classroom, Professor Yu's has contributed to course curriculum development and has written seven case studies (along with teaching notes) that have been used in the courses she teaches at HBS. These are admirable achievements.

Professor Yu's service both at HBS and to the academic profession meets and even exceeds that expected of an untenured faculty member. In addition to participating in faculty and Ph.D. recruiting, Professor Yu has participated in various MBA events at HBS as well as serving as an accounting expert in an online education course at HBS. Within the academy, Professor Yu's most notable service activity is her role as an editorial board member on *The Accounting Review*.

This professorship was established in the Provost's Office and was named in July 2007. Richard P. Mitchell served the University of Michigan continuously from 1956 until his untimely death in Cairo at age fifty-eight in September 1983. A stipend funded from college resources accompanies this professorship. Appointments to this professorship may be up to five years and may be renewed.

During the last five years, Professor Cole conducted research in Egypt, Tunisia, and Libya leading to the publication of his monograph, The New Arabs: How the Millennial Generation is Changing the Middle East (Simon and Schuster, 2014; translated into Spanish by Bellaterra Press, Barcelona). Professor Cole also co-authored a major two-volume world history textbook, Global Connections: Politics, Exchange, and Social Life in World History (with J. Coatsworth, et al., Cambridge University Press, 2015). He holds a publishing contract with The Nation Books for a monograph on "The Meaning of Peace in the Qur'an," and with I.B. Tauris for a retranslation and introduction to the Rubaiyat of Omar Khayyam; both projects are currently in progress. In addition to the books, he has published eleven articles or book chapters in refereed venues, five of which are related to The New Arabs, but cover topics or areas (such as Morocco and the Gulf) not treated at length in the book.

Professor Cole was granted a research residency at the Doris Duke Foundation for Islamic Art in Honolulu (December 2016), and he was appointed to the John W. Kluge Chair for Countries and Cultures of the South at the Library of Congress (summer 2016). He received funds from the college and other units for a major conference on "The Arts of the Arab Spring" in November 2013 (with C. Gruber in Art History). He was a co-recipient of a grant from the International Institute Enterprise Fund for a three-year project on "Peace and Peace Movements in Islam" (with S. Ali). He has presented numerous invited lectures at Northwestern University (2012), the University of

Brian Jacob received his A.B. in 1992 from Harvard University and Ph.D. in 2001 from the University of Chicago. He was appointed as an assistant professor at Harvard's John F. Kennedy School of Government in 2001. He joined the faculty at the University of Michigan as a professor, with tenure, in 2007, also serving as the director of the Center for Local, State and Urban Policy (CLOSUP) from 2007-2012. He is also a member of the Board of Editors of the American Economic Journal: Applied Economics, a research associate at the National Bureau of Economic Research, and a non-resident fellow in Economic Studies at the Brookings Institution.

Professor Jacob's research seeks to illuminate, and find policy solutions for, complex societal challenges. By identifying highly credible natural experiments and carefully evaluating them with sophisticated analytic procedures, he has made important contributions to our understanding of the consequences—both intentional and unintentional—of popular policy reforms in education, crime prevention, and low-income/affordable housing. His prolific research has not only enhanced our academic understanding of these policy innovations, but has also substantially influenced major policy debates. His current research focuses on school accountability, teacher labor markets, and virtual schooling. In 2008, he received the David N. Kershaw Prize, an award given every two years

to honor persons who, at under the age of 40, have made a distinguished contribution to the field of public policy. In 2011, he received the UM Faculty Recognition Award.

Since 2012, Professor Jacob has co-directed the Education Policy Initiative (EPI), a program within the Ford School that brings together nationally-recognized education policy scholars focused on the generation and dissemination of policy-relevant education research. Since its inception, EPI has raised over \$23 million in research funding and annually convenes over three dozen seminars, conferences and public lectures. EPI has established formal research collaborations with many state education agencies and engages with local education practitioners and researchers at other leading universities.

Professor Jacob serves as the director of the Ford School's joint Ph.D. program. He is a favorite teacher in the program evaluation course required for our flagship master's program, and recently pionecred a successful program evaluation course for undergraduates. He is lauded as a thoughtful advisor and mentor to students at all levels who have an interest in economic and education policy

With the endorsement of the Executive Committee of the College of Literature, Science, and the Arts, we are pleased to recommend the reappointment of James M. Joyce as the Cooper Harold Langford Collegiate Professor of Philosophy, College of Literature, Science, and the Arts, for a five-year renewable term, effective September 1, 2017 through August 31, 2022.

This professorship was established in the Provost Office and was named in July 2012. Cooper Harold Langford was a faculty member at the University of Michigan from 1929 to 1964. A stipend funded from college resources will accompany this professorship. Appointments to this professorship may be up to five years and may be renewed.

Over the last five years, Professor Joyce has continued to make outstanding contributions to the research, teaching, and service missions in his department and in the college. He is on schedule to submit a final version of a major new book, <u>Decision Theory</u>, to Princeton University Press. The book is an opinionated overview of decision theory aimed at a wide audience, ranging from advanced undergraduates to graduate students and professionals in philosophy, psychology, economics, and statistics. It is notable for its extensive discussion of the relationship between normative and empirical approaches to the study of decision making. It breaks new ground on questions about the nature of risk and the rationality of risk aversion, and decision making with preferences that change over time. It also provides a defense of causal decision theory against recent objections. Professor Joyce has used several chapters of his book successfully in his course on Rational Choice (PHIL 443).

Over the past five years, Professor Joyce has also written several major articles that are either published or in review, as well as critical reviews, published in leading journals, of three major books in decision theory. These are not mere book reviews, but essays that present new and substantial philosophical arguments. Since his work plays a major role in all three books, these essays allowed him the opportunity to advance his work in decision theory and thereby cement

his position as a world-class leader in causal decision theory. There is only slight overlap between these essays and his book.

In teaching, Professor Joyce performs vital roles in the philosophy major, teaching introductory and core majors' courses, and also in the Program in Philosophy, Politics and Economics and Cognitive Science, which are interdepartmental majors that are now driving most of the department's enrollment growth. He has grown "Rational Choice" (PHIL 443) into the department's first 400-level course large enough to take GSI discussion sections. Student evaluations are consistently very high for all his courses, from introductory philosophy to technically challenging advanced courses, making him one of the top four or five instructors in the department. Professor Joyce also plays a central role in the graduate program, chairing and serving on more dissertation committees than all but two colleagues.

Regarding service in the past five years Professor Joyce has served in multiple vital leadership roles in the department, at various times chairing graduate admissions, graduate placement (with outstanding placement rates for new Ph.D.s in two successive years), and faculty recruitment. As one of only two former chairs of the department still on the faculty, he provides indispensable advice to the current chair, as only a former chair can do. For the university, he has served on the Governing Board of Rackham Graduate School. Professor Joyce is also a leader in the profession. He has written 24 tenure or promotion letters in the last five years. He has served on the editorial boards of several leading philosophy journals, on the nominating and program committees of the Philosophy of Science Association, and on three external review committees (Carnegie Mellon, Indiana University, and University of California, Berkeley).

Kelley as the Ruth Bordin Collegiate Professor of History, American Culture, and Women's Studies, College of Literature, Science, and the Arts, for a five-year renewable term, effective September 1, 2017 through August 31, 2022.

This professorship was established in the Provost Office and was named in August 2002. Ruth Bordin was a curator at the Michigan Historical Collections (now the Bentley Historical Library) from 1957 to 1967. A stipend funded from college resources will accompany this professorship. In the five years since her last reappointment, Professor Kelley has maintained her standing as one of several preeminent specialists in the social and cultural history of U.S. women in the 19th century. Most notable among her achievements is her selection as a Distinguished Fellow in Residence at the American Antiquarian Society (2013-2014); election to the American Academy of Arts and Sciences (2014); the inauguration of the Mary Kelley Annual Book Prize in Women's and Gender Studies (2015); and election as the vice president of the Society of American Historians (2016).

Although Professor Kelley has been teaching only one term per year since 2014, she remains a pivotal and highly valued mentor of graduate students in history and American culture. Her intellectual influence is often definitive and she serves as an important cognate member on the Department of English Language and Literature committees. In terms of service, she has been a model citizen in her units. In American Culture, she joined the search in Asian/Pacific-Islander

Studies and had a definitive role in its very successful outcome. In History, she has served on promotion and tenure committees, chaired the Post-doctoral Fellowship Committee, and served on the Augmented Executive Committee during the 2016-2017 promotion season.

Last year, a conference was held in her honor at Michigan that was organized by her colleagues and students, and represented a gathering of junior and senior scholars whose work was deeply influenced by Professor Kelley.

The Dean and the Executive Committee of the College of Literature, Science, and the Arts are pleased to recommend the reappointment of John Montgomery as the Margaret and Herman Sokol Professor of Medicinal Chemistry, College of Literature, Science, and the Arts, effective January 1, 2018 through August 31, 2022.

The Margaret and Herman Sokol Professorship in Medicinal Chemistry was established by the Regents in July 2007 as a result of a generous gift from Herman Sokol. Appointments to this professorship may be up to five years and may be renewed.

During the past five years, Professor Montgomery has continued to sustain an exceptional record in research, teaching, and service. He is a leader in the discovery of new transition metal-catalyzed chemical reactions, the study of the mechanisms of these reactions, and the application of these processes to complex synthetic problems that have applications to the fields of medicinal chemistry and traditional organic chemistry. He has made major strides in these fields and continues to publish on diverse topics in the top chemistry journals worldwide. He has submitted a patent on a new class of nickel catalysts that is currently being evaluated for commercialization by chemical vendors and for applications in industry through materials transfer agreements. Several high impact publications on new topics of research in his laboratory are currently in preparation. His published papers have been cited over 4000 times, his H-index is 36, and his most cited publication has been cited over 400 times.

Professor Montgomery received a \$2 million National Institutes of Health (NIH) MIRA award (2016) in the inaugural round of funding. This new funding mechanism was originally made available only to senior investigators who rolled two or more NIGMS R01 grants into a single NIH award. Additionally, two of his National Science Foundation grants were recently renewed. Professor Montgomery has maintained continuous funding on all of his projects and has supported a research group of approximately twelve graduate students and post-doctoral fellows.

Professor Montgomery has demonstrated an unwavering commitment to education. He has consistently excelled in the largest undergraduate service courses in organic chemistry and has taught thousands of undergraduate students over the past five years in the introductory organic chemistry sequence. He consistently received excellent teaching evaluation scores, with Q2 scores ranging from 4.3-4.7 over his last five times teaching large lecture courses. He also taught an advanced

undergraduate course and received a Q2 score of 4.9. His exceptional evaluations are clear evidence of his dedication to teaching at all levels. Professor Montgomery serves on the Comprehensive Studies Program (CSP) Advisory Council (2015-present), and he is scheduled to teach a new course in fall 2017 that is geared toward CSP students who are enrolled in the challenging introductory organic chemistry course (CHEM 210).

Professor Montgomery has led several high impact initiatives at Michigan. He created and directed a Rackham Global Engagement for Doctoral Education program, which supports a graduate student exchange and research collaboration with the Institute of Chemical Research of Catalonia (ICIQ) in Tarragona, Spain. To date, 23 advanced graduate students have conducted a ten-week graduate research exchange with faculty paired with their research interests. Professor Montgomery also serves as the director and the principal investigator of the Department of Chemistry's NIH-sponsored Chemistry-Biology Interface (CBI) Training Program, bringing together faculty and graduate students from LSA, the College of Pharmacy, and the Medical School. In a key contribution of his role as the principal investigator of the CBI training program, he was the lead organizer of a major three-day career development conference in Ann Arbor (2016), which attracted a diverse group of panelists on sessions describing career opportunities in government, large and small academic positions, big pharma, agrochem, biotech, entrepreneurship, scientific consulting, law and intellectual property, and science writing, among others. Based on his exceptional record of mentoring students, Professor Montgomery received a Rackham Distinguished Graduate Mentoring Award (2017). In other service activities over the past five years, he served on the ADVANCE Advisory Board for the college, was a faculty mentor on the Leadership and Integration at Faculty Transitions (LIFT) program, and led the Department of Chemistry's effort for the 2016 NextProf event. He has chaired numerous department committees and serves on the editorial board for Organic Reactions, and as a faculty mentor for the 2016 NIGMS Mentoring Workshop for NewFaculty in Dallas. These efforts demonstrate an exceptional commitment to service, both nationally and locally.

On the recommendation of the Executive Committee of the College of Literature, Science, and the Arts, we are pleased to recommend the reappointment of Alexander D. Potts as the Max Loehr Collegiate Professor of the History of Art, College of Literature, Science, and the Arts, effective September 1, 2017 through August 31, 2022.

This professorship was established in the Provost Office and was named in July 2002. Max Loehr was a faculty member at the University of Michigan in the 1950s. A stipend funded from college resources will accompany this professorship. Appointments to this professorship may be up to five years and may be renewed.

Professor Potts is a scholar of great intellectual distinction, who has continued to be extraordinarily productive over the past five years. The statistics are themselves remarkable. In addition to publishing a major book, Experiments in Modern Realism: World Making, Politics and the Everyday in Postwar European and American Art (Yale University Press, 2013), Professor Potts has published sixteen single-authored articles (with three more in press) and eight essays. He has also delivered thirty-five high-profile lectures and talks in the U.S., Canada, Britain, and Germany. What is especially impressive is the breadth of his topics and his obvious reluctance to repeat himself in print or in speech. It is no wonder that he is regularly sought out to collaborate in significant publishing initiatives and to speak on panels organized by prominent individuals in the discipline. Professor Potts' writing is theoretically acute and issue-driven; the specific content ranges widely over time and includes everything from the 16th to the 21st centuries in the classical tradition with roots in antiquity. He is thus able to transcend specialist niches within the discipline. Professor Potts often writes on art historical thought itself, offering acute critiques of the works of the discipline's major theorists. He currently has several projects in the works, including another major book picturing the social in 19th-century art. Professor Potts continues to receive distinguished awards, including two terms as a member of the Institute for Advanced Study at Princeton University (2014-2015) and he was named as a Corresponding Fellow of the British Academy (2015).

Professor Potts has taught and mentored significant numbers of appreciative students at every level. He continues to introduce undergraduate students to the art of modernity in a core 200-level course. He offers as well an array of upper-level undergraduate courses, including, "Perspectives in Recent Art" – which shows him alert to international trends in art-making, not only in painting and sculpture, but also in photography, film, text-based work, performance art, and interventions in the

environment. Professor Potts has regularly advised undergraduate honors theses, sometimes several in a given year. His great gift to the graduate program has been his willingness to teach an introductory pro-seminar, required of all students entering the department's doctoral program and increasingly attended by students in cognate disciplines. Professor Potts is masterful in bringing out the complexities and subtleties of art historical methods. His E&E scores are always in the upper percentiles and, in the case of graduate seminars, his students give him the highest rankings in every category almost without exception. He is heavily in demand as a dissertation advisor. Virtually all students in the modern field invite him to sit on their committees. In the last five years, he has advised four completed dissertations, is supervising another now nearing completion, has served as a committee member for five dissertations, and has agreed to serve on eight more.

Professor Potts is a colleague who virtually always says "yes" when asked to help out. A mainstay of his department, he continues to sit on the Executive Committee (elected by the faculty) and can be counted on to attend virtually all departmental events. His generosity extends to other departments as well; he is frequently called in as a panel member, moderator, or respondent in interdisciplinary events. His service to the university is extraordinary. He has served on both the college's Divisional Committee (2008-2011) and Executive Committee (2011-2014). He now serves on the President's Advisory Committees on Public Art (appointed interim chair, fall 2016) and on University History (2016-present). He continues to sit on the Executive Committee of the UM Museum of Art, and is currently on the search committee for its new director.

For the field at large, Potts continues to evaluate scholarly articles (Oxford Art Journal, Art Bulletin, Art History, History Workshop Journal and Historical Materialism) and to review book manuscripts (Yale University Press, Ashgate Publishing, University of Chicago Press, University of California Press, and Museum of Modern Art, New York). He recently served on the Art History Review Committee at New York University. He regularly takes on the arduous task of vetting applications for organizations, including the Center for Advanced Study in the Visual Arts, the Stanford Humanities Center, and the ACLS. His work even extends to the public domain: he serves as juror for the Nasher Prize, honoring the work of contemporary sculptors (Nasher Sculpture Center, Dallas).

On the recommendation of Kristen J. Verhey, Ph.D., the A. Kent Christensen Collegiate Professor and Interim Chair of the Department of Cell and Developmental Biology, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the reappointment of Billy Tsai, Ph.D. as the Corydon Ford Collegiate Professor, Medical School, effective September 1, 2017 through August 31, 2022.

The Corydon Ford Collegiate Professorship was established in October 2012, through funds derived from the G. Carl Huber Professorship. It is intended to support a tenured faculty member in the Department of Cell and Developmental Biology with a focus on research and teaching. The appointment period is five years and may be renewed.

Dr. Tsai's laboratory has a long-standing interest in understanding the molecular basis of viral and microbial pathogenesis. They seek to clarify how the DNA tumor virus family of polyomaviruses (Pys) and the bacterial toxin cholera toxin (CT) penetrate the host endoplasmic reticulum (ER) membrane to reach the cytosol, a decisive infection step. While it is clear than Pys and CT are evolutionarily distinct toxic agents, findings from Dr. Tsai's laboratory nonetheless have revealed a remarkable similarity in their membrane penetration mechanism. Despite their obvious differences, toxins and viruses appear to hijack similar host machineries during entry. Due to the extremely interdisciplinary nature of his work that merges the virology, microbiology and cell biology fields, Dr. Tsai has published review articles in various journals, including the *Annual Review of Cell and Developmental Biology*, the *Annual Review of Microbiology* and the *Spring Harbor Press*.

Dr. Tsai is supported by two NIH R01 grants and a multi-PI R01. He is the co-director of Research for the Protein Folding Fast Forward Initiative, and is an editorial board member of the *Journal of Virology*. Dr. Tsai is also a standing member of an NIH study section.

Dr. Tsai has established himself as one of the foremost scholars in his discipline and has earned the honor for which this professorship recognizes. I am pleased, therefore, to recommend the reappointment of Billy Tsai, Ph.D. as the Corydon Ford Collegiate Professor, Medical School, effective September 1, 2017 through August 31, 2022.

A stipend funded from college resources accompanies this professorship. Appointments to this professorship may be up to five years and may be renewed.

Professor Tsebelis continues to be a productive and influential scholar, as well as a valuable mentor and disciplinary citizen. In the last five years, he has published a co-authored book, Reforming the European Union: Realizing the Impossible with D. Finke, T. Koenig, and S.O. Proksch, Princeton University Press, 2013, which was accepted by Cambridge University Press and Princeton University Press); co-edited a book, Legislative Institutions and Lawmaking in Latin America with E. Aleman, Oxford University Press, 2016, and published seven articles in referred journals along with chapters in edited volumes. In addition, his classic book on Veto Players just came out translated in Serbian.

Professor Tsebelis has been recognized by being inducted into the American Academy of Arts and Sciences. He received an honorary Doctorate from the University of Crete and a Kellogg Fellowship from the University of Notre Dame to study constitutional amendments. His work on constitutions has been recognized internationally. He has been invited by government institutions to speak on the constitutional revisions of Italy and Chile. He has given several key note speeches at different conferences, and his lectures have been published by or submitted to professional journals. The combination of these publications will be the basis for a book manuscript on "Constitutional Revisions in Democracies" (covering 92 countries). Professor Tsebelis' most important contribution to teaching has been the publication of two articles with students (one of which received a prize for best article on Federalism by the relevant section of the American Political Science Association).

Professor Tsebelis continues to be active in service to his department and to the profession. He serves on personnel committees, writes student recommendations, carries out colleague evaluations, serves on journal editorial boards, and serves as a referee for the National Science Foundation, as well as the John Simon Guggenheim and John D. and Catherine T. MacArthur foundations. He organized an international conference on Latin American Institutions and Policies at Michigan, which was the launching point of his co-edited book.

We are pleased to recommend to the appointment of Gordon L. Amidon as the William I. Higuchi Distinguished University Professor of Pharmaceutical Sciences, effective September 1, 2017.

The first Distinguished University Professorships were created in 1947 by the Board of Regents to recognize members of the faculty for exceptional achievement and reputation in their appointive fields of scholarly interest and for their superior teaching skills. Each professorship is named in honor of an eminent individual—preferably one associated with the university—in the scholar's same general field of interest. An appointment to a Distinguished University Professorship continues to be one of the most prestigious honors conferred by the university upon a member of its faculty.

Professor Amidon received his B.S. degree from the State University of New York, Buffalo (1967), and his M.A. degree in mathematics (1970) and Ph.D. in pharmaceutical chemistry (1971) from the University of Michigan. From 1971 to 1981 he was on the faculty at the University of Wisconsin. He was appointed as a professor of pharmaceutics at the University of Michigan in 1983 and was appointed as the Charles R. Walgreen, Jr. Professor of Pharmacy in 1994.

Professor Amidon is internationally known for his research in the field of drug absorption, transport phenomena, solubility and dissolution, and prodrugs. Professor Amidon is the leading biopharmaceutical scientist in the world today. His special expertise is in oral biopharmaceutics and drug absorption mechanism from delivery systems, both immediate release and controlled release. His scientific accomplishments have contributed to the pharmaceutical industry drug product development as well as regulatory standards for pharmaceutical products worldwide. His oral drug absorption mechanism work has led to modernizing of regulatory standards. He developed a Biopharmaceutics Classification System with the Food and Drug Administration, impacting bioequivalence standards worldwide. Among his many achievements, he was the first scientist to characterize the mechanisms for the absorption of metabolized medications across membranes. He also identified the intestinal mucosal cell activating enzyme, opening the way for the development of more efficiently absorbed anti-viral medications. He is the program director for a large multi-investigator and multi-disciplinary FDA-funded research project for developing innovative new scientific regulatory standards for oral products, an undertaking that brings together specialists in computational fluid dynamics, chemical reactor engineering, mathematical/statistical modeling, clinical gastroenterology, as well as pharmaceutical science. This

project will modernize, improve, and make less expensive the implementation of worldwide pharmaceutical product quality standards to ensure the safety and efficacy of pharmaceutical products.

Professor Amidon has published extensively in journals, with over 350 published papers and 370 abstracts. He has contributed chapters to over thirty books and monographs, is co-editor of eight books, and holds eighteen US patents. He has received numerous awards including best paper awards in the *Journal of Pharmaceutical Sciences* and *Pharmaceutical Research* and the Scheele Award of the Swedish Academy of Pharmaceutical Sciences for outstanding contributions to the field of oral drug delivery and biopharmaceutics. He has received an honorary degree from the University of Uppsala; the Founders Award of the Controlled Release Society; the Volwiler Award of the American Association of Colleges of Pharmacy; the AAPS Distinguished Pharmaceutical Scientist Award; the International Pharmaceutical Federation Distinguished Pharmaceutical Scientist Award; the Alexander von Humboldt Research Award; and the Japan Society for the Promotion of Science Fellowship Award. He served as president of the American Association of Pharmaceutical Sciences in 1998, and is editor of the American Chemical Society Journal, *Molecular Pharmaceutics*.

Professor Amidon has been an outstanding mentor to the more than 80 doctoral and post-doctoral students performing research in his laboratory. Many have gone on to careers in academia, and others have chosen careers in industry. His mentorship extends to the many visiting scholars from around the world that he has welcomed into his laboratory.

As he assumes the Distinguished University Professorship, Professor Amidon wishes to be named the William I. Higuchi Distinguished University Professor of Pharmaceutical Sciences.

Professor William I. Higuchi was a professor of pharmaceutical science at the University of Michigan from 1961 to 1981. He is a pioneer in the application of physical science to drug formulation and has had a profound impact on the development of the pharmaceutical sciences. He has received numerous international awards and in 2013 received an honorary degree from the University of Michigan.

The appointment of Gordon L. Amidon as the William I. Higuchi Distinguished University Professor of Pharmaceutical Sciences, effective September 1, 2017, recognizes his extensive and outstanding scholarly achievements, his commitment to excellence in education for his students, and his extensive contributions to the University of Michigan and beyond. We are pleased to recommend to the appointment of Charles L. Brooks III as the Cyrus Levinthal Distinguished University Professor of Chemistry, effective September 1, 2017.

The first Distinguished University Professorships were created in 1947 by the Board of Regents to recognize members of the faculty for exceptional achievement and reputation in their appointive fields of scholarly interest and for their superior teaching skills. Each professorship is named in honor of an eminent individual—preferably one associated with the university—in the scholar's same general field of interest. An appointment to a Distinguished University Professorship continues to be one of the most prestigious honors conferred by the university upon a member of its faculty.

Professor Brooks earned his B.S. in chemistry and physics from Alma College, and his Ph.D. in physical chemistry from Purdue University in 1982. After working as a post-doctoral fellow at Harvard University, in 1985 he joined Carnegie-Mellon University as an assistant professor of chemistry, where he was promoted to the rank of professor. In 1994 he was appointed as a professor of molecular biology at The Scripps Research Institute. In 2008 he joined the University of Michigan and was appointed as the Warner-Lambert/Parke-Davis Professor of Chemistry and Professor of Biophysics. He is currently the director of the enhanced program in Biophysics, which was born as an evolution of the interdisciplinary program in biophysics that was established in 1949 and is one of the first such programs in the world.

Professor Brooks is widely recognized as a pioneer in the fields of theoretical and computational chemistry and biophysics. Through the application of statistical mechanics, quantum chemistry, and computational methods to chemically- and physically-oriented problems in biology, he has made ground-breaking discoveries in research that span a broad range of topics. The spectrum of his research includes the processes through which proteins are assembled and folded to acquire a three-dimensional structure that is biologically functional; the processes that protein shells of viruses undergo during the viral life cycle, including the self-assembly into icosahedral nanostructures; the structure and dynamics of RNA in cellular processes; and the modeling of the dynamics and fabrication of complex small molecule biological assemblies. In addition, while a post-doctoral fellow at Harvard, he helped develop the first computational software for modeling and simulating molecular mechanics. The CHARMM program is now the most widely used software for bio-molecular simulation, and Professor Brooks continues to oversee its development and support and to advance new methods for using high performance computing

on large parallel and distributed supercomputers to model molecular dynamics. By making available these publicly-available tools, he has enabled and inspired the scientific community and has catalyzed the advances in the physical understanding of bio-molecular behavior. Professor Brooks has published more than 350 articles in leading scientific journals, and is co-author of <u>Proteins: A Theoretical Perspective of Dynamics</u>, Structure and Thermodynamics (Wiley Interscience, 1988).

For his scientific accomplishments, Professor Brooks has been appointed as a fellow to the American Association for the Advancement of Science, the Royal Society of Chemistry, and the Biophysical Society. He has received the Protein Society's Hans Neurath Award for his contributions of unusual merit to basic research in protein science, and the Gilda Loew Memorial Award from the International Society of Quantum Biology and Pharmacology. He has been recognized with the Computerworld Smithsonian Award for high performance computing and a permanent exhibit in the Smithsonian.

Professor Brooks is an exceptional teacher of undergraduates and has been an exemplary advisor and mentor to over one hundred graduate students and post-doctoral fellows. Former students hold academic positions across the United States, and others have made careers in the software and the pharmaceutical industries. His service includes membership on NSF and NIH review panels, an advisor to the National Research Council on supercomputing resources and the current President of the Protein Society.

As he assumes the Distinguished University Professorship, Professor Brooks wishes to be named the Cyrus Levinthal Distinguished University Professor of Chemistry and Biophysics.

Cyrus Levinthal (1922 – 1990), who began his academic career at the University of Michigan, was among a group of eminent scientists who in the 1950s defined the new field of biophysics. He moved to MIT in 1957, and joined Columbia University in 1969 as founding chair of biological sciences. He made significant discoveries relating to the mechanisms of DNA replication and virus architecture and function, and was a pioneer in developing graphical visualization of protein structure to understand the folding of proteins and the properties that arise through their mis-folding. Professor Brooks' present research builds on these efforts to develop software and models to study protein and nucleic acid structure, dynamics, and folding and to achieve rapid computational modeling of biological systems.

The appointment of Charles L. Brooks III as the Cyrus Levinthal Distinguished University Professor of Chemistry and Biophysics, effective September 1, 2017, recognizes his extensive and outstanding scholarly achievements, his commitment to excellence in education for his students, and his extensive contributions to the University of Michigan and beyond. We are pleased to recommend to the appointment of John M. Carethers, M.D. as the C. Richard Boland Distinguished University Professor of Internal Medicine and Human Genetics, effective September 1, 2017.

The first Distinguished University Professorships were created in 1947 by the Board of Regents to recognize members of the faculty for exceptional achievement and reputation in their appointive fields of scholarly interest and for their superior teaching skills. Each professorship is named in honor of an eminent individual—preferably one associated with the university—in the scholar's same general field of interest. An appointment to a Distinguished University Professorship continues to be one of the most prestigious honors conferred by the university upon a member of its faculty.

Dr. Carethers received his B.Sc. in biological sciences from Wayne State University and earned his M.D. from Wayne State University School of Medicine in 1989. He completed an internship and residency in internal medicine at the Massachusetts General Hospital, and a fellowship in gastroenterology at the University of Michigan Hospitals. In 1995, he was appointed as an assistant professor of medicine at the University of California, San Diego, and was promoted to professor in 2005. In 2009, Dr. Carethers joined the University of Michigan as the chair of the Department of Internal Medicine, professor of internal medicine, with tenure, and the John G. Searle Professor of Internal Medicine. In 2015, he was appointed as a professor of human genetics.

Dr. Carethers is internationally recognized as a leading researcher in the field of colorectal cancer genetics. His laboratory was among the first to demonstrate the involvement of BMP and activin signaling pathways in the pathogenesis of colorectal cancer. His research of the DNA mismatch repair system demonstrated how this effectuates chemotherapy for colorectal cancer patients as well as how it repairs specific mutations within DNA. His laboratory also demonstrated a causal link between DNA mismatch repair dysfunction and inflammation, and how this may contribute towards racial disparities for colorectal cancer. His research has generated more than 200 publications. He completed a two-year appointment on the National Commission for Digestive Diseases. For his pioneering work, Dr. Carethers has been elected to the American Society for Clinical Investigation, the American Association of Physicians, and American Academy of Arts and Sciences, the American Association for the Advancement of Sciences, and the National Academy of Medicine. Dr. Carethers has held or holds

leadership positions in the American Gastroenterological Association, the American Association for Cancer Research, and the American Association of Physicians.

Dr. Carethers is an outstanding mentor who in 2017 received the American Gastroenterological Association's Distinguished Mentor Award. In addition to teaching medical students, he has advised nearly sixty doctoral students and post-doctoral fellows. He has been an inspiring mentor and role model to aspiring minority scientists, and co-directed an NIH-funded Minority Serving Institution-Comprehensive Cancer Center Partnership.

As he assumes the Distinguished University Professorship, Dr. Carethers wishes to be named the C. Richard Boland Distinguished University Professor of Internal Medicine and Human Genetics.

C. Richard Boland received his M.D. degree from Yale, did his internship at St. Francis Hospital in Connecticut, and completed a residency in internal medicine at the Public Health Service Hospital in San Francisco. He completed his gastroenterology fellowship at UCSF. After joining the UCSF faculty, he was later recruited to the University of Michigan where he developed a genetic approach to solving his own family's cancer syndrome. After 11 years on the University of Michigan faculty, Dr. Boland became the chief of gastroenterology at UCSD, then later the chief of gastroenterology at Baylor University Medical Center in Dallas, Texas. His lab did path-breaking research on defective DNA mismatch repair and the genetics of colorectal disease. Dr. Boland was awarded the Beaumont Prize and the Julius Friedenwald Medal from the American Gastroenterological Association (AGA) and is a past president of the AGA.

Mark D. Hunter received his B.A. and M.A from the University of Oxford in 1984, and his D.Phil. in 1988. He completed a NATO Fellowship at Pennsylvania State University and a Natural Sciences and Engineering Research Council of Canada (NSERC) Fellowship at Laval University before joining the faculty at the University of Georgia from 1995 until 2006. In 2006, he joined the University of Michigan as a professor of ecology and evolutionary biology and natural resources and environment. In 2010, he was appointed as the Henry A. Gleason Collegiate Professor of Ecology and Evolutionary Biology.

Professor Hunter is a brilliantly innovative ecological scientist whose fundamental contributions have reconceptualized and integrated two bodies of research: population and community ecology and ecosystem ecology. Through his far-reaching and widely influential research that examines how plant-insect interactions shape ecosystem functioning, he has demonstrated the role of plant chemistry in linking animal population dynamics with ecosystem processes. Among his many contributions include a comprehensive theory for the evolution of plant defense systems that has great significance for control of insect pests and the conservation of endangered species. He has demonstrated how genetic diversity in plant chemistry maintains nutrients in soils and streams, and how the loss of this diversity leads to declines in soil fertility and forest productivity.

Professor Hunter is an exceptionally influential scientist who has produced dozens of articles in leading journals. He has written or edited six books, including The Phytochemical Landscape: Linking Trophic Interactions and Nutrient Dynamics (Princeton, 2016), a highly influential work that confirmed his international reputation as a leading thinker in fundamental ecological research. He has received numerous grants and prestigious awards, including the National Science Foundation's Opportunities for Promoting Understanding through Synthesis grant for evolutionary biology. In 2014, he was elected a lifetime fellow of the Ecological Society of America.

Professor Hunter is an exceptional teacher and an extraordinarily impactful research mentor of both undergraduate and graduate students. He received the Rackham Master's Mentoring Award in 2013. He is passionate about broadening participation in science, founding the landmark Frontiers Master's Program in the Department of Ecology and Evolutionary Biology to increase participation of underrepresented students. For his exceptional contributions to diversity, he received the Imes and Moore Faculty Award from the College of Literature, Science, and the Arts in 2010.

As he assumes the Distinguished University Professorship, Professor Hunter wishes to be named the Earl E. Werner Distinguished University Professor of Ecology and Evolutionary Biology.

Earl Werner received his B.A. from Columbia University in 1966 and his Ph.D. from Michigan State University in 1972. After serving on the faculties of the University of Iowa and Michigan State University, he joined the University of Michigan in 1986, retiring in 2014. Professor Werner has made seminal contributions to ecological science throughout his career, pioneering the study of changes in prey behavior as a response to predation risk, and the impacts of this behavioral change on population dynamics. Each professorship is named in honor of an eminent individual—preferably one associated with the university—in the scholar's same general field of interest. An appointment to a Distinguished University Professorship continues to be one of the most prestigious honors conferred by the university upon a member of its faculty.

Professor Katz earned his B.M. in music in 1966 from the University of Southern California, where he studied piano and the specialized field of accompanying vocal soloists, and had the unique opportunity of accompanying master classes and lessons of luminary musicians such as Jascha Heifetz and Gregor Piatigorsky. He served with the United States Army Band and Chorus in Washington, DC, where he was piano soloist and accompanist from 1966 to 1969. He was an adjunct associate professor at Westminster Choir College and a visiting professor at the University of Maryland, College Park, before joining the University of Michigan's School of Music, Theatre, & Dance as a professor of music (collaborative piano) in 1983.

Professor Katz is an internationally renowned chamber and *lied* pianist and teacher who has had a profound influence on music performance and education the world over. He is the world's leading collaborative pianist, a specialized area of performance where the pianist works in partnership with vocalists and other instrumentalists. He has performed more than fifty-five times in Carnegie Hall and has made frequent appearances on leading stages across the globe, including Hill Auditorium for the University Musical Society. He has been sought out to accompany the most renowned singing artists of our time, including Cecelia Bartoli, Karita Mattila, David Daniels, Marilyn Horne, Frederica von Stade, Kathleen Battle, Samuel Ramey, Kiri Te Kanawa, Grace Bumbry, Jose Carreras, Renata Tebaldi, and has made many lauded recordings with these artists that are part of the core collections of major record labels. He has written The Complete Collaborator: The Pianist as Partner (Oxford, 2009), which is the standard guide for singers and musicians who partner with pianists, and which has been translated into other languages including Japanese and Mandarin. Professor Katz also conducts, partnering soloists on the podium with orchestras in Washington DC, Houston, and elsewhere. He has edited operas by Rossini and Handel for performance by the Houston Grand Opera, the National Opera in Ottawa, and the

Metropolitan Opera in New York, and has led opera productions for the BBC, Tokyo's NHK broadcasting organization, and San Francisco's Merola Opera Program. He also has conducted over thirty productions for the School of Music, Theatre, & Dance.

Professor Katz is a beloved teacher who has shaped many graduate students with his incomparable pianistic and musical knowledge. His former doctor of musical arts students teach at leading schools of music and are professionals at leading companies such as the Paris Conservatoire, the Berlin Opera, and the Chicago Lyric Opera. Notwithstanding his heavy performance and teaching schedule, he also performs faculty recitals with his colleagues and curates a new series of art song performance for UMS.

For his extraordinary accomplishments as a performer and teacher, *Musical America*, the oldest American magazine on classical music, created a special category for its annual acclamations and named him "Accompanist of the Year" in 1988. He has been honored by being appointed as an adjunct professor of music by Finland's Sibelius Academy, and is a regular conductor and guest teacher at the New National Theatre, Tokyo. In recognition of his distinguished career, he has received honorary doctorates from the University of Southern California, Shenandoah University, and Westminster Choir College. Each professorship is named in honor of an eminent individual—preferably one associated with the university—in the scholar's same general field of interest. An appointment to a Distinguished University Professorship continues to be one of the most prestigious honors conferred by the university upon a member of its faculty.

Professor Smith earned her B.A. and M.A. in English at the University of Michigan and her Ph.D. in English literature from Case Western Reserve University. She taught at the University of Arizona and in 1983 joined the State University of New York at Binghamton where she rose to the rank of professor of English, comparative literature, and women's studies. In 1996, she joined the University of Michigan as a professor of English and women's studies and in 2001 was appointed as the Martha Guernsey Colby Collegiate Professor of English and women's studies. In 2012, she was appointed as the Mary Fair Croushore Professor and the director of the Humanities Institute.

Professor Smith's research and writing focus on the intersection of the poetics and politics of autobiographical acts and practices and feminist theory. She has pioneered a field of literary study, that of "life writing," or the study of the heterogeneous genres that emerge as people tell stories of themselves and of others. She is the author of four books that have developed the scholarship of autobiography, including A Poetics of Women's Autobiography: Marginality and the Fictions of Self-Representation (1987); Subjectivity, Identity, and the Body: Women's Autobiographical Practices in the Twentieth Century (1993); and Moving Lives: Women's Twentieth Century Travel Narratives (2001). In addition to dozens of articles, she has published three co-authored books, including Reading Autobiography: A Guide for Interpreting Life Narratives (2001, 2010), which is recognized as the essential guide for autobiography studies, and Human Rights and Narrated Lives: The Ethics of Recognition (2004). She has co-edited six collections of essays that have ignited interest in such issues as the de/colonization of the autobiographical subject, the everyday uses of autobiography, and the textual-visual interfaces of

practices of life writing in the arts. She also co-edited two anthologies, one on works of 19th century women's life writing and the other on indigenous writing in Australia.

Professor Smith has received Fulbright and Rockefeller Fellowships, and has held scholarly visitorships at the University of Queensland, the University of Toronto, the Rockefeller Foundation Center in Bellagio, the University of Canterbury (New Zealand), and elsewhere. In 2010, Professor Smith served as the president of the Modern Language Association, the principle professional association for scholars of language and literature which includes some 30,000 scholars from around the world. In this role, she articulated the pressing challenges for the humanities to respond to new opportunities for teaching and scholarship in the twenty-first century. She was a persuasive advocate for a vision of a humanistic doctoral education that is more expansive and networked in its forms of scholarship, more diverse in its fields of study, and more engaged with the public. During her presidency, she spearheaded conversations about concrete changes to doctoral programs, including a deeper engagement with technology and new forms for the dissertation. Her effort culminated in the inspiring and influential book Manifesto for the Humanities: Transforming Doctoral Education in Good Enough Times (2016). She now lectures and consults broadly on initiatives in transformation at universities across North America.

Professor Smith is a passionate teacher and a generous mentor of graduate students, chairing or serving on nearly forty doctoral dissertations. She is an inspiring teacher of undergraduates in English and women's studies. She is also an outstanding academic administrator who, in addition to her current position as director of the Humanities Institute, has served as the chair of the Department of English and director of Women's Studies. In 2015, the University of Michigan recognized her extraordinary contributions in research, teaching, and service by presenting her with the Distinguished Faculty Achievement Award.

Professor Yang earned his B.S. in chemical engineering from National Taiwan University, and his M.S. and Ph.D. in chemical engineering from Yale University in 1968 and 1971, respectively. After working at Brookhaven National Laboratory, he joined the State University of New York at Buffalo as an associate professor of chemical engineering in 1978. He was promoted to professor in 1982 and served as the chair of Chemical Engineering from 1989-1995, while he was appointed as the Praxair Professor in 1993. In 1995, he joined the University of Michigan's Department of Chemical Engineering as a professor and department chair. He served as the department chair from 1995 to 2000 and in 2002 was appointed as the Dwight F. Benton Professor of Chemical Engineering in the College of Engineering.

Professor Yang's research is centered around phenomena on solid surfaces and their new applications, and is internationally known as the leading academic expert in gas adsorption science and engineering. He has made many fundamental contributions that have had enormous impact. His main research area is the theory, methods and materials for the separation of gases, particularly separations by adsorption, but his work is far-reaching and extends to carbon materials, particularly gas-carbon reactions, and environmental catalysis, where his research has had profound significance. His research and writing have educated a generation of chemical engineers and scientists worldwide. In addition to two books that are standard texts in their field, Gas Separation by Adsorption Processes, (London, 1987) and Adsorbents: Fundamentals and Applications, (New Jersey, 2003), he and his students have published 420 journal papers in adsorption and related areas. He is also the holder of 33 U.S. patents.

For his research accomplishments, he has been elected to the National Academy of Engineering (2005), Academia Sinica (Taiwan, 2008) and, as a foreign member, to the Chinese Academy of Engineering (2015). He has been honored by the highest awards in his research fields, including three awards from the

American Institute of Chemical Engineers (AIChE): the William H. Walker Award for Excellence in Contribution to Chemical Engineering Literature, the Institute Award for Excellence in Industrial Gases Technology, and the AIChE Separations Division's Gerhold Award. The American Chemical Society (ACS) has honored him with the ACS Award in Separations Science and Technology (2003), and the American Carbon Society awarded him with the triennial SGL Carbon Award for the "Most Significant Overall Contributions to Science or Technology of Carbon Materials." In 2007, the University of Michigan recognized his extraordinary contributions in research, teaching, and service by presenting him with the Distinguished Faculty Achievement Award.

Professor Yang is an exceptional teacher. He also is an inspirational advisor and mentor to his nearly forty doctoral students and to the more than thirty post-doctoral fellows and visiting scholars who have worked under his supervision, many of whom now hold leading positions at top engineering programs across the US.

Following graduation, Professor Arruda was appointed as an assistant professor at the University of Michigan. She was promoted to associate professor in 1999 and to professor in 2005. She also currently serves as the co-director for the Exercise and Sport Science Initiative.

Professor Arruda teaches and conducts research in the areas of theoretical and experimental mechanics of macromolecular materials, including polymers, elastomers, composites, soft tissues and proteins, and in tissue engineering of soft tissues and tissue interfaces. Her research programs include experimental characterization and analytical and computational modeling of soft materials, including native and engineered tissues. Her interests in tissue engineering include scaffoldless methods using primary and mesenchymal cell sources, tissue engineering of tissue interfaces such as the myotendinous junction, and enthesis and multi-phasic tissue

engineering. Her polymer mechanics work has focused on the mechanics of these highly strain rate and temperature dependent materials with emphasis on the relationships among the structures at various length scales to the deformation mechanisms of those structures to predict the mechanical responses.

Professor Arruda has published nearly 100 papers in scientific journals with more in press or under review. She has chaired 14 Ph.D. committees with another six in progress. Professor Arruda is a fellow of the American Society of Mechanical Engineers, the American Academy of Mechanics, and the Society of Engineering Science. She is a member of the National Academy of Engineering (class of 2017). She is currently the president of the American Academy of Mechanics.

Dr. Grabb has published more than 60 scientific works and his research resulted in two awards from the American Society of Plastic and Reconstructive Surgery and one from the American Society for Surgery of the Hand.

Dr. Grabb was a member of the Board of Directors of the Educational Foundation of the American Society of Plastic and Reconstructive Surgeons from 1968 through 1976 and was its president from 1974 through 1975. He was also an active member of the University of Michigan Medical School faculty, holding numerous committee memberships. Dr. Grabb passed away in 1982.

This professorship will honor the important contributions Dr. Grabb made to the university and the Department of Surgery, specifically the Division of Plastic Surgery. Marvin Pollard Professor and Chair of the Department of Molecular and Integrative Physiology, and with the concurrence of the Executive Committee of the Medical School, I am pleased to recommend the naming of an existing unendowed collegiate professorship as the William H. Howell Collegiate Professorship in Physiology, Medical School, effective May 1, 2017.

This professorship was established through the Provost Office and will be funded by the Department of Molecular and Integrative Physiology. The appointment period may be up to five years and may be renewed.

Dr. William H. Howell was recruited to the University of Michigan in 1889 from Johns Hopkins University as a lecturer in physiology and histology and was quickly promoted to professor. He had a tremendous impact on the department, despite a short stay at the University of Michigan of three years. He established a laboratory course in physiology in 1891, which was the first course to be required in any medical school in the United States. Dr. Howell left the University of Michigan to become the chair of physiology at Johns Hopkins.

Dr. Howell's research findings touches several areas of biology and medicine, including blood physiology and pathology, and blood flow to the brain. One of the papers he published while at the University of Michigan provided a description of particles in red blood cells that take up nuclear stains, which many years later become known as Howell-Jolly bodies. He was later awarded the Weir Mitchell Prize for an article published that dealt with nerve degeneration.

Dr. Howell pioneered the use of heparin as a blood anti-coagulant, served as the dean of the Medical School at Johns Hopkins, and as the president of the American Physiology Society. This professorship honors his accomplishments and contribution to field and the University of Michigan. I am pleased, therefore, to recommend the naming of an existing unendowed collegiate professorship as the William H. Howell Collegiate Professorship in Physiology, Medical School, effective May 1, 2017.

John A. Jacquez, M.D. was born in 1922 in France and his family moved to the United States in 1929. After an internship, he became an assistant professor at the Sloan-Kettering Division of Cornell University and was promoted there to an associate professor. Dr. Jacquez came to the University of Michigan in 1962 to establish the area of biomedical data processing when the field was at its infancy. He held joint appointments in the Departments of Physiology in the Medical School, and in Biostatistics in the School of Public Health. He served as the chair of the Department of Physiology from 1985-1987 at the University of Michigan.

Dr. Jacquez retired in 1990 as an emeritus professor, then spent the rest of his life in Ann Arbor until his passing in 1999. He was a pioneer in the field of mathematical biology; his research covered a wide range of areas, including mathematical analysis of subjects that included kinetics of cellular amino acid uptake, the transmission of AIDS, and AIDS vaccine development. This professorship will honor his many achievements. I am pleased, therefore, to recommend the establishment of the John A. With approval of the faculty at the School of Information, we are pleased to recommend the appointment of Eric Gilbert as the John Derby Evans Endowed Professor of Information, School of Information, effective September 1, 2017 through August 31, 2022.

The John Derby Evans Endowed Professorship in Information was established by the Regents in March 2017. The John D. Evans Endowed Professorship represents a significant gift from the John D. Evans Foundation. This is a developmental professorship for a recently tenured associate professor and will be given for a five-year term, with the expectation that it will be awarded to a different junior faculty member each cycle. The gift is intended to foster the development of new ideas in the area of digital studies at the University of Michigan; educate students to think critically and become leaders in future media and information industries; and influence other faculty and research on campus.

Professor Gilbert received a Bachelor's degree in math and computer science from University of Illinois at Urbana-Champaign in 2001. He earned a Ph.D. in computer science from University of Illinois at Urbana-Champaign in 2010. Professor Gilbert has been an assistant professor at Georgia Institute of Technology Atlanta in College of Computing since 2011, where he received tenure in 2017. Before that, he was a research assistant at University of Illinois at Urbana-Champaign from 2006-2010. Professor Gilbert joins the faculty at the University of Michigan School of Information as an associate professor, with tenure, in September 2017.

Professor Gilbert's work is focused on the study of existing, and construction of new, social media systems. In his research statement, he articulates his goals to "uncover insights about social life" and "design better tools for the billions who use social media." He accomplishes these goals by combining his deep technical skills from human-computer interaction and computer science with his knowledge of theory from the social sciences, particularly psychology and linguistics. This has led to a highly influential body of work that has had impact in three ways: 1) theoretical contributions; 2) system building; and 3) methodological innovations. Over the course of his career, he has addressed important issues such as social translucence, fake news

and censorship. He has received four best paper awards seven nominations for best paper from top conferences in his field.

Professor Gilbert is a prolific, skilled, and thoughtful scholar who has expertise in human computer interaction, social media, and computer science: he identifies interesting research questions, then devises and executes technical solutions, collects and analyzes relevant data, and presents impactful results while also attending to higher-level implications and ideas. The advantage of working across this space--from theoretical modeling and testing to system building --is that Professor Gilbert's work is highly robust. Models are tested in deployed systems and systems are designed with theoretical models driving design decisions. Thus, his results contribute to both system design and theory. This combination of skills, together with Professor Gilbert's high level of productivity, intellectual spirit, and ability to engage with theory, is notable.

The Howard R. Marsh Visiting Professorship in Journalism was established in 1974 by a gift of securities from the Howard R. Marsh Trust. Marsh Visiting Professors are eminent professional journalists or distinguished academic scholars who lecture in undergraduate and graduate courses, teach mini-courses, and often present public lectures.

Prior to joining the Department of Communication Studies in September 2016, Mr. Potter was a Knight-Wallace Fellow in Law Reporting at the University of Michigan. He has been invited to guest lecture in a dozen university courses, including Johns Hopkins University MFA courses, George Washington University writing seminars, and Georgetown University sociology courses. He holds a M.A. in writing (2008) from the John Hopkins University and a B.A. in journalism (2002) from University of Texas at Austin. In 2011, his book <u>Green Is the New Red: An Insider's Account of a Social Movement under Siege</u> was published.

During the 2016-2017 academic year, Mr. Potter taught two courses for the Department of Communication Studies: "Rebel Reporters: Investigative Journalism and Social Change" and "Spies, Traitors, Heroes: The Ethics and Implications of Whistleblowing." Both courses were extremely well received by students in the fall term, and both courses have had maximum enrollment during the winter term.
